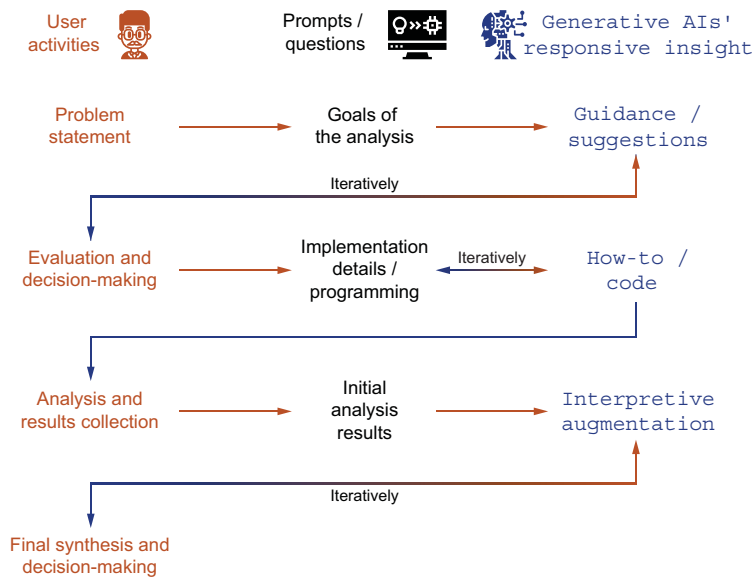

## *about this book*

---

This book can be read on three levels, so essentially you have three different books in front of you. At the highest level, it's a book about data analytics, and you'll find a basic introduction to the discipline, tools, algorithms, and some more advanced concepts, which together should allow you to perform analytics on your own. It will give you a high-level overview of data analytics as an initial step into the field.

Going deeper, or from a different perspective, if you prefer, it's a book about taking advantage of the rise of generative AI, as exemplified by ChatGPT. At each step of the journey through data analytics, we'll lead you through examples of how LLMs can support you in implementing and often also explaining data analytics concepts just through natural language prompts—this is simply a fancy way of saying that you can ask for something in plain English (or whatever language you are working in) and ChatGPT will respond. In some respects, it's almost miraculous: you ask, and you receive, be it a solution to a problem, an algorithm, or whole pieces of custom-written code. No more going through countless posts on Stack Overflow or similar websites, trying to find people with similar problems, and hoping that some kind soul helped them. You just need to state your question, and the algorithm is chosen and the code is written for you. Moreover, LLMs can also help beyond generating code: they can explain in plain language the functioning of a code snippet you provide or provide plain language descriptions of data and results.

Finally, it's a book about how the preceding “miracle” is illusory and how hidden traps await those lulled into a false sense of security. Generative AIs are not infallible. Despite the confident tone of their responses and their superhuman (sic!) ability to recall vast amounts of information, they still don't “understand” as such, and we'll show you examples of narrow focus, limited context awareness, communication mishaps, and pure AI hallucination.



It's been said that generative AI will cause various groups of people to lose their jobs, data analysts included. We'd clarify this notion, stating that, at least at the current level of advancement of the technology, the people who should beware are the ones who trust the responses from these models uncritically, for they will, sooner or later, repeat some obvious rubbish that the model has spewed out. Don't get us wrong: the models are brilliant and can do so much to help that it seems untrue at moments, but humans should not replace their own intelligence with artificial ones just yet. In most cases, we should use these models as tools to help humans do their jobs better.

### ***Who should read this book***

This book caters mainly to two audiences. First, it's tailored for individuals either embarking on a journey into data analytics or aiming to strengthen their existing skills. Our guide offers a detailed look into the analytical process, from initial planning to the practicalities of Python code-writing. Second, this book is insightful for managers and leaders. As the importance of data-driven decisions grows, having a foundational understanding of the analytics process and its associated risks becomes essential. This book provides a window into what managers can expect from their analytics teams and the challenges that might arise. In doing so, it serves as a resource for both the practitioners of analytics and those making decisions based on its outcomes.

### ***How to read this book***

Consider the book you hold as a travelogue. We wrote it from the perspective of someone not overly burdened with experience in data analytics who has embarked on a journey from raw data to business conclusions. We will introduce and discuss data analytics concepts, testing how much help we can expect from our GPT advisor.

#### **Generative AI vs. LLMs vs. GPT: Decoding the trio**

Throughout this book, we will be using the following sets of terms.

- *Generative AI* refers to a subset of artificial intelligence algorithms designed to create content. These algorithms can generate various forms of data, from text and images to music and videos, often by discerning patterns in the training data they've been fed and applying those patterns to the inputs, or "prompts," from the user. Their capability to produce new, original content mimicking the data they've learned makes them especially useful in creative and data-intensive tasks.
- *LLMs* (large language models) are a type of generative AI designed specifically for tasks involving human language. By training on vast amounts of textual data, these models aim to understand and generate text in a manner that's akin to humans. The LLM category contains multiple architecture types such as GPT, BERT, MoE, GShard, GLaM.
- *ChatGPT*, *ChatGPT 4*, or our *GPT/LLM/AI* advisor refers to a specific LLM implementation, namely ChatGPT 4 by OpenAI.


Throughout this book, we've chronicled our interactions with generative AI. While we feature mainly ChatGPT 4, the scope of the book isn't confined to just this particular implementation. Engagements and insights, along with associated risks, can be similarly derived from other LLM renditions.

### Your mileage may vary (a lot!)

When transcripts of conversations with ChatGPT are given, you should not expect to receive identical answers, even to the same prompts. There are several reasons for this:

- The version of the model you use may be different, with newer optimizations, training, and overlays.
- The responses we got were usually in the flow of larger conversations, and the context may influence the response.
- The model employs a certain randomness in its responses. Hence, if you click the Regenerate button next to a response, you will get a differently worded one. Hopefully the core meaning will be the same, although we did have examples where the model hallucinated enough that it even changed the meaning of the answer. You'll find more on AI hallucinations in chapter 8.

Let's have a look at a typical scenario where we use ChatGPT 4 to generate posts for Facebook and Twitter announcing the launch of a certain book:

Despite the emphasis we put on the risks related to using Generative AI, throughout the book, we believe that most of the conversations you’ll have with sufficiently developed models will have great educational value. Or at least, they may provide you with interesting food for thought.

Should you expect the answers we received? Absolutely not! We’ll explain why at the very beginning of the first chapter.

## **The business data used in the book**

To make the examples in this book coherent and illustrative, we will be using the Brazilian e-commerce public dataset of orders made at the Olist Store. The dataset has information on 100,000 orders from 2016 to 2018 made at multiple marketplaces in Brazil. Its features allow you to view orders from multiple dimensions: from order status, price, payment, and freight performance to customer location, product attributes, and, finally, reviews written by customers.

This is real commercial data. It has been anonymized, and references to the companies and partners in the review text have been replaced with the names of *Game of Thrones* great houses.

This dataset is available on Kaggle, under CC BY-NC-SA 4.0 license: <https://www.kaggle.com/datasets/olistbr/brazilian-e-commerce>. Access to the dataset requires creating a free account on the Kaggle platform.

## **About the code**

This book uses a data analysis example performed in a Python environment. If this irks you, feel free to adjust the prompts to the language or environment of your choice. A large part of chapter 7 is about utilizing generative AI to seamlessly move between programming languages.

The code is organized into Jupyter notebooks, one for each chapter, which are available in an online GitHub repository ([https://github.com/mariansiwiak/Generative\\_AI\\_for\\_Data\\_Analytics](https://github.com/mariansiwiak/Generative_AI_for_Data_Analytics)) and for download from the Manning website (<https://www.manning.com/books/starting-data-analytics-with-generative-ai-and-python>).

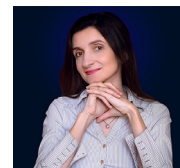

## *Introduction to the use of generative AI in data analytics*

As the dust over the generative AI hype begins to settle and the notes of disappointment mix in with the chorus of praises, it may be a good time to ask yourself a question: “If LLMs aren’t the silver bullet to all world problems, what are they really good for?” Our experience using these amazing tools to improve various processes gave us the answer. They are really good, and we mean *really good* in supporting improvements for different processes. Throughout this book, we will guide you through our methods for utilizing the enormous potential hidden in the matrices of generative AI to improve your analytics skills without falling victim to the risks inherent in this technology.

**UNDER THE HOOD** To excel in these goals, you will preferably have in the back of your mind what drives the responses you get to your prompts.

However, due to the architecture-agnostic nature of this book and the rapidly changing technology landscape, we have consciously avoided the technological nitty-gritty, focusing instead on process implementation. We encourage you, though, to get a good overview of what's what. You can learn it from several Manning books, such as *The Complete Obsolete Guide to Generative AI* by David Clinton or *Introduction to Generative AI* by Numa Dhamani and Maggie Engler. For the technical details of GPT models, see *How GPT Works* by Drew Farris, Edward Raff, and Stella Biderman.

In this chapter, you will learn about three important aspects of working with generative AI. As we strongly believe that first things should indeed be first, we'll start by presenting the inherent limitations of generative AI. We already mentioned the misalignment between the expectations and results of generative AI applications. A good understanding of the unavoidable limitations is critical to avoid disappointments at your work. The second aspect is related to embedding generative AI into the data analytics process. This part of the chapter will help you develop your first intuition about when and how to use generative AI when trying to solve an analytical problem. We will also manage expectations when it comes to automating processes involving generative AI. The last part of the chapter will provide you with knowledge about methods of accessing generative AIs. In the lion's share of cases, browser-based access to chat would be sufficient, but history teaches us that this may not be an advisable method when working with sensitive data.

The overall goal of this chapter is not to give you encyclopedic knowledge of this technology, but to ensure you have a deep enough understanding to demystify generative AI and allow for a more critical interpretation of its abilities.

## 1.1 Inherent limitations of generative AI models

In the Middle Ages, map edges had the inscription *Hic sunt dracones* (Latin for “Here be dragons”). You also may find monsters depicted in areas of uncharted waters. Later, the dragons, sirens, and krakens were replaced with depictions of reefs, shoals, and ice fields. We would like you to consider our warnings as the latter, rather than the former. For any endeavor, knowing the dangers to be wary of is at least as important as knowing what benefits to hope for.

The following list outlines the inherent limitations of any generative AI system. Some of them may be reduced or even removed in the future, but reading about a potentially obsolete limitation will cost you less than being unaware of even one that remains valid. So, here are the treacherous waters we should be aware of:

- *Generative AIs will always provide an answer (even if it's a wrong one)*—Like a child who finished their “why?” phase, or an overpromoted manager with heavy impostor syndrome, generative AIs, when asked a question, know everything and, as their first reaction, are unable to admit the limits of their knowledge. One of the main reasons you really want to read this book is because generative AIs can be convinced otherwise. In chapter 8, we'll also discuss the model's



sensitivity to input phrasing. Slightly rephrasing a question may result in different answers with varying degrees of quality and relevance. It's worth noting that, since prompts are usually supplied in natural language, this sensitivity is slightly different than for search engines. The latter only react to clusters of keywords, whereas generative AI may provide a different response based not just on the keywords, but also on the grammatical structure of the prompt, its perceived emotional tone of writing, and the context created by recent exchanges.

**HE SAID, SHE SAID** You can help generative AI provide correct, or at least useful, answers by providing underlying LLMs with the ability to search additional data sources and require linking answers to sources. You can learn more about that form from *Generative AI in Action* by Amit Bahree or *AI-Powered Search* by Trey Grainger, Doug Turnbull, and Max Irwin, both available from Manning Publications.

- *Some of the answers might be entirely made up*—There are instances where generative AI provides an answer that appears plausible but is not based on facts or directly linked to the training material. This is because the model sometimes fills in gaps in its knowledge by generating content that aligns with the patterns observed in the training data, even if the information is not accurate or complete. We will cover this problem in chapter 7, when we discuss the phenomenon of AI hallucinations.
- *Inherent sycophancy*—The larger the model at the base of generative AI, the more likely it is to exercise agreeability over reliability and accuracy. If confronted or questioned about the provided answer, it's likely to apologize and present the point of view contradicting its previous statement, even if it was correct the first time—truth be damned! Generative models can even make up numbers and falsify references to support the user's perspective!
- *Inaccurate or outdated information*—Each generative AI's knowledge is derived from the content corpus it was trained on. The model may provide outdated or incorrect information depending on the knowledge cutoff. This will be visible in examples in this book, where the model gives answers using API calls or programming language structures from obsolete versions. This is not as severe a limitation as it might initially seem. First, the majority of the concepts covered don't evolve that quickly, and most people will have a lot of ground to cover in the basics before they reach the need to tap the latest developments. Second, many generative AIs have access to the internet. However, mixing the time-constrained body of knowledge used to train the model with continuous updates may lead to inaccurate results. It's also worth remembering that some generative AIs only check the internet for the latest information when directly prompted.
- *Input and output limits*—When using generative AIs, you should be aware that the amount of text they can process (the amount of input they can read as a

whole and, on this basis, generate the output) is limited, although it can vary greatly between different models and implementations. The unit of text processed by generative AI is called a *token*, and it can be a word, part of a word, or a punctuation mark, depending on the tokenization method employed. Tokenization algorithms translate text into tokens with an average of 4 tokens per 3 words, or 0.75 words per token (this value should be relatively stable). At the time of writing this book, models have context windows ranging from several thousand up to millions of tokens, and the race to truly limitless context is full-on. For now, however, the available tools offer a limited number of input (prompt) and output (response) tokens, and you should remember that the context window covers both. You will get no warning if some data falls out of the window (no pun intended) and gets forgotten. Such truncation will usually manifest itself by the model giving responses inconsistent with previous exchanges, showing it has forgotten previous prompts or responses. In section 1.3, we present methods for estimating the number of tokens used. As a way of dealing with this limitation, you may frequently summarize the conversation and its key findings to ensure they are not left out of the context window.

- **Verbosity**—When you try some prompts, it will quickly become apparent that generative AIs generate overly verbose responses or overuse certain phrases (e.g., they tend to “unwaveringly delve into vast landscapes of the rich tapestry of intricacies of...” anything they encounter). This verbosity can be attributed to biases or patterns in the training data, where longer responses, or responses of a particular structure, might be more common.

**A WORD TO THE WISE** The prompt/response size limit and the verbosity can often lead to incomplete or cut-off responses. When designing a conversation with a generative AI, one option is to ensure that the combined length of the prompt and expected response doesn’t exceed the token limit.

- **Biased or inappropriate content**—Despite efforts to reduce harmful and biased content, generative AIs, especially those fine-tuned on unknown data, may still generate responses that exhibit biases or produce content that could be considered inappropriate. This can result from some biases still being present in the training data, biases that are hidden or purposefully included in the prompts, or a multitude of other overlapping factors. However, the developers of most generative AIs have gone to great lengths to balance the model’s responses. An example can be found in the GPT-4 System Card document (<https://cdn.openai.com/papers/gpt-4-system-card.pdf>).

Awareness of these limitations is crucial when you are interacting with generative AIs or incorporating them into various applications. Continued research and development aim to address these limitations and improve the performance and safety of generative AIs.

## 1.2 The role of generative AIs in data analytics

On groups and forums focused on generative AIs, there are dozens of questions to the effect of “Where can I find a GenAI-based tool that does [very specific task description here]?” Even if a requested tool does not exist yet, it probably will, and soon. And it’s all good. Data warehouses, lakes, lakehouses, meshes, fabrics, and so on replace Excel files, data in emails, and napkins (if not for all intended purposes). Dashboards and self-serve business intelligence (BI) platforms replace manually created reports and PowerPoint presentations (OK, questions about using generative AI to create, modify, or improve PowerPoint slides are the most common). However, beware of silver bullets. Only 0.5% of data collected in data warehouses, lakes, and so on is ever analyzed, while the remaining 99.5% generates costs and big-data hangover to companies that over-eagerly started to collect the data without a data utilization plan. BI platforms, in turn, are filled to the brim with rogue analytics (for example, data slicing and dicing that serves no purpose other than the justification of poor business decisions).

The effectiveness of generative AI use in data analytics will depend on your, the data analyst’s, ability to harness the possibilities and overcome the limitations of this new tool. Generative AIs, like any tool or technology, cannot be expected to do all the work. Let’s look closely at what we are dealing with and at generative AI’s differences from and similarities to other elements of the data analytics flow, namely the analytical process and software.

Until now, we have leaned toward the doom-and-gloom side of things, giving you a lot of warnings about generative AI’s limitations and discouraging you from jumping onto every tool labeled as “GenAI-powered” (we have an internal betting pool regarding when the first toothbrush labeled as such will hit the market). We did this on purpose as we noticed that overinflated expectations are the main blocker to the efficient use of this amazing tool. Now let’s get out of this shadow of doubt and step into the light of the bright generative AI-supported future of data analytics.

### 1.2.1 Generative AI in the data analytics flow

Years and years of working with data has convinced us that its value does not come from the complexity of the utilized technologies. We’ve seen millions of dollars saved with a simple breakdown of costs done by process rather than by organizational unit. We’ve seen millions of dollars lost because an overcomplicated market analysis involving dozens of tools and teams poorly reflected actual customer sentiments. *Data analysis is not about transforming raw data into charts. It’s about supporting business decisions using conclusions from relevant business data.* Your success in this endeavor will depend on a couple of aspects, of which the available tooling is just one.

Different types of data and different business questions require different analytic pipelines. If you work in a retail company, you most likely seek insights into customer behavior. Your pipeline may begin with the collection and cleaning of data from multiple sources: transaction records, customer feedback, and website interactions. Once the data is scrubbed and standardized, you will process it through algorithms

performing customer segmentation, product affinity analysis, and sales forecasting. Working with a healthcare provider, your input data would include patient electronic health records, medical imaging, and sensor data from wearable devices. Your processing would employ algorithms for disease diagnosis, treatment optimization, and patient outcome prediction. If you find yourself in a manufacturing firm, you'll be integrating data from IoT sensors on the factory floor, quality control checks, and supply chain logistics, with the analytics focused on anomaly detection, predictive maintenance, and supply/demand forecasting.

Irrespective of what you're analyzing and for whom, the essence of the process remains the same: collect and clean input data, process it using more or less advanced algorithms, and finally, present the results to the desired audience.

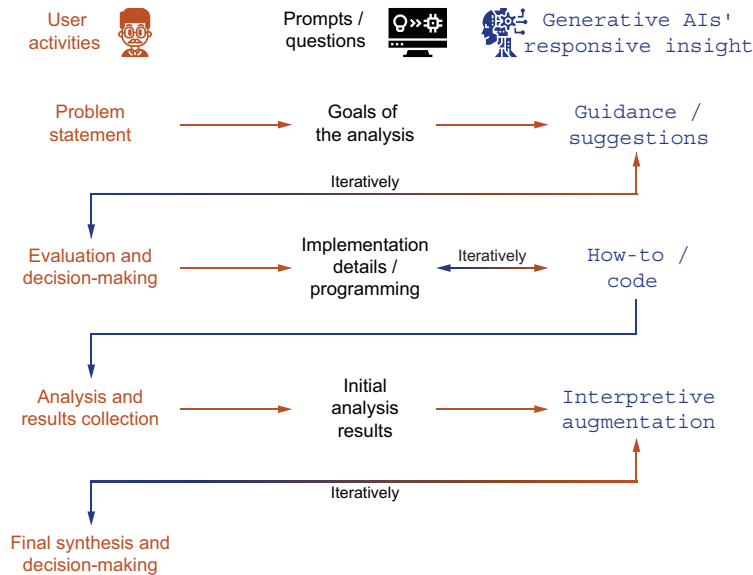
The details differ greatly depending on the business area, data sources, analytical methods applied, and expected output format. Each of these topics warrants a book (or six) on how to most effectively perform each of these steps, taking into account both cost and time, using this or that technology stack.

This book does not aim to answer all possible questions about all the possible scenarios you may encounter in your work as a data analyst. We offer you something much, much better. We propose a structured method to effectively use generative AIs' unbelievable knowledge repository (from Wikipedia to scientific papers, to books and literature, to dialogue data, to the Pile (<https://pile.eleuther.ai/>), and so on) to prepare an analytical pipeline tailor-made to solve exactly your problem.

**THE MISSING LINK** The scale of generative AIs' abilities is only starting to be explored. However, it's already clear that they can be taught to respond consistently and relevantly on a wide range of topics. They have the ability to drill down into details, summarize, explain, and associate related concepts to an extraordinary degree. These abilities can be used to effectively unblock your own thinking and get you out of your rut. You no longer have to trawl through dozens of random articles trying to find inspiration or pointers. Just ask a question. Even if the answer is imperfect, it may point you to concepts you haven't thought of before. Use this to expand your horizons.

In the preface, we identified a question you should ask yourself every time you encounter a new analytical problem: *where do I start?* Searching for the right input data might not be the worst possible choice, especially if it's accompanied by an analysis of what input data is actually relevant. Let's assume you work in a healthcare unit and get a question like "What are the average patient waiting times on Tuesdays?", or you work in retail and are asked to analyze, "How do our customers use loyalty cards?" Do not be fooled by the simplicity of the former question. They can, in fact, both be tricky.

The flow presented in figure 1.1 will help guide you through the crucial steps in going from the question to decision-enabling conclusions, focusing on getting the most added value from both the human and generative AI along the way, while avoiding the common pitfalls. It can be applied to any analytical task and technology stack you may have. All the examples you'll encounter in this book will follow this general structure.



**Figure 1.1** Recommended generative AI-supported data analysis flow

You always need to start with a problem statement. Let's look at our healthcare example. We were asked a question about waiting times on Tuesdays; however, issues around waiting times on a specific day are more likely to be the symptom of a deeper problem. The question you get asked will not often translate directly into an effective problem statement. We should ask ourselves, "What real problem are we looking at here?" While it's the job of the final decision maker to define the scope of the requested analysis, the guided questions can get you into a much better starting position for your analysis and, ultimately, provide more value from the analyzed data.

Now, the fun part. Even if the request comes from an area of operations you don't have experience with, generative AI can help you put the received request into a business context without bothering your stakeholders with unnecessary inquiries! Let's try a couple of generative AI on our Tuesdays-specific question.

MA


I work in a healthcare unit. I've been asked to answer a question: "What is the average waiting time for patients on Tuesdays?" What do you think could be some actual reasons behind such a question?

The answers are too long to include here, but both OpenAI's ChatGPTs (3.5 and 4), Google Gemini and Gemini Pro, and Meta's Llama 2 (13B) provided lists of possible project types where such an analysis could be of importance. The answers generally involve planning and budgeting (including resource allocation and staffing optimization), patient experience and quality of care, operational efficiency, and staff training.

Depending on your knowledge of current projects in your environment, you may come back with more or less specific questions, which shouldn't be considered a waste of time. For example, if you ask a stakeholder asking for an analysis a follow-up question like, "Is it connected to our latest focus on increasing patient satisfaction?", you could get an answer like, "Oh yeah, we've often heard complaints about Tuesdays, and we want to try to do something about it." Once you understand that patient complaints and waiting times are the root issues behind the original question about waiting times on Tuesdays, your final problem statement may look something like this: "What is the distribution of waiting times and its correlation with patient satisfaction?" This question balances specificity with scope, aiming to uncover actionable insights that can directly influence patient care protocols and satisfaction.

The level of detail you disclose about your project in conversations with your generative AI advisor should be tailored to the confidentiality requirements of your analysis and the specifics of your generative AI setup. It's advisable to share more freely within a locally managed software environment than on public platforms. This topic, including the associated risks of employing generative AI, is explored further in chapter 8.

You can then try querying generative AI about the best ways to answer the final question.

 And how could I approach analysis leading to answering the question: "What is the distribution of waiting times and its correlation with patient satisfaction?"

Yet again, the answers are quite lengthy and detailed. They offer you seven- to nine-step approaches, which, with additional iterative inquiries, should allow you to construct a robust pipeline. Chapter 3 provides a practical example of using generative AI to develop a detailed analysis design from an extremely vague request (unfortunately, likely to be encountered in the real world). Here, our aim is to show you that the value of generative AIs extends beyond just answering highly specific queries. Their utility isn't really reliant on the craft of "prompt engineering." Instead, it depends on your readiness to present the full scope of your problem and to recognize that (as in the case of any meaningful conversation with a well-informed colleague) you're unlikely to receive a flawless answer on the first attempt. Instead, expect to engage in an iterative process, refining broad concepts to meet your particular requirements.

Inquiring into details of the analysis or code and discussing the received results are common for all the steps of your analytical process on all levels of granularity. You should use them as elements of the flow of the whole project and when going through detailed substeps, such as when cleaning the data or formatting the final charts. Generative AI can help you clarify what you want to achieve at any given moment, determine how to effectively get there, and test if what you got is what you wanted.

As we mentioned, generative AI will not replace analytical tools but help you optimize their use. Let's have a look at the areas where they shine the brightest.

### 1.2.2 The complementarity of language models and other data analytics tools

On their own, generative AIs are particularly well-suited for tasks involving text data, such as sentiment analysis, text classification, summarization, and question-answering. However, their potential extends beyond text-based tasks. Multimodal AIs like Google's Gemini or OpenAI's GPT-4 allow you to upload different types of files, with the latter accepting raw data in formats such as CSV. But as we mentioned before, your success as a data analyst will depend on your ability to utilize generative AIs in a wider analytical environment. Luckily, that's precisely where you can get excellent support from generative AI. It's like having an expert on a speed dial!

First, all generative AIs worth their mettle have deep knowledge of most analytical frameworks available on the market. They can help you navigate through a vast array of technologies to extract, process, analyze, and visualize data. Suppose you have data in a bunch of Excel files and are tasked with creating the dashboard in Power BI. Try dropping the following question into the generative AI of your choice:



I have data in a bunch of Excel files and am tasked with creating the dashboard in Power BI. What shall I do?

You will get detailed instructions, including where to click to upload your data, basic options for modeling it, and, again, where to click to prepare a dashboard. And that's just the first step of the iteration.

Did your company just move from WordPress plugins to Google Analytics, but Google Tag Manager-based event tracking is needed for yesterday?



I'm tasked with enhancing our website's performance and need to leverage Google Tag Manager (GTM) for tracking various user interactions. Additionally, I must provide detailed reports in Google Analytics 4 (GA4). I'm completely new to the Google environment. Can you please help?

You'll get a good list of options, and you will be able to choose what's right for your specific case. Again, no "prompt engineering" is needed. Just a good, old cry for help.

Second, if you're more invested in serious data analytics, language models can generate code in various programming languages, such as Python, R, Scala, or even, for the more adventurous, PHP, Perl, or even Cobol or Intercal. The best-known example of this concept implementation is the GitHub Copilot, with software like Bito, Tabnine, Codeium, and FauxPilot (and many more) following in its footsteps. This capability allows you to obtain ready-to-use code for data processing, analysis, and visualization tasks, saving time and effort. The generated code can vary in size and complexity, from short snippets and single functions serving as a starting point for customizing and refining analyses to whole algorithm implementations and modules, limited only by your imagination and patience to coax the model to spit it out. Unlike raw code snippets downloaded off the internet, generative AI will provide code suited




exactly to your needs, and it has the invaluable ability to explain the code, as we'll see in several examples in this book, and optimize it to your specifications.

This ability to generate and explain code will be the most helpful feature for us throughout the book, but it also comes with the biggest warning, which we'll repeat in many places and cover in depth in chapter 7. Specifically, never *trust* the model to spit out entirely correct answers or perfectly working code on the first try. The higher the importance or risk of your project, the more scrupulously you should verify any output through review and testing. In subsequent chapters, you'll find examples of model-generated code that doesn't work as expected or that has incorrect explanations attached to it. *Caveat emptor!*

Finally, once the analysis is performed, language models can help interpret the results by generating natural language summaries and explanations. This feature may help you understand the intricacies of complex analytical results and communicate your findings to a broader audience.

There is an old story of a math professor complaining to his colleague about students: *I explained it to them three times, I finally understood it myself, and they still had questions.* With generative AI, you can allow yourself to be such a student, shamelessly pestering your advisor with questions until you're comfortable with the answer.

If you wish to practice and feel audacious, start by pasting the following prompt into multiple generative AIs of your choice.

 I got a confidence interval of 0.55-0.9 using the Wilson Score Interval (95% confidence level). How should I precisely communicate what it means for the performed test?

Statistics should be a very important part of your toolbox. Generative AI can help you avoid situations where stakeholders will evaluate your analyses on this scale: small lies, big lies, and statistics.

After reading the previous two sections, you should now feel excited about adding generative AI to your data analytics practice. We share that feeling every time we accomplish our tasks in a third or a quarter of the time they used to take. But, as always with generative AI, you need to be aware of some limitations.

### 1.2.3 Limits of generative AIs' ability to automate and streamline data analytics processes

While you can successfully employ generative AIs in all the applications listed previously and in the subsequent sections of this book (and more), their effectiveness in automating and streamlining data analytics processes has certain limitations. You can incorporate them into the data analytics domain, but their limitations make them an amazing supplement, not a replacement, for a data analyst.

#### LACK OF QUANTITATIVE ANALYSIS SKILLS

Generative AIs excel at understanding and generating natural language, but they lack the inherent ability to perform complex quantitative analysis (aka math). ChatGPT



has already included an add-on running Python code on the fly (utilizing an external environment, not as a native LLM capability), and other generative AIs will probably follow suit, but the success rate of the generated analytical runs, as you'll see in the following sections, is not something we'd wage the success of our business on. Data analytics processes often require mathematical and statistical methods, such as regression analysis, time-series forecasting, and clustering techniques. While generative AIs can suggest such methods and often offer the relevant code, the code must be thoroughly tested before it is put into the production environment.

#### **LIMITED UNDERSTANDING OF DOMAIN-SPECIFIC CONCEPTS**

While generative AIs can generate human-like text based on the context provided, their training data may not include highly specialized domain knowledge. Consequently, their ability to accurately generate insights or recommendations in the context of specific industries or niche subjects may be limited. This problem is enhanced by the already mentioned inherent inability of generative AIs to admit their ignorance. Knowledge limitations differ between generative AI providers and can be somewhat mitigated by providing GenAI with internet access, but you really don't want to base critical business decisions on an enthusiastic hallucination!

In the case of such specific needs, your best option is to provide the model with more general prompts and refine the answer based on your specialist knowledge.

#### **INABILITY TO INTERACT WITH DATABASES AND APIS**

Your work in data analytics will, more often than not, involve working with databases, APIs, or other data sources to extract, clean, and process data. Generative AIs lack the built-in capability to interact directly with these sources. While it is possible to integrate generative AIs with custom-built solutions to bridge this gap, doing so can be resource-intensive and challenging to implement effectively. As in the previous cases, the model can still be effectively used to guide your analysis and provide solutions or even whole swathes of code, which you can execute independently of the model.

#### **UNRELIABLE INTERNET ACCESS**

Some generative AIs, such as Google's Gemini, are "internet native." The internet connectivity is a natural part of their operations. For others, not so much. Self-hosted models, which you can download and run on your machine, such as Llama 2, need access to a search engine API and an implementation of so-called multistage reasoning, where in the first answer, the LLM decides what it needs to do to get the proper answer, and in the following steps, the architecture runs the internet search and provides the answer to the LLM, which on that basis can form the final response. ChatGPT 4 implements this in its web-based interface.

It seems complicated, and it is. The connectivity of self-hosted LLMs depends on external APIs and either a lot of code or fast-changing libraries. ChatGPT, in turn, sometimes forgets it can connect to the internet. When it was trained, it couldn't, and this memory still lingers in its network's deep layers. If your analysis depends on access to the latest data or news, you need to choose your tools very carefully.

In the following chapters of this book, we will show you how to apply this general-to-specific problem-solving path for the best results.

## 1.3 Getting started with generative AIs for data analytics

There is an old Chinese proverb, “In the forest of algorithms, the path to wisdom has many branches.” Actually, there isn’t—ChatGPT generated it for us. We have tried to convey that, depending on the situation, you have more than one way to access your AI advisor. To utilize generative AI’s potential, you need to get comfortable with conversing with it, as most of the tools built upon it strip its answers of relevant nuance, but you should know your options here.

### 1.3.1 Web interface

In this book, we will mainly use ChatGPT (<https://chat.openai.com>) and Gemini (<https://gemini.google.com>) as examples of generative AI. These are readily accessible (it’s more true than you’d like, as this access can be bidirectional—do not paste your confidential data there!), and the underlying language models are in constant, rapid development. There is also a chance that your company will have a self-hosted generative AI based on either of these or some other model, such as the  $n$ -th incarnation of Llama or Mixtral, but hopefully it will be accompanied by a proper web interface.

**AND THE WINNER IS...** *At the time of writing this book, GPT 4 was by far the most useful of all the tested generative AIs for any analytics-related tasks. However, this will change (just not with GPT 4o). Keep your eyes open and don’t be shy when it comes to engaging new generative AIs and testing their usefulness. Each model has its own training dataset and an architecture influencing its interpretation of your prompts and the resulting answer. Just remember that the technicalities behind them are irrelevant from your perspective (unless they are related to cost-effectiveness, of course). What interests you, as a data analyst, is the model’s ability to support your process.*

If you need specific models, you can search for one of half a million hosted on the AI-development website, [www.huggingface.co](http://www.huggingface.co). Some of them require downloading, but some can be run there. You can register for free, but extensive model use will require creating your own “Space” and purchasing processing power.

The use of generative AI via web interface is as simple as writing a query and reading the answer. Sometimes, there will also be a button allowing you to upload files to be analyzed.

### 1.3.2 Beware of tokens

If you plan to connect directly to a model, you must understand the critical difference between your and GenAIs’ perceptions of text. As explained earlier, generative AIs break down input text into manageable units known as *tokens*. This foundational step is critical, as it transforms raw text into a structured form that an AI model can efficiently process and learn from.

Tokenization involves dissecting the input text into a sequence of tokens. This process is not a mere splitting by whitespace; it's more nuanced, incorporating an understanding of the language's syntax and semantics. For instance, the word "don't" may be tokenized into "do" and "n't" to better capture its meaning and structure. Advanced models leverage subword tokenization schemes to balance the tradeoff between representing common words as single tokens and decomposing less common words into smaller, meaningful components. This approach enables the model to handle a vast vocabulary, including neologisms, with a fixed set of tokens.

**TOKENS OF BABEL** The method of tokenization—how the words are split before processing—is specific for each model. This is a critical point, as using tokenization meant for one model as input for another may cause the latter model to interpret the input as a meaningless, or worse, misleading, soup of semi-words misaligned with how the model's training material has been prepared.

As we warned you in section 1.1, when the input surpasses the context window, the earliest tokens are truncated, leaving the model with only the most recent tokens within its comprehension horizon. This truncation can lead to a loss of crucial context or information necessary for generating coherent and relevant responses. Have you ever been in a situation where someone overheard just the last couple sentences of a lengthy conversation and offered unsolicited advice? Such a response rarely adds to the conversation. Exceeding the context puts generative AI in a similar position. It's "deaf" to parts of the conversation exceeding its context window. This is particularly dangerous if you work with a large piece of code!

Several strategies can be employed to navigate the constraints of limited context windows. One common method is chunking the input text into smaller segments that fit within the model's context window, ensuring that each segment contains enough context to stand on its own for generation tasks. Another approach involves using techniques like sliding windows or iterative refinement, where the model progressively processes text, maintaining as much relevant context as possible across segments. For more complex interactions involving longer texts or conversations, strategies like creating a summary of previous interactions or leveraging external memory mechanisms can help maintain coherence.

### 1.3.3 Accessing and using the API

For more advanced use cases and seamless integration with your existing data analysis tools, you can access most of the popular models via their application programming interface (API). These APIs suit various programming languages, including Python, JavaScript, and more. With API access, you can create custom applications, integrate generative AIs into your existing data analysis workflows, and even build GenAI-powered analytics dashboards.

To further simplify the process of integrating generative AIs into your data analysis projects, you can use available SDKs (software development kits) and libraries created

by model or third-party developers, one of the most prominent being LangChain ([www.langchain.com](http://www.langchain.com)). These resources can save you time and effort when it comes to working with the API, as they provide prebuilt functions and classes that handle common tasks. You can find popular SDKs and libraries for various programming languages on platforms like GitHub. Make sure to check the compatibility and support status before using them in your projects.

#### AN EXAMPLE OF PROGRAMMATIC ACCESS TO CHATGPT

You can access different ChatGPT versions through the OpenAI API. This method allows you to programmatically send requests and receive responses, giving you greater control over the AI's capabilities. Sign up for an API key on the OpenAI website to get started (<https://platform.openai.com/signup>). Then, follow the API documentation to learn how to interact with ChatGPT using your preferred programming language.

To illustrate programmatic access, let's look at an example of accessing the ChatGPT models from Python. Similar code will be used in some of the discussions in chapter 5 on using ChatGPT directly for data analysis. If you haven't yet set up the OpenAI API, follow the instructions to install the library and set up an API key at the OpenAI signup page.

**A ROSE BY ANY OTHER NAME.** . . Throughout this book, we'll work with Python (in a Jupyter environment or any Unix environment). In chapter 7, we'll show that generative AIs are also capable of supporting many other programming environments.

Once you have the OpenAI API, it is recommended that you assign it to the `OPENAI_API_KEY` variable in the environment, either through your shell setup (depending on your system) or, preferably, through a `.env` file in your project. You can then use the following simple Python code to interact with ChatGPT.

The preceding code sets up an example exchange to be further completed by the model. It exemplifies how the model can handle multiturn exchanges (for example, multiple question-answer iterations) with context. The main input is the `messages` array of message objects, where each object consists of two components:

- A role, either system, user, or assistant
- The content

A system-role message is typically included first, followed by alternating user and assistant messages. The system-role message sets up the background for the behavior of the assistant. The example in listing 1.1 modifies the assistant's personality to reflect the style of responses we want it to take. This can be omitted, and without any specific tone or audience requirement, the model will reply in its usual helpful but flat language.

The rest of the messages should consist of alternating user and assistant content, providing the model with the exchange context. Initially, you can provide one user message to which the model should respond. In subsequent exchanges, you can build up the message array with the history of prompts and responses to provide the model with a context of the exchange so far, allowing the model to relate better to subsequent prompts. By default, the models have no memory of past requests, and all the relevant information must be supplied as part of the message array in each request.

The `model` parameter specifies which instance of LLM we want to access. It's best to refer to the OpenAI models website (<https://platform.openai.com/docs/models/>) for the latest list of available models, as it changes quite frequently. To get started, a good choice would be to experiment with the following:

- `gpt-4`—The latest production version of the GPT 4 model
- `gpt-4o`—A younger, faster, if less thoughtful brother of GPT 4
- `gpt-3.5-turbo`—Still a very good choice, and it can be more cost-effective in some cases
- `dall-e-3`—Optimized for image generation
- `tts-1`—Designed to generate natural-sounding speech from text
- `whisper-1`—Can recognize speech and transcribe it as text

New models are being developed continuously; the preceding list illustrates the breadth of capabilities already available. Obviously, for the models using images or sound as either input or output, more advanced programming techniques will be required to interact with them.

Listing 1.1 used only one of the plethora of other optional parameters: `temperature`. As you can guess, this controls randomness in the model responses. Increasing `temperature` can generate interesting results, but it has a high risk of causing the model to hallucinate. Experimenting with this is very interesting, but please use it

cautiously in production environments. We'll touch more on hallucinations and related risks in chapter 8.

Refer to the latest OpenAI documentation for other up-to-date information and additional parameters.

#### PROGRAMMATIC ACCESS TO OTHER OPENAI API-COMPATIBLE MODELS

Many models are available in the market (over a million models in HuggingFace alone), each with its own interface. However, a lot of them are compatible with OpenAI API de facto standards, such as Meta's Llama models.

To access these models, you can just replace the OpenAI API call code in the previous example.

#### Listing 1.2 Code to direct the client to a specific model, e.g., Llama

The base URL parameter specifies the server hosting the model. Obviously, you'll need to provide a specific API key, such as the Llama API token referenced here, as each provider will require their own user authentication.

Additionally, as you probably noticed, we used the "gpt-4-0125-preview" model in listing 1.1. If you switch to Llama, you'll need to provide a valid model, such as "llama-13b-chat" or one of the other available Llama variants. The rest of the code can remain unchanged most of the time.

#### EXAMPLE OF PROGRAMMATIC ACCESS TO GOOGLE VERTEX AI

A slightly different API worth mentioning is the one defined by Google to access its powerful Gemini AI models, as well as Codey, which is optimized for code generation and completion, and Imagen, designed for image generation, editing, captioning, and visual question answering. Given the power of Google in the market, this API may also be a good contender for a standard in the future.

The quickest way to access these models is through the Cloud Shell (<https://cloud.google.com/shell/docs/launching-cloud-shell>), which is a terminal, or command line, used to access cloud services. Once you activate the shell, you need to install the API.

#### Listing 1.3 Command to install the Google AI package on Google Cloud

Then you can use the following script to generate completions from the selected model.

The preceding code follows a similar flow as the OpenAI example. Apart from the project ID and location, which Google uses to authenticate access to the API, we need to specify which model we want to use. In this case, we chose “gemini-1.0-pro”, the basic text-only model. Google’s API also supports multimodal requests, including sound and images both in the input and response. A range of examples is available on the API web pages. We’d need to specify the “gemini-1.0-pro-vision” model for multimodal requests.

Listing 1.4 also shows how to provide the `temperature` parameter, analogous to the one discussed in the OpenAI example, which is used to control the randomness in the responses.

It’s worth mentioning that Google provides an interface for explicitly setting the safety parameters of the model to block unsafe content, based on a list of defined

blocking thresholds (table 1.1). The safety parameters can limit the model when it comes to generating content containing harassment, hate speech, explicit sexuality, or that may otherwise be dangerous. The full list for the newest Google models is provided on Google's AI website (<https://ai.google.dev/gemini-api/docs/safety-settings>).

**Table 1.1** Blocking thresholds for configuring Google's model safety parameters

Threshold name	Description
BLOCK_NONE	Always show, regardless of the probability of unsafe content.
BLOCK_ONLY_HIGH	Block when there is a high probability of unsafe content.
BLOCK_MEDIUM_AND_ABOVE (default)	Block when there is a medium or high probability of unsafe content.
BLOCK_LOW_AND_ABOVE	Block when there is a low, medium, or high probability of unsafe content.
HARM_BLOCK_THRESHOLD_UNSPECIFIED	The threshold is unspecified, so block using the default threshold.

In listing 1.4, we set very conservative parameters, `safety_config = {...}`, so the model would apply quite stringent filters to the output. This may result in a lower risk while the model is used, but at the cost of returning less useful responses to some prompts. Chapter 8 will offer a broader discussion of model risk considerations.

### 1.3.4 Third-party integrations of generative AI models

In addition to the methods mentioned in previous sections, you may also find a number of generative AI models integrated into various third-party applications and plugins. These integrations typically focus on specific use cases, such as code generation and completion, data visualization, natural language processing, or predictive analytics.

These are some examples of such integrated models:

- GitHub Copilot, designed to assist with code generation, completion, and explanation, with integrations available for the most common integrated development environments (IDEs), such as VSCode, Visual Studio, and the JetBrains suite of IDEs.
- Packages within the RStudio IDE, like *air*, provide integration of LLM models into this popular R and Python environment.

The advantage of such integrations is that they usually have direct access to the data or code inside the host environment and are able to directly insert and modify the code, which saves the user the effort of copying each code snippet from the IDE to the model chat window and back again.



### 1.3.5 Running LLMs locally

Running any downloadable model on your personal computer isn't rocket science. You don't need NASA-grade equipment either; a decent PC with enough RAM should suffice (with a definition of "decent" being somewhat dynamic). A solid GPU would speed things up, but that is not an absolute requirement. You will need some familiarity with the command line and a couple of libraries to bridge the gap between ambition and reality.

Let's look at how we can use Python to connect to the Llama 2 model. Implementing it as advertised on Meta's page is a bit daunting, so we'll cheat a little. First, we'll use a quantized model to save on RAM requirements. In essence, quantization of the model means "shaving off," or rounding, the model weights, sacrificing a little accuracy in exchange for computational efficiency. We'll also utilize models transitioned into an easy-to-use GGUF file format. If you requested and got a proper license from Meta, you can download the Llama of your choice from the HuggingFace portal.

Two libraries we propose to make your task easier are LangChain and llama-cpp-python. Overall, the environment setup is as simple as presented in listings 1.1 and 1.2. It's worth mentioning that LangChain could also be used to streamline connecting to ChatGPT or Gemini as well.

#### Listing 1.5 Command to install the LangChain and Llama libraries

A word of fair warning. The llama-cpp-python library has some non-negotiable requirements, especially when installed in a Windows environment. However, as it's a fast-developing tool, check the library site for the latest details.

Now that we have our model downloaded and the proper libraries installed, all we need to do is send a prompt to a model and capture the result.

#### Listing 1.6 Example of sending a prompt to Llama

And that's it! Depending on your hardware and the chosen model size, you should get your answer in anywhere from a few seconds to a few minutes.

**CONTEXT IS NOT ONLY ABOUT TOKENS** The minimalistic implementation we have presented here does not have any conversation memory. It's a shoot-and-forget method of getting a specific answer to a specific question. Implementing chat memory using LangChain is, however, relatively simple, and you should not be afraid to check the website for current instructions.

Funnily enough, it even has an LLM-powered chatbot to answer your questions about the library.

There are many options for both model instantiation and prompt development, which you may find useful. You'll find detailed instructions on the LangChain library website ([www.langchain.com](http://www.langchain.com)). We will not dig into them deeper, as this simple setup is sufficient for our purposes: asking Llama a question and getting an answer.

### 1.3.6 **Best practices and tips for successful generative AI implementation**

Although this book won't cover advanced topics related to the direct integration of generative AI into applications using APIs, we encourage you to follow some best practices and consider the following tips to successfully integrate generative AIs with your data analytics solutions:

- *Define clear objectives*—Start by clearly identifying the goals and expectations of integrating generative AI into your data analytics solution. Determine the tasks you want generative AI to perform, such as data preprocessing, generating insights, or creating visualizations, and tailor your integration accordingly.
- *Familiarize yourself with the API or SDK you are planning to use*—Thoroughly read and understand the OpenAI API documentation, including details about the API's or SDK's features, limitations, and best practices. This knowledge will help you design efficient and reliable interactions between generative AI and your data analytics tools.
- *Use appropriate data formats*—Ensure that you are using compatible data formats when sending requests to and receiving responses from generative AI. Transform your data, if necessary, to ensure seamless integration and prevent data loss or misinterpretation.
- *Monitor usage and costs*—Keep track of your API usage to prevent unexpected costs, especially when working with large datasets or complex analytics tasks. Implement rate limiting, caching, or other optimizations to manage your API calls and stay within your plan's limits.
- *Handle errors and timeouts*—Implement proper error handling and retry mechanisms to deal with potential issues, such as timeouts or rate-limit errors. This will help ensure the stability and reliability of your integration.
- *Simplify and optimize your prompts*—Craft your prompts carefully to obtain the most accurate and relevant results from generative AI. Use clear, concise language, and provide enough context to help the AI understand your requirements. You may need to experiment with different prompt structures to find the best approach for your specific use case.
- *Maintain the prompt cheatsheet after optimizing (and verifying the output)*—Regularly update and refine your prompt notes as you continue to work with generative

AI. As your application evolves and your understanding of AI capabilities deepens, your cheatsheet should evolve to include new findings, common errors to avoid, and updated best practices.

- *Provide source material and context*—Alongside the problem or question, give the model context data examples or explicitly ask it to follow a certain reasoning path. You can also suggest steps in the prompt for the model to follow in its reasoning or ask it to explain certain solution steps. All of this will ensure a greater probability of a correct response and increased transparency regarding how it was generated.
- *Evaluate the AI's output*—Generative AI's output may not always be accurate or relevant. Always double-check the results provided by the AI, and consider implementing human review or validation processes, especially for critical or high-stakes decisions.
- *Test and iterate*—Before fully integrating generative AI into your data analytics solution, thoroughly test its performance with various tasks and datasets. This will help you identify any issues, limitations, or inaccuracies. Continuously iterate on your prompts, data formats, and integration methods to improve the overall effectiveness of the AI in your analytics workflows.
- *Ensure data security and privacy*—When working with sensitive data, make sure you comply with data protection regulations and follow security best practices. If you're working with cloud-based generative AI, encrypt data when transmitting it to and from the provider, and consider using data anonymization techniques to protect the privacy of your users.
- *Stay updated on generative AI developments*—Keep track of updates and new features developed in the field, as these may impact your integration or offer additional capabilities. Regularly review the API documentation, and subscribe to relevant newsletters or forums to stay informed about any changes or improvements to generative AI.
- *Leverage community resources*—Take advantage of resources provided by the AI community, such as sample code, tutorials, and forums. These resources can help you learn from others' experiences and discover best practices for integrating generative AIs with various data analytics solutions.

By following these best practices and tips, you can successfully integrate generative AI into your data analytics workflows and harness its full potential to enhance your decision-making, automate tasks, and uncover valuable insights.


Hopefully, after this introduction, generative AI no longer appears to be a mysterious and, possibly, useless invention. Subsequent chapters will demonstrate specific exchanges between a human and a generative AI and will show us using the responses in all aspects of data analytical work. We'll also comment on the shortcomings and pitfalls that need to be looked out for to make this cooperation between humans and AI as painless and productive as possible.

# *Using generative AI to ensure sufficient data quality*

---

## ***This chapter covers***

In MS Excel, you can calculate the trend line and standard deviation of a sample on the basis of just two data points. Clearly, such “data analysis” is meaningless. This chapter will help you focus your efforts on things you *should* do with data, rather than just expand on what you *can* do with it. It explains the necessary background for any analysis you may wish to perform. You will learn about best practices and non-negotiable rules, ensuring that your conclusions are related to the business activities you’re analyzing, rather than to flaws in the underlying data.

You’ll develop a structured approach to quality assessment and assurance, you’ll purge your data of artifacts, you’ll identify the blind spots, and you’ll learn to think

about the benefits and risks of guesstimating missing pieces. Finally, you'll learn to look at the collected data from a new perspective—the perspective of its usefulness for the process of analysis.

## 2.1 On a whimsey of fortune

Imagine you bet your business future on the flip of a coin. Let's say you bet on tails. You threw the coin and, fortunately, got tails. Do you think it would be a good idea to do this again? And again? We most assuredly hope not. The fact that you once got the tails you bet on doesn't mean that you will get tails again next time.

In classical logic, conclusions drawn from false assumptions can be either true or false. It's crucial to understand that you really can draw a *true conclusion* from a *false assumption*. We will call such a conclusion an *unreliable* one. It doesn't mean you'll be right the next time you follow that false assumption.

Coming back to our example, let's say you weigh a coin in your hand and say to yourself, "I'm going to flip this coin. If I get tails, I'll have more customers next month than I did this month." You throw your coin, get tails, and have more customers next month. Was the assumption that the coin has a predictive power related to the success of your business true? Probably not. We could get into psychology, the influence of self-belief on success, and so on, but even then, it's not the coin that brought your customers. It was your self-belief and hard work. Or perhaps luck. Or weather. Or a smart marketing strategy. Or your main competitor's mishap. Or . . . you get the idea. Nevertheless, if you believe in the predictive power of the coin, you'd draw true conclusions from a false assumption.

Similarly, business analytics performed on false assumptions (false input data) may result in true or false conclusions. Poor quality input data leads to *unreliable* results regardless of the sophistication of the analysis, with the critical word here being *unreliable*.

Let's assume you risked performing an analysis on poor data, and it returned "good" results. You bet on tails and got more customers next month. It doesn't sanctify the approach. Yes, it happens, but it doesn't mean your results will be good next time. Like flipping the coin, you will get heads or tails, and your next analysis will yet again yield *unreliable* results.

In data analytics, this concept is often referred to as "garbage in, garbage out." You now know that "garbage out" doesn't mean *inaccurate* results. It's much, much more dangerous. It means *unreliable* results. You bet 10 bucks on a flip? How about 100? Did you succeed again? How about a car or a house?

On the other hand, if you throw the coin multiple times and get your expected tails each time, the coin may not be random after all. Perhaps the quality of your data and, therefore, the following analysis is *sufficient* for your purpose.

*Reliability* of results depends heavily on the quality of the input data. In many cases, we try to avoid being too absolute about the advice we give, as there is often more than one way of solving any given problem. However, if your analysis is to be used in any

decision-making process, you simply cannot accept anything less but the best *possible* quality of available data. We emphasized the word *possible* for a reason. In most real-world scenarios, you will not have the luxury of working with the quality of data you'd want. But all the compromises you make here must be conscious and taken into account when evaluating the *reliability* of the final result.

Unfortunately, despite some marketing claims, there is no one-size-fits-all solution ensuring data quality. The most effective way to prepare for analysis is to closely examine the data and carefully consider the meaning of each variable within the specific context of your business. There may not be any way to entirely automate this task, but there are techniques and protocols that can help you approach data evaluation and cleaning in a structured and systematic manner.

## 2.2 A note on best practices

Let's clean our data, then! Take the first data file you have on your desktop or in your project repository, and open it. Is it "clean"? (And if you do actually keep data files on the desktop, have a hearty chat with the generative AI of your choice about data management and governance.)

**TRUST, BUT VERIFY** If you got your data from someone who told you that it is "clean," ask yourself a question—do you trust this person's data skills and (not "or"; specifically "and"! ) diligence enough to hinge the success of your business on their opinion about what it means that data is "clean"? Even if you do trust them, control is the highest form of trust in the data world: better safe than sorry, look before you leap, and so on.

If you're uncertain about whether your data is clean, we're on a good path. Several aspects must be checked before you deem your data clean enough to be analyzed:

- *Relevance*—The data should be pertinent to the specific business question or problem being addressed. Irrelevant data can lead to confusion and detract from the focus of the analysis.
- *Accuracy*—The data should be correct, error-free, and consistent with the real-world objects or events it represents.
- *Completeness*—All *required* data points should be present. Any missing or incomplete information should be identified and addressed. At the same time, spurious data should be avoided to maintain clarity.
- *Timeliness*—Data should be up-to-date and relevant to the analyzed period. Outdated data can result in misleading or irrelevant insights.
- *Uniqueness*—Duplicate data should be identified and eliminated to prevent redundancies and inaccuracies in the analysis.
- *Consistency*—Data should be consistent across different sources, formats, and systems. Inconsistencies can lead to incorrect conclusions or insights.
- *Integrity*—The relationships between data elements should be maintained, ensuring the data is coherent and meaningful when analyzed.

It looks like a lot of work because it is. You want to be sure that your data *adequately describes the slice of reality* you're analyzing (first four points) and that its *structure allows for reliable analysis* (last three points).

**SLOW IS SMOOTH, AND SMOOTH IS FAST** Data quality is not a place to skate on thin ice. You need to get used to doing things systematically. A lot of data specialists claim that at least 80% of data work is related to data cleaning and preparation, and these are rather slow processes. Unfortunately, you may be pressed to omit it, due to a very unpleasant feedback loop. Businesses do not see the value of analysis, so they demand more of it. The more they demand, the higher the time pressure. The higher the time pressure, the more corners that are cut (usually in areas that do not get into final reports and thus are invisible or useless from the perspective of the business sponsors). The more corners that are cut, the less reliable the analysis. The less reliable the analytics, the lower the subsequent value of said analytics. The lower the value of the analytics . . . Doing things right from the start will reduce the bumps and hiccups on your analytical journey, caused by your stakeholders coming back to you, requesting repeat analyses better aligned to the reality they observe.

Ensuring data quality can be daunting—there is no silver bullet, and cutting corners can lead to unreliable data (and therefore unreliable results). But there is still hope: a good structure can guide you through this process in a finite amount of time. Knowing what to look for, and when, can help you discover the quality issues and estimate their impact on the final analysis.

## 2.3 Getting started

Do you still have your data file open? Yes, the one from your desktop. No? Open it. Have a look at it. Scroll it up and down, and if needed, left and right. Try to get to know your data.

Do you think you look silly? Not as silly as you'll look trying to explain why you added the sales volume to the physical product volume (yes, we've seen it). In an ideal world, you'd have richly described metadata explaining all the columns down to the expected decimal places and the name of the person who wrote the script that parses texts scraped from the web (if applicable). But most probably, you won't. You'll get the file with "address", "time", and "sales" columns, and it will be up to you to decipher whether the addresses are of customers or brick-and-mortar shop locations; whether the sales are in USD, EUR, or metric tons; and whether the time is the time of order or purchase, or perhaps a test column left by developers.

We will repeat this again. If you work in business and are not absolutely, positively sure about the exact meaning of the variables received from your IT department, don't assume. Ask! We happened to analyze the efficiency of a service sending tens of millions of messages to the clients of a multinational company. We discovered an anomaly that would occur very rarely, where the ratio of opened-to-received messages was higher than one. Trying to understand what was *actually* defined as a received message and what was *actually* defined as an open message, we discovered that the error in



the logging system was so deep that all the previous analytics on the efficiency of messaging were worthless! We cannot overemphasize the importance of close collaboration between the business and data or IT crowds.

From clay tablets to AI, tools change, but the mess in the data doesn't. What did change with the introduction of generative AI is your access to expert knowledge, which may save you a lot of time. It won't replace your experience and responsibility for understanding your data, but it may help you get to know it much quicker.

If you have read the available metadata, there are still a couple of steps you should take to make this initial inspection a part of a structured analytical approach. What steps? We could tell you, but this book wouldn't be about generative AI then, would it?

We want you to accept that your AI advisor is infinitely patient and perfectly non-judgmental. There is no question too simple to ask. "What was the name of this curve . . . you know, this looking like the hill? How do I plot two columns from a DataFrame?" Honestly, searching one's own memory is sometimes more time consuming than dropping a quick question and running the provided code.

We also want you to forget about "prompt engineering." It has its place, and some models, such as smaller Llama versions, are incredibly vulnerable to prompt structure. Changing a single word to a synonym can sometimes drastically change the model's understanding of the prompt. We assume, however, that you will use a generative AI that understands the linguistic context sufficiently to not require more work on prompt engineering than it would take to find relevant information about actual analytics elsewhere.

**NOTE** As mentioned in the "about this book" section (before chapter 1), we mainly use the Python environment to process example datasets. Chapter 7 will guide you through using generative AI to adapt the code to your environment if needed.

Let's see how generative AI (in this case, ChatGPT 4) deals with a plain language question to the effect of "I'm lost and need guidance."



I want to perform data analysis. I imported my data into pandas DataFrames. What is the first thing I should do with it?



After importing your data into pandas DataFrames, the first thing you should do is to explore and understand your data. You can start by performing the following steps:

- 1 Inspect the first few rows of the DataFrame:

Use the `head()` method to display the first few rows of the DataFrame. This will give you a quick overview of the data structure, column names, and the type of data contained within each column.

- 2 Check the shape of the DataFrame:

Once you have a better understanding of your data, you can proceed with data cleaning, preprocessing, and analysis. This may involve handling missing values, encoding categorical variables, feature engineering, and other tasks based on the specific requirements of your analysis.

In its first sentence, our AI advisor agreed with the importance of *understanding* your data. A careful read of the rest of the model's answer may reveal some less impressive components. Some steps seem redundant. For example, the `df.isna().sum()` method does not offer any information not previously provided by `df.info()` (which, in fact, also includes information returned by `df.shape`).

**YOU NEED TO DECIDE ON YOUR PRIORITIES** Efficiency versus readability is just one of the choices you'll have to make when choosing the methods you'll be using to reach your goals. Generative AI, when inquired, can often present you with the benefits and weaknesses of different methods. Still, you need to be conscious of these choices and sometimes explicitly request a specific method or solution, prioritizing one characteristic over the other.

Nevertheless, the overall answer is very good. Like the old carpenter's adage says, it's better to measure twice. We appreciate that ChatGPT errs on the side of redundancy. Provided with a wide enough toolset, you'll soon be able to select the tools that best suit your analysis style. Equipped with insufficient tools, you may stay in the dark.

In summary, you want to check the following:

- 1 The overall "look" of the data.
- 2 The size of the tables.

- 3 The types of variables in each column. The quick check should reveal whether there are mismatched data types, such as text strings in place of numerical values or vice versa.
- 4 For numerical columns, the basic statistics, count, mean, extreme values, etc.
- 5 The number of missing values in each column. A note of a warning here: some data is inherently sparse. Simply counting the missing values in the column will not provide a definite answer on data completeness; however, if you combine it with the knowledge of data meaning, it should.
- 6 The number of unique values in each column.

This should give you a good intuition about the data you're working with.

Let's load our example data so we have something to analyze: the Brazilian e-commerce public dataset by Olist ([www.kaggle.com/datasets/olistbr/brazilian-ecommerce](https://www.kaggle.com/datasets/olistbr/brazilian-ecommerce)). As we mentioned in the preface, you'll need to use a free Kaggle account. The following listing shows the code we used to load our data. (All the code required to perform the analytics we present is available in our GitHub repository, [https://github.com/mariansiwiak/Generative\\_AI\\_for\\_Data\\_Analytics](https://github.com/mariansiwiak/Generative_AI_for_Data_Analytics).)

As the next step, we'll look at the properties of the DataFrames in listing 2.1. Unfortunately, that means running all of the commands proposed by our generative AI advisor for all downloaded datasets. That's a habit you should develop for every bit of data you import.

Did you just stop reading and run all the tests on all the DataFrames? Let's try to induce in you a healthy dose of paranoia. We'll share some alarming findings to show you how looking at data summaries can point you to potential problems. We'll also work on identifying the solutions.

We found two interesting points while we waded through the data structures in our example data:


- The number of customers in the `df_customers` DataFrame and the number of orders in the `df_orders` DataFrame are identical. There are two possibilities. One is that each customer, as identified by the system, made one and only one


purchase, and the second is that we have been provided with an incomplete set of data. Both possibilities have far-reaching implications related to further analytics. (The number of 99,441 rows has arbitrarily been set by whoever generated this dataset for us. In this case, reading the metadata on a dataset would tell us this, but let's assume it's not available.)

- The `df_customers` DataFrame contains two suspiciously similar columns: `customer_id` and `customer_unique_id`. As we will probably want to analyze customer properties in other DataFrames, the column that will allow us to connect them is `customer_id`. As such, this column is of great importance, so we should stop and ask if `customer_id` is indeed a unique identification for customers.

As we mentioned and will keep mentioning, it's of utmost importance not to wave away anything that doesn't look right! You could send an email with questions to whoever provided you with the data and, depending on their workload, get the answer within minutes or months.

If you're not fluent enough in the available analytical environment, fret not! As long as you know what you want to do, you have a generative AI advisor to help you determine how.

 I have a pandas DataFrame with `customer_id` and `order_id` columns. How can I quickly check if every customer made just one order or if there are customers who made more than one order?

 You can quickly check if every customer made just one order or if there are customers who made more than one order by using the `value_counts()` method on the '`customer_id`' column and then checking the maximum count. Here's an example:

In this example, `df['customer_id'].value_counts()` returns a pandas Series containing the number of orders for each unique '`customer_id`'. If the maximum value in this Series is greater than 1, it means that at least one customer has made more than one order.

Generative AI understood what we wanted to achieve and proposed code we could adapt to our needs, replacing just the name of the DataFrame to be tested with `df_orders`, as we defined it when loading our datasets.

You can check the results in the files we placed in the repository. It shows that either we got the data from the online platform with the lowest customer retention rate in existence (one visit per user) or there is a problem with the `customer_id` column in the `df_orders` DataFrame.

We previously noted that the `customer_id` column in `df_customers` DataFrame is accompanied by a `customer_unique_id` column, which seems redundant if the `customer_id` column was constructed correctly. The following conversation will show you that working with generative AI is indeed different from using any other software you have ever encountered. All you need to do is provide a plain language explanation of the problem you need to solve.

 In my DataFrame containing customers' data, I have two columns: `customer_id` and `customer_unique_id`. How can I check how one relates to the other and which one contains actual identifiers?

 To check how the `customer_id` and `customer_unique_id` columns relate to each other and which one contains actual identifiers, you can analyze the uniqueness of the values in each column and their relationship. Here's an example of how you can do this using pandas:

In this example, `df['customer_id'].nunique()` and `df['customer_unique_id'].nunique()` return the number of unique values in each column. Comparing these numbers can give you an idea of which column is more likely to contain actual identifiers.

Next, `df.groupby('customer_unique_id')['customer_id'].nunique()` groups the DataFrame by the `customer_unique_id` column and computes the number of

unique `customer_id` values for each group. This will help you understand the relationship between the two columns.

Based on the results, you can determine which column contains actual identifiers and how they are related. For example, if `customer_unique_id` has fewer unique values and each `customer_unique_id` maps to multiple `customer_id` values, it may indicate that `customer_unique_id` is the actual identifier, and `customer_id` represents multiple records or transactions for each unique customer.

That's an interesting response, mainly because it doesn't suggest that the answer will be definitive! There is even a possibility that none of these columns are valid identifiers (see, this is how you get paranoia in this line of work). That point is essential. Don't assume anything about data you received from an uncertain source, even if you firmly believe and logic dictates that some values mean one thing or another. In nine out of ten cases, it will be what you expect, but in that tenth case, you'll thank us after reaching out to the data source and learning what this or that variable *actually* means.

Returning to our analysis, the resulting `relationship` Series is too big to analyze manually. This is another important lesson about working with generative AI. Do not settle for the answers if the result is unsatisfactory. Complain!



With my data, the `relationship` Series produced by your previous code is too long to check manually. Can you propose a method to analyze its contents?



Sure! You can analyze the `relationship` Series by generating a summary of its contents, such as the minimum, maximum, mean, and count of unique `customer_id` values per `customer_unique_id`. Here's an example of how you can do this:

This summary will give you a better understanding of the relationship between the two columns without having to manually check the entire `relationship` Series.

After we run the code suggested by our generative AI advisor, the results are indeed easier to digest:

It looks like `customer_id` values uniquely identify *records* in the dataset rather than uniquely identifying *customers*. Therefore, `customer_unique_id` is more likely to serve as a customer identifier. In the actual business environment, our next step would be to check with the IT or other relevant departments whether over 93% of our clients really make only a single order in their lifetime, or whether this is indeed a data quality issue. For now, we'll take the data at face value and continue our analysis.

The key takeaway here is that generative AI can help us choose suitable analytical methods. Still, it is up to us to ask the right questions and *understand the meaning of the data* in the context of our business domain.

## 2.4 Quality assessment structure

We should now know what information is encoded in the data at hand, and we should have an overview of its completeness.

We mentioned previously that you will need a structured approach to ensure sufficient data quality. In the introduction to this chapter, we also emphasized that even “successful” results from an analysis do not ensure the repeatability of this success. The following sections on data cleaning and exploratory data analysis present the

main elements of such a quality assessment. This should give you a solid foundation upon which you can build a structure fit for your use case.

### **2.4.1** *Data cleaning steps*

You can compare data cleaning to preparing ingredients before cooking a meal. We strongly advise against dropping the contents of your fridge directly into a cooking pot. A good chef inspects ingredients to remove any spoiled parts, washes them to ensure cleanliness, and chops them to uniform sizes for even cooking. Similarly, data cleaning involves inspecting the dataset for inaccuracies or inconsistencies, removing or correcting these elements, and ensuring the data is in a uniform format. This preparatory step is essential to ensure that the final dish (or analytical result) is of high quality and free from elements that could compromise its taste (or integrity). We've emphasized multiple times that analyzing unclean data can lead to unreliable conclusions. The comparison with cooking serves this point. By cooking with unprepared ingredients, you can get something edible; we just wouldn't advise this approach when you're cooking to impress your date.

To ensure your data is technically clean, you should do the following:

- 1 Remove duplicates.
- 2 Handle missing values.
- 3 Correct data entry errors.
- 4 Validate the data.

These steps should ensure that your tables contain data points describing business processes rather than artifacts from the data collection and preparation processes. The next phase should give you a better understanding of the data's meaning.

### **2.4.2** *Exploratory data analysis elements*

By now, your data, or dish ingredients, are filtered and cleaned. Continuing with the cooking analogy, exploratory data analysis (EDA) can be compared to tasting and seasoning the ingredients. Is your tomato fresh and sun-ripened, or did it travel half the world in a freezer and is still so hard that you could play baseball with it? Does your variable have the normal distribution required by many algorithms, or is it skewed? Just as you would taste the dish at different stages, adjusting spices and ingredients to balance flavors and textures, EDA examines the dataset through various analytical and visualization techniques to understand its characteristics, trends, and outliers. This process allows you to adjust your analysis approach, like seasoning, to ensure the outcome is well-balanced and palatable. EDA is about getting a feel for the "flavor profile" of the data, identifying which ingredients (variables) play well together, anticipating how the final dish (analysis) might turn out, and making adjustments as needed for the best possible result.

The basic EDA structure you should employ for all data you lay your hands on could look like this:



- 1 *Variables distribution testing*—What are the characteristics of the data samples, such as mean, standard deviation, range, and so on?
- 2 *Variables visualization*—What can you read from visual representations of the data?
- 3 *Data meaning clarification*—Does the data represent what you think it does?
- 4 *Data mapping and harmonization*—Are all the data points sampled using the same units, and do the headings use standardized description vocabulary?

Some people add extra steps to EDA, like correlation testing or text analysis. Others also add feature engineering. Depending on your data, their approach may be more suitable to your needs.

### One way from Sunday

We do not think a one-size-fits-all, silver-bullet, cure-all data preparation protocol exists. The general framework we believe will lead to high quality data is as follows:

- Understand the relation of your data with reality (what each variable means and how it was generated).
- Ensure the data meets some basic technical standards (that you are working on all available *relevant* data points and can cross-relate them between data sources if needed).
- Before you analyze reality using your data, analyze the data itself (ensure it adheres to either expertise- or common-sense-based expectations).

In the following sections, we will walk through an example and ensure the data describes phenomena rooted in reality.

## 2.5 Data cleaning

Data cleaning must be done as early as possible, as errors resulting from poor data representation, consistency, or integrity are persistent and stack up quickly. Unclean data can misguide other data preparation and evaluation steps as well as your analytics results.

Let us repeat: We don't believe there is one best way of cleaning data or performing EDA. In your work, you may encounter data cleaning protocols, including steps we describe as a part of EDA, and vice versa. You may be given a protocol that includes steps we consider analysis. If specialists in their field prepared these protocols, there is a chance they are better for the data types they are designed for. Be flexible. Just make sure you understand what's happening.

**ORDER MATTERS** Some cleaning steps may obfuscate errors, especially in preparatory work. It is of great importance to understand how things change after each step. For example, if you fill missing data with average values from a certain column, you cannot do this before removing duplicates.

We'll assume the worst-case scenario for this exercise. That's the scenario where you're unsure what to expect from your data.

### 2.5.1 Removing duplicates

There are many ways duplicate records can sneak into your data. From data entry mistakes (human errors) and system glitches (software errors) to poorly designed identifiers (human error), to synchronization problems in distributed systems (software error), to errors in merging datasets, to import issues . . . the list goes on. With so many things that can go wrong, some of them most likely will. In all honesty, we're still waiting to see a duplicate-free dataset that was not previously curated for sharing.

How do you efficiently eliminate duplicate records to avoid overrepresenting certain data points, which could skew the analysis results? It depends on your analytical environment. Do you need to memorize details? Most certainly not!



How can I remove duplicate entries from a DataFrame?



To remove duplicate entries from a DataFrame, you can use the `drop_duplicates()` method. By default, it considers all columns when identifying duplicates and keeps the first occurrence of a duplicate row. Here's an example:

```
import pandas as pd

# Sample DataFrame with duplicate rows
data = {'A': [1, 2, 2, 4, 5, 1],
        'B': [6, 7, 7, 9, 10, 6]}

df = pd.DataFrame(data)

# Remove duplicate rows

If you want to remove duplicates based on a specific set of columns, you can use the `subset` parameter:

In this example, `df.drop_duplicates(subset=['A'])` removes duplicate rows based on the values in column A while keeping the first occurrence of each duplicate.

This answer is technically correct and, under regular circumstances, sufficient.

**EFFICIENCY MAY NOT BE THE TOP PRIORITY, OR IT MAY** Depending on your generative AI's specifics, it may consider the answer's simplicity rather than the resource-effectiveness of the solution. Quoting Grace Hopper, *it's a feature, not a bug*. Chapter 5 describes methods for using even general-knowledge generative AIs to optimize code.

In our case, the answer is sufficient (as we didn't have any duplicates in the first place), so we can triumphantly tick this box and move on to the next step.

### 2.5.2 Handling missing values

We will repeat the warning we issued earlier: some data *is* sparse. However, a list of the possible causes for missing data entries would be at least as long as the one for duplicates. Data entry errors, sensor malfunctions, copying errors, integration errors, you name it. Finally, there is the unavailability of information.

Depending on the context and the amount of missing data, you can choose to either delete the incomplete data entry or variable (the row or column in tabular formats), ignore it, or somehow fill in missing values. You could fill empty fields with a default value, an estimate (such as a mean, median, or mode), or use interpolation methods. It's critical, however, to make these decisions consciously, depending on the meaning and importance of the data. Recently there was a case of a renowned macro-economist filling missing data for some countries by copying them from adjacent cells. In that case, the dataset was sorted alphabetically by country names, which caused this method to make completely nonsensical adjustments.

It is paramount that the decision on what to do about missing values is based on understanding why the value is missing. Was it, for example, a sensor system error causing a missed measurement? Or was it an error in the system writing down the results? Was there an error when multiple data sources were connected together? To decide what to do with the missing values, you should first have a look at the data.

In our example data, we should notice three DataFrames where the number of non-null values differs from the number of rows in some columns (meaning it's not just an empty column). These are `df_orders`, `df_order_reviews`, and `df_products`.

In the `df_orders` DataFrame, we noticed that some approval and delivery dates are missing. We'll use this DataFrame in section 2.6 to analyze the underlying process described by the data and the relation of the order status with the missing dates.

In the case of `df_products`, we are missing some category names, the same number of product names, description lengths, and pictures, and some product size data. Let's see if we can say anything by looking at the products where some of the values are missing.

There are 611 rows where some of the data is missing. This would be a chore to analyze and address manually, and if we were dealing with 6,111 or 61,111 rows, it would become unfeasible. What can we do to automate the process somewhat? Let's start with investigating whether the number of missing values in different columns is coincidental or if there is some structure to it.

There is a lesson here about working with generative AI. If you have any doubts about your data but are unsure how to voice them precisely, don't. We mean, don't voice them *precisely*. Simply voice them as best you can.



In my DataFrame, I have missing values. It looks like the number of missing values in some columns is correlated. How can I check if the missing values form a pattern?



You can check if the missing values form a pattern by analyzing the co-occurrence of missing values across different columns. To do this, you can use pandas to create a DataFrame indicating which values are missing and then compute the correlation between these binary indicators. Here's an example:

In this example, `df.isna()` returns a DataFrame of the same shape as `df`, where each element is a boolean value indicating if the corresponding element in `df` is missing (True) or not (False).

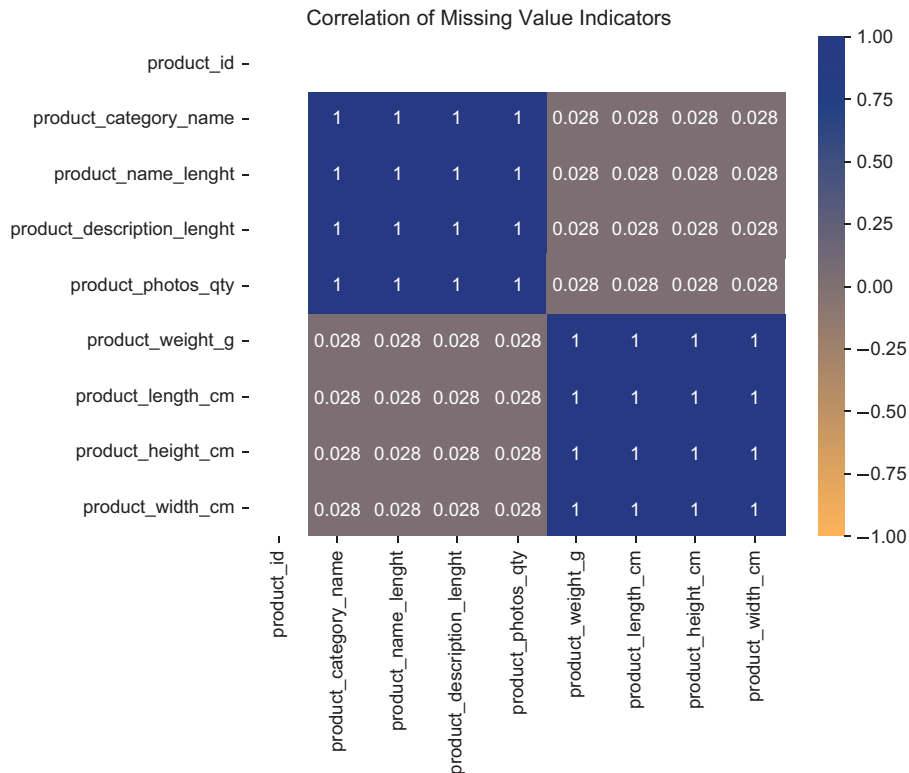
`missing_indicator.corr()` computes the pairwise correlation between the columns of the missing value indicators. The resulting correlation matrix represents the correlation between the missing values across different columns. High positive correlation values indicate that the missing values in the corresponding columns tend to co-occur.

Finally, the correlation matrix is visualized using a heatmap from the Seaborn library. This heatmap can help you quickly identify patterns in missing values, such as whether missing values in certain columns tend to coincide with missing values in other columns.

This time, we got some really heavy artillery, including visualization libraries. Skillful visualization is one of the most important skills in data analysis, and you shouldn't be shy about leaning on your generative AI advisor to provide you with the tools you need.

**A PICTURE IS WORTH A THOUSAND WORDS** If you'd like to learn more about the importance of proper visualization for statistical analysis, we can't recommend timeless books by Professor Edward Tufte enough. His *Visual Explanations: Images and Quantities, Evidence and Narrative* (Graphics Press, 1997) and *The Visual Display of Quantitative Information* (Graphics Press, 1997) are technology-agnostic bibles of excellent visual communication.

Figure 2.1 shows the results of one of the analyses proposed by generative AI. While there are many types of analysis that can be performed, most of the steps would be similar, so we'll just use this one as an example.



**Figure 2.1** The correlation between missing values in different columns

We can see that some products have missing values in all of the `product_category_name`, `product_name_lenght`, and `product_photos_qty` columns, or in all of the `product_weight_g`, `product_length_cm`, `product_height_cm`, and `product_width_cm` columns. This means that some products could either be weightless and dimensionless (services, perhaps?) or they don't have any category, product name, or photos (a mystery box comes to mind).

**NOTE** The typo in the variable name `product_name_lenght` is preserved here to conform to the naming in the original dataset.

When we looked for rows in the dataset where every column except for the `product_id` was empty, we found just one: `product_id 5eb564652db742ff8f28759cd8d2652a`. As we discussed earlier, before deciding whether to remove or keep such an item, we should check the business or data collection process behind such an oddity.

Fraud detection and forensic analysis are outside the scope of this book, but following our attempt to instill in you a bit of professional paranoia, we can't completely ignore the fact that this case begs for an investigation. If we were to investigate such a case, we would first check the simplest explanation: someone was playing with the database and didn't clean up after themselves. In such a case, this `product_id` should be present only in this single table. The `product_id` in question, however, seems to be connected to an order. If possible, we'd try to find the product's website and see if it is a service (unlikely, as there is just one such case). If we felt especially inquisitive, we'd move to check this seller's other transactions, particularly with the same buyer. In short, we would try to understand the actual event and the expected shape of the data describing it. From there, we would try to identify how the error could occur in the data (if it is, in fact, an error instead of a non-typical but a legitimate situation).

Unfortunately, we now need to take off our Sherlock Holmes caps and get back to dealing with a much more prevalent, if not so exciting, category of problem.

### 2.5.3 Correcting data entry errors

Is “Washington” the same thing as “Washington D.C.”? Or did an employee who was saving their precious time by typing just “SD” have in mind “Shipment Delayed” or “Standard Delivery”? You'll encounter multiple data entry error types in your work, such as typos, mislabeling, or inconsistent formats, all of which negatively affect the dataset's quality. You need to identify and correct these errors to ensure accurate and consistent data.

This is one of the most strenuous and least automatable parts of data preparation. Unfortunately, the best tool you can use to search for such errors is biological rather than digital. As of the time we're writing this book, nothing beats a good old-fashioned eyeball. Some of the methods described in section 2.1 can help identify the oddities. For example, `df['column_name'].value_counts()` can help you spot values that occur only once, which may be suspicious if you expect uniform distribution. However, detecting and correcting data entry errors requires a combination of these techniques, along with domain knowledge and manual inspection.

The specific type of data entry error analysis we want to point out is outlier detection and treatment. *Outliers* are data points that deviate significantly from the rest of the dataset (for example, when almost all transactions in a set are from NY, and suddenly one is from LA). Identifying and handling outliers is very important, as they can disproportionately impact the analysis results. Alternatively, they can indicate data points of extreme importance. Outliers can be accepted, removed, capped, or transformed, depending on the context.

### 2.5.4 Data validation

You'd really rather not find entries like "last Tuesday, around noon" or "it was a beautiful spring morning" in the date column of your table. Validating the data ensures that the data adheres to specific rules or constraints, such as data types, value ranges, or relationships between columns. This is crucial for maintaining data integrity and avoiding inconsistencies that could lead to erroneous conclusions.

If this seems like a lot of work, that's because it is. The good news is that this is yet another opportunity for you to get intimately familiar with analyzed data, and that's something you can't fake.

These are the four steps for validating your data:

- 1 Define expected values for your data.
- 2 Check if any bits of data fall outside your expectations.
- 3 If any do, do something about it.
- 4 Check the consistency of the data coming from multiple tables.

The specifics of what values are expected will vary, depending on your dataset. There are no universal rules for determining expected versus unexpected values; that's where your domain knowledge kicks in. You must remember, however, that data points deviating from expectations might signal either errors in data collection (worth investigating) or events of significant importance to your business (definitely worth investigating). To give you a starting point, we'll outline three basic areas you should consider when validating your data.

#### UPFRONT VALIDATION RULES AND CONSTRAINTS DEFINITION

We mentioned that the whole analytical protocol should be defined before running an analysis, to avoid having to "tweak" the analysis to fit expectations better.

Validation rules and constraints, indeed, *must* be defined upfront. If you scrolled through the files, as we advised you to do at the beginning of section 2.3, you should have a more or less solid intuition about the structure and distribution of variables in your data. You should also study your domain and related data enough to know what values are typical and expected. Suppose you don't know the exact acceptable border values for your variables. In that case, you should be able to state your expectations in terms of deviations from the mean, percentiles, cicada chirps, horse's lengths, or whatever applies to your data.

Now, let's get off our high horse for a minute. Data quality assurance *is* an iterative process. We will perform an EDA, and we may learn that some of the assumptions we made after our initial analysis were not sufficiently grounded and that our intuition led us astray. In that case, we'll go back and correct our validation rules to better discriminate between valuable data and potential artifacts.

#### DATA TYPES

Assigning correct data types to your variables will make your life much easier down the line, as many libraries make operations on columns with well defined types (especially numerical ones) easy and efficient. In general, if you want to perform an operation

like 111-11, you'd like to get 100, not 1 or a system error (where, as we will repeat throughout this book, the latter would be preferable).

When looking at the properties of our example DataFrames revealed by `df_name.dtypes`, or by calling the `df_name.info()` method, you should notice that pandas successfully derived the types of numerical columns. However, it assigned general *object* types to columns containing dates.

Time representation in programming is far from straightforward. There are myriad methods and formats for noting something as seemingly simple as a timestamp, reflecting the complexity of time zones, calendar systems, and coding standards. In Python, there is no singular “date” type due to these complexities. Instead, for our datasets, we have found that the most suitable format is `datetime64ns`, which offers a precise timestamp down to the nanosecond:

Analyzing methods for reading different time formats from text may be beyond the scope of this book, but it's surely not beyond the scope of knowledge of your GenAI advisor! When in doubt, provide an example of your data, and ask the generative AI how to transform it into the format you'll be using in your pipeline.

### RELATIONSHIPS BETWEEN COLUMNS

We mentioned that we'd seen sales volumes added to physical volumes. How do you think that happened? This point is critical if you work with multiple DataFrames from different data sources. Blind trust that identical column names mean that the two columns describe the same thing may very easily deprive your analysis of any functional value.

Before you start coding (or copying) a cross-reference function, you should have a good understanding of which of your DataFrames will serve as the reference—the source of so-called *primary keys*—and which DataFrames will have *foreign keys*—meaning the values reference existing primary keys. This way, you'll create a lineage of DataFrames.

If you have a DataFrame containing the data on all your customers, their identifiers become primary keys. Suppose you have another DataFrame describing orders from some range of time, and it has information on which customer made an order; all these customers' identifiers will exist in the DataFrame of customers. However, there is a possibility that some of the customers in the reference dataset didn't order anything in the timeframe in question, so they don't need to all be in the orders DataFrame.

You can use the following code to identify problems with keys within `df_orders` and `df_order_payments`.

In the course of our work with this example dataset, we’ve already discovered that there is a problem with `customer_id`, so the relation between `df_orders` and `df_customers` here is unexpectedly 1:1, but when checking `df_orders` against `df_order_payments`, we can see the expected behavior of `order_id` being a primary key in `df_orders` and a foreign key in `df_order_payments`. There is one violation, but we’ll leave dealing with it as an exercise for you.

Yet again, there is an issue of causality, which you should identify as an analyst. By that, we mean identifying the actual cause of an unexpected data structure. Any explanation you can come up with should be confirmed with the data creators. Of course, sometimes, your ability to confirm things may be limited, and you may need to rely on cross-referencing all the DataFrames and checking if there is a logical pattern in identifier columns. Still, in cases where you work without 100% certainty on the data’s meaning, you should clearly communicate to your stakeholders the risk of analysis being performed on an unconfirmed dataset.

We now should have our data adequately cleaned. By performing a thorough data cleaning, you increase the likelihood of obtaining reliable and accurate insights from your data analysis. A clean dataset serves as a strong foundation for the subsequent stages of data preprocessing, EDA, and modeling.

The dataset we use in this book is provided in a modeling-ready state, and as such does not require additional cleaning or preprocessing, so we will move directly to EDA. In your work, you shouldn’t be so hasty!

## 2.6 Exploratory data analysis

Now that the data has been sliced and diced, it’s time for some seasoning, mainly of you as a data analyst. In most cases, your stakeholders will require simple analyses, and they’ll have strong opinions about the visualizations they want. You’ll be surprised how often they refuse bleeding-edge interactive, flashy, blinking, and sparkling tools and demand good old static charts. And there is nothing wrong with that. Your role is to make sure their decisions are informed. If their preferred way of acquiring the required information is through one type of chart or another, you should respect that in most cases. You’ll need to stomp down your foot, however, when you realize that some other data presentation introduces new and required information. Pick your battles.

Why do we talk about visualization types here? Because you will get many useful charts as a side-effect of your EDA. Doing them right at this stage (which means they’re useful to your stakeholders) can save you time and effort later. In this section you will find some examples of such useful charts.

In our opinion, EDA is the process that distinguishes great analysts. It’s a form of art, linking the meaning of data with its structure. In EDA, you will combine statistics, domain knowledge, and visualizations. (You may use your new visualization toys, but if you want your stakeholders to adopt them, make sure you sometimes show them what you use—luring them generally works better than forcing things down their throats.)

This mix of required knowledge may seem intimidating, but you now have access to a fantastic source of multidisciplinary know-how. Let's ask generative AI about the DataFrame containing order reviews, aptly named `df_order_reviews`, as it has an interesting combination of numbers, text, and dates.

The preceding answer comes from ChatGPT-v4, as it was the most comprehensive. It developed one solid EDA plan, touching upon multiple topics at once. It shows how different levels of analysis overlap with each other. You shouldn't be surprised to see some of the steps we performed in the data-cleaning phase included here. Other steps, in our opinion, are elements of the data analysis itself. As we mentioned, there is no gold standard for EDA, and generative AI often provides the broadest possible answer.

### 2.6.1 Reviewing score distribution

Let's get back to our coin-flip gambling problem for a second. If you recall, at the beginning of this chapter, we said, ". . . if you throw the coin multiple times and get your expected tails each time, the coin may not be random after all." Before betting on a coin, you most definitely should check what the distribution of results is. If it's really random, you most likely should not bet on it at all, but if it's not random, you can use it to your advantage. You can think about reviewing the score distribution as you would about testing multidimensional coins.

The importance of score distribution cannot be overemphasized, as distribution analysis can reveal potential issues that may impact the study's validity, such as data entry errors or biases. Visualizing the distribution through histograms, box plots, or density plots can also help to determine whether the data follows a specific pattern or conforms to a known statistical distribution. This knowledge can help you select appropriate statistical tests, predictive models, or data transformation techniques to ensure accurate and reliable results.

Reviewing the distribution typically involves comparing the observed data distribution with a theoretical distribution (for example, normal, exponential, or binomial) to assess how well the data conforms to expected patterns. You have multiple distribution

testing methods at your disposal, including visual inspection with histograms or Q-Q plots, or more quantitative measures like the Kolmogorov-Smirnov test, the Shapiro-Wilk test for normality, or the Anderson-Darling test. Each method has its strengths and particularities, making it more or less suitable depending on the size of the dataset and the assumptions you're willing to make.

If this task seems complex, that's because it used to be. Now it's as simple as typing:

**MA** How can I test what distribution does my dataset fit best?

If you're looking for a more specific answer, you can add details about your analytical environment, data source, or an intuition you want to examine (note that we didn't use the word "confirm"). From our experience, ChatGPT-4 beats all the other tools in its statistical prowess.

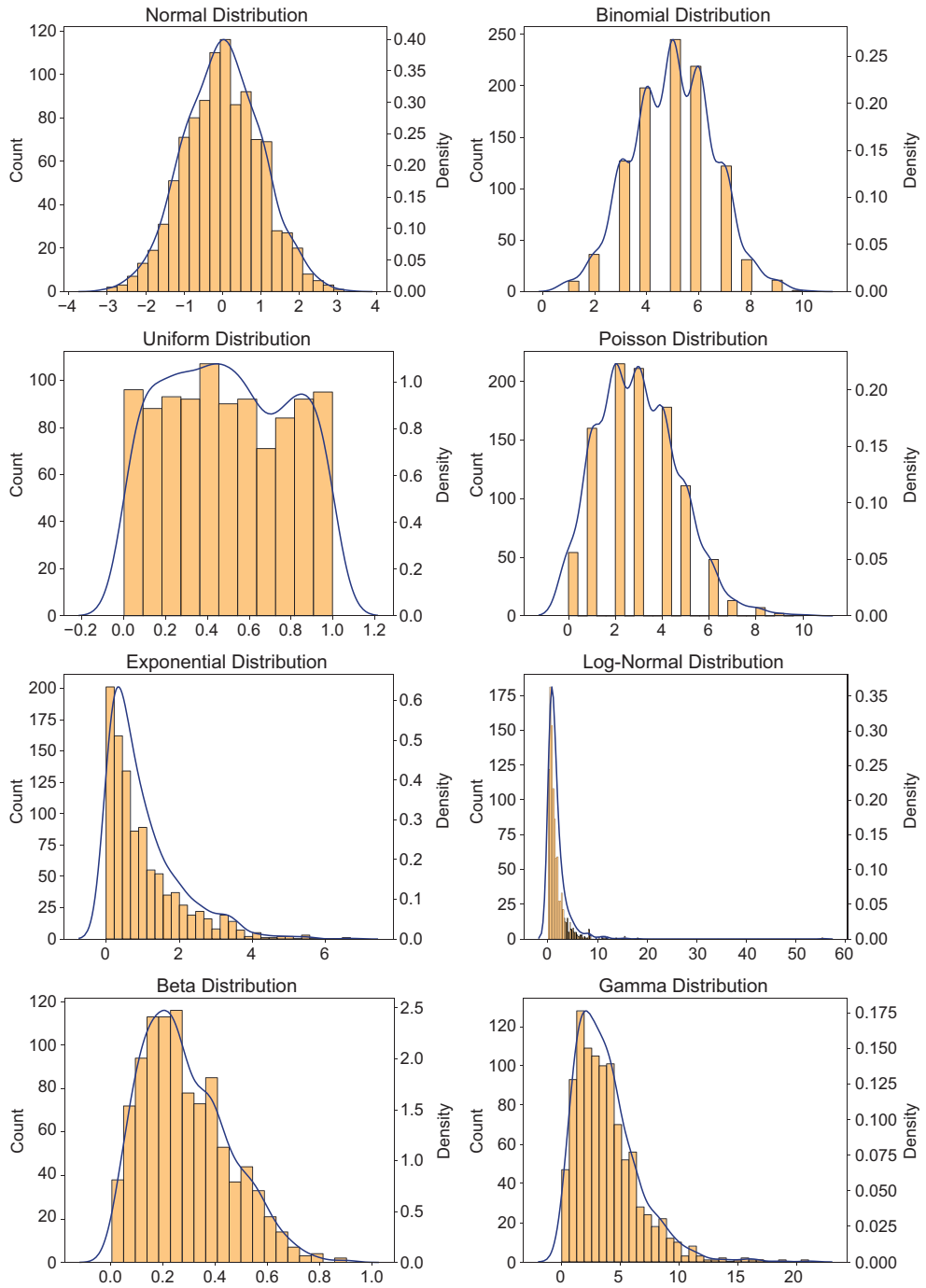


Figure 2.2 Commonly encountered data distributions

Let's look at some popular distributions and where you may expect them. The shapes of commonly encountered distributions are presented in figure 2.2.

#### **NORMAL DISTRIBUTION**

The normal distribution is also known as Gaussian distribution or "bell curve." It's often the first assumption for continuous data, due to the central limit theorem, which posits that the mean of a sufficiently large number of independent random variables, each with finite mean and variance, will be approximately normally distributed, regardless of the underlying distribution. Be careful, though. Some statistical tests rely heavily on the assumption of the normality of the data distribution. If your data is skewed, your test results may get screwed as a result.

The normal distribution is particularly relevant for metrics like sales figures, heights of individuals, and errors in measurements.

#### **BINOMIAL DISTRIBUTION**

The binomial distribution is used for binary outcomes in data, like coin flipping. This distribution is relevant when dealing with success/failure, yes/no, or 1/0 types of outcomes in data, such as conversion rates in A/B testing, pass/fail rates in quality control, or click-through rates in online advertising.

Seeing more than two bars in a binomial distribution chart often leads to confusion, so let's try to dispel that right away. The binomial distribution describes the number of successes in a fixed number of independent Bernoulli trials, each with the same probability of success. When you see a binomial distribution with more than two bins, it does not represent just a single trial (which would result in only two outcomes: success or failure, 1 or 0). Instead, it represents the outcomes of multiple trials, so it can have more than two bins.

For example, suppose you analyze the binomial distribution of  $n=10$  different trials. In that case, the distribution doesn't show just two outcomes but the probability of achieving 0, 1, 2, ..., up to 10 successes out of those 10 trials. Each "bar" in this context represents the number of successes: one bar for 0 successes, another for 1 success, and so on, up to 10 successes. So while each individual trial has a binary outcome, the

aggregate result across multiple trials can range from 0 successes (all failures) to  $n$  successes (all successes), leading to  $n+1$  possible outcomes. Hence the number of bars in the distribution's representation.

#### **UNIFORM DISTRIBUTION**

A uniform distribution assumes that all outcomes are equally likely. It's frequently a starting assumption for simulations or when modeling unbiased random variables, such as random digits, the simulation of equal-probability scenarios, or when no prior information is available.

While this distribution is less common in raw business data, it's worth remembering.

#### **POISSON DISTRIBUTION**

The Poisson distribution applies to count data where occurrences happen independently over a constant rate in space or time. It's commonly used for modeling the number of times an event occurs in a fixed interval of time or space.

You may encounter this distribution when analyzing the number of customer arrivals per hour, daily demand for a product, or the number of failures of a system.

#### **EXPONENTIAL DISTRIBUTION**

An exponential distribution is often used to model the time between events in a Poisson process, representing the time until an event occurs.

Look for this distribution when working with the lifespan of machinery before failure, the time until a customer's next purchase, or the inter-arrival times in a queuing system.

#### **LOG-NORMAL DISTRIBUTION**

The log-normal distribution comes into play when dealing with variables that are the product of many independent random variables. It's used when data cannot be negative and the distribution is skewed right.

You'll encounter this distribution in datasets concerning stock or real estate property prices or income distributions.

#### **BETA DISTRIBUTION**

The beta distribution is useful in modeling variables that are bounded on both sides, such as proportions and percentages. It's flexible and can assume a variety of shapes, making it suitable for modeling the behavior of random variables limited to intervals.

This distribution appears when the data represents conversion rates with values between 0 and 1.

#### **GAMMA DISTRIBUTION**

The gamma distribution is related to the exponential distribution and is useful for modeling the wait time for the  $n$ -th event in a Poisson process.

You'll need the gamma distribution when modeling things such as the amount of rainfall accumulated in a reservoir, service times in systems, or the reliability of systems over a continuous scale.

**NOTE** Can multimodal generative AI be used to identify distribution type from a chart? At the time of writing this book, no. We tried to feed parts of figure 2.2 to different generative AIs, and their answers were often as diverse as misleading. However, generative AIs can still guide you through proper testing procedures.

### 2.6.2 Time series exploration

Now we enter a grey zone. You may encounter discussions on analyzing changes over time as a part of EDA or as a part of in-depth analysis itself. On the one hand, visualizing all the time series is a part of EDA. Sometimes this will allow you to identify outliers or errors requiring cleanup. On the other hand, these outliers could encode significant issues or events in business processes.

We conclude that distinguishing between EDA and in-depth business analysis is a false dichotomy. EDA is an integral part of in-depth analysis. It's not something you want someone else to do for you. Nor is EDA a once-off event—you will be coming back to it now and then.

From the process management perspective, it's clearer when steps related to evaluating the data's technical and structural properties are separate from those related to discovering business-related insights. However, the two are too closely related to be wholly compartmentalized.

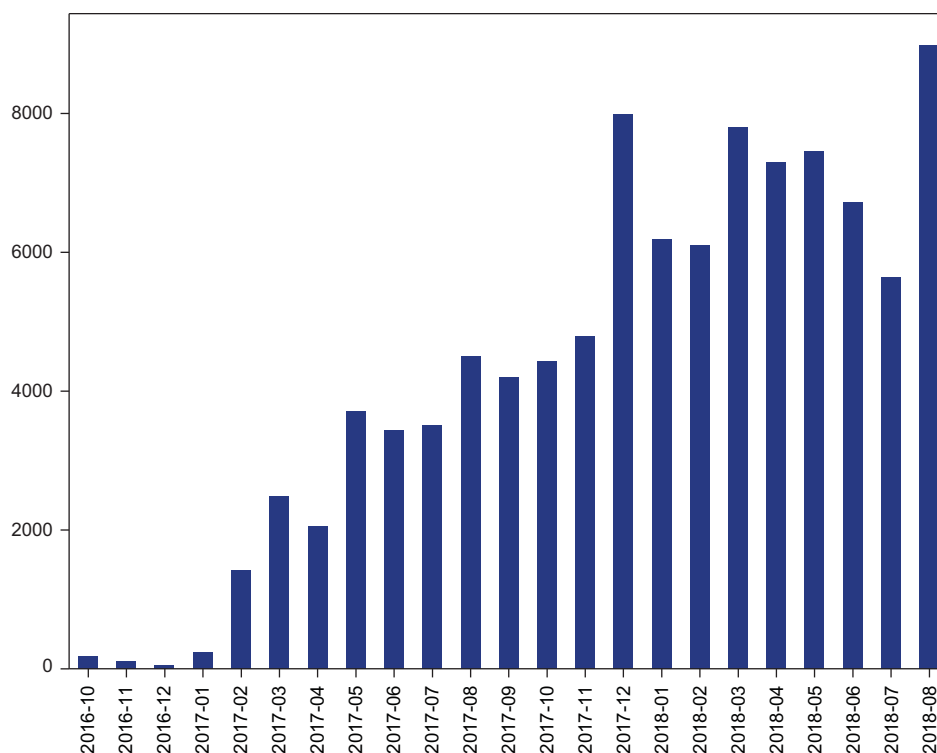
There are two tests that we propose to run at the first EDA iteration. First, we'll visualize and look at the data to search for outliers; second, we'll perform cyclicity detection.

#### CHANGES IN THE NUMBER OF RESPONSES: QUICK DATA VISUALIZATION

We've seen situations where the success attributed to a project was, in fact, caused by the change in the overall market or the performance of another business function. Taking a good look at how different variables change over time can be very informative indeed!

This is a very basic yet important task, which should be performed on most of your date-related variables. Most business activities have a continuous character, and analyzing their performance over time is critical for understanding those activities.

Figure 2.3 presents the number of reviews recorded in our dataset per month. We can clearly see three distinct phases. The first one lasted from October 2016 to January 2017. The almost non-existent number of reviews suggests that either the business operations or review collecting system were just getting traction. Then, from February 2017 to November 2017 (or May 2018, really), we can see a phase of rapid growth in the number of reviews collected monthly. Then, from December 2017 the system stabilized and started fluctuating, or from June 2018 it had a moment of collapse and rebounded in August 2018.



**Figure 2.3** The number of reviews over time—monthly aggregation

This information could be crucial if we were to quantitatively compare metrics involving the number of reviews between different points in time. Now that we’ve checked the number of reviews, let’s move on to checking the scores associated with reviews.

#### CHANGES IN REVIEW SCORES OVER TIME

Some data is expected to be cyclic, and other data, not so much. Discovering and describing cycles in data can help you identify whether the dataset you’ve provided is relevant to explaining the related business processes.

The following recording of our conversation with the AI advisor proves our point from chapter 1, related to the limitations of embedding generative AI directly into your analytics pipeline in a shoot-and-forget manner.



How can I detect internal cyclicity in data?



Detecting internal cyclicity in data involves identifying recurring patterns or periodic fluctuations over time. Time series data is a common example where cyclicity might be present. Here are some techniques to detect cyclicity in your data:



- 1 Visual inspection: Plot the data over time to visually inspect if there's any noticeable cyclical pattern. This can be a quick and simple way to identify obvious patterns.

These techniques can help you detect internal cyclicity in your data. Depending on the characteristics of your data and the nature of the cyclicity, some methods may be more appropriate than others. It's essential to understand the underlying assumptions and limitations of each technique and to choose the one that best fits your specific data and objectives.

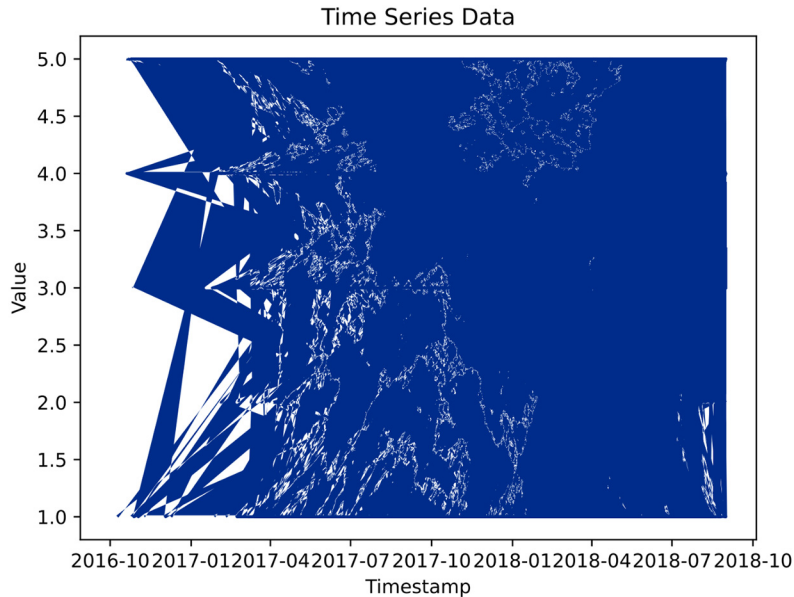


Figure 2.4 The relationship between the score and the time of the review

The code provided by generative AI sometimes differs from expectations. Three of the four pieces of code we received are dysfunctional (and are therefore censored), and the other . . . Well, look at figure 2.4 to see the resulting visualization of the relationship between the score and the time of the review.

We believe that some people gifted with an affinity for postmodern art could find an application for the resulting chart. In business analytics, however, you aim to get something a tad more readable.

Let's get back to the dysfunctional code, as there is a lesson to be learned here. The FFT and Lomb-Scargle methods didn't work due to problems with data types. So far, we've advocated that you present your generative AI advisor with general queries to confirm your expertise or expand your horizons. However, sometimes you'll encounter problems resulting from false assumptions that generative AI may make related to the data types available for analysis. That doesn't mean the answer is useless. It means you'll have to change gears.

**VARIABLES WON'T, CONSTANTS AREN'T** Generative AIs are language models. They operate on a general set of knowledge of mind-boggling scope. Expecting them to correctly assume the alignment of data type requirements for some advanced methods with our specific data may be overly optimistic.

As the general inquiry failed, let's try to be more specific.

**MA** Values in my data are categorical, with possible values of 1, 2, 3, 4, 5. They are review scores given to orders by customers. Can you propose a method to detect if there are any cyclical dependencies of the score in time?

**🌀** Since your data consists of categorical values (review scores), you can analyze cyclical dependencies by examining the distribution of scores over different time periods. One approach is to use aggregated bar plots to visualize the score distribution over time.

Here's a step-by-step guide to analyze cyclical dependencies:

- 1 Convert the timestamp to a more suitable frequency (e.g., daily, weekly, or monthly), depending on the length and resolution of your data.

Examine the stacked bar plot for any apparent cyclical patterns. If you observe any regular fluctuations in the proportions of different scores, there might be a cyclical dependency in the data.

Please note that the choice of aggregation frequency (daily, weekly, or monthly) will impact the granularity of the analysis. You might need to experiment with different frequencies to find the most suitable one for your data.

As we used web-based generative AI, it even remembered the name of our DataFrame in the conversation context, so no code adjustment in this regard is needed. It's equally as awesome as it may be dangerous. All of its assumptions should be taken with a pinch of salt and noted down, as they often may turn out to be a reason why some of the steps don't work as expected.

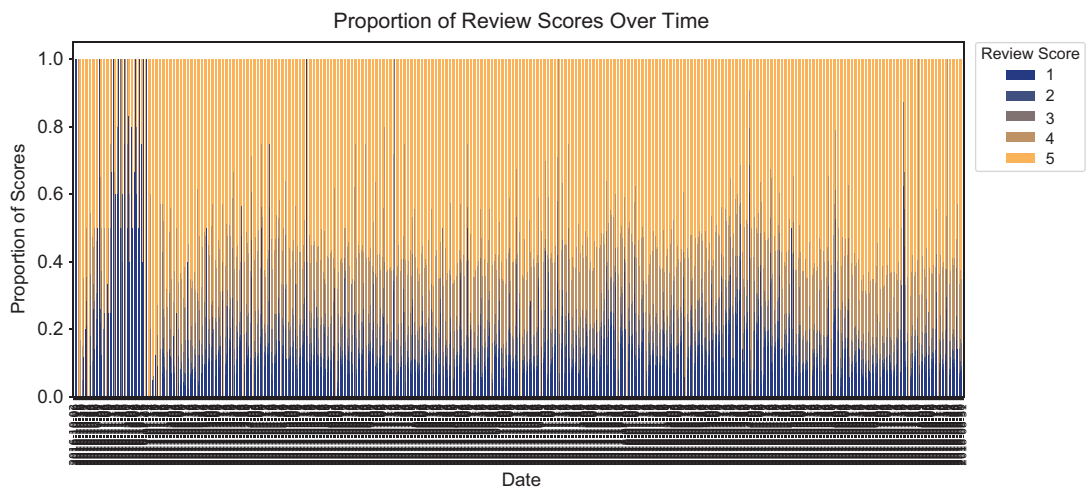


Figure 2.5 Order scores distribution over time—daily aggregation

Figure 2.5 presents the result of the proposed code. As you can see, the initially proposed frequency does not work well with our data. However, there is no obvious way of changing it. Does that mean we need to change the tools—revert to Excel and pivot tables or find something with a nice, big “change frequency” button? Or should we spend another week searching the matplotlib documentation?

Maybe not. This is the brilliance of generative AI in action. You encounter a problem, you mention it to your AI advisor, and . . .



How would I change the frequency to monthly?



To change the frequency to monthly, you'll need to resample your data accordingly. Here's how you can modify the code to aggregate the data on a monthly basis:

- 1 Convert the timestamp to a more suitable frequency (e.g., monthly).

Now, the analysis will be performed at a monthly level, which can help reveal long-term cyclical patterns in the data. Feel free to adjust the frequency according to your requirements and the granularity of your data.

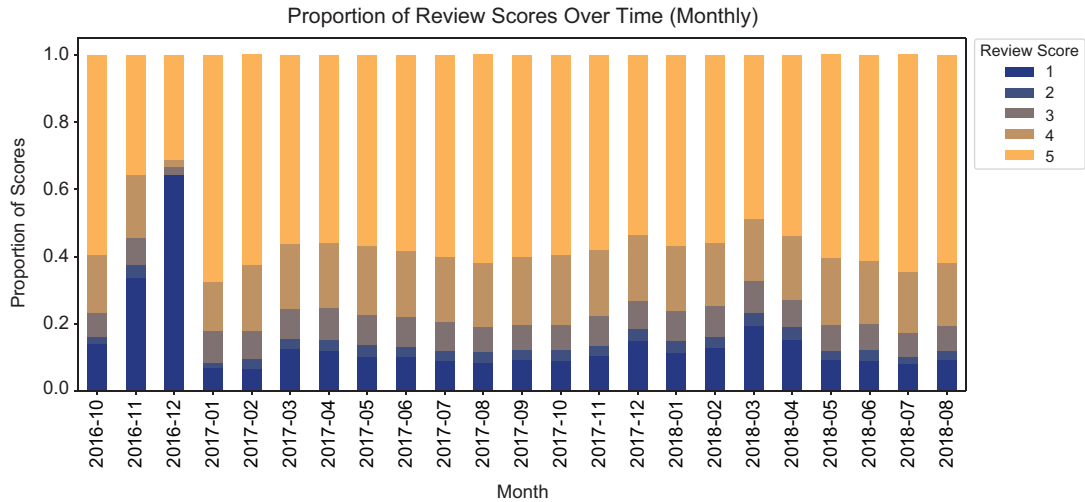


Figure 2.6 Order scores distribution over time—monthly aggregation

. . . there is a high chance that generative AI is capable of solving it. Figure 2.6 presents the distribution of review scores over time, aggregated by month.

We can see that there was a spike in low scores in November and December 2016, and maybe, just maybe, there is a cyclic rise in low scores in the spring, but the signal is so weak that we won't dig much deeper into it unless we want to run some precise predictive analysis.

We can safely conclude from this section that generative AIs may make mistakes, but they can still help you write and modify code, such as for time series analysis, and they are not shy of using really advanced libraries and algorithms (Lomb-Scargle is an algorithm developed by biologists to analyze biological cycles, later adopted by astronomers to search for patterns in star brightness observations). We believe that with a little patience and an iterative approach to clarifying the method requirements and your data properties, generative AI will become the greatest facilitator of your analytical processes.

### 2.6.3 Mysterious variable investigation

If mysterious variables don't already plague your days as a data analyst, you can expect they will. We mentioned, and will again, that nothing beats solid metadata, but things like thorough documentation data pipelines are considered a luxury in these times of ever-increasing time pressure. Therefore, some of your data may come from a poorly documented system. As much as we discourage using unconfirmed data for any reason other than warming your server room, sometimes it is possible to deduce the meaning of some variables to a satisfying level of certainty.

To show how you can deal with an example of a mysterious variable, let's feign ignorance as to the meaning of one of the columns in our example data. Let's try to get some insight into the `review_answer_timestamp` column. With our Sherlock cap on, let's see if there is any other column could be connected to it. Using intuition alone, we'll check the relation with `review_creation_date`. Both columns relate to reviews and, in some form, to a time.

But what does it mean for two columns to be related? A knee-jerk reaction could be to check for a correlation, but this could be a risky proposition in the case of time series. Correlation measures the linear relationship between two variables, assuming that this relationship is consistent across the dataset. However, this assumption often doesn't hold in time series, data due to factors like autocorrelation, trends, seasonality, and external shocks. *Autocorrelation* refers to the correlation of a signal with a delayed version of itself, a common characteristic of time series data that can inflate correlation measurements between two time series. Similarly, *trends* and *seasonality* can create spurious correlations that do not reflect a true causal relationship but rather the presence of underlying patterns that both series share. Moreover, *external shocks*

impacting both series can temporarily increase correlation without indicating a meaningful or lasting relationship.

In our case, the critical factor is that the values in both columns relate to orders, which themselves were placed as series in time, so they *will* be correlated. Whatever these columns mean, their values will grow in time with orders. How, then, shall we define the relationship?

Maybe we won't? We have tested generative AI for ideas and found its ability to understand the problem and propose a solution worthwhile.



Can you propose how I can investigate the relationship between the `review_answer_timestamp` and the `review_creation_date` columns?



To investigate the relationship between `review_answer_timestamp` and `review_creation_date`, you can calculate the time difference between these two timestamps and analyze the distribution of the time differences. This will give you insights into how long it typically takes for a review to be answered.

By analyzing the distribution of time differences between `review_answer_timestamp` and `review_creation_date`, you can understand the typical response time and identify any outliers or trends in the data.

You can also further investigate the relationship by looking at how the time difference varies with other factors, such as review scores or specific time periods (e.g., days of the week or months of the year).

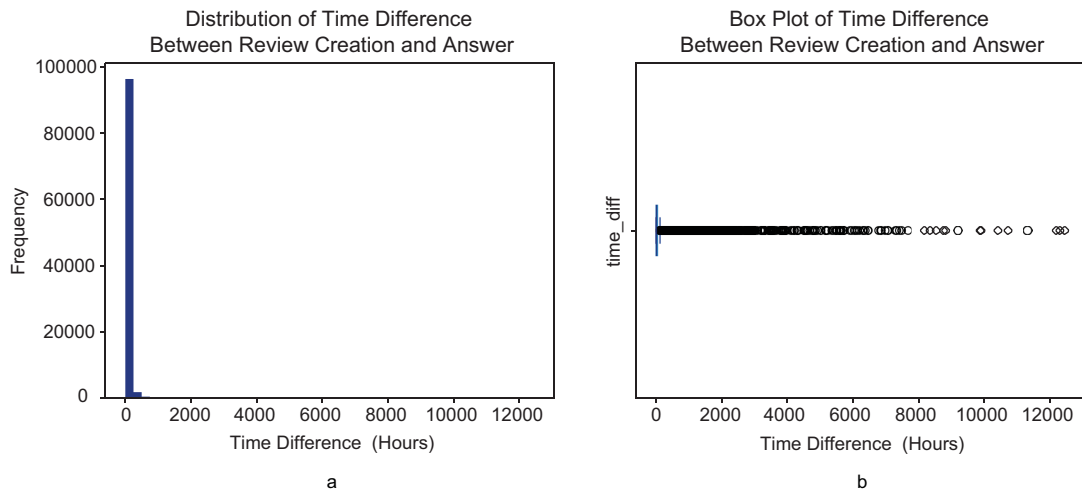
It makes perfect sense to check the distribution of time differences between dates in two investigated columns. Let's apply the proposed code.

The time difference summary analysis proves that the default timeframe of seconds may not be the most useful for the analysis.

However, our AI advisor mentioned that seconds might not be the best units for this data analysis. Fortunately, getting it to other time units is as simple as dividing the result by a constant. Feeling lazy, we asked generative AI to amend the code. It even took care of proper axis titles. The resulting images are presented in figure 2.7.

Judging by the time distribution, where some answers are provided within a few hours and others after many months, it seems very much like some human interaction drives the difference.

Let's try to apply logic here. We have a review creation and review answer. As the data comes from an online platform, the first intuition is that the user creates the review after purchase, and the seller answers to the reviewer after some time.

This example shows that the combined might of generative AI and human expertise can easily be beaten by vague column-naming conventions and a lack of metadata. Actually, the `review_creation_date` column contains the date of sending the survey to the customer, and the `review_answer_timestamp` indicates when the customer answered it. This is yet another reason to *always* confirm the naming convention data creators used.

### 2.6.4 Harmonizing data

Let's turn our attention to the structural issue of the number of reviews per . . . and here is the trick: are you actually sure what those collected reviews are concerned with? Getting multiple reviews of the same product is one thing. It's not unusual for multiple people buy the same thing and express their, often diverse, opinions. However, getting multiple reviews of the same order would require your attention, as you would need to decide how to evaluate order satisfaction in the case of more than one score. Would you use the last review or the average?

In our dataset, 547 orders have more than one review. Now we should check if they come from the customer who ordered it, or from multiple customers, which would be worrying. To answer the question, we need to harmonize our data and connect different sources to form a coherent whole.

Let's assume we feel lazy (that's a reasonably safe assumption) and that we want our generative AI to do the heavy lifting.



I have another DataFrame named `df_customers`. There are two columns `customer_id` and `customer_unique_id`. What shall I do to create in the previously discussed `df_order_reviews` an additional column with `customer_unique_id` correctly assigned to `customer_id`, which is already there?



To add the `customer_unique_id` column to the `df_order_reviews` DataFrame based on the `customer_id` column, you can use the `merge()` function in pandas. Here's how to do it:

Merge the `df_order_reviews` and `df_customers` DataFrames on the `customer_id` column.

Now, that's a nice bit of code with no right to work! It's trying to assign customers to orders in the `df_order_reviews` DataFrame. However, no column in `df_order_reviews` allows us to do this directly. We know that the only actual identifier we have is the `order_id` column, as we did our homework and learned that `customer_id` does not, in fact, identify customers.

**THE CUSTOMER IS ALWAYS RIGHT** Generative AIs will neither question nor correct you. If you tell them to believe in something, they will assume you have your reasons. Although, there is a limitation to their suspension of disbelief. We tried to convince generative AIs that the Earth is flat, and even though they agreed to keep this assumption for the sake of the discussion, they reminded us every now and then that the Earth is, in fact, round. However, their tolerance borders are set pretty far.

We can get the desired result in a two-step process by first connecting `df_orders` and `df_customers` on the `customer_id` field. This will give us a DataFrame that contains the `customer_unique_id` for each order. We can then connect this DataFrame to `df_order_reviews` on the `order_id` field. Alternatively, we could start by connecting `df_orders` and `df_order_reviews` on the `order_id` field. Then we could connect the resulting DataFrame to `df_customers` on the `customer_id` field. Hopefully you can now see why the initial data analysis is critical. You need to see all the DataFrames to harmonize data from multiple sources effectively.

Joining, merging, and concatenating tables may be obvious to you, but, for others, this bit of data engineering 101 may still be something to worry about. In the past, just knowing *what* needs to happen was a required but not sufficient condition for getting the code to perform the desired operation. We've seen the computer science degree requirement in many data analysts' job descriptions. Let's take this opportunity to check if today's gaps in coding experience can be closed using generative AI.



I have my `df_order_reviews` DataFrame, which has the `order_id` column. I also have the `df_orders` DataFrame, where I have the `order_id` and the `customer_id` columns. I also have the `df_customers` DataFrame, where I have the `customer_id` and the `customer_unique_id` columns. How do I assign a valid `customer_unique_id` from `df_customers` to each `order_id` in `df_order_reviews`?



To assign the valid `customer_unique_id` from `df_customers` to each `order_id` in `df_order_reviews`, you will first need to merge `df_orders` with `df_customers` to create a DataFrame with `order_id` and `customer_unique_id` columns. Then, merge this new DataFrame with `df_order_reviews`. Here's how to do it step by step:

This time, the code works as advertised. Generative AIs indeed can supplement you with the code; they know *how* to do it (even if they sometimes need severe prodding to get something working). The decision about *what* needs to happen is still yours (even if the initial conversations provided you with suggestions).

Now, to finish this part of the exercise, let's check if multiple reviews do come from different customers; in such a case, you should probably inform your IT department, as there would be a strong possibility of erroneous review assignments to orders. The following code should give you the required answer (and no, we didn't write this ourselves).

This code groups the `df_order_reviews` DataFrame by counting unique `customer_unique_id` values, checks for cases where the count of unique `customer_unique_id` values assigned to `order_id` is greater than 1, and finally prints the results. All the multiple reviews came from the same customers. This saves you a trip to the IT den and even allows an analysis of how prevalent an opinion about the order is over time.

We can assume that you now either know your data well enough or know how to use sufficiently eloquent and knowledgeable generative AI models to help you get a good insight into your data structure and properties. In the next chapter, we'll focus on the business analysis itself.

### Things to ask generative AI

- What is the typical data structure for data coming from <some\_business\_area>?
- What data quality problems should I test for in the DataFrame I have provided you?
- What distribution should I expect in the column describing <some\_activity>?
- How do I deal with <a\_clear\_description\_of\_the\_encountered\_problem>?

### Summary

- Be aware of the context of your conversation with your generative AI advisor. Ask it to summarize its understanding of the context (this is particularly useful if you want to start a new session on the same topic, such as to research different approaches).
- Don't shy away from reminding your AI adviser about the purpose of the current work or the variable names used. Remember, it aims to please, not to be precise.
- There is no better way to understand the data than by looking at it.
- When evaluating data quality, it's essential to check its structure, consistency, and contents.
- Double-check your data, triple-check, and reach out to data providers for clarification when you're still in doubt.
- It's a good practice to keep data quality investigation separate from the actual in-depth analysis . . .
- . . . however, data cleaning and EDA *are* integral parts of your data analysis, and you'll be repeating them sooner than you hope.

# *Descriptive analysis and statistical inference supported by generative AI*

## ***This chapter covers***

- Using generative AI to design analytics
- Descriptive analytics of collected data using generative AI

The work described in the previous chapter was challenging and strenuous but absolutely necessary. You ensured that the data is of acceptable quality and that you understand its meaning. Your understanding of the data may still change as analysis uncovers nuances and intricacies of the underlying process, but you should have a solid foundation by now.

In this chapter, we will walk through the first part of an in-depth business analysis, the end-to-end descriptive analysis, learning how generative AI can help us at each step. And it can help a lot, from answering questions related to available data

to providing real business insights. We will start with high-level analysis planning, touch on even more data preparation (surprise!), and then describe and visualize the data, searching for business-relevant information. We will also apply more advanced statistical modeling tools to our data, hoping to infer more insight from it.

### 3.1 Research questions

In the first chapter, we explained how you can use generative AI to help specify the business goal of your analysis. As we said then, your goals should usually be determined by the business stakeholders. In the second chapter, you did a primary cleanup of your data and investigated the contents of available data sources.

Let's now make millions for your company! That's your role, no? Well, actually, no. At least, it *shouldn't* be. Your role is to inform decisions made by business stakeholders. But to do that, you need to translate the business questions into research questions. The plural here is not by accident. Usually, you'll discover that answering a single business question requires answering multiple research questions. Take a simple question: "How do we make more money?" To answer that, you may go down the following path: "Who spends the most money with us?", followed by "Can they buy more of our product?", or "Where do we find similar people?" Or, as the dollar saved is worth ten dollars earned: "What step in our production produces the most scrap?", followed by "What production parameters could we optimize to reduce this?"

The possibilities are endless, and you're limited only by your imagination and data availability. That's why knowing your data is so important! Business stakeholders usually think in terms of business processes. A person managing a supply chain would love to lay their hands on a prediction of product demand across different regions to minimize overstocking and understocking issues. A person responsible for alloy casting would love to have a tool that calculates optimal ratios of different substrate materials to get the final product. They understand the supply chain or metal mixing process; they might not appreciate the complexity of integrating regional sales trends and global economic indicators, or the need for confirmed quality and trace element analysis that are crucial for creating robust models. They don't necessarily know the limitations and possibilities inherent to your data sources.

The key point here is that you will rarely answer the business question you've been presented with. More often than not, you will need to break it down and translate it into a series of research questions, and only after their analysis will you synthesize the final answer. In the first chapter, we showed you an iterative way of defining the analysis scope. Even if it seems you defined your scope just a short while ago, the moment you've finished cleaning and assessing your data inventory is a good time to look at the problem with fresh eyes. Maybe some questions you thought were answerable aren't, and perhaps new opportunities have arisen.

As we were writing this book, we asked generative AI what information it would want from us to help us formulate research questions about the dataset we have at

hand (think of a situation when a business stakeholder drops data on your lap with a short request “do something about it”; it happens). What we got back was a handy checklist, which should help you structure your thinking about what questions are and aren’t answerable in the context of your data environment:

- *Data dictionary*—A brief description of each variable in your dataset, including its type (e.g., continuous, ordinal, or nominal), measurement scale (e.g., interval, ratio), and any potential coding or transformation applied.
- *Data sources and context*—The origin of the data, the context in which it was collected, and any relevant background information.
- *Data collection and sampling methods*—How the data was collected, any sampling methods applied, and any potential biases or limitations in the data.
- *Domain knowledge*—Any specific domain knowledge or expertise you have about the subject matter of the dataset.
- *Goals and interests*—Goals and interests for this analysis, such as identifying patterns, making predictions, evaluating a policy, understanding relationships between variables, and so on.
- *Stakeholders*—Stakeholders who will benefit from the insights generated from your analysis.
- *Temporal and spatial aspects*—Temporal or spatial components that may affect the research questions.
- *Previous research*—Any knowledge of prior research or studies conducted using similar data or in the same domain.
- *Limitations and constraints*—Any limitations or constraints in the data or the analysis process that might affect the research questions you can explore.

Collecting all this information at this stage will allow you to design an analytics process that won’t suddenly stop midway when you realize you are missing a critical bit of required data.

With all this information at hand, you may come up with a bunch of research questions, answers to which you will be able to synthesize into the answer to your business question. But are they really all relevant questions? Fortunately, you have access to a tool with hundreds of combined years of analytical experience. With its help, you can make sure you didn’t omit any relevant issues and check that all the research questions you are thinking of asking are indeed relevant to the analyzed business issue. Such help will be of exceptional value if your boss sends you an email with a pile of files and asks you to extract all possible insights from them.

Let’s see how a generative AI advisor tackles the problem of overly general business problems in the context of available data. As you can see, you can identify multiple areas of interest within seconds! While our initial inquiry didn't specify objectives beyond enhancing business value, performing the suggested analytics should provide business stakeholders with information, allowing them to make significant steps toward the overarching goal of increasing business efficiency.

**I FOUND 1,000 WAYS OF NOT DOING SOMETHING** It would be best to talk to the business at this stage. They should think about whether such an insight will help them and if they want to prioritize it. Most importantly, this list will hopefully spark some new ideas about what kind of analysis they could immediately use to generate value.

This list is good enough for us to use as a base for our analysis. Of course, we might expect more of a typical analysis, like the Net Promoter Score (the most common method of measuring client satisfaction), but the result is not bad, not bad at all!

### 3.2 *Analysis design*

Once you have a clear goal, you'll probably feel energized and may be tempted to jump into creating pivot tables and charts . . . Sit down, sip a coffee, and wait until that feeling passes. In chapter 1, we advised you to *first* prepare a protocol of what your analysis will look like, what the possible results are, and what the *meaning* of each of these possible results would be. This element of experiment design is often overlooked, even in the academic research world, but you don't want to learn from the worst. Getting some results and trying to fit a theory to them may result in worthless science fiction research papers (not to be mistaken with a respectable literature genre in which we've authored some titles ourselves); in business reality, this may lead to significant financial losses. Always plan ahead. No result should come as a surprise. Prepare a complete list of possible results and their meaning in the context of your business case. For example, if the current price is higher than the purchase price, sell; if they are equal, hold; otherwise buy.

Of course, no protocol is set in stone. You will likely revise it after preprocessing your data (you may find that not all planned analyses are possible, or new ideas might strike you while scrolling through the data). Your stakeholders may change their priorities or focus areas when you're halfway through. Even in this book we ignore our own advice—the speed of GenAI development outpaced our typing abilities, so we had to revisit parts of this book a couple of times. Pretending that we followed the assumed path would be a straight-up lie.

Unfortunately, cases where playing analysis by ear is justified are less common than the popularity of this approach. The sad fact is that as rare as proper experiment design is in an academic environment, it's even rarer outside of it. You won't find many good materials to guide you through the process. Even in the data (or text) corpus on which most generative AIs are trained, the cases where analytics design includes prior result analysis are most likely rare and far between, as none of the tested AI advisors considered it worth mentioning.

Following this general design for your analysis will help you systematically answer the proposed research questions using the provided data.

Let us share a little story, or actually more than a dozen we encountered, fitting the same scenario: The analyst performs a regression analysis to explore the relationship between social media advertising spend and sales. The results indicate a statistically

significant correlation between the amount spent on social media ads and increased sales. The company decides to increase social media spending, only to find out their return on investment (RoI) is in the negative. To make things worse, the budget diverted to social media campaigns weakened other business functions. That is a typical example of a poor analytics design with a perfectly avoidable outcome.

It is not our goal to follow in the footsteps of Don Quixote, pursuing lofty ideals that we will never obtain, but you should spend some time inquiring about the possible results of different types of analytics and their meanings. In some cases, predicting all possible outcomes is not feasible. For example, you don't want to come up with all possible variants of a chart you're expected to generate. But you should have a general idea of expected shapes or traces. We touched upon this previously when we discussed data cleaning. You need to understand what's expected to notice what's relevant that's unexpected. In some analyses, you should spend more time thinking about the meaning of the results. A good example here would be correlation analysis.

What does correlation mean from the business perspective? How big a correlation is actually *meaningful*? (Do not mistake this for statistical significance, as did the protagonists of the earlier story.) When calculating regression, what is the predictive power you require? There are no ready-to-use templates to be filled out. Your domain knowledge and understanding of the business will allow you to distinguish between valuable and misleading insights. Generative AI can help you, but don't expect it to do all the heavy lifting for you. You need to talk to your business people to be able to deeply integrate domain knowledge into your analytical pipeline.

In the generative AI's proposed design, there is one popularity-bias-driven element—the content of point 3.a, the methods for statistical testing. We'll explain our gripe with that particular point in the introduction to section 3.5.

Other than that, the execution of this plan may indeed extract some insight from the data we meticulously cleaned.

### 3.3 *Descriptive data analysis*

Many people approach data analysis (both stakeholders and naive newcomers to the job), with quite high expectations. Wouldn't it be great to just drop all your company's data into a magical box and receive back a set of simple instructions, like "Fire Sue from the third floor, as her micromanagement style kills the soul and effectiveness of her team. While you're firing people, don't forget Joe from packaging, as he's the reason behind 20% of your returns"? Or, "Add the pink *Buy now!* button in the left-right corner of your landing page, and you'll get 61.73% more sales in the first week"?

Going from data to information to insight is a process. It can be somewhat automated or sped up by the tools, but a lot of data analysis is just that—*analyzing*: a detailed examination of the elements or structure of the data. Despite the best efforts of AI-focused companies, the part where someone needs to describe data elements and structure is not going anywhere, primarily because it offers an overview of business performance. Various statistical measures and visualization techniques enable you to identify

patterns, relationships, and anomalies within datasets. You can use descriptive analytics to understand your business operations, customer behavior, and market dynamics better, laying a solid foundation for informed decision-making and future analysis.

It doesn't matter if you work for an organization, big or small. Analyzing data from a restaurant, you may use this approach to identify the most ordered items versus those rarely ordered. While working in the corporate office of the restaurant chain, you may use it to determine the most popular items by location and time of day. This insight could then guide decisions around stock management, staff scheduling, and targeted promotions, ultimately enhancing operational efficiency and customer satisfaction. Despite its simplicity, descriptive analytics is crucial in paving your way toward more advanced analytics methods, such as predictive and prescriptive analytics.

You should describe your data using *nomen omen* descriptive statistics, including mean, median, mode, standard deviation, and percentile values. You should also prepare visualizations like bar charts, histograms, and scatter plots to further enhance your ability to identify and examine patterns and trends within the data.

Four of the nine research questions initially proposed by generative AI can be addressed using these methods. We will do just that in the following subsections. The other five will require a somewhat different toolbox, presented in section 3.4.

### 3.3.1 Popularity of product categories

Recall the question provided by ChatGPT: “What are the most popular product categories in terms of revenue, and how do their sales performance vary across different regions in Brazil?” If working with e-commerce data makes you stifle your yawn, don't worry. The same methodology is helpful in many business areas. Let's explore some examples where this approach can provide you with valuable insights:

- *Retail, e-commerce, and manufacturing*—Beyond product categories, this method can be applied to understand customer segments' buying behavior across different regions or time periods, such as analyzing seasonal trends in purchasing or the effect of marketing campaigns on various demographics.
- *Healthcare*—In healthcare, similar techniques can be used to analyze the distribution of disease incidence or treatment outcomes across different geographical areas and demographic groups. This can help in resource allocation, understanding disease spread patterns, and tailoring public health interventions.
- *Financial services*—For banks and financial institutions, analyzing the distribution of loan or credit card defaults by product type and geographic region can help in risk management and in designing targeted financial products.

Generative AI failed to understand what question we were referring to. We hoped it would recall the question it itself proposed just two prompts earlier: “What are the most popular product categories in terms of sales volume and revenue, and how do their sales performance vary across different regions in Brazil?” Instead, it provided us with unhelpful output related to identifying the most common product categories instead of their sales performance. Let this be a warning that you shouldn’t always rely on generative AI to recall your conversation correctly if your prompt is vague.

**TOMAYTO, TOMAHTO** Sometimes, the difference between the question you asked and the question generative AI answered might be minute and hard to spot, but inferring any insight from the answer to a question that’s different than you asked may have far-reaching implications.

It is important to remember that we don't leave our own analytical skills at the front door when we let generative AI help us out. Any experienced data analyst could tell you that a large DataFrame such as this will benefit from the visualization of the results. So before we go further with the steps proposed by generative AI, we'll take a moment to get some visuals.

We present this transcript as a warning. Bugs and problems *are* to be expected. Getting generative AI to debug the code can take some effort, as appendix B shows. However, this exercise resulted in two conclusions worth presenting here:

- Generative AIs may provide you with incorrect code, and more than once at that. We can still use them to debug the code (with more or less success, depending on the language), as it may take less time than learning all the intricacies of syntax from the ground up yourself.
- You should not leave the debugging process to generative AI completely, as it doesn't have access to the results. Looking for oddities in the output and informing your AI advisor about them significantly speeds up the process.

Thanks to the provided code, we were able to generate four figures: two bar plots and two heatmaps.

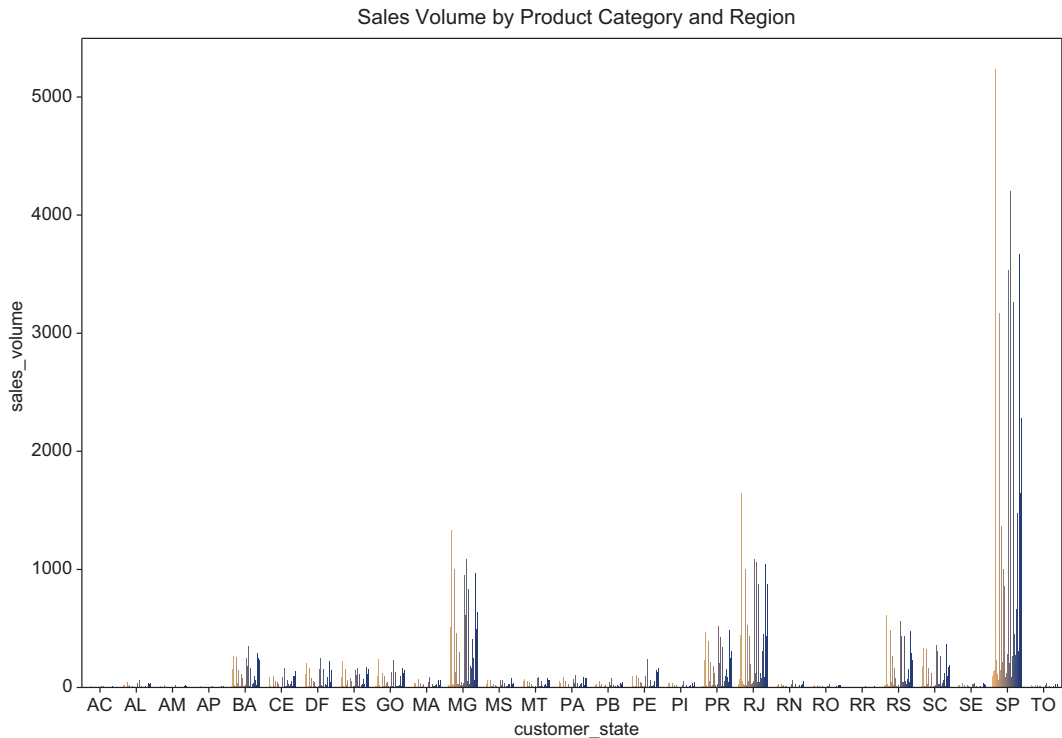


Figure 3.1 Bar plot of sales volume by product category and region

The bar plots may not be suitable for adding to a presentation destined for an SD projector. In figure 3.1 you can find one of them; the second one is almost identical. To make it fit the page, we dropped the legend containing 71 categories (they are still present on the figure generated in the accompanying Jupyter notebook). It's still unreadable, but that's hardly generative AI's fault. We are trying to visualize almost six thousand data points, after all!

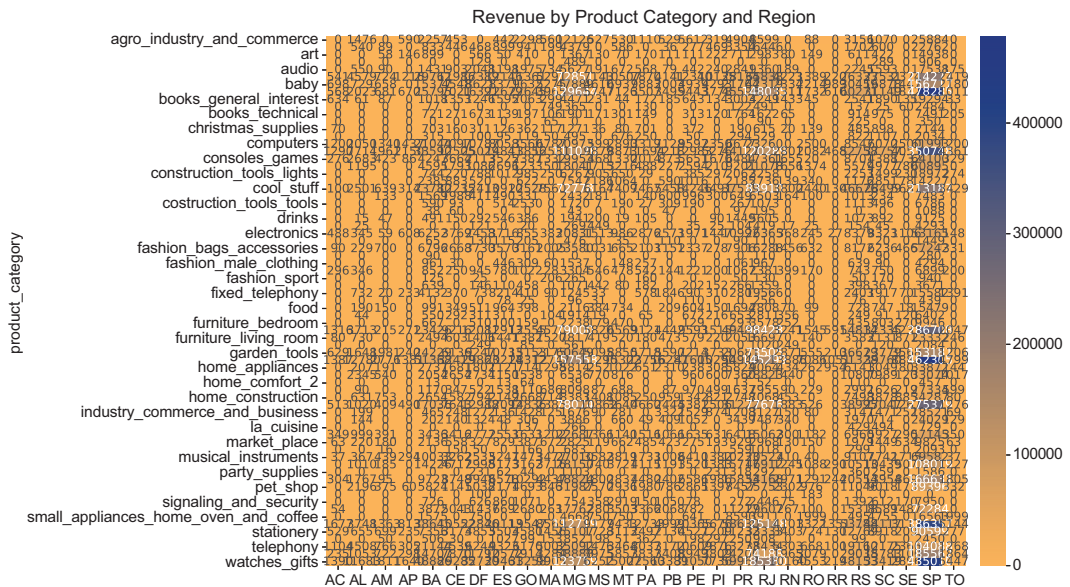


Figure 3.2 Heatmap of sales revenue by product category and region

To make this figure more consumable, we can ask our AI advisor to break it down by state or product group, but we'll end up with dozens of charts. Let's check if using heatmaps will save us this trouble. A visualization of the same data is presented in figure 3.2. Both heatmaps are available in the Jupyter Notebook in the book's GitHub repository.

Unfortunately, the generated heatmap is not much more readable, is it? We printed this indecipherable image in this book as valuable learning material.

You will see unreadable graphics in your work every now and then. If you're asked to prepare "something that will fit a PowerPoint slide," it can really ruin your day. In such a case, you need to consider whether you face an inherent issue, like the number of bars in figure 3.1, or if the visual clutter can be remedied with a simple reformatting. If you're unsure how to tweak your visualization software's settings, generative AI is there for you! You should get the solution and an explanation to help you in your future work.

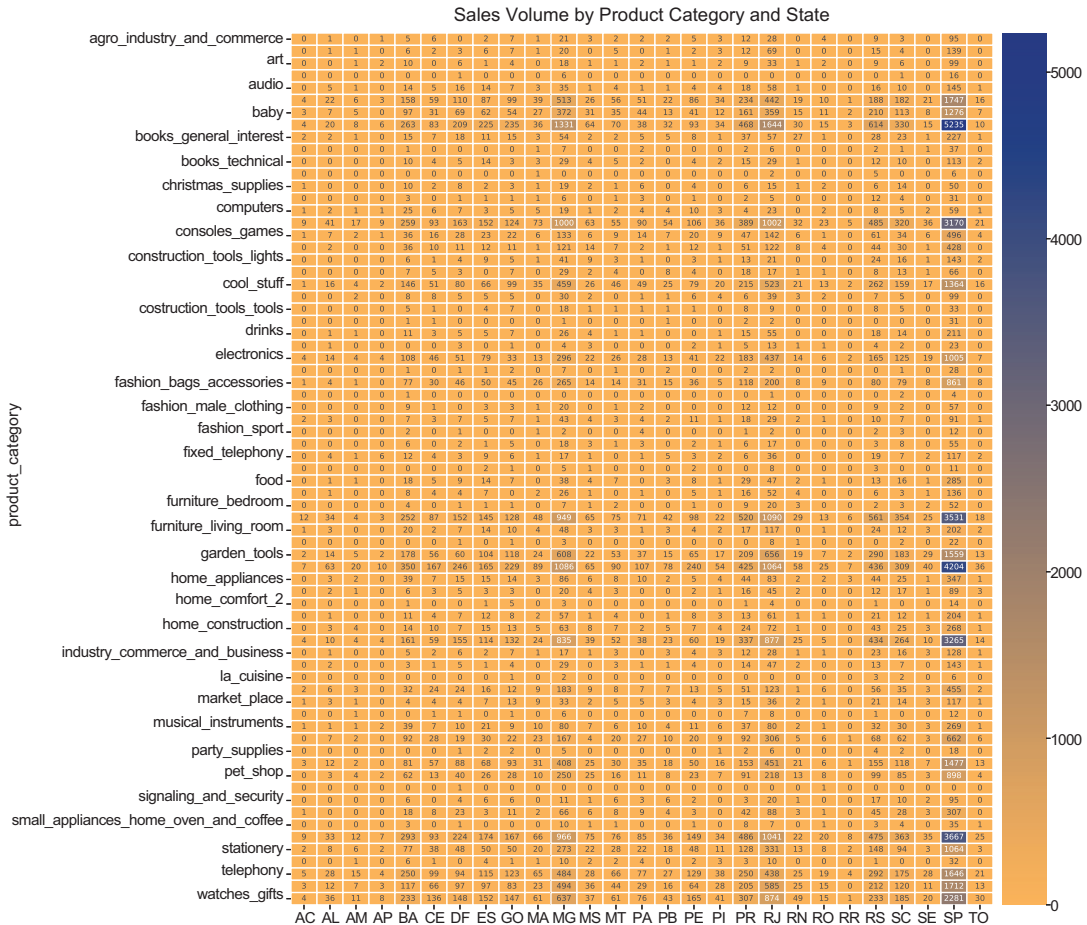


Figure 3.3 Heatmap of sales revenue by product category by state, reformatted

Before we proceed to present the result, we need to note that the `revenue_df` Data-Frame mentioned in the code was defined in the previously mentioned appendix B, where we show a long and winding road to the correct code. This time, however, things progressed as expected. The result is presented in figure 3.3.

The overall result is now possible to analyze. Maybe not so much in terms of reading individual numbers, but that's precisely the purpose of the heatmap. It's meant to pinpoint outliers in the dimensional distribution.

The other visualization proposed is stacked bar plots, which are included in the book's GitHub repository.

At this stage, we are well equipped with visualizations for drawing business conclusions on the most popular product categories. Following our AI advisor's guidance, we will now move on to research their performance.

### 3.3.2 *Performance of products in their categories and regions*

As a reminder, based on our data availability, our generative AI advisor proposed the following approach to measuring performance: "How does the average product price, freight value, and payment value differ across different product categories and

To ensure the proper contextual awareness of your AI advisor, when you notice it hallucinating about provided data structures, paste it a reminder with a detailed description of the data in question, or move on to a new conversation session.

Remember, that's not the worst-case scenario. Errors that break the code are simple to spot. Errors where things go smoothly, but the results are based on wrong data, are a different kettle of fish. Consider this fair warning.

The resulting DataFrame has 1,356 rows. Yet again, we should probably think of visualizing the result.



Could you propose a visualization method suitable for data in the generated `average_values` DataFrame?

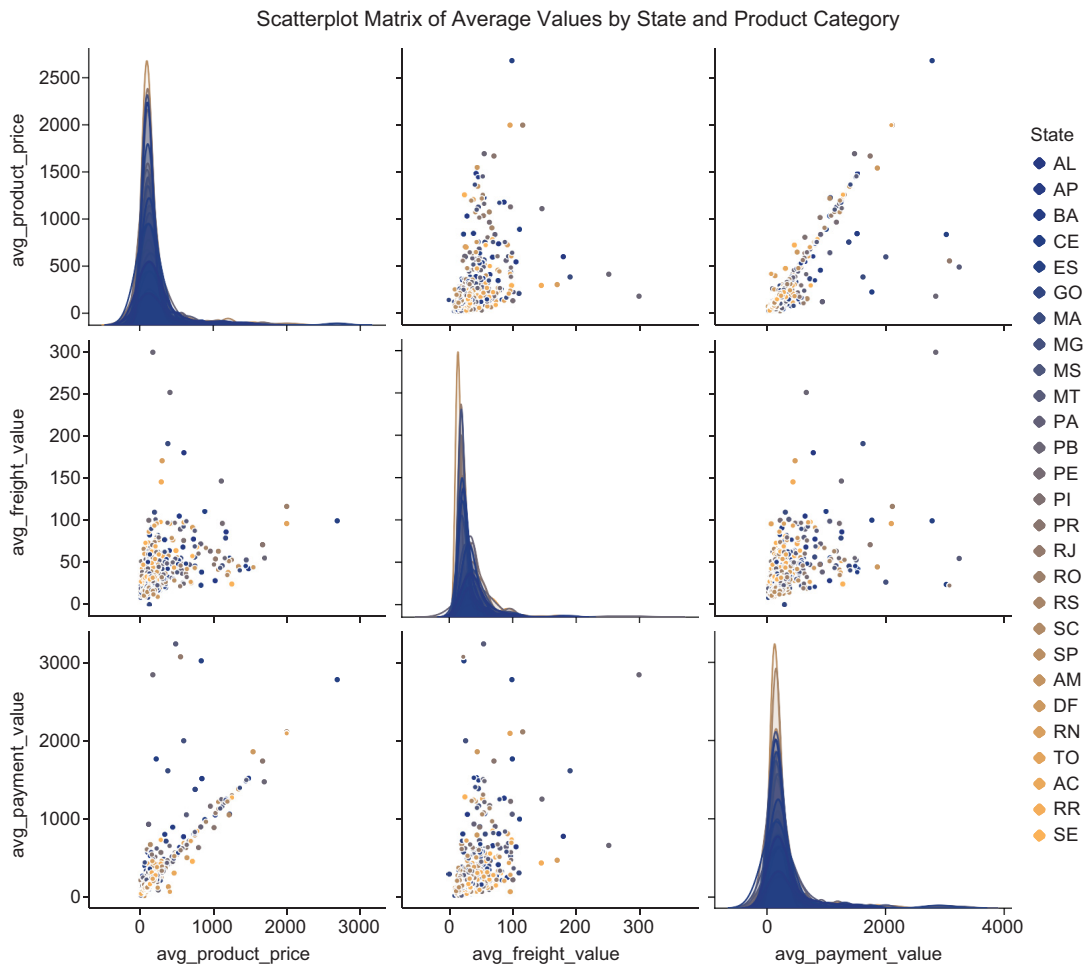

**Figure 3.4** Scatterplot of relationships between average payment values, average freight values, and average product prices



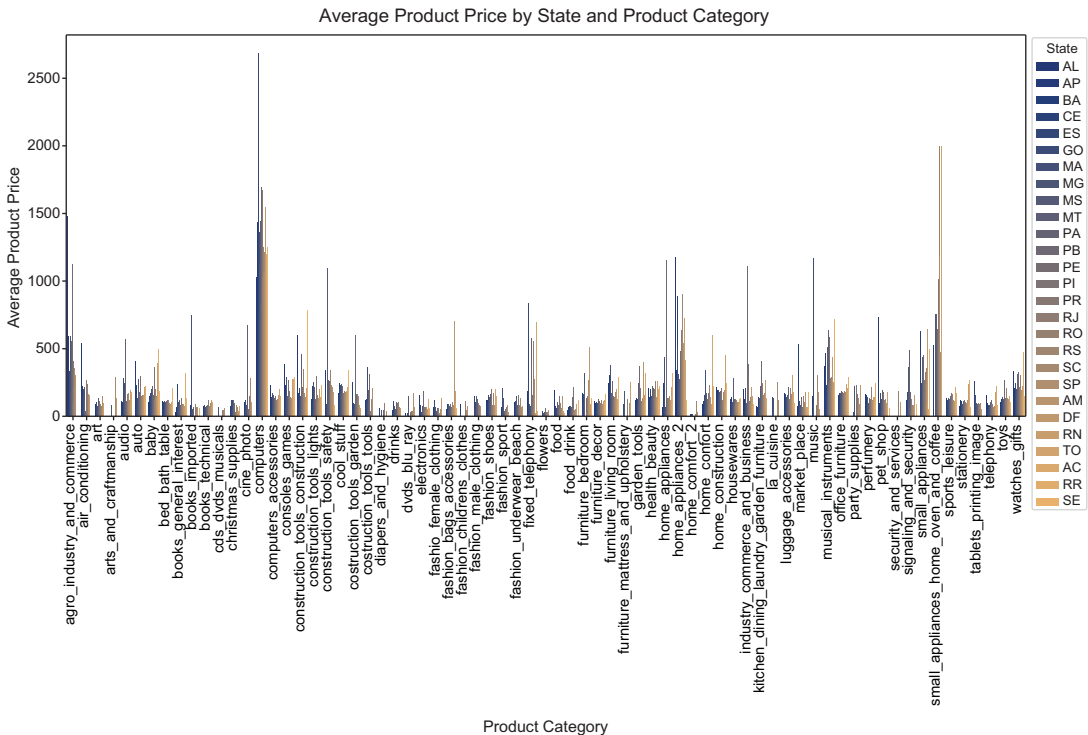


Figure 3.5 Grouped bar plot showing the relation of average product price per category per region

The piece of code responsible for explicitly naming the chart axes didn't work correctly. Fortunately, the DataFrame column names used by matplotlib as a default are informative enough. We left it as is to drive home a more general point: Sometimes, in your work, especially under time pressure, you'll be tempted to "save time" on naming conventions. Quickly, all variables will become `x`, `tmp`, or `var1`—it's a terrible habit. You'll agree with us after you open a file you wrote two months ago. You're saving seconds now to lose literally hours later. Using informative variable names is a time saver. Of course, being too verbose won't do much for your code readability either. A variable named `second_attempt_to_average_the_sales_in_Joe_Smiths_analysis_of_his_shop` may be overkill.

The resulting figure 3.5 may take some time (and a magnifying glass or two) to analyze, but it should suffice to provide some business insight into product performance. If you lack a magnifying glass of sufficient magnitude, we will discuss utilizing generative AI to cluster product categories in the next section, where we'll analyze product perception.


### 3.3.3 Review scores distribution


The value of knowing the distribution of review scores is relatively apparent. It's critical feedback about how the products are perceived by the people paying for them. As we mentioned before, there are certain methods and measures for representing overall client satisfaction as a single number. Still, we'll forget about them for the time being (pretending we are working on unknown data) and try to answer the question proposed by our AI advisor: "What is the distribution of review scores across different product categories?"

If you feel like skipping this exercise because you know how to make a bar chart of a single variable in Excel, you can skip it. We're not rediscovering the wheel here. However, if you feel like spending a minute learning how generative AI can help you work on the granularity of your results, read on!

**REPETITION IS A MOTHER OF LEARNING** We previously wrote about the issues with how far back generative AI can reach in its conversation context analysis. Every now and then, you should clarify whether it remembers all the details correctly. If there is a problem, you can remind it of the full data description instead of correcting one variable after another.

Let's see if generative AI will provide any helpful twists to this simple exercise. After jogging generative AI's memory on the structure of the involved DataFrames (as presented in appendix A), we received the following answer to our question.

 How should I extract information on the distribution of review scores, and how does it vary across different product categories and sellers?

The code worked as advertised, but the problem is that we again beat our own record, and now we have a DataFrame with 14,503 rows. We're going to need visualizations again if we're to make any sense of this.

This plot will give you an idea of how different product categories perform in terms of customer reviews. Keep in mind that this plot might be quite large and hard to read

depending on the number of product categories in your dataset. You may want to filter or aggregate the data further to focus on specific categories or review score ranges.

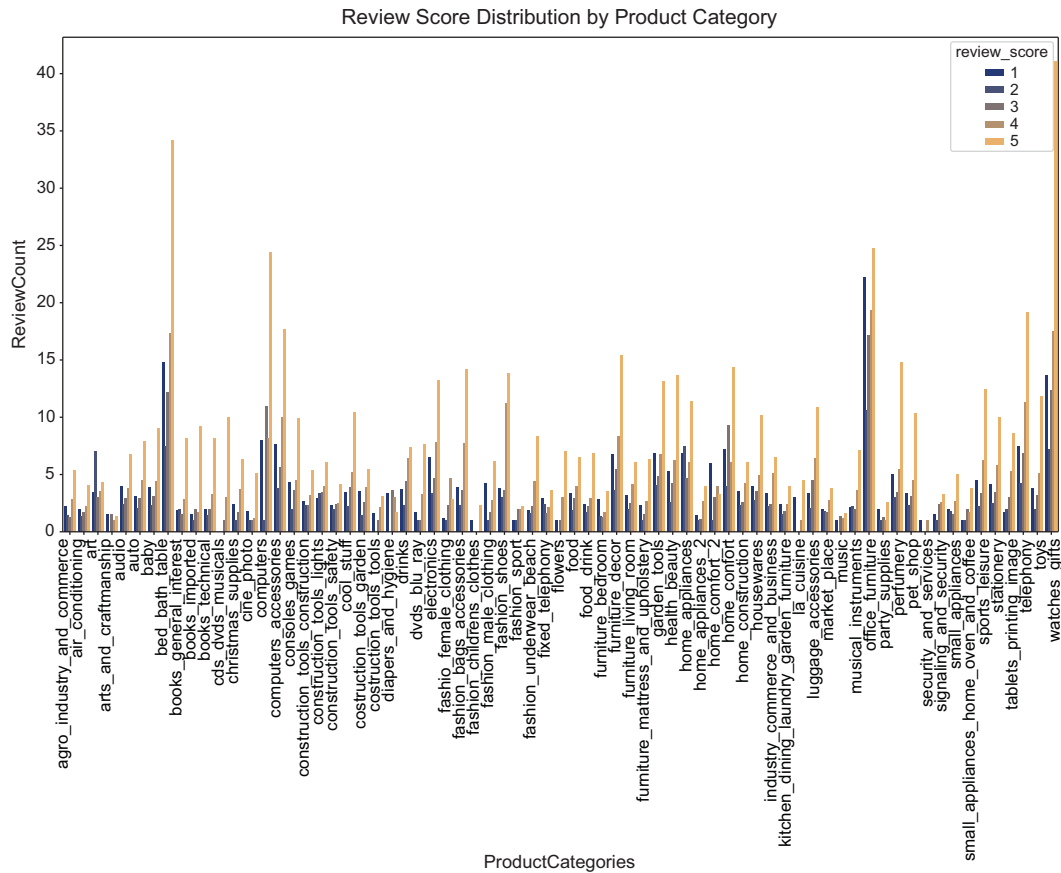


Figure 3.6 Grouped bar plot showing review score counts by product category

It looks like generative AI was able to estimate that the size of the results will be bigger than the previous ones. Figure 3.6 shows that it wasn't wrong. At this time, the advised course of action would be a trip to a stakeholder, who will receive this analysis and a solid heart-to-heart. They could decide to accept the oversized chart and promise never to print it, or they could propose an aggregation meaningful to them.

For the sake of argument, we will assume that this analysis is being prepared for an elevator pitch and, as such, cannot be approved in advance. Let's divide the reviews into positive (4 or 5 points) and negative (1, 2, 3 points), with us arbitrarily deciding what scores are considered positive (and negative). Getting the code from generative AI is straightforward.

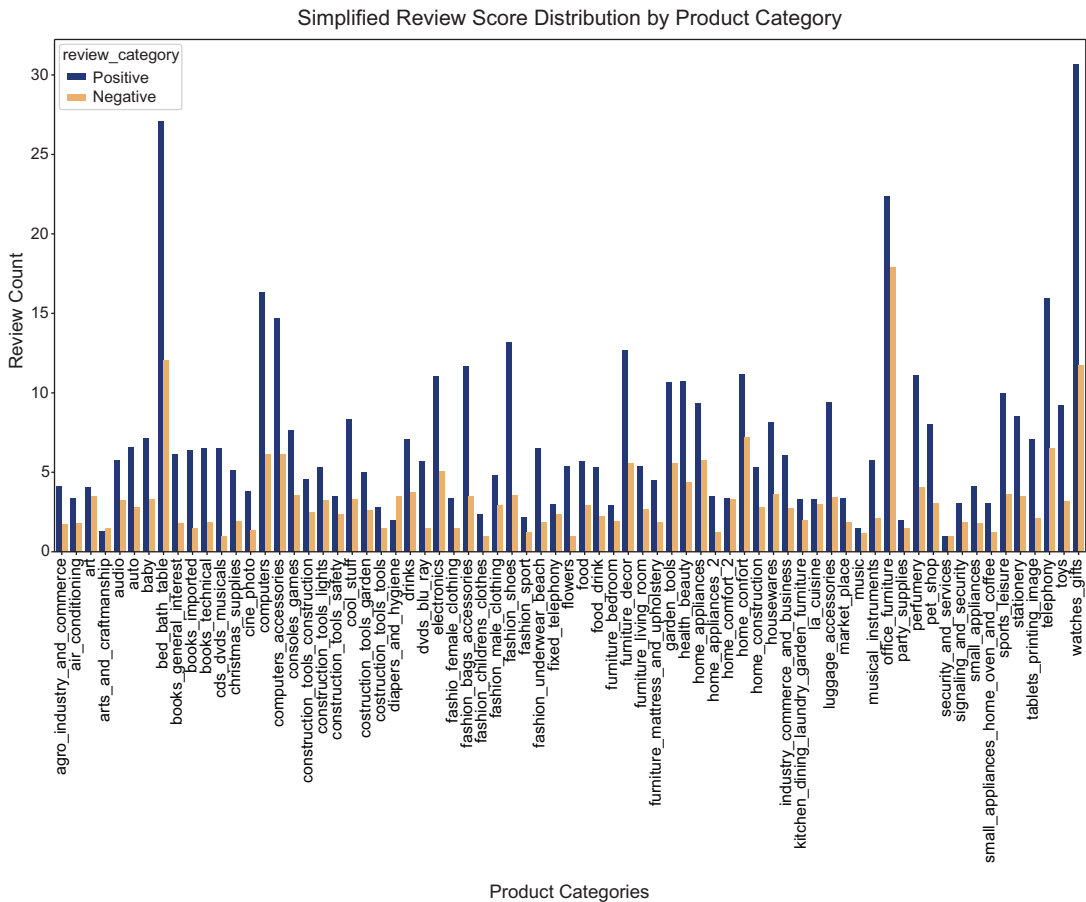


Figure 3.7 Grouped bar plot showing aggregated review score counts by product category

As shown in figure 3.7, the result is a bit more readable than figure 3.6. With “bit” being the key word.

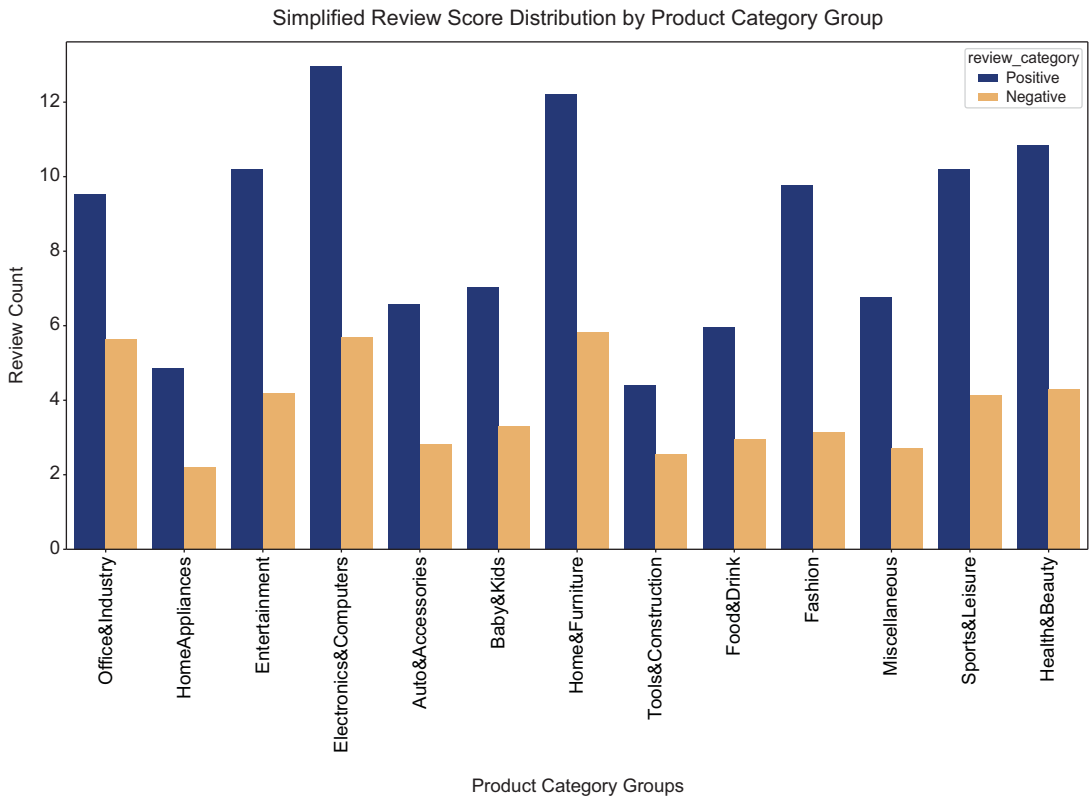

As seen in figure 3.8, the result is much more comprehensible than previous versions.

Having secured analyzable results of the review score distribution, we can now move on to the last of the descriptive analyses—the description of order statuses and their distributions.

### 3.3.4 Order status

There are multiple reasons to research order statuses, from identifying problems with logging systems to improving the user experience. To answer the question, “How does the order status (e.g., delivered, shipped, etc.) vary across different regions, product categories, and sellers?” we will extract information about types of order statuses across categories and regions. Later, in section 3.4, we will do a more advanced regression analysis on delivery times.

This will be a recurring theme in your work. You will take a first glance at the data when cleaning it, a second during descriptive analytics, and sometimes then decide what data is rich enough to drive data modeling. This may seem inconsistent with our previous remarks about having a strict protocol, but that’s not the case. Your protocol should be flexible enough to allow for evaluation and decisions.

Generative AI will readily provide the code needed to merge the necessary DataFrames to get the required information in one place, and then to group and analyze the data.

The code is simple enough to work without a hitch. A glance at the resulting DataFrame shows that some orders have the status of *approved* but have apparently never shipped. This could be investigated further.

However, with a result including 7,524 rows, we need something worth a thousand words to analyze these results. Fortunately, in data analytics, as we prove over and over again, the power of generative AI goes way beyond code generation.

 What type of visualization would you propose for the previously generated `status_distribution_sorted` DataFrame?

 For the `status_distribution_sorted` DataFrame, a stacked bar chart would be an appropriate visualization. This will allow you to display the distribution of order statuses for each product category while also making it easy to compare the total number of orders among product categories.

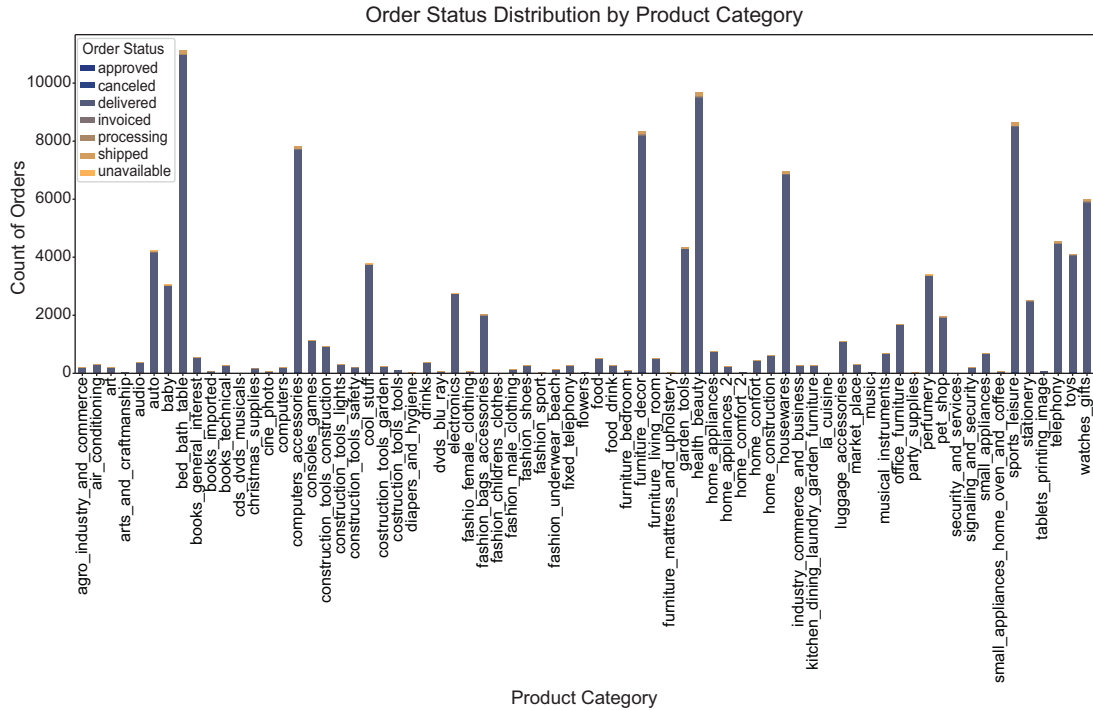

If we were to just going to generate another bar chart, we wouldn't bother you with reading this section. Let's try to go beyond the obvious and add our own twist to the question proposed by our AI advisor.

This visualization will help us identify any patterns or trends in delivery time based on the customer's and seller's locations. Keep in mind that this is a high-level overview, and further analysis may be required to draw more specific conclusions.

Interestingly, this time we received the end-to-end solution. From merging required DataFrames, to feature engineering (creating a completely new column), to visualization! That's impressive.

In the notebook in our GitHub repository, you'll notice that the initial visualization is less than impressive. The data distribution is clearly skewed toward low values, while high-value outliers “hijacked” the upper part of the color range, leaving the vast majority of results barely distinguishable. In addition, the order of regions on both axes is random. However, it wasn't much work to get code to deal with these problems.

Applying generative AI's suggestion to use the logarithmic scale solved the “blueiness” problem we encountered, and the alphabetical order of regions makes finding relevant pairs much easier. As you can see in figure 3.10, the result is a perfectly analyzable image; we will conduct the analysis itself in chapter 4. For now, it's enough to see that there are indeed differences in delivery times depending on the region.

### “WHEN WE TALK ABOUT TASTES AND COLORS, THERE IS NOTHING TO BE DISPUTED”

Certain elements of human perception may be hard for a computer program to notice. If done properly, things like the distribution of colors or order of elements will enhance the human ability to absorb the information presented. You can try to get some theoretical background and sound advice from generative AI, but the responsibility for the clarity and readability of the final results is on you.

In this section, you learned that generative AI can provide you with the code required to perform all the necessary elements of descriptive analytics. It's not error-free, but you must remember that LLMs do not run actual calculations or transformations,

despite being computer programs. They generate answers based on their understanding of the language patterns involved in mathematical reasoning rather than by performing a numerical calculation. The accuracy of the provided answers depends on how well-represented related mathematical patterns are in the data they were trained on. However, descriptive analysis is relatively easy. Let's see how well our AI advisor fares when facing more demanding tasks.

### 3.4 Inferential analysis

In the previous section, you mainly visualized data, grouping it this way or another along the way. Luckily (from the business decision-making perspective), or unluckily (from your workload perspective), there is more to descriptive analysis than bar and line charts. More even than scatterplots.

Imagine that your organization has recently implemented a novel marketing strategy aimed at increasing product sales. The plan was rolled out across several regions with distinct market dynamics and consumer behaviors. To evaluate the strategy's effectiveness, you need to determine not only whether sales have increased post-implementation but also if the observed changes can be attributed directly to the marketing efforts rather than external factors or mere chance. Furthermore, you're tasked with identifying which specific strategy elements were most effective in different regions and among various demographic groups.

The toolbox you need to open for more advanced problems is called inferential or inference statistics. *Inference analysis* is a branch of statistics that focuses on drawing conclusions about a population based on data obtained from a sample (inferring things about the population based on what you find in the sample—it does what it says on the tin, really). It is grounded in probability theory and employs various statistical tests and methods to estimate population parameters, test hypotheses, and assess the strength and direction of relationships between variables.

The following sections will test generative AI's ability to guide us through this statistics-laced minefield.

#### 3.4.1 Before you begin

Unfortunately, we need to put on our Don Quixote cap (or helmet) for a moment. The methods we will show you are not very popular, and you may rightfully ask yourself, why don't we use methods we'll find in most textbooks or websites? There are a couple of reasons for that.

First, we perceive our role as pointing you to ways of doing things right, where right means analyzing your data in a way that allows you to draw correct conclusions.

The second reason results from the availability of generative AI. Where previously you'd need to spend a considerable amount of time learning the intricacies of statistics to even begin to do things right, you now have, at your fingertips, all the required knowledge and a tool to parse and explain it to you in a way you'll feel comfortable with. Plus, this tool will provide the complete code to perform the analysis as a bonus.

**THE IMPORTANCE OF USING CONFIDENCE INTERVALS IN INFERENCE ANALYSIS**

In section 3.1, we mentioned that we disagree with generative AI's popularity-based approach to selecting methods for evaluating the results of statistical analyses. We realize that for the majority of our readers, the concept on which we base the following analyses may be new, so we'll present an overview here.

We already mentioned that the role of inference analysis is to draw conclusions about the population from the sample. Imagine we wanted to know the average monthly spending of our company's customers on some product category (one they may also buy outside of our company). Since it's not feasible to survey all our customers, we may decide to randomly select 100 customers and calculate their average spending. Let's assume the result turned out to be \$200.

The sample might not perfectly represent our entire customer base. We would then calculate the *confidence interval* (CI) to account for potential variability. A 95% confidence interval for average monthly spending might be between \$180 and \$220. This means that we can be 95% confident that the *true* average spending of all customers on this product category lies within that range. In other words, if we repeat the sampling and CI calculation 100 times, 95 of the calculated confidence intervals will contain the true mean.

Confidence intervals offer certain advantages over more widely used null hypothesis significance testing (NHST), or p-value, as they provide a range of plausible values for the population parameter, allowing for a more comprehensive understanding of the effect size and its uncertainty.

Therefore, confidence intervals contribute to a better interpretation of the results and more informed decision-making. This is why, despite the general, popularity-driven consensus approach proposed initially by ChatGPT, we modified the proposed analysis design for the questions we will discuss in following subsections and explicitly asked our AI advisor to focus on methods utilizing confidence intervals.

**AN IMPORTANT NOTE ON THE COMPLETENESS OF THE DATA**

We use inference statistics here because we know that the data we have is a sample of a bigger set. If you work with a full dataset, such as all the customers you have and all the transactions made, there is no need to calculate confidence intervals for the purpose of historical data analysis, as your sample *is* your population. However, inference statistics will come in handy if you want to use your data for any kind of predictive analytics.

We are now equipped to plunge back into analyzing our e-commerce data.

**3.4.2 Relationship between product attributes and shipping costs**

The question, "What is the relationship between product attributes (e.g., weight, dimensions) and overhead costs (e.g., shipping costs)?" posed by our AI advisor may seem a little naive, but it will help us build an intuition about the power of confidence-interval-based linear regression. The importance of this tool is impossible to overestimate. You will encounter it when working in various fields:



- *Economics*—Economists use linear regression to understand the relationship between economic indicators, such as GDP growth and unemployment rates, or inflation and interest rates. Confidence intervals in these regressions help policymakers assess the reliability of these relationships when making fiscal or monetary policy decisions.
- *Finance*—In finance, linear regression is used to model the relationship between the risk and return of assets, as described by the capital asset pricing model (CAPM). Analysts use confidence intervals to gauge the precision of beta coefficients, which measure the sensitivity of asset returns to market movements, thereby informing investment strategies.
- *Healthcare*—Researchers employ linear regression to study the relationship between various risk factors (e.g., smoking, diet, physical activity) and health outcomes (e.g., heart disease, diabetes). Confidence intervals around the regression coefficients provide insights into the significance and reliability of these factors, guiding public health recommendations and patient treatment plans.
- *Marketing*—Marketing analysts use linear regression to understand how different aspects of marketing strategies (e.g., advertising spend, promotional activities) influence sales or customer behavior. Confidence intervals help in assessing the strength of these relationships, optimizing marketing budgets, and tailoring strategies to maximize ROI.
- *Real estate*—Linear regression models are used to predict property prices based on features such as size, location, and amenities. Confidence intervals around the predictions provide potential buyers and sellers with a range of expected prices, aiding in negotiation and decision-making processes.
- *Environmental science*—Scientists apply linear regression to model the impact of human activities on environmental indicators, such as CO<sub>2</sub> emissions and global temperature rise, or the effect of environmental variables on biodiversity. Confidence intervals help quantify the uncertainty in these models, crucial for environmental policy and conservation strategies.
- *Manufacturing*—In the manufacturing sector, linear regression is used to model the relationship between production processes (e.g., temperature, pressure, material properties) and product quality or yield. Confidence intervals allow engineers to understand the variability in these processes and to optimize them for better outcomes.
- *Education*—Researchers use linear regression to explore the impact of educational interventions (e.g., class size, teaching methods, technology use) on student performance. Confidence intervals provide a measure of the effectiveness and reliability of these interventions, informing educational policy and practice.
- *Sports analytics*—Linear regression is applied in sports analytics to evaluate the performance of players based on various metrics (e.g., scoring, defensive actions) and their impact on game outcomes. Confidence intervals around these estimates help teams make strategic decisions about player training and game tactics.

- *Technology and innovation*—In technology companies, linear regression can analyze the relationship between features of a product or service and user engagement or satisfaction. Confidence intervals around these relationships guide product development, feature prioritization, and customer experience strategies.

In our opinion, quantitatively checking how much one thing depends on the other is irreplaceable in any decision-making process. Fortunately, generative AI can help you go through the whole process quickly and efficiently.



How can I check if there is a relationship between product attributes (e.g., weight, dimensions) and shipping costs?



To investigate the relationship between product attributes (e.g., weight, dimensions) and shipping costs, you can use a linear regression model with confidence intervals. First, let's combine the necessary data from the `df_products` and `df_order_items` DataFrames:

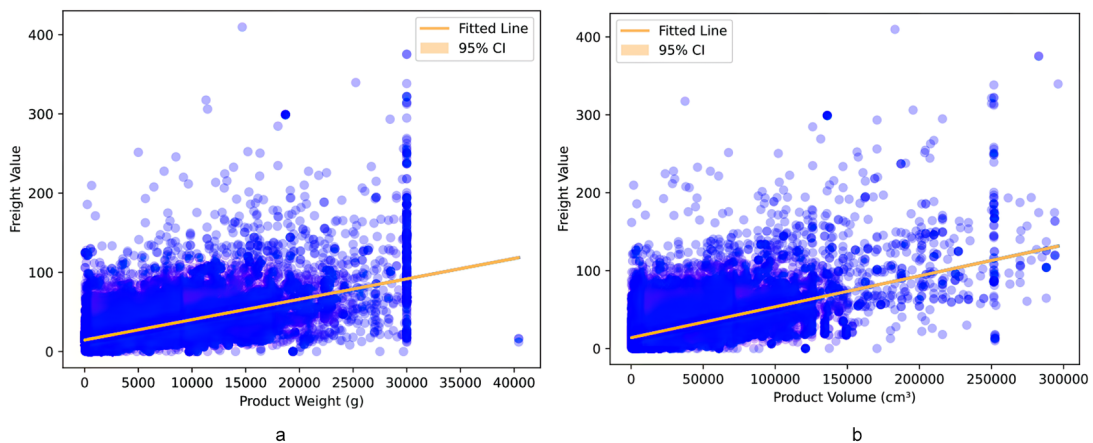

By examining the plots and their 95% confidence intervals, you can determine whether there's a relationship between the product attributes and shipping costs. A narrow confidence interval around the fitted line indicates a stronger relationship between the variables, while a wider interval suggests more uncertainty in the relationship.

Our AI advisor proposed a complete solution. It engineered the required DataFrame, built regression models, and proposed a visualization of results. The latter turned out to be way more cluttered than we could hope, but it is presented in figure 3.11 nevertheless.

There are interesting vertical lines of data points at 30,000 g and 25,000 cm<sup>3</sup> in figure 3.11. We guess it's caused by some standard package sizes used by delivery companies across Brazil.

The other thing worth discussing is that the confidence interval is so narrow that it's not even visible in the picture. That means, from the statistical point of view, that the line most likely is where we drew it—we have so much data that we can be sure about our estimation's precision. That doesn't mean this regression is immediately useful, though.

The results are spread wide around the regression line. Its predictive power seems to be low, to say the least. If we have a package of 20 kg, for example, we can estimate its freight value to be anywhere between 0 and 200 BRL (it's our assumption that that's the monetary unit the data provider uses).

**HOW MUCH WOOD WOULD THE WOODCHUCK CHUCK?** The main value of regressions is their ability to predict dependent variables based on a set of independent variables. To assess the performance of a regression model, we may employ various metrics, such as mean absolute error (MAE), mean squared error (MSE), root mean squared error (RMSE), and  $R^2$  (coefficient of determination). These metrics provide insights into the model's accuracy, the magnitude of the errors, and the proportion of the variance in the dependent variable explained by the independent variables. Additionally, residual analysis and diagnostic plots can be used to examine the model's assumptions, such as linearity, homoscedasticity, and the normality of residuals.

We promised you a quantitative analysis of the dependency, and we're not going to stop at drawing a chart this time. These are several commonly used metrics that you'll want to look at when analyzing regression data (especially in the context of its predictive power):

- *Mean absolute error (MAE)*—The average of the absolute differences between predicted and actual values. It gives an idea of how wrong the predictions are. A smaller MAE indicates better predictive performance.
- *Mean squared error (MSE)*—The average of the squared differences between predicted and actual values. It tends to penalize large errors more than small ones. A smaller MSE indicates better predictive performance.
- *Root mean squared error (RMSE)*—The square root of the MSE. It has the same units as the dependent variable and is more interpretable than the MSE. A smaller RMSE indicates better predictive performance.
- $R^2$ — $R^2$  measures the proportion of variance in the dependent variable that can be explained by the independent variable(s). A higher  $R^2$  value indicates better predictive performance.

As usual, accepting the help of generative AI is the quickest way to get code that calculates all of these values.

The results show that just about 35 percent of the variability in the freight value is explained by product weight or volume. It may be interesting to see if combining the two would increase the available predictive power.

**NOTE** You can learn a lot about the measurements and parameters used in statistics from the perspective of someone dealing with money, rather than basic science, from *Mostly Harmless Econometrics* by Joshua Angrist and Jörn-Steffen Pischke (Princeton University Press, 2009).

The critical information here should be  $R^2$ , which tells you that almost 40% of the variability in freight value can be explained by product weight and volume variability. This means that by controlling and optimizing these two variables, you can impact the freight value. If the freight value is an essential factor of the overall cost of the product, this result could lead to the conclusion that it would be worth trying to reduce the weight or size of products without reducing their functionality or quality. This could lead to freight cost savings.

**BEGGARS CAN'T BE CHOOSERS** As we explained in chapter 2, the quality of results depends heavily on the quality and accessibility of data. Given a choice, you should avoid proposing business solutions based on data with the spread seen in figure 3.11. The observed effects are also not too significant. However, the key phrase is “given a choice.” Sometimes you will not have any better data, and your business may require any support it can get. Relying on even imperfect results like these may mean the difference between letting the business sink and giving it a fighting chance.

We will spend a bit more time drawing conclusions from this result in chapter 4. For now, we'll turn our attention back to the review score.

### 3.4.3 *Relationship between product, transaction, shipping attributes, and the review score*

Your boss would be proud of you if they saw you doing what we will do in this section—merge the three research questions proposed by our AI advisor into one:

- “What factors (e.g., delivery time, price, product attributes) contribute to differences in the average review score?”
- “How do different payment methods and the number of payment installments affect order completion rates and customer satisfaction?”
- “What is the impact of delivery time (actual vs. estimated) on customer satisfaction and review scores?”

The method of answering them is identical, so why waste time (which is money) doing the same work three times? Well, that would only work if you don't care too much about the reliability and accuracy of the results. That's an important lesson: even if you technically can do something, it doesn't mean you should.

**LESS IS MORE** In regression analysis, you could hope that the more independent variables you drop into the model, the better the result, but that is not necessarily the case. Too many variables may muddy the water, so to speak, as they can result in either overfitting the model or causing issues related to

multicollinearity. Overfitting means your model starts to fit the noise, rather than the underlying patterns, and it usually occurs when you have too many parameters in relation to the number of observations. Multicollinearity occurs when two or more predictor variables are highly correlated—the estimated coefficients may then become unstable and sensitive to minor changes in the data. This instability makes it difficult to reliably interpret which variables are genuinely impactful and how much they contribute to explaining the dependent variable.

We have only limited information on the product and transaction process. We also know already that the majority of transactions are finished when they are delivered. This should prepare us not to expect great success in finding a correlation between these factors and the level of happiness expressed by the customers in their reviews. However, we think the techniques for investigating such relationships are worth learning about.



What inferential statistics should I use to research how the average review score varies across different product categories, and what factors (e.g., delivery time and its difference vs. estimation, price, product, and payment attributes) contribute to these differences?



To use inferential statistics to research how the average review score varies across different product categories and how factors like delivery time, price, and product attributes contribute to these differences, you can follow these steps:

- 1 Prepare the data:
  - a Create a DataFrame containing the necessary columns: product category, review score, delivery time, price, and product attributes (e.g., weight, dimensions).
  - b Merge the necessary DataFrames to obtain this information.
  - c Ensure there are no missing values and convert categorical variables to numerical format if required.
- 2 Perform ordinal logistic regression:
  - a Since the review score is an ordinal variable (1-5), you can use ordinal logistic regression to model the relationship between the review score and the factors of interest (product category, delivery time, price, and product attributes).

With this approach, you can explore the relationship between the average review score and various factors using ordinal logistic regression.

If the comment in the code saying “assuming you have already merged necessary DataFrames into analysis\_df,” was not a red flag for you, we’ve done a poor job so far. Whenever you see any assumptions on the part of the generative AI, you need to shiver, curse under your breath, and double-check them. We won’t include the whole conversation we had, trying to specify what generative AI hallucinated analysis\_df to be. You can see the final code in listing 3.6.

The DataFrame resulting from the preceding code will be devoid of all unnecessary information about identifiers, geographic locations, and timestamps, as they will not

be used in this particular analysis and would be unnecessary noise. We want to focus on variables of interest and their impact on review score.

The result of the logistic regression analysis is relatively easy to read.

This accuracy means that you can explain 43% of the variability in review scores.

**RIGHT ON THE MONEY?** Misinterpretation or overestimation of a model's accuracy can be very costly. A confusion matrix is a table layout that visualizes the performance of a classification algorithm, typically used in supervised learning. In binary prediction, it displays the number of correct and incorrect predictions made by the model, comparing them to the actual outcomes. The matrix is organized into four quadrants representing true positives (TP), true negatives (TN), false positives (FP; also known as type I errors), and false negatives (FN; also known as type II errors). By assessing the matrix, we can estimate the rate of type I errors, which occur when the model incorrectly classifies a positive instance as negative, and type II errors, which occur when the model incorrectly classifies a negative instance as positive. You'll find more information on error types in chapter 5.

In a multivariate confusion matrix, such as the preceding one, each row represents the actual class, while each column represents the predicted class. The elements on the main diagonal of the matrix correspond to the correctly classified instances for each class, while the off-diagonal elements indicate misclassifications. To get a better intuition, let's take a look at our classification of reviews and focus on the third column in the matrix, representing predictions of score three. In 109 cases, the classifier correctly assigned the score. It also misclassified 71 actual threes as twos, 401 as ones, 100 as fours, and 208 as fives.

To make analysis easier, let's ask generative AI for the code linking the received result with the remaining variables.

The interpretation of coefficients resulting from the ordinal regression is similar to the interpretation of results we obtained from the linear regression, if not so straightforward. The resulting numbers represent the change in log-odds of being in a higher category of the outcome variable for a one-unit increase in the corresponding predictor variable, holding other variables constant. In simpler terms, when we're predicting something with a specific order, like "low," "medium," and "high," the coefficients give us information about how our prediction changes with input changes.

For example, let's say we want to predict a happiness level based on how many hours you sleep. The coefficient would tell us how much the odds of being "more happy" (moving up a level from "low" to "medium" or "medium" to "high") change for each extra hour of sleep you get. All of this is assuming that nothing else in your environment has changed. So, if the number (coefficient) is positive, that means getting more sleep increases the odds of being "more happy." If it's negative, more sleep decreases the odds. The bigger the number, the stronger the effect.

From the research perspective, it's not ideal to evaluate sleep's influence on your happiness if the increased sleep results from holidays from stressful work. Still, we're

not always given perfect testing conditions. The method described here could allow you to identify the influence of sleep if you provide multiple conditions and your mood record as input.

We will discuss how our coefficients translate to business insights in chapter 4.

#### **3.4.4 Differences in sales performance and customer satisfaction between sellers**

In this section, our focus will be on the differences between groups of sellers. We'll try to answer the question, "are there any significant differences in sales performance and customer satisfaction between sellers from different cities or states?"

As it's later in the chapter and you may be eager to move on to the next one, let's take a look at where this approach could be successfully applied. Who knows, maybe something here will be of interest to you:

- *Healthcare performance analysis*—Comparing patient outcomes (e.g., recovery rates, satisfaction scores) between different hospitals or healthcare providers to identify quality disparities and areas for improvement.
- *Educational achievement gaps*—Analyzing differences in student performance (e.g., test scores, graduation rates) across schools or districts to uncover educational inequalities and target interventions.
- *Marketing campaign effectiveness*—Evaluating the impact of different marketing campaigns across regions or demographics to determine which strategies are most effective in enhancing brand awareness or sales.
- *Human resource management*—Comparing employee satisfaction and performance metrics across different company locations or departments to identify best practices and areas needing attention.
- *Financial services comparison*—Analyzing loan approval rates or default rates across different branches to assess risk management effectiveness and customer service quality.
- *Supply chain efficiency*—Comparing delivery times or inventory turnover rates across different distribution centers to optimize logistics and supply chain management.
- *Product quality control*—Analyzing return rates or customer complaints for products manufactured at different facilities to identify quality control issues.
- *Environmental policy impact*—Comparing pollution levels or conservation outcomes across regions before and after the implementation of environmental policies to assess their effectiveness.
- *Retail chain performance*—Evaluating sales volumes or customer loyalty scores across different store locations to identify high-performing stores and understand factors contributing to their success.
- *Public policy and social programs*—Assessing the effectiveness of social programs (e.g., unemployment aid, public health initiatives) in different communities by comparing outcome metrics like employment rates or health indicators.

Before we jump into the analysis, we need to expose you to the method called bootstrapping.

Bootstrap methods are a powerful resampling technique you can use to estimate confidence intervals, especially when the underlying data distribution is unknown or difficult to determine analytically. The bootstrap approach involves generating multiple random samples with replacements from the original dataset, each of the same size as the original sample. This means that while constructing each sample, every data point from the original dataset can be selected multiple times, and the number of data points in each new sample matches the number in the original dataset. A statistic of interest (e.g., mean, median, or regression coefficient) is calculated for each generated sample. These calculated statistics form a bootstrap distribution for estimating the population parameter's confidence interval. A bootstrap distribution is essentially a frequency distribution of a statistic—like the mean or a regression coefficient—computed across multiple resampled datasets.

What does this mean in practice? Imagine you work for a company manufacturing extremely expensive equipment, such as quantum electronics. They need to make destruction tests to estimate safety parameters, such as the temperature the product can withstand. Destroying too many samples would literally bankrupt them, but let's assume they can afford to overheat 50 pieces of equipment. The engineers run the test 50 times and come to you with 50 breakpoint temperatures. The reliability of a simple average calculation isn't sufficient to satisfy the needs of clients, who want to know exactly how critical the cooling requirements are. Remember, we're talking about huge costs for the products, but also huge costs for ensuring safe operational requirements. Safety margins are good and nice, but widening them too much can make your product unfeasible for clients.

Enter bootstrapping. You create "new" test batches by randomly selecting 50 scores from your original test results, with replacement. In other words, some scores may be selected multiple times and others not at all, simulating a new batch of tests under identical conditions. You repeat this resampling process many times—let's say 10,000 times—each time calculating the average score of the resampled batch. This extensive repetition produces a wide range of possible breakpoint temperatures, reflecting the natural variability in your equipment's durability. The collection of these 10,000 breakpoint temperatures forms your bootstrap distribution. This distribution gives you a statistical model of what the average durability score for your quantum electronics equipment might look like, based on your actual testing data. Given this bootstrap distribution, you can determine the middle 95% (or 99%, or 99.9%) of the average breakpoint temperatures as your confidence interval. This interval provides a statistically sound estimate of where the true average breakpoint temperature of your equipment lies, offering insights into its performance and how it might hold up in real-world use.

The bootstrap method shines in situations where traditional assumptions (like the normal distribution of the data) may not hold, or where sample sizes are too small to

rely on the asymptotic properties of estimators (e.g., the simple calculation of a mean). Here are a few examples:

- *Startup performance metrics*—Early-stage startups often have limited data on customer behavior, revenues, or engagement metrics. Bootstrap methods can help estimate the variability and confidence intervals of key performance indicators (KPIs) like average revenue per user (ARPU) or customer lifetime value (CLV), providing valuable insights for decision-making despite small sample sizes.
- *Drug efficacy in clinical trials*—In clinical trials, especially early-phase trials with small sample sizes, the distribution of treatment effects can be skewed or multimodal due to heterogeneous responses among participants. Bootstrap methods allow for the estimation of confidence intervals around the median treatment effect or other non-normally distributed outcomes, offering a more robust understanding of the drug's efficacy.
- *Environmental impact studies*—Environmental data, such as pollution levels or species counts, often exhibit skewed distributions due to the presence of extreme values (e.g., very high pollution levels on certain days). Bootstrap methods can provide reliable confidence intervals for median pollution levels or mean species counts, which are more informative and robust for policy-making than simple means.
- *Economic policy evaluation*—Evaluating the impact of economic policies on outcomes such as employment rates or GDP growth often involves dealing with complex, non-normal distributions of effects across different regions or industries. Bootstrap confidence intervals can offer a more nuanced understanding of policy impacts, helping policymakers identify the range of potential outcomes and the reliability of estimated effects.

In each of these scenarios, the bootstrap method's ability to provide reliable confidence intervals without relying on strict assumptions about the data's distribution is invaluable. It allows researchers and practitioners to draw more confident conclusions from their data, even in challenging analytical contexts.

Let's move from quantum electronics and economic policies into more commonly encountered customer satisfaction issues. In the case of customer satisfaction, you will often operate on opinions collected from just a sample of the total number of customers. Only some customers will leave a review or answer a survey. Businesses should know, reliably, their customers' opinions across different categories.

Chapters 5 and 6 will discuss analyzing the reviews' texts. Here, we'll ask generative AI to prepare bootstrap-based confidence intervals for two numerical values important from the business perspective: average price and average customer review.

We will limit our attention to a single category of products. From the computational perspective, it doesn't matter if we drop in the whole DataFrame or a filtered selection. We would like, however, to point your attention to the importance of the business meaning of the analysis. In a real-life scenario, even selecting a single

category—in our case, “health and beauty”—wouldn’t be granular enough. Luxury and commodity products differ greatly in both prices and expectations. Mixing them does not offer sufficient insight into the market situation. Mixing them all together with car sales would muddy the waters even more, don’t you think?

Let’s get to the code.

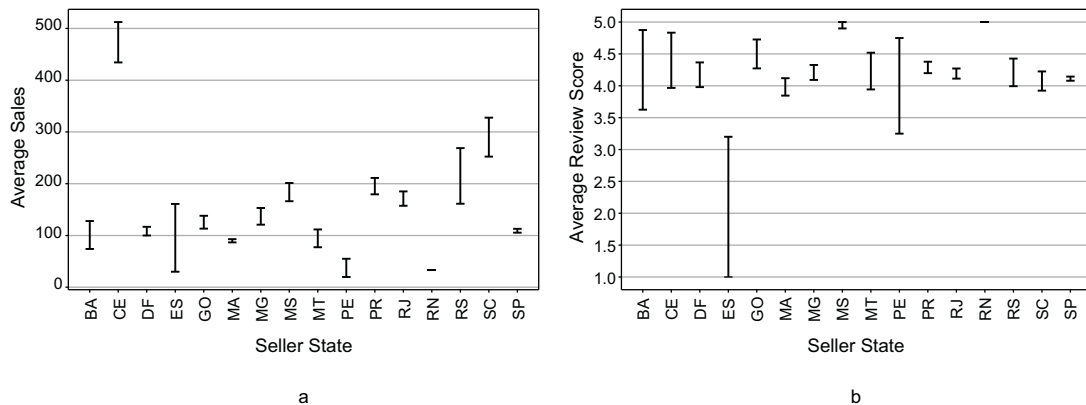

As you can see, going through data harmonization, statistical modeling, and visualization results in quite a substantial amount of code. Fortunately, generative AIs are capable of not only providing the code, but also commenting it in an informative way.

The confidence intervals calculated for our examples are presented in figure 3.12.

We would like to repeat that, while doing the full-scale analysis, you should prepare separate charts for each product category, or dig even deeper, to avoid comparing apples with oranges or visual clutter.

**A WORD ON SOFTWARE EFFICIENCY** There are two main elements of increasing program efficiency. One is to optimize code execution, and we write about that at length in chapter 7. The other one, oftentimes no less important, is the parameterization of the algorithm used. Bootstrap methods balance two main parameters: the number of resamplings and the accuracy of the confidence interval. If you analyze really big data, before you jump into the technical aspects of optimization, you should try to understand whether the parameters of the algorithm you are using don't offer ways of getting to your goal faster. Or at least closer to your goal. That's another bonus of learning about parameters—you can usually understand the results better if you know what the assumptions behind each of them are.

We can see some interesting differences in the results, but we'll leave interpreting the results for chapter 4. For now, we would like to leave you with a riddle: Why, when working with our example, does it make sense to use bootstrapping and calculate confidence intervals for our prices, and why would it most likely not make sense if you worked with your business data?

Having read this section, you should now be able to use inferential statistics and its different methods in your analytical work. In this chapter, you broke down the data and identified multiple relationships between different parameters. You used different visualization tools, like heatmaps and scatter plots, as well as regression analysis, to see how some parameters correlate with others.

**CORRELATION DOES NOT IMPLY CAUSATION** Sleeping with shoes on correlates with headaches in the morning, ice cream sales correlate with violent crimes, hair color correlates with ice-skating skills. These examples demonstrate that seeing a correlation is just a first stop in explaining observed phenomena. Often the correlation is caused by a third factor influencing your observed parameters. Sleeping with shoes on and headaches go hand in hand with alcohol overuse, ice cream sales and violent crimes result from heat waves, while blond hair is more often found in countries where you can find ice outside every now and then. *Never* assume causation on the basis of observed correlation without identifying a logical link between the observations.

There are many more methods in descriptive analytics, but after reading this chapter, you should be able to use generative AI to quickly identify and implement the best analytical tools for your dataset. All you need to do is to honestly and precisely describe the data you have available, and as honestly and as precisely as you can (which could mean not at all!), describe the goal of your analytics.

You should also be aware of generative AI's weaknesses. The most notable one is its tendency to hallucinate when asked about topics and data defined too long before the prompt. Also, the provided code always needs to be tested. Applying this “trust, but verify” approach, generative AI can substantially improve and accelerate your analysis process.

**Things to ask generative AI**

- What research questions related to the provided data can be asked?
- What analysis design would lead to answering the following question?
- What statistical method is best to analyze <available data>?
- Provide me with code to <data transformation>.
- How should I visualize <data structure>.
- Provide me with a solution answering the following question: . . .
- Modify the code to change the visualization format.

**Summary**

- Generative AI may be excellent at suggesting proper analytical tools and providing end-to-end analytical strategies.
- Generative AI will first suggest the most popular methods, but they can provide competent support in the implementation of more niche ones too.
- Generative AI may supplement analysis with market-specific information.
- Feeding generative AI with results to get insights requires caution and sometimes re-engineering of the output.

# 4

## *Using generative AI for result interpretations*

---

In the previous chapter, you performed a number of descriptive analyses and ended up with quite a few charts and some statistical modeling parameters. Yay! You can now bag it all and send it to your boss, right? Maybe . . . Depends on your boss, really.

In your work, you may encounter different types of managers. Some will be really well-versed in analytics themselves, and you'll be cooperating with them, learning a ton of useful stuff. They will accept your results and discuss assumptions and methods with you; they may ask you to do some analytics neither you nor your generative AI advisor expected in this context. All will be good. The kind of boss

you need to be wary of is the type with an overinflated opinion about their analytical skills. We won't dwell on this type, as dealing with these people is a matter of psychology, rather than data analytics.

The type relevant for this chapter are bosses who expect you not only to provide the results, but also to propose the interpretation. Some of them overlap with the first category we mentioned, and they want to help you understand the business better and grow as analysts. Others are too busy to be bothered with the trivial task of drawing business-critical conclusions. There is also a chance that you will be analyzing data for your own business (in this undoubtedly short period when your company won't be able to hire dedicated analysts).

Regardless of the reason, you may find yourself in a situation where you'll be scratching your head over the charts you prepared. To derive the most business value, you need to ensure that your interpretation of results is

- *Holistic*—When interpreting results, it's important to look at the big picture. Make sure your conclusions from one set of data don't clash with those from another. Consider all your findings together to get a full understanding of what the data is telling you.
- *Precise*—Be careful not to stretch your interpretations beyond what the data actually shows. Stick to the facts and avoid making assumptions that the data doesn't support. Remember, being accurate is more important than making the data seem more exciting or significant than it really is.
- *Well-communicated*—Make sure you explain your findings in a way that everyone can understand, whether they're a data expert or not. Use clear and simple language and visuals to share your insights. It's all about making sure your audience can easily grasp and act on the information you provide.

Regarding the last point, you may be required to engage in some form of storytelling. (You can learn more about AI-powered storytelling from another excellent Manning book, aptly named *Data Storytelling with Generative AI*, by Angelica Lo Duca.) The narrative-building skills are beyond the scope of this book, but in the other two aspects of your interpretation, generative AI can help you. This chapter will cover how to get helpful advice, from interpreting charts to enhancing results with a meaningful business context.

## 4.1 Problem definition

In previous chapters, we asked our generative AI advisor about the structure of the analytical process and about its implementation details, including writing the code. We then put real-life business data through the pipeline we created and got a handful of results. However, there is currently one big limitation of utilizing generative AIs for interpreting results: most of our results are in graphical format, while the large language models (LLMs) discussed here are, as the name suggests, language models, and as such excel at text-oriented tasks.

Multimodal generative AIs allow you to upload your images for analysis. However, we have discovered that the precision required to register visually minute differences between bar heights, for example, isn't there yet. We will be limited to describing the generated charts and asking for help in their interpretation. If we want to fully utilize generative AI's power, we need to provide our AI advisor with a proper context.



I performed a series of analyses on Brazilian e-commerce portal data. These include:

**1** Descriptive analysis of:

- the popularity of product categories per state, resulting in the heatmap of product categories on the y-axis, states on the x-axis, and value of sales as a value in cells);
- performance of products in categories and regions, resulting in:
  - a** a matrix scatterplot of average payment value, average freight value, and average product price against each other
  - b** grouped barplot showing the relation of average product price per category per region.
- review score distribution by product category, resulting in a grouped barplot showing review score counts by product category

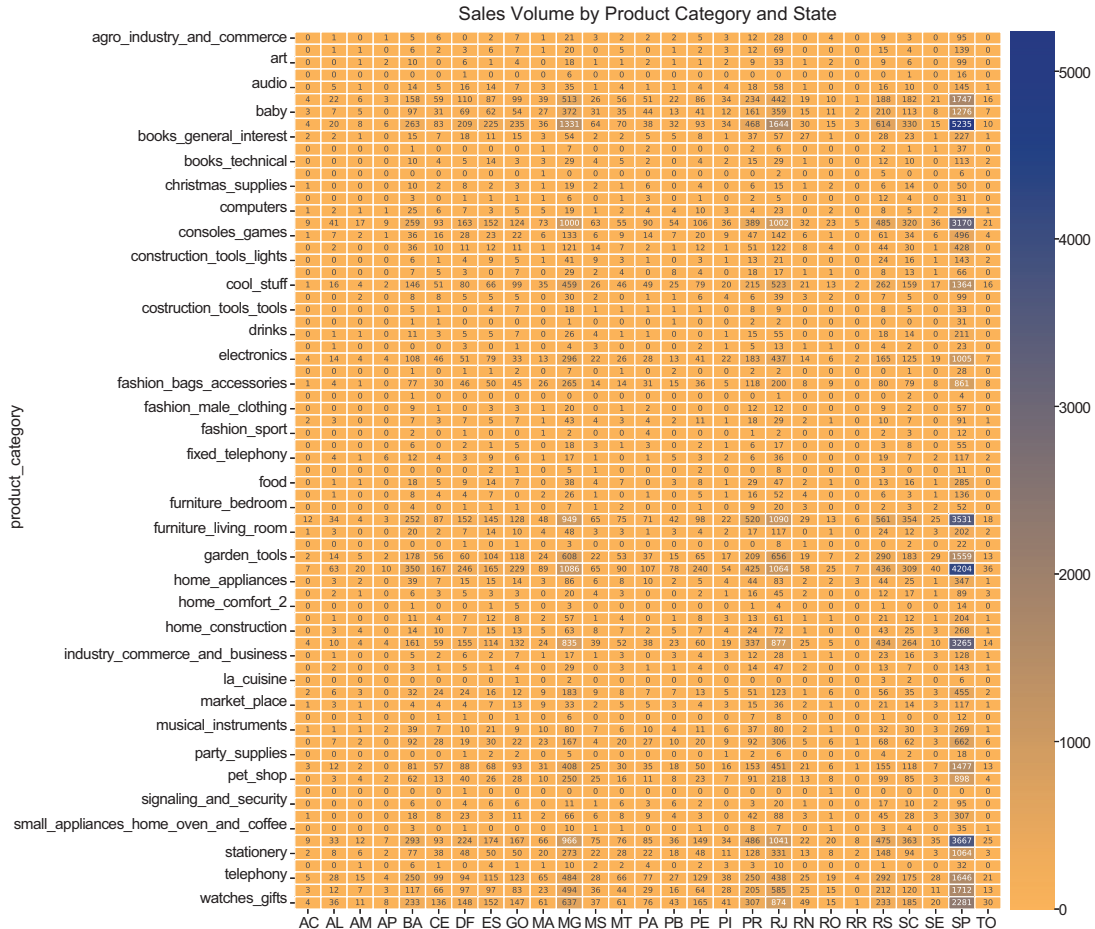

## 4.2 Popularity of product categories

Do you remember how we mentioned that your interpretation needs to be holistic, precise, and well-communicated? The reason behind the vagueness of these answers is a lack of detail in our prompt.

**IMPOSSIBLE IS NOTHING** The title of this callout is a blatant lie! The world of data analytics is full of limitations. In chapter 2, we explained how your analysis can only be as good as the data you have at your disposal. Generative AIs seem to be trained to respect such limitations and are reluctant to offer specific advice on the basis of vague data.

As a test, we uploaded into ChatGPT the whole table we built figure 4.1 on, but we didn't get any business insights in response. Instead, we got a set of data processing and visualizing instructions very similar to what we did in chapters 2 and 3. While ChatGPT is capable of running a simple analysis on a limited dataset, deploying a full-blown, multistep analytical pipe still requires data analysts.

What can you do if you still want to get more specific answers for the business? Provide more data. Focus on regions or products to make the analysis more specific. As retyping the data from the chart doesn't seem feasible, let's ask a generative AI for code to provide revenue for each state.

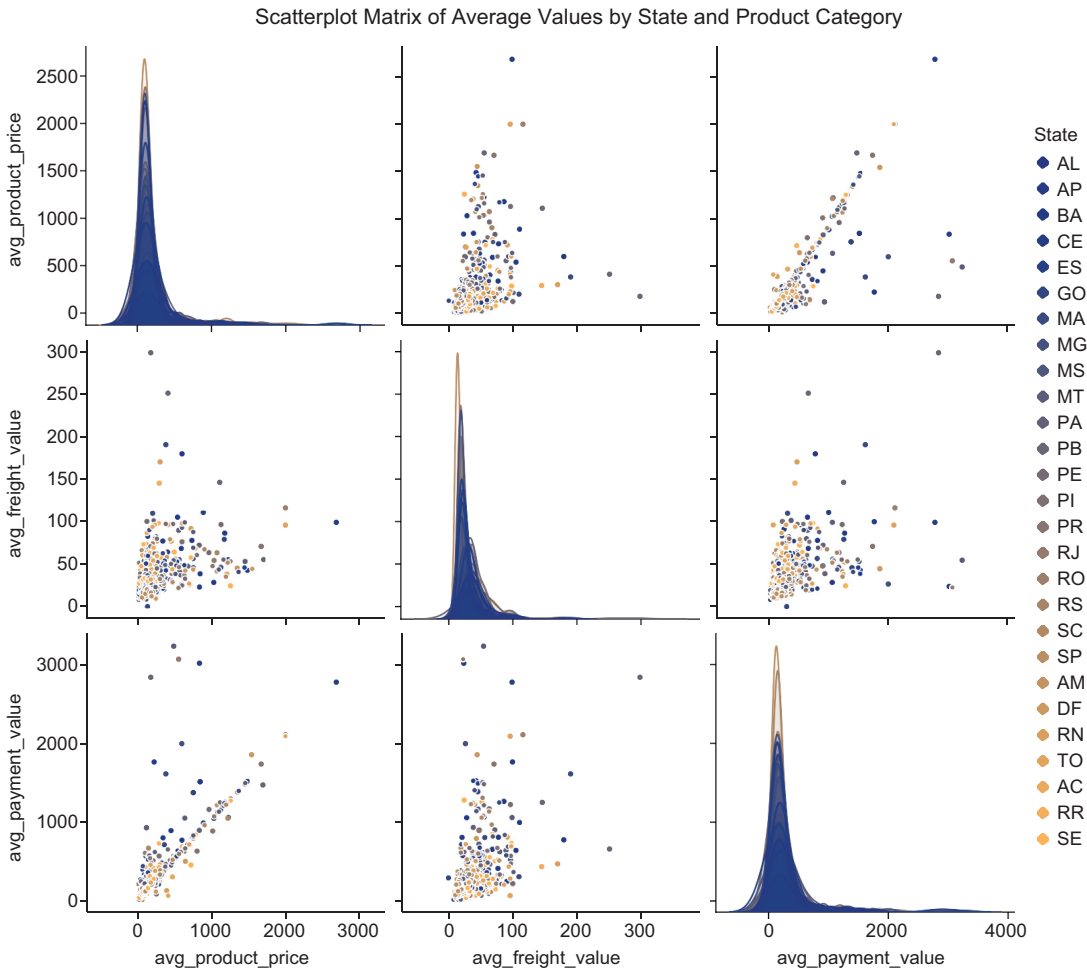

### **4.3** *Performance of products in their categories and regions*

The scatterplot we generated in chapter 3 when checking the performance of products in their categories and by region can be eye-glazing (figure 3.4). Let's have a look at it again in figure 4.2.

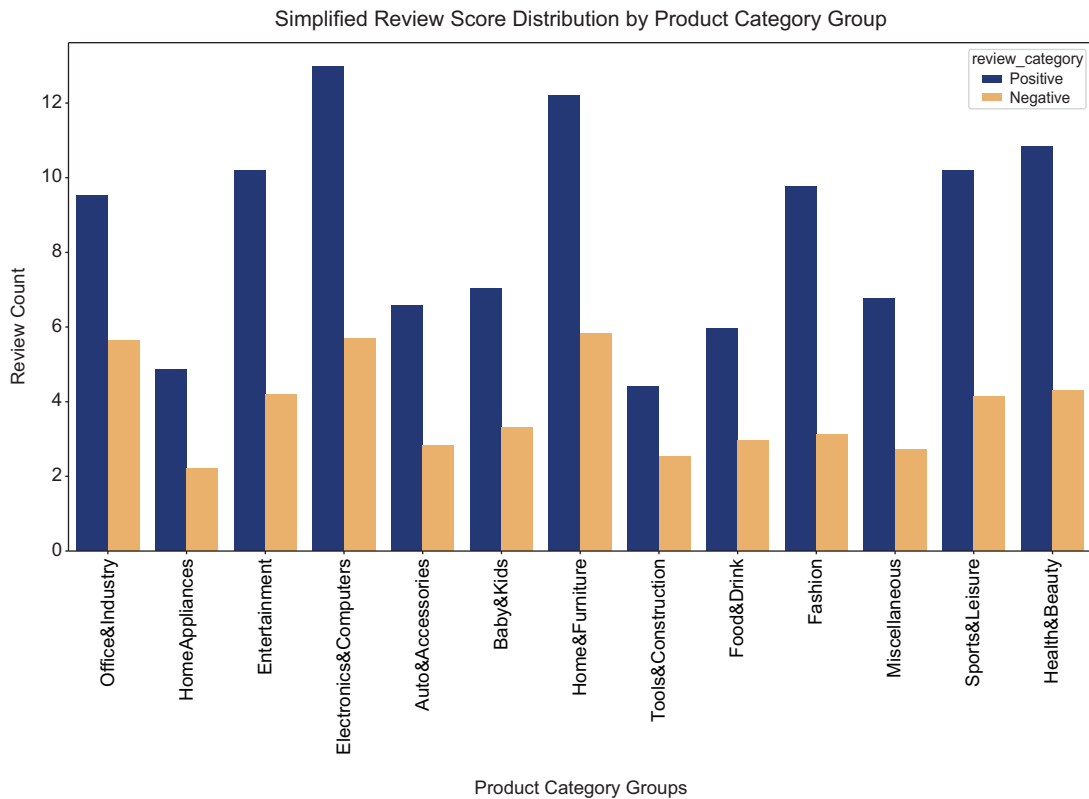
## 4.4 **Review scores distribution analysis**

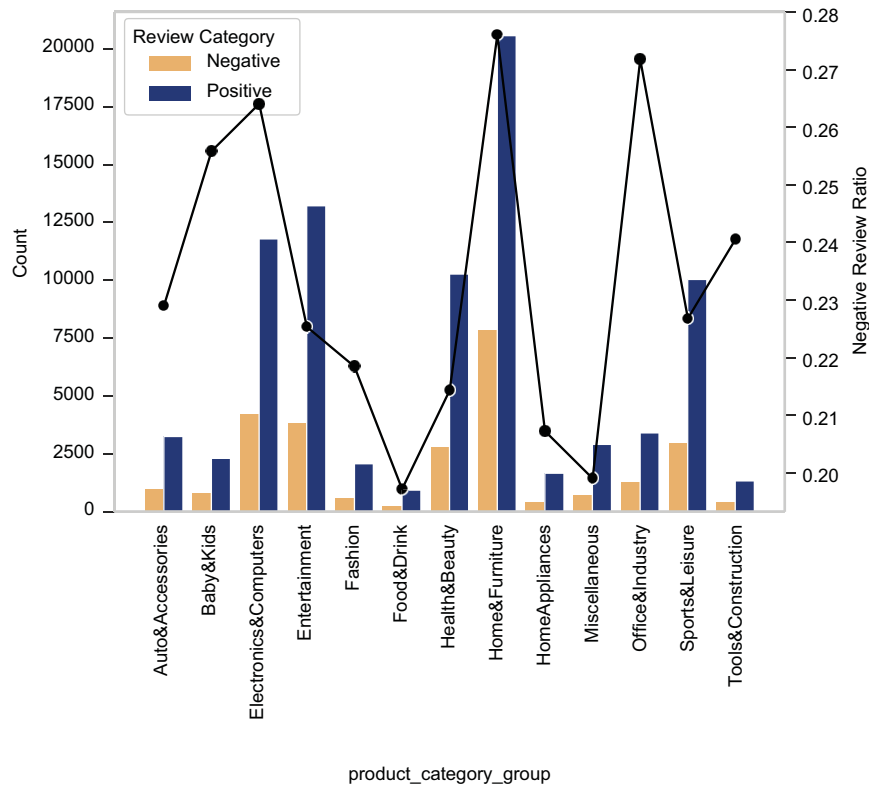

We will ignore the error related to library syntax and focus on the result presented in figure 4.4.

For some categories, you can see a really high number of positive reviews. Others clearly present a high ratio of negative reviews. It's important to note the scale on the right side. In this case, the differences in absolute values are not as dramatic as might be assumed from their amplitude on the chart. The raw number of reviews (both positive and negative) is a result of the high number of purchases in the category, so the ratio is a much better approximation of the relative happiness of customers with these purchases. A word of warning, though: if the raw number of reviews is really low, the ratio might not be representative.

We do realize that a similar result could easily be achieved in Excel. We performed this exercise because avoiding moving data between environments is very important. ## 4.5 Order status

We approached this part of the analysis with real curiosity. The interpretation of figures 3.9 and 3.10 from the previous chapter is relatively straightforward. The majority of orders have been delivered, which we should expect, given that we are working with data from five years ago. Orders that are neither delivered nor canceled should be analyzed one by one. Did some system error cause their status, or was there another reason?


The heatmap of delivery times shows big differences in the average delivery time. Let's visualize figure 3.10 again, as figure 4.5.

Gemini stuck to the vague "good advice."

Let's see if we will be able to get some specific insights now. Let's select two pairs of states, and ask our GPT advisor about expected differences.

## **4.6 Relationship between product attributes and the shipping costs**

In contrast, time spent on learning regression, one of the most powerful analytical tools, will be time well spent. In section 3.4.2, we presented you with a list of (not all) possible application areas for this methodology. But getting a result is one thing. Making sense of it . . . that's where the value of analysis is.

You might expect that only large  $R^2$  values are worth reporting (recall that the  $R^2$  value is a measure of what percent of the variability in the dependent variable is explained by the changes in independent or tested variables). These are certainly the values most desired by business stakeholders. Who wouldn't want to present a slide showing "85% of our sales are driven by our brilliant marketing"? I guess product development and customer support would turn green, but bragging rights are not the only business driver worth pursuing.

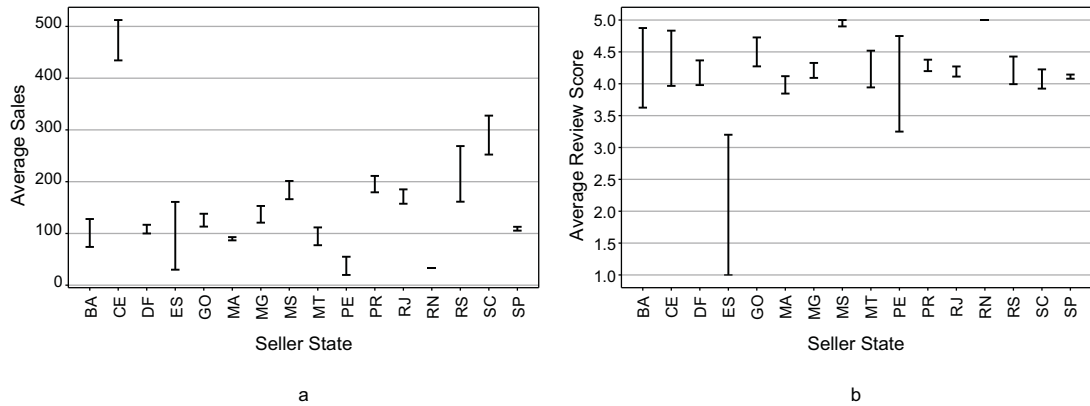

Both generative AIs provided us with a lot of food for thought on the basis of a couple of parameters, their coefficients, and a single-sentence business description. Before being transformed into airtight business recommendations, most of these results would need deep-dive analytics, but we got some solid leads, and that's more than we bargained for!

## 4.8 ***Differences in sales performance and customer satisfaction between sellers***

In chapter 3, we used the bootstrap method to calculate the confidence intervals for the average price of health and beauty products and for the customer satisfaction across Brazilian states. The resulting figure 3.12 is repeated as figure 4.6.



**Figure 4.6** Confidence intervals for (a) average sales price and (b) average review scores, for transactions in the “health and beauty” category of products

The first important part of analyzing this result is to understand that the actual average value is somewhere within the confidence interval. Somewhere—we don’t know where. The width of the confidence intervals depend on three main factors:

- The size of the sample
- The selected confidence level
- Inherent data variability

Many managers are used to seeing point estimations, and they want to be able to say that the average satisfaction of our customers is, for example, 3.7495735 points out of 5.

This is where we solve the riddle we posed in subsection 3.4.4. We asked you there, “why, when working with our example, does it make sense to use bootstrapping and calculate confidence intervals for our prices, and why would it most likely not make sense if you worked with your business data?” We calculated the average price confidence intervals, because we know from the exploratory data analysis that we are working with a subset of the data. In our table, we don’t have all the transactions for the analyzed period. If you work with complete data, your average sales price *can be* USD 3.7495735 (the purposefulness of reporting it with this level of accuracy is a different issue altogether). You don’t *estimate* the average of a complete population—you *calculate* it.

Working with surveys requires *estimation*, and estimations come with inherent limitations in *accuracy* and are subject to *uncertainty*. It’s crucial to account for this uncertainty in the decision-making process.

Have a look at figure 4.6.b, which shows the confidence interval between the SP and PE states. Customers in which state are more satisfied? We don’t know, mainly because we don’t really know how satisfied PE customers are.

In the figure, we have some conclusion-ready confidence intervals. ES customer satisfaction requires immediate attention, and that would be obvious even if you just

calculated average scores. The average price of products in CE is much higher than anywhere else in the country.

There is more to analyzing confidence intervals. The most obvious interpretation is that if the confidence intervals calculated for two categories (e.g., states) are not overlapping, the actual calculated values indeed differ. There are analytical methods for estimating the difference of the overlapping confidence intervals, but we won't follow this rabbit hole here. In many business contexts, the width of the confidence intervals, which indicates the estimate's precision, can be just as crucial as the difference between the estimated values themselves. A narrower confidence interval implies greater precision and reliability in the estimate, which is important from an informed decision-making perspective.

Throughout this chapter, our generative AI advisor proved invaluable in crafting analyses, offering relevant questions that could be addressed using the available data, supplying code to transform that data into visualizations and models, and providing insightful hints about the results' significance and potential avenues for further analysis and business implications.

The process also revealed the weaknesses of generative AIs. The most notable is their tendency to hallucinate when asked about topics and data defined too long before the prompt. Also, the provided code needs to be tested, as sometimes it's buggy and sometimes prepared for outdated library versions.

All in all, we determined which topics are important to research with just a couple of discussions with generative AI about the goals of your analysis and what it could look like, running some code it developed for you, and then another couple of discussions on results. When you get fluent and choose the generative AI best fitted to help in your problems, you'll be able to do it in a couple of hours instead of days!

# *Basic text mining using generative AI*

In previous chapters, you dealt with numerical data and learned the basic analytical methods for translating a bunch of numbers into sound business advice. This chapter and the next will show you how to deal with something far more sinister than numbers—text. Most of the text you’ll encounter won’t be clean, literary language that an author has double-checked and had edited by specialists. More often, you will deal with hastily prepared notes, offhand reviews, and emails. Such data is riddled with errors that can significantly impact the quality of analysis and results. These include spelling mistakes, typographical and punctuation errors, and irregular use of capitalization. Additionally, texts often contain irrelevant or redundant information such as headers, footers, or metadata, as well as linguistic noise from nonstandard abbreviations, slang, or jargon. Just when you think you are prepared



to handle all this by adapting your text-cleaning functions, you may encounter another exception, like a piece of . . . ASCII art!

To make things worse, most text analysis is done on an amount of text exceeding the average person's capacity for bedtime stories, especially since a lot of text you'll work with is the stuff of nightmares. Fortunately, people who were likely fond of different types of literature developed many methods enabling them to draw conclusions from large amounts of text without reading it all. We'll discuss some of these techniques in this and next chapter. And thanks to generative AI, they are readily available to you.

In particular, chapters 5 and 6 will guide you through the complexities of unstructured textual data to extract valuable insights, patterns, and knowledge. By the end of this chapter, you will be equipped to harness generative AI for a broad range of foundational text-mining tasks, all while avoiding the typical pitfalls associated with large language models (LLMs), such as hallucinations or ad hoc changed assumptions. As in previous chapters, you will learn how generative AI can aid you in information gathering, analytical planning, data interpretation, and coding, as well as enable you to perform quick, initial text analyses—either through direct interaction with the model or by leveraging its API. Moreover, you will learn about more of generative AI's limitations, recognizing when they may provide unreliable results, and also about identifying key factors you'll need to watch to ensure accurate results.

In this chapter, we will perform an analysis of customer reviews. You will also see how the polyglot abilities of generative AIs are invaluable for handling data in foreign languages. Additionally, you will be impressed by the generative capabilities of LLMs to summarize findings in a format that is ready to be presented to your boss.

## 5.1 Text mining in the era of generative AI

Even with well over half of internet traffic being dedicated to certain types of videos and unwanted marketing communications, there is a lot of data movement left to analyze. And there is a chance some of it will end up on your computer, with the expectation that you'll be able to draw some insights from the content. As we mentioned in the chapter's introduction, a lot of this data might, in fact, be text. The ever-increasing volume of unstructured textual content from social media, websites, emails, company documents, and academic publications has elevated the role of text mining.

Text mining employs the combined powers of natural language processing (NLP), machine learning (ML), and artificial intelligence (AI) to convert the deluge of unstructured text into organized data for more straightforward analysis and interpretation. NLP is crucial, as it allows systems to understand and manipulate human language, converting sentences into structured forms that a computer can understand. For instance, NLP techniques can break down text into components like phrases and sentences, identify parts of speech, and extract relationships and entities. This structured data is then more amenable to analysis. ML complements this by providing models that can learn from the structured data, identifying patterns or predicting outcomes

without being explicitly programmed to look for something specific. This is particularly useful in sentiment analysis or topic modeling. Lastly, AI integrates these technologies to automate the entire process, enhancing the ability to make decisions or generate insights from large volumes of text data efficiently. AI systems can adapt to new patterns in text, refine their understanding over time, and handle a wide variety of text sources and formats, making the process of text mining more dynamic and context-aware.

In its final form, text mining enables the discovery of underlying patterns, trends, and insights, offering valuable capabilities such as sentiment tracking, trend spotting, threat identification, and a deeper understanding of customer preferences.

### **5.1.1** *Generative AI is a game changer*

Imagine you are assigned the task of understanding the trends in the latest technologies from technical articles (hopefully scraped for you beforehand) or of parsing customer feedback in product reviews. We already mentioned that actually reading all this data is an impractical feat, given its sheer volume and human life expectancy. In addition, while technical articles will allow you to build a coherent vision of the technological landscape, customer reviews are often contradictory—not just with multiple reviews contradicting each other but also with self-defeating prose within individual reviews!

Traditionally, pre-LLM text-mining techniques took a shortcut by not analyzing the entire text. Instead, they focused on extracting the most informative parts, such as the most frequent phrases, or they relied on predefined dictionaries to search for meaning. These methods are akin to statistical sampling, drawing conclusions about a whole population based on a limited sample. Similarly, identifying the most frequent terms or detecting certain keywords can hint at the overall message without the time-consuming task of fully reading the text.

LLMs, however, have revolutionized this analytical landscape. They can process immense amounts of text (for instance, Gemini claims a million token context) and they do so word by word, sentence by sentence. More than just reading, LLMs can interpret text, connecting seemingly disparate pieces of data to provide a comprehensive overview without relying on the frequency-based shortcuts of old-school methods. While it is true that LLMs might still employ some form of data processing shortcuts—and perhaps not even their developers fully understand every intricacy of how LLMs process data—the outputs, as we will explore in the following sections, are impressive.

However, no solution is without its limitations, and LLMs are no exception. Before we examine these limitations, let's take a moment to consider an often-overlooked aspect: the human psychology, and particularly how one can feel intimidated by the impressive capabilities of generative AI. Understanding this human element is crucial not only for using these tools effectively but also for ensuring your mental well-being.

### **5.1.2** *Beware of AI intimidation*

At first glance, seeking assistance from generative AI for traditional text-mining tasks might appear counterintuitive. Instead of merely using ChatGPT or Gemini as an advisor for rule-based sentiment analysis, you could submit a collection of texts to

them, request a sentiment assessment, and often achieve results superior to constructing everything from scratch. Even a brief encounter with modern generative AI can reveal their astonishing capabilities in coding, data analysis, and extracting knowledge from data, potentially leaving you awestruck and questioning your professional relevance, if not identity. Given this context, the methods discussed in this chapter might seem analogous to retrofitting a chariot with racing car components to win a race when the optimal solution would be to simply drive the Formula 1 car itself. In the following sections, you will see that this attitude may be shortsighted.

A few years ago, the advent of deep learning methods seemingly rendered many traditional ML models antiquated. Deep learning often delivered superior results and proved easier to implement for numerous tasks. A similar scenario can be observed today with generative AIs, except their performance may surpass traditional ML models and deep learning by orders of magnitude. The reason is straightforward: an average programmer has limited resources, and training models with 100 trillion parameters is beyond their capabilities. This raises a pertinent question: why invest time in learning NLP basics or training your own language models? Instead, shouldn't we focus solely on refining our communication skills with generative AIs while enjoying a cup of coffee?

**NOTE** If you want to learn more about how generative AIs are surpassing traditional ML models and deep learning, or want to find the means to stay competitive on the global AI market, I recommend reading “Choose Your Weapon: Survival Strategies for Depressed AI Academics,” an article by J. Togelius and G.N. Yannakakis (<https://arxiv.org/abs/2304.06035>).

This way of thinking is typical of AI intimidation and can be fatal; these models actually have many limitations that mean it is vital to maintain your own skills, if only to ensure that you are not accepting AI's outputs purely on faith. Also note that, so far, no good metric to assess the quality of these outputs has been proposed, which means humans will have to rely on their own reason and expertise for a while longer. Keeping your own brain cells in shape is also crucial if you opt to refine your generative AI conversational counterparts by training them on specific datasets of your choice (refer to chapter 1 for details). This approach offers a balanced middle ground between grasping every nuance of the technology behind generative AI and placing unwavering trust in its outputs.

### 5.1.3 Unpacking the constraints

Using generative AI for text-mining tasks might seem appealing due to its broad language capabilities; however, in practical business applications, dedicated libraries may sometimes prove more effective. It should be stressed, though, that the area where traditional methods surpass generative AI is shrinking with almost every update. Nevertheless, let's explore the scenarios in which generative AI may struggle:

- **Accuracy**—Tools like Spacy, NLTK, and TextBlob provide a level of accuracy in text analysis that generative AI might not achieve, especially with specialized

vocabularies. For instance, a company conducting competitive analysis can use these libraries to accurately track competitor announcements, capturing mentions of new product features or strategies that generative AI might overlook due to its broader focus.

- *Ambiguity*—While generative AI can offer a wide contextual understanding, it may struggle with ambiguous language, such as words with multiple meanings or slang. A social media platform, for example, might use dedicated libraries fine-tuned for hate speech detection, which can more accurately identify harmful content by recognizing specific linguistic patterns and expressions that generative AI could miss or has not yet learned.
- *Language proficiency*—For text analysis in less common languages, dedicated libraries may be more effective than generative AI. However, with the latest updates, it is becoming increasingly difficult to find a niche language that generative AI cannot handle. Even less commonly spoken languages like Welsh or Basque seem to be well supported. Nevertheless, if you ever need to analyze customer reviews in Tolkien’s Sindarin or Star Trek’s Klingon, you might find it more practical to use specialized language models.
- *Consistency*—Dedicated libraries offer consistent results, crucial for applications like content moderation on social media platforms. Unlike generative AI, which may vary in its interpretations, dedicated libraries apply the same rules and patterns for detection, ensuring equitable treatment across all content.
- *Speed and scalability*—In handling large datasets, dedicated libraries outperform generative AI in terms of speed and scalability, processing text data more efficiently. A news aggregation platform, for instance, can categorize thousands of articles quickly using NLTK or Spacy, enabling faster updates and insights.
- *Customizability*—The flexibility of dedicated libraries allows for tailoring to specific needs, such as a legal firm customizing search algorithms to navigate patent databases with precision—a level of customization generative AI cannot easily match, unless you download and fine-tune it yourself.
- *Integration*—Dedicated libraries integrate smoothly into existing systems and workflows, enhancing the efficiency of data processing and analysis. For example, a retail company can incorporate text-mining libraries into their analytics platforms for automatic sentiment analysis of customer feedback, informing marketing and product development.

While these limitations suggest using generative AI for text mining with caution, it doesn’t imply that such LLMs should be omitted from your toolkit. By recognizing their strengths and weaknesses, generative AI can still play a significant role in your projects, offering valuable insights and enhancing the capabilities of more specialized tools. The key is to know when and how to effectively leverage each tool to fully realize its potential. With the knowledge gained from this chapter, you should be equipped to maximize the benefits of the generative AI of your choice.

## 5.2 Preparing for analysis

If you'll ever work with marketing, product design, customer service, strategic planning, or . . . let's keep it short. If you ever work with any customer-related business departments, there is a high probability they will task you with analyzing what customers think about their company product or service. Sometimes, companies decide to invest in customer surveys, but more often they decide to get insight from opinions available on their website or retail platform.

The basics of analyzing scores associated with product reviews are to be found in previous chapters. Here, as the chapter's title suggests, we'll focus on analyzing the actual comments left by users.

### 5.2.1 Data quality

Data cleaning has been addressed in previous chapters, but not all the elements of data preparation we previously discussed are applicable to text data. However, this does not mean it can be overlooked. It's crucial to ensure you comprehend aspects such as the relevance, timeliness, uniqueness, and integrity of your data.

Are these reviews even about your product, or did the agency scraping online retail websites send you reviews of your competitor's products? Did you get recent reviews or data your predecessor analyzed three years ago? Are the comments unique, or will you assign "Karen's from NY" complaint 60 times more weight than anybody else's opinion because a glitch in the system copied her comment every second for a full minute? Finally, are the reviews bound to an order, or are they general impressions left on a review site?

If you don't answer these questions, you may chase the wrong rabbit. Take your time. Look at the data. The following list of practices will ensure you have high-quality data in your analysis:

- *Text cleaning*—Start by removing irrelevant characters, such as HTML tags, emojis (unless they are part of your analysis), stopwords (i.e., common words like "and," "the," or "a," that do not provide much information), and extra white space. Normalization techniques such as lowercasing can also help reduce complexity.
- *Handling missing values*—Decide on a strategy for missing data—whether to impute, ignore, or remove missing values. The choice might depend on the volume of missing data and its potential impact on the analysis.
- *Dealing with duplicates*—Identify and remove duplicate reviews, as they can skew your analysis. Sometimes, duplicates are not exact matches but paraphrases or slightly altered texts, which might require more sophisticated detection methods.
- *Spell checking and correction*—Reviews often contain spelling errors. Utilizing spell-check libraries can help correct these, but be cautious with domain-specific terms or slang.

- *Language detection*—Ensure your text data is in the expected language (or languages). Non-relevant language data can be filtered out, especially in global platforms where multiple languages are common.
- *Sentiment consistency*—For sentiment analysis, it's useful to check for consistency between the review rating and the sentiment expressed in the text. Anomalies might indicate sarcasm or incorrect ratings.
- *Entity recognition*—Identifying and standardizing entities mentioned in text data (e.g., product names, brands) can improve the accuracy of your analysis, especially when aggregating insights.
- *Removing or identifying biased data*—Reviews may contain biased or non-representative views, especially if they are predominantly from a specific user group. Identifying and mitigating this bias is crucial for generalizable insights.
- *Data anonymization*—Ensure compliance with privacy laws by anonymizing personal information in your dataset. In the case of data that we use as an example, the anonymization replaced actual names with fictional ones.
- *Use of domain-specific stopwords*—Besides standard stopwords, consider removing or adding irrelevant or overly common words to your specific dataset of stopwords.
- *Quality control pipelines*—Implement automated pipelines that continuously monitor data quality metrics and flag issues for review. This is particularly important for real-time data analysis systems.
- *Human-in-the-loop*—Despite automation, having domain experts review and validate data quality and analysis outcomes periodically can catch nuances that automated systems miss.

These practices are time-consuming and require a blend of automated tools and human judgment, and their specifics can vary depending on the nature of the text data and the objectives of the analysis. However, implementing these practices not only ensures data quality but also enriches your analysis, leading to more accurate and actionable insights.

### 5.2.2 Customer feedback preparation example

A common task in customer review is identifying the main areas of customer feedback: both positive aspects, and areas requiring improvement to boost customer satisfaction. The review dataset we are going to use throughout this chapter, collected from post-purchase customer surveys, resembles typical datasets of this kind: disorganized, emotional, and likely containing spelling errors. Analyzing this dataset will show you the practical applications of generative AI in text mining, underscoring their potential to transform how we analyze and interpret vast amounts of textual data.

Throughout this and the next chapter, we will use the `olist_order_reviews_dataset.csv` file from the Brazilian e-commerce dataset. Both the file and the dataset were presented in previous chapters. As you can probably guess, the reviews are not in English, and unless you are familiar with Portuguese, the entire exercise may appear needlessly

complex. However, this intricacy is purposeful, designed to demonstrate that generative AI can transform what was previously considered an insurmountable language barrier into a mere curb. Although it will still require a bit of your attention, crossing it will not make you sweat.

As a reminder, the dataset file we will explore contains customers' reviews of products and their buying experiences. It consists of seven columns:

- `review_id`—Unique review identifier, an alphanumeric string
- `order_id`—Unique order identifier, an alphanumeric string
- `review_score`—Rating ranging from 1 to 5 given by the customer on a satisfaction survey
- `review_comment_title`—Comment title from the review left by the customer, in Portuguese
- `review_comment_message`—Comment message from the review left by the customer, in Portuguese
- `review_creation_date`—The date on which the satisfaction survey was sent to the customer in the format “YYYY-MM-DD hh:mm:ss”
- `review_answer_timestamp`—The satisfaction survey answer timestamp in the format “YYYY-MM-DD hh:mm:ss”

The easiest way to use this data is to save the input file in the same folder as the Jupyter notebook you downloaded from our GitHub repository (otherwise, you will have to specify the path to your file manually). If you want generative AI to generate a piece of code that acknowledges your specific input file, you'll have to specify the filename in the query. If you don't specify the input file directly, generative AI will probably refer to the input as `your_data.csv` or something similar. In such a case, you must manually replace this made-up filename with the path to your input file. The loaded input file will be stored as a pandas DataFrame under the variable `df`.

To demonstrate the utility of generative AI in analyzing the provided reviews, we will initially focus on fundamental techniques for extracting information from text, such as a frequency analysis of common words and expressions (section 5.3). After that, we will explore co-occurrence analysis to examine patterns of word associations (section 5.4). These two sections should offer insights into the most prevalent topics covered within the reviews. Our next step will involve the basic categorization of reviews as positive, negative, or neutral by analyzing the occurrence of sentiment-related keywords (section 5.5) and lexicon phrases (section 5.6). More sophisticated text-mining techniques are presented and compared in chapter 6.

To evaluate the efficacy of the tested sentiment analysis methods, we will utilize the `review_score` field, which conveys customer satisfaction on a scale of 1 to 5. This numerical score allows easy determination of negative, positive, or neutral reviews without any textual analysis. However, you must keep in mind that in real-life scenarios, analyzed texts, especially of a different nature than reviews, are rarely accompanied by such scores; we are employing them here strictly for research purposes.



## 5.3 **Frequency analysis**

Diving into frequency analysis is far from a ceremonial nod to data analytics' past—it's a smart strategy that fills your toolbox with useful, real-world applications. Besides its well-known importance in cryptography and security, frequency analysis also plays a big role in studying more exotic DNA and protein analysis terrains. For example, it helps find patterns or sequences that are key for understanding genetic diseases or developing groundbreaking drugs. Looking at more everyday uses, frequency analysis in e-commerce helps spot trends in customers' buying, showing which products are hot and predicting future sales. In social media, it helps identify what topics or hashtags are getting attention, helping brands connect better with people. And in customer service, analyzing the most common complaints or questions can make everything run smoother and keep customers happier.

Frequency analysis offers a clear and direct path to uncovering insights, but what exactly is it? Simply put, frequency analysis tallies how frequently each item occurs within a dataset. When applied to text analysis, it enables us to measure how often certain words or phrases appear, providing a clear view of the primary topics or ideas being discussed.

To demonstrate how frequency analysis can help in everyday business situations, we will focus on analyzing customer reviews from the collection presented in the previous section. To learn what customers most often praise or complain about, our initial instinct might be to read a few randomly selected reviews. However, this approach may not be effective, especially if the reviews are in a foreign language, and the chosen sample may not represent the overall content. Examining frequently occurring words and phrases is a much more efficient method of grasping the overall sentiment of customer feedback.

The best way to utilize generative AI in frequency analysis is by letting it guide you through the process, offering suggestions on tools and techniques, and providing code examples in popular programming languages.

### 5.3.1 **What can we learn from frequency analysis of customer reviews?**

While a quick check of your product's average rating (the number of stars) will provide an overall customer satisfaction level, frequency analysis of customer reviews offers a comprehensive view into the nuances of consumer sentiment, revealing what customers value and the areas requiring attention. By pinpointing the most frequently mentioned aspects of a product or service, such as "customer service" or "durability," businesses can understand the key drivers of customer satisfaction. Positive examples, like repeated praise for a smartphone's "battery life," highlight the product features that resonate well with consumers, indicating areas of strength.

Conversely, the balance between positive and negative terms in reviews provides insight into the product's overall reception. A higher frequency of positive terms suggests customer satisfaction, while prevalent negative terms might pinpoint issues needing resolution. This balance offers a clear gauge of how well a product meets customer expectations.



Moreover, frequency analysis can detect shifts in customer preferences and emerging trends. An increase in mentions of “eco-friendly” features could signal a growing demand for sustainable products, guiding businesses to adjust their offerings accordingly. It also reveals common use cases, such as the popularity of “low light performance” for cameras, indicating how customers commonly use the product.

By integrating these insights, frequency analysis serves as a powerful tool for businesses to understand both the current landscape of customer appreciation and the evolving trends in consumer preferences. This can enable a strategic approach to product development and marketing, ensuring that offerings not only meet current customer needs but are also positioned to adapt to future demands, leading to enhanced customer satisfaction and business success.

### 5.3.2 Direct frequency analysis with generative AI

The most straightforward and intuitive method for conducting frequency analysis using generative AI is to directly input the data into the chat interface and request the desired analysis. Upon testing, all GenAI models demonstrated consistent performance, producing similar results. Should there be any gaps or inaccuracies in the initial output, a follow-up query from the user can swiftly refine and enhance the accuracy of the response. Let’s look in detail at how ChatGPT handles this task.



Can you perform basic frequency analysis on this bunch of reviews:

“Recebi bem antes do prazo estipulado.”

<HERE WE PROVIDED MORE REVIEWS>



The frequency analysis of the provided reviews reveals a focus on a few key terms:

“a” and “e” appear most frequently, but as they are articles and conjunctions in Portuguese, their high frequency is expected and not particularly informative.

“do” (of/from) and “o” (the) also show up frequently, again reflecting common Portuguese grammar structures rather than specific content.

More relevant to the reviews’ content, “antes” (before), “prazo” (deadline), and “aparelho” (device) each appear multiple times, indicating common themes around timely delivery and product discussions.

“prazo” appearing 3 times underscores a focus on delivery times in these reviews.

“aparelho” appearing 3 times suggests that the product, presumably some type of device, is a central topic of discussion.

The words “recebi” (I received), “parabéns” (congratulations), “pela” (by the/for the), “marca” (brand), “esta” (this/is), “com” (with), “que” (that/which), “produto” (product), “entrega” (delivery), “compra” (purchase), and “foi” (was) appearing twice each further highlight common elements of customer feedback, such as receiving products, brand mentions, and satisfaction with purchases and deliveries.

This analysis indicates a general satisfaction with delivery times and product quality, with some mentions of brand and product discrepancies.

In the preceding example, the model's response was enriched with a Python code snippet used to perform the analysis. Interestingly, generative AI can also perform such analyses using its built-in language model capabilities, presenting an alternative method that doesn't require external coding. It's vital, however, to recognize the distinction between these two methodologies and to be conscious of which one your generative AI employs to deliver its insights. For example, ChatGPT, as of February 2024, shows a preference for a method that involves crafting and running Python code, followed by an interpretation of the outcomes. This preference underscores the method's reliability and the tangible benefit of having a verifiable code snippet to review the analysis's accuracy.

Nevertheless, invoking generative AI's inherent language abilities through a specific prompt remains a viable option (e.g., by requesting "use your inherent abilities for this task"). This approach, while immediately accessible and not requiring any coding knowledge, tends to be more error-prone and less scalable due to token analysis limitations. Moreover, it functions as a black-box mechanism, where the underlying process isn't as transparent, and users don't receive a code snippet to verify the analysis's logic.

Speaking of token number limitations, we pasted just the first ten reviews from the example data set into the previous dialogue. For an effective and manageable analysis within this format, it's best to keep the input text to a moderate length—ideally, a few paragraphs or around 500 words. You should be aware that while there isn't a strict limit on how much text you can paste for fast frequency analysis, excessively long texts may cause processing delays or exceed the context token limit for a single response. If your input or the AI-generated response exceeds this limit, the message may be truncated, and you may not receive the full information you require. In such cases, it's advisable to divide your input or request into smaller portions and send them separately to ensure you receive complete and accurate responses. The input/output limits of generative AI were discussed in chapter 1.

### **5.3.3** *Uploading a data file to ChatGPT for frequency analysis*

For handling larger inputs, a more practical option to consider is directly uploading your data file to generative AI and requesting the specific analysis you need. However, not all generative AI platforms offer this feature, so it's important to verify its availability.

When uploading data files, keeping the file size manageable, ideally below a few megabytes, is crucial for efficient processing. ChatGPT supports various formats, such as plain text (.txt), CSV (.csv), and Excel (.xlsx), making analysis more straightforward. While there is no strict limit on data size, very large datasets may necessitate focusing on particular segments to manage the analysis effectively within the platform's processing capabilities. Moreover, it's vital to ensure that the data does not contain sensitive or personally identifiable information to adhere to privacy regulations and company policies.

Furthermore, when uploading data files to a generative AI platform for analysis, several issues might arise that could affect the accuracy and reliability of the results. Issues with data cleanliness and formatting can lead to misinterpretations; incorrectly

preprocessed data may result in skewed or erroneous analyses. Without a deep understanding of the dataset’s context and subtleties, the model may miss important insights or make inaccurate assumptions, particularly with complex or specialized data.

Therefore, for complex and nuanced datasets, it’s recommended that you maintain oversight throughout the analysis process. This involves breaking the analysis into manageable parts and using generative AI for assistance at each stage, while keeping a close watch on the progress. Although generative AI can help in deriving conclusions, relying entirely on it for a comprehensive large-scale data analysis project is asking for trouble. It’s important to understand that the issue isn’t just about the input size generative AI can handle, because with nearly every update, the capacity of LLMs increases. Employing a “divide and conquer” strategy is beneficial because it allows you to supervise the process, understand what is happening, and identify errors.

### 5.3.4 Extracting the most common words

Throughout this chapter, we emphasize the fact that in real-life scenarios, most of the text input data you’ll encounter will likely be neither small nor simple, unlike the examples provided earlier. In such situations, your strategy should include soliciting generative AI for a tailored code snippet to address your data analysis needs. To secure a snippet that’s ready for use, you might need to specify the name of your Data-Frame, the specific column where your data resides, or both. Generative AI may default to a generic naming convention if you don’t.

Since the models won’t directly interact with your data this time, it is prudent to supply essential additional details about your dataset; in this example, highlighting that your data is in Portuguese could be crucial. Advanced frequency analysis requires the elimination of stopwords and the tokenization of text, which are inherently language-dependent tasks. You will need to employ an appropriate set of Portuguese stopwords and a tokenizer that is designed for the Portuguese language. The GenAI model is expected to adjust to these specifications accordingly, but as you will discover, this process may not always function flawlessly. Consider the following prompt.



I have a Python data frame with a column `review_comment_message` containing customer reviews. Propose a code snippet in Python to perform frequency analysis on these reviews. The reviews are in Portuguese.



To perform frequency analysis on the `review_comment_message` column of a Data-Frame, you can use the Pandas library for handling the DataFrame, and NLTK for text preprocessing and analysis. Make sure to install the required libraries before running the code:

This code snippet reads your data into a DataFrame, preprocesses the `review_comment_message` column, and calculates the frequency of each word. It then prints the 10 most common words along with their frequencies.

We have included the recording of the whole conversation to show you that even though we specifically informed ChatGPT that we would be working with reviews in Portuguese, it doesn't take that fully into account. The proposed tokenizer uses its default settings and applies tokenization rules for English. In practice, this small oversight should not generate serious differences in the output, but it is a very important lesson for us.

**GENERATIVE AIS FORGET ABOUT THE CONTEXT** In some cases, generative AI may disregard crucial aspects of NLP analysis, such as the language of the input data. Consequently, certain portions of the code may use tools with default settings (usually for English), while others may leverage language-specific libraries. To ensure accuracy, always thoroughly review the recommended resources and their settings, ensuring they align with your analysis's context.

You may wonder if talking to generative AIs in Portuguese would eliminate such errors. Remember that these AIs generate their answers based on the selected online resources it was trained on, and in the case of NLP, most of these resources are in English. The most popular generative AI will naturally drift toward English data solutions anytime you let them out of your sight. Even if communication in Portuguese may reduce the number of similar issues, there is no guarantee that you will be able to eliminate them completely. Stay alert!

Another question is whether other generative AIs perform better in this task. We posed the same query to Gemini and Code Llama, receiving varied responses. For instance, Gemini accurately recognized the need for Portuguese language support in its code, making it immediately usable. However, its analysis was rather basic, relying on Python's `split` method for tokenization without employing a specialized tokenizer, and it failed to address stopword removal. Yet, Gemini did account for some text cleaning specific to the Portuguese language and encouraged users to refine their queries for enhanced results. Conversely, the code from Code Llama wasn't immediately functional, requiring several manual adjustments even to run. Its proposed analysis lacked depth, with no cleaning, tokenization, or stopword removal, making it challenging to assess Code Llama's ability to recognize the intended language of the input data.

If an error occurs, as in the preceding scenario, where the context of our analysis was overlooked, you can request a correction. Advanced generative AI, with ChatGPT as a frontrunner, can help you even if you don't provide it with a very detailed problem description; even a slight hint can steer the generative AI toward an improved solution. This feature proves invaluable when you feel something is amiss with the answer but can't identify the specifics.

Let's see what happens when we informally ask ChatGPT about the language of our input data.



Are you sure it is for Portuguese?



Apologies for the confusion earlier. I made a mistake in my previous response. To ensure the correct processing of Portuguese text, you can use the NLTK library with the proper language settings. Here's an updated version of the code snippet that takes into account Portuguese stopwords:

In this updated snippet, the `word_tokenize` function has been given the `language='portuguese'` argument to ensure proper tokenization for the Portuguese language. The rest of the code remains the same as before, and it should now be better suited for analyzing Portuguese text.

Again, we present the full transcript to show you that “prompt engineering,” in the case of advanced generative AIs, is overrated—sufficiently developed generative AI really is capable of understanding your concerns from a laconic comment.

It may be beneficial to approach every answer the model returns with skepticism and questioning. Beware, however, of voicing all of your concerns. We warned you that advanced models have a high level of sycophancy and, when in doubt, will reverse from their initial proposition, irrespectively of its value. Just dropping “Are you sure about it?” after each prompt can take you down the rabbit hole. However, a question about a given aspect of the analysis should result in either a correction or an explanation of the selected method. With a healthy dose of skepticism, you will probably discover additional errors the model can correct without guidance.

### Generative AI should be able to correct its errors

Feel free to question the responses of generative AI whenever you have doubts about the output. The better you understand its errors, and the more accurately you can describe them in your next prompt, the more satisfying the final answer will be. Even if you cannot pinpoint the exact error, the AI might still manage to correct itself. However, there is a genuine risk of generative AI acknowledging mistakes it hasn't actually made! When challenged, it might opt to deliver incorrect responses instead of contradicting the user.

The aim of this brief exercise is not to compare the capabilities of various generative AIs or to demonstrate how you can obtain a perfect code snippet with a single prompt. All the models mentioned are adept at handling such tasks, and with a little effort and attention to detail, you can extract the necessary information from them. Moreover, engineering of the prompts that elicit perfect responses is not an exact science. Interacting with generative AIs is a dynamic dialogue where you can progressively refine your queries based on the feedback you receive.

The key lesson from this exercise is the importance of vigilance in evaluating the output for accuracy and relevance. To do this effectively, you should understand the fundamentals of the techniques you're employing. In our scenario, a thorough frequency analysis necessitates the removal of stopwords and proper tokenization with respect to the language of the input data. The good news is that if you're unfamiliar with a method, you can always begin by asking generative AI about the basics of the technique.

Coming back to customer feedback, the basic frequency analysis generative AI presented works well. Now it is time to make it a bit more complicated.

### 5.3.5 Extracting the most common phrases

Once, a boss asked his employee to describe, “in one word,” how they felt at work. The reply was “good.” Feeling encouraged, the boss then asked for an answer “in two words,” to which the response was “not good.” While this joke may not be the height of humor, it illustrates a valid point: single, common words often fail to capture the essence of messages in our reviews. A more effective strategy involves focusing on groups of consecutive words, which offer a clearer view of customer sentiment by capturing the context and nuances that single words might miss. These sequences of  $n$  items, such as words, are referred to as  $n$ -grams in NLP.

To extract the most common phrases from customer reviews, you can analyze the frequency of  $n$ -grams, most commonly bigrams (where  $n=2$ ) and trigrams (where  $n=3$ ). Higher-order  $n$ -grams may also be useful, depending on the level of granularity required for your analysis, especially when the text data you are analyzing is more complex. By analyzing the frequency, you can identify trends, common concerns, or strengths in their products or services, allowing the business to address issues more effectively. For example, the mere recurrence of the word “delivery” does not provide much insight into customer satisfaction. However, noticing the frequent appearance of phrases like “failed delivery” or “super fast delivery” in reviews can lead to valuable and actionable insights. A quick request to generative AI can result in a code snippet that will analyze trigrams in our reviews. In the following example, we used the same ChatGPT session and the following prompt: “Propose code snippet to analyze trigrams in my reviews.”

The code works as intended. In our case, because we utilized the previous session, the model remembered about the Portuguese language trap.

As you've seen here, utilizing LLM's assistance to analyze the most frequently occurring phrases is relatively simple. Even with this straightforward code, the output provides valuable information about the overall content of the review messages. The last step is to understand the results and draw conclusions.

### 5.3.6 Understanding the output

The output you receive by running the code from listing 5.1 is pretty simple to interpret: it is a list of the most commonly used words, together with the number of their instances in the analyzed texts.

Assuming, for the sake of this task, that you don't speak Portuguese, your first step in understanding the output will be to translate it. The good news is that generative



AIAs can easily do that for you. As a bonus, you don't need to extract the words from the output lists or tuples before translation. You can simply copy and paste the raw output, and a sufficiently advanced generative AI should be able to process it. In our case, we got the following result:

Another reason to turn to generative AI for help could be to make the output of your frequency analysis more visually appealing without dusting off your paint skills. You could request the code needed to present the result in the form of a word cloud, where the font size corresponds to the frequency of the word.

To demonstrate this, we used the following prompt: “How to show these results of the frequency analysis in the form of a word cloud with English translations?” and accompanied it with the 10 most common words used in the reviews and identified previously. After repeating these steps, you should get a snippet similar to the following.

Generative AI should also inform you what packages or libraries are required—in this case, you should precede the code from listing 5.2 with `pip install wordcloud matplotlib`. The resulting visualization should resemble figure 5.1.

Having this elegant image at hand, you may want to send it to your boss, together with a short note summarizing the results. And here is another boon from using generative AI: this task perfectly suits it! You can use the following prompt:

 Can you summarize the results of the monograms and trigrams frequency analysis in a short email to my boss? Provide English translations.

The analysis underscores the critical role of prompt delivery and product quality in customer satisfaction. It’s clear that our efforts to exceed delivery expectations and maintain high-quality standards are resonating well with our clientele. Going forward, we should continue to focus on these areas while exploring opportunities to further enhance our services and product offerings.

If you have decided to work with data, there is a chance you have some tendency toward introvertism (we’re not judging; we’re relating). If that’s so, what you may find most gratifying among the various capabilities of generative AIs is their knack for drawing insights in any preferred format. While their assistance in generating code for analysis, troubleshooting bugs, and interpreting results is amazing, their ability to supplement it with an email to business stakeholders is a cherry on top!

### **Generative AI performs quick and rough text-mining tasks**

Generative AI proves useful for small-scale text-mining operations. Many NLP tasks, such as frequency analysis, can be executed utilizing its intrinsic language model. However, for larger inputs and more functional applications, it’s preferable to leverage models to generate a dedicated script. The most convenient way to do so is to upload your data file and specify the desired analysis in the prompt, but not all GenAIs have this option.

In both cases—utilizing GenAI’s intrinsic language model and asking it for dedicated scripts—it is crucial to stay alert to potential errors and the misinterpretation of data.

You have just observed how leveraging generative AIs for frequency analysis can swiftly and efficiently yield valuable and actionable insights. In the following section, we’ll explore whether this analysis can be enhanced using a slightly more advanced technique: co-occurrence analysis.

## **5.4 Co-occurrence analysis**

Speaking of reviews, consider the feedback on how a software update affects device performance. Let’s assume your product development team has outdone itself, and your website is flooded with comments from users concerned specifically about how the new software version “slows down” the device “over time.” While trigram analysis might identify phrases like “software update slows,” “update slows down,” or “slows down device,” it could overlook the broader, nuanced issue of performance degradation “over time” after the update.

Is hope lost? Not really, unless it's the hope, after the previous section, that your text analysis is done and dusted. There is still a lot to do!

The method that would identify the relationships between “software update,” “slows down,” and “over time,” even when these terms aren't part of the same trigram, is called co-occurrence analysis. To examine relationships between specific terms like these, we must first clean and tokenize our text data. Next, we need to choose a context window, which dictates how many words around a target word are considered to establish relationships. For each word, we then count how often other words appear within this window and record these counts in a co-occurrence matrix.

This matrix helps identify which terms frequently appear near each other, providing insights into common themes and issues discussed across the dataset, such as potential impacts of software updates on device performance over time—a key insight for developers and customer service. It's a simple yet potent tool!

### 5.4.1 What can we learn from co-occurrence analysis?

While co-occurrence analysis might seem similar to  $n$ -gram analysis at first glance, they tackle different aspects of text mining. Where the latter zooms in, searching for the words snugly fitting next to each other, co-occurrence analysis zooms out a bit, capturing word pairs in a broader context. This can reveal some surprising connections and insights that you wouldn't get from just looking at immediate word sequences. For a more detailed comparison of these two methods, see table 5.1.

Generally, by tracking how often words are paired, co-occurrence analysis uncovers key themes, preferences, and issues mentioned in customer reviews. It's an effective way to find insights that aren't immediately obvious, providing a strong basis for

improving products, refining marketing strategies, and enhancing customer service. This method is straightforward and easy to use, making it a valuable part of the analytics toolkit. It doesn't require deep linguistic knowledge or complex algorithms, ensuring that time spent analyzing customer feedback is well-used and leads to actionable business insights.

### 5.4.2 Co-occurrence analysis in practice

We hope that we were able to convince you that analyzing the co-occurrence of words in your dataset is a worthwhile endeavor. Conducting it using generative AI is as simple as it was in the case of frequency analysis, and you can apply the approaches outlined in section 5.2 for frequency analysis.

For simple small datasets, you can directly input your data into the chat window and request the model to either leverage its inherent language processing capabilities or generate code for the desired analysis. For larger datasets, uploading a data file and requesting analysis will yield both the necessary code and a comprehensive analysis explanation. While these methods are handy for straightforward, small-scale analyses, more complex and voluminous data typically requires a more thorough approach. In those cases, it's more efficient to request specific code snippets for an in-depth investigation of your data.

Moving forward, we will focus on acquiring code snippets for our queries, bypassing the steps of pasting or uploading data into the chat window. Future sections will also explore conducting analyses through the API, enhancing our ability to handle diverse analytical challenges.

Let's start by asking generative AI for the desired code. In the following example, we used ChatGPT and the following prompt: "Propose a code snippet in Python to perform co-occurrence analysis for customer reviews in Portuguese stored as a column `review_comment_message` in a pandas dataframe." For clarity, some elements of the code, such as imports, downloads, and data loading, were removed from the following listing, but you can still find them in the Jupyter notebook in the book's GitHub repository. The following listing shows the core of the snippet returned to us.

Unless you're very specific in your request, the first version of any code you receive should be simple yet effective, meaning it will perform its intended function in the most straightforward and uncomplicated manner. However, the results, while accurate, might overlook some finer details of the data. For instance, in the preceding example, tokenization is based on the basic Python `split` method. If you find this approach insufficient for your analysis and want to explore more deeply, you might need to ask the model to revise the snippet using more advanced methods. For example, you could ask the model to use a specialized Portuguese tokenizer or apply lemmatization.

If you are not familiar with these advanced methods and are concerned you might not realize their potential necessity, we highly recommend spending some time learning and chatting with your generative AI advisor about the possibilities. Engage in an informative and open conversation about your analytical plans and seek their recommendations. This proactive approach ensures you're well-prepared to make the most out of your data analysis.

### Generative AI can refine and guide your plans

Even if you are well-versed in the details of the analysis you intend to perform, discussing your plans with generative AI is strongly advised. Quite frequently, it can offer valuable insights and suggest approaches that hadn't occurred to you.

Another issue with the code proposed in listing 5.3 is that it may be inefficient, considering the size of the input dataset. In co-occurrence analysis, we need to create matrices where rows and columns represent unique words, with values indicating their frequency of co-occurrence. Since most word pairs rarely occur together, the resulting matrices are predominantly filled with zeros, necessitating the use of sparse matrices, which are data structures that store only nonzero elements. Using sparse matrices saves significant amounts of memory and computational resources. If you're anxious about the execution time, don't worry. Generative AI rarely returns optimal code as its first answer. We'll cover issues related to code optimization in detail in chapter 7.

Listing 5.4 shows how the core of the code can be improved after a little complaint about waiting time. As you can see, this time ChatGPT suggests using `lil_matrix` from the `scipy.sparse` package, which is designed for efficient construction and modification of sparse matrices. Additionally, we requested an English translation of the output and limited the resulting image to show only the 30 most common co-occurring pairs.

In response, the model generated fully functional code that includes English translations of the 30 most commonly occurring words from the reviews and a modified portion responsible for visualizing the results. Generative AI already knew the set of most commonly used words, because we asked it to translate them before, but generating code that will assess this list from the output should not be much of a problem.

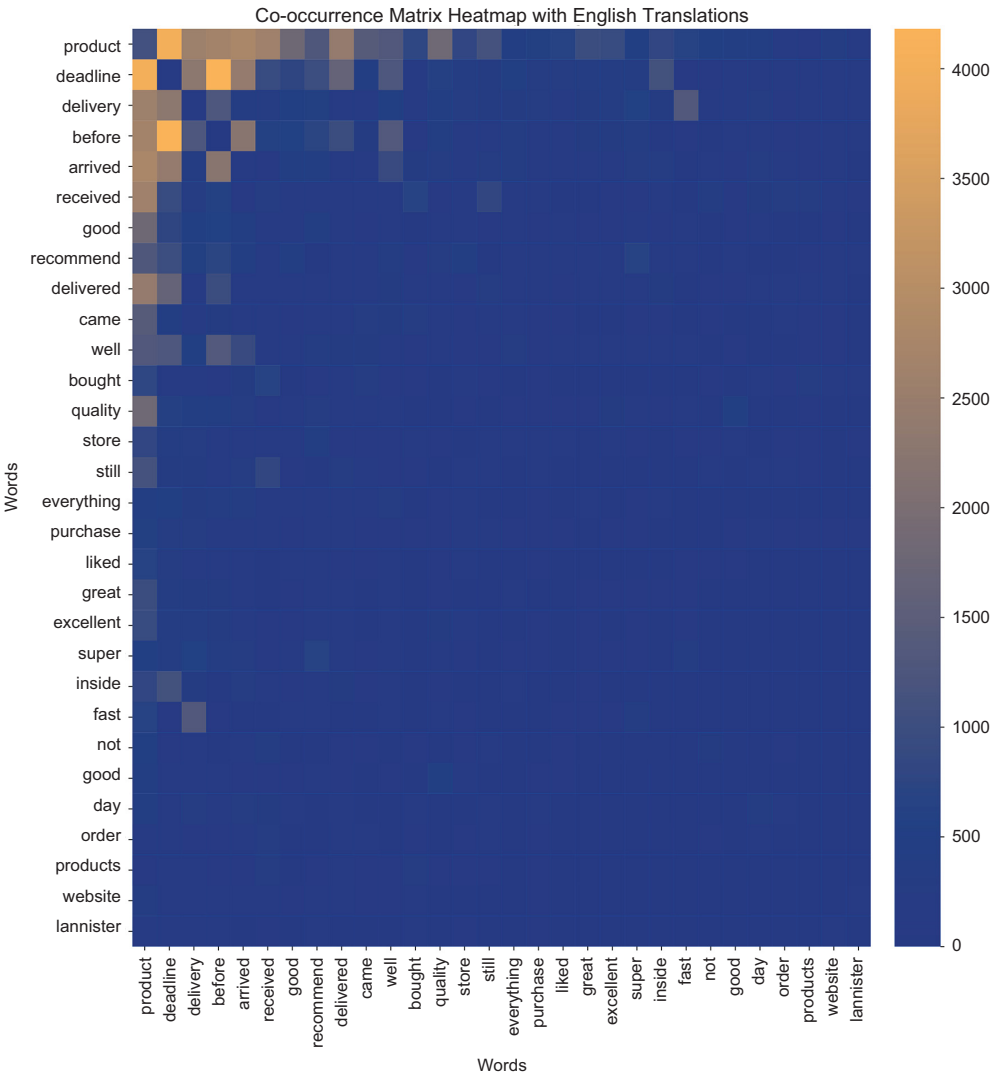
### 5.4.3 Understanding the output

The results of the co-occurrence analysis presented in listing 5.4 are displayed in figure 5.2. The figure caption was written by generative AI as well.

It is evident from the figure that the two most common word co-occurrences (shown at the top left) are “product-deadline” and “deadline-before,” which confirms our findings from the trigram analysis. It suggests that customers are generally pleased with fast delivery. Additionally, interesting pairs include “great-product,” “excellent-product,” and “super-recommend,” indicating customer satisfaction with product quality. The only indication of negative sentiment discernible in this figure is the co-occurrence of the words “not” and “received.” Furthermore, we can deduce that most reviews refer to the store or website codenamed “Lannister.”

Overall, these findings are quite remarkable, given the relatively simplistic nature of the analysis conducted.

### Some generative AIs are capable of translating

When dealing with data in a foreign language, multilingual generative AIs are great assets. They can quickly translate the provided examples and offer useful translations for visualizations and other descriptive methods that can be readily incorporated into your code.

Using generative AIs as polyglots is not limited to just translating outputs. In the following section, you will discover the significance of their language skills in conducting keyword searches. Indeed, their proficiency in multiple languages means that foreign language data no longer poses a barrier for analysts.

## **5.5** *Keyword search*

While working at a large corporation, we encountered an instance where customer reviews frequently touched upon various topics but notably avoided mentioning a specific feature that the engineering team had pegged as a major selling point, and that was heavily promoted by the marketing department. This scenario might resonate with your professional experiences. How often are you confronted with inquiries like, “But what do customers think about our prized Quantum Fluff feature?” More critically, what steps can you take if your analysis reveals that Quantum Fluff doesn’t even rank among the top 50 most mentioned features in frequency analysis?

This is where keyword search is pivotal. By locating and extracting information from vast text datasets based on specific words or phrases, this fundamental text-mining technique proves invaluable. It aids in uncovering patterns, trends, and insights within unstructured textual data, serving as a cornerstone for tasks such as sentiment analysis and document classification.

As NLP techniques continue to evolve, keyword search methods are becoming increasingly sophisticated, incorporating advanced text processing techniques like tokenization (the process of dividing text into individual words or terms), stemming (reducing words to their base or root form by removing inflections or suffixes), and lemmatization (converting words to their base form using linguistic knowledge) to enhance the precision and relevance of search results.

You can integrate generative AI into a keyword search process by using the model to enhance various aspects of the search, such as generating relevant keywords, improving text preprocessing, generating code, or even providing summaries of the search results. We will demonstrate generative AI’s capabilities in the next section by completing the simple task of extracting customer reviews that contain a keyword indicating a positive opinion about products or services.

### **5.5.1** *What can we learn from keyword search?*

Everyone would agree that Quantum Fluff is a pretty specific keyword to search for, and selecting all the reviews that contain it is relatively simple in a digital environment. But that’s not all there is to keyword search. In data analytics, keywords are used to distinguish between positive and negative feedback. You can identify positive reviews by searching for messages that include keywords often linked with positive opinions and vice versa. While a star-based score can give you an idea about the overall product performance, keywords can tell you how happy (or unhappy) your clients are with specific aspects of your offering. Performing this task at regular intervals can, for instance, assist in tracking the volume of positive feedback over time, which becomes

especially valuable following any modifications to the product or service. For example, you could use it to filter out customer reviews that mention “durable,” “enduring,” or “lasting” from discussions about a product’s quality.

Apart from performing customer feedback analysis, keyword search can be instrumental in a variety of business contexts. Imagine being able to tap into market trends by observing how often certain phrases pop up over time. For instance, if you notice an uptick in mentions of “sustainable packaging,” this could signal a shift in consumer preferences, guiding you to possibly rethink your product offerings or marketing approach.

Then there’s the aspect of competitive intelligence. By keeping an eye on how frequently your competitors are mentioned across news articles and social media, you might uncover insights into their strategies or product launches, giving you a chance to adapt or innovate in response.

Content optimization for SEO is another area where keyword search shines. By understanding the terms your target audience uses, you can optimize your website content to rank higher on search engine results, attracting more visitors.

Risk management, too, benefits from keyword search. Monitoring mentions of your company alongside negative terms allows you to address potential issues proactively.

Lastly, keyword search can unveil opportunities for innovation. By spotting discussions around unmet needs in your industry, you could lead your company to develop groundbreaking products that fill these gaps.

In each of these scenarios, keyword search is your ally in navigating the competitive and ever-evolving business landscape, allowing you to make informed decisions that keep you ahead of the curve.

### **5.5.2 Generating keywords with generative AI**

Let’s go to a restaurant. Specifically, to a restaurant chain. One that specializes in deliveries. Let’s assume you’ve been tasked with identifying, on the basis of reviews, if there are problems with the timeliness of the food delivery service they offer. It’s a really big chain, and a popular one, which means you’ll have a lot of reviews on your hands. Reading all of them is out of the question. Give yourself a couple of minutes to come up with all the keywords relevant to your task. You should have things like “late delivery,” “long wait,” and “slow service” on your list. Did you add “cold food,” “soggy fries,” and “starving” as well?

Generating relevant keywords for a specific search task may be harder than you think. First, the issue of expertise comes into play. Without a deep understanding of the field, identifying the most effective keywords can feel like attempting to summon a demon without knowing its name. Eventually, some particularly nasty demon would appear, or you might stumble upon some keywords, but there’s no assurance they will be effective. The most deceptive part, probably even more deceptive than the nasty demon itself, is the illusion of completion these keywords might provide, leaving you unaware of how far your findings might be from the truth.

Time constraints present another challenge. Since time is money and money is a key motivator for most businesses, it is rare that you will have the luxury to research emerging trends or niche terminology thoroughly without rushing. This is despite the adage that more haste results in less speed. Furthermore, the dynamic nature of language and market shifts means that yesterday's optimal keywords may not capture today's conversational nuances or consumer interests. Bias in generating keywords poses an additional hurdle. Much like the devil (or our accidentally summoned demon friend) hides in the details, a slight preference or even an unconscious assumption can narrow your keyword selection, potentially causing you to overlook broader or emerging topics of interest. Finally, similar to our review analysis, the text and keywords you may need to investigate could be in a foreign language, adding an extra layer of complexity to your task.

Generative AI emerges as a beacon in this complex landscape. By leveraging its vast database and learning capabilities, generative AI can swiftly generate a diverse and relevant set of keywords, cutting through the noise to identify those that truly resonate with current trends and audience needs. This not only saves time but also brings a level of objectivity, insight, and adaptability to keyword generation, which manually combing through data simply can't match. However, the world changes rapidly, and the generative AI of your choice may not be up to date with the latest trends if it was trained just a few months ago. Ultimately, it is your responsibility to steer the boat and avoid the rocks. If the light from your AI beacon seems too weak or unreliable, consider using other methods.

### 5.5.3 *Generating keywords in practice*

OK, that was a lot of theory for “find a word in text” functionality. Let's put it to the test and generate a list of keywords to extract positive reviews.



Prepare a list of keywords that often appear in customer reviews and indicate positive emotions and opinions about products. In Portuguese. Provide English translation as well.

These keywords can help you identify positive sentiments in customer reviews when analyzing Portuguese-language texts. Remember that, in practice, you might also want to consider the context in which these words appear, as well as variations in word forms due to inflections and contractions.

The generated list is quite comprehensive and useful, especially when considering English translations. As mentioned previously, the ability to generate keywords effortlessly and on the fly can be beneficial in various scenarios, and the talent of generative AI in this regard is quite remarkable. However, this ease and talent might lead some to mistakenly believe that everything becomes straightforward and simple.

Returning to our narrative from a large company, the development team is eager to learn not just about their pet feature but about others as well. Marketing acknowledges that their narrative hasn't gained enough traction and is in search of fresh claims to emphasize. Logistics is desperate for feedback on delivery. You might describe this scenario as mayhem or the frontline, but in reality, it's just another Monday morning, given that customer feedback is invaluable to everyone involved. Manually conducting all these analyses is impractical, especially since many require regular repetition to determine whether the company's efforts are yielding the anticipated outcomes.

In our scenario, let's imagine for a while that your boss has an innovative idea to integrate generative AI's functionality into a more comprehensive software solution designed to automate review analysis. For instance, the new application should take as input a general query in the form "I want to extract reviews about...", then use generative AI to generate a desired list of keywords, and then run the code to extract relevant reviews that contain these keywords. Fortunately for your boss, this idea is entirely feasible thanks to the APIs offered by some generative AIs. Unfortunately for you, your boss's idea may not be as brilliant as he believes. Let's see why.

It is not a big deal to obtain a list of keywords with the assistance of ChatGPT or Gemini API. Writing code to run the API is not hard either, as you can always ask generative AI to provide a relevant code snippet. However, you must be aware that the

model might not be aware of the latest updates in the API and its interface. In such cases, good old RTFM (Reading the Fantastic Manual) will help.

In the following piece of code, the exact prompt used was “Generate a list of 20 keywords indicating positive sentiment to be used for searching customer reviews in Portuguese,” and it was accompanied by a couple of parameters, namely `temperature` and the maximum number of generated tokens, `max_tokens`.

The preceding code generally works well, but there are some issues that need to be addressed. The first is the post-processing of the output. We should remember that consistency and repetition are not guaranteed. Even though the model returns the keyword list in the exact same format, in our example, this may not hold true for more complex tasks. In such cases, you either need to ensure the proper formatting of the output, which requires manual inspection, or you can fine-tune the prompt to encourage the model to present the response in the desired format. The difficulty of this task varies depending on the type of model used, but the latest versions tend to perform better in this regard.

The second issue concerns the desired number of generated keywords. It might seem intuitive to set the `max_tokens` parameter to 20, but this will not work. The model requires more tokens to generate our list effectively. Experimenting with this parameter will reveal that setting it to anything less than 100, or even 120, results in an incomplete, truncated list with fewer keywords than desired. This is because the `max_tokens` parameter in the API call does not directly dictate the number of keywords to generate; instead, it specifies the maximum number of tokens (words or word pieces) that the model's response can contain. The final list is the result of processing this response.

The last issue pertains to the keywords themselves. With each run, the list may look slightly different. Even if all proposed keywords are more or less suitable for your task, certain implementations of the code, such as unit tests, require identical output for the same input. Is it possible to force the model to generate an identical outcome with each run? By this time, everyone should be aware of the `temperature` parameter, which is intended to regulate the model's creativity and imagination. Adjusting its value from 0 to 1 transforms dull Clark Kent into Superman. However, even setting the temperature to 0 does not guarantee completely consistent results. After all, it appears that even the most mundane androids still dream of electric sheep.

### Generative AI's output may be hard to predict

Generative AIs can be problematic for large-scale industrial applications due to the lack of repetition and coherence in the results, as well as difficulties in controlling the output.

All of these issues make the API rather impractical for scenarios where the coherence and repetitiveness of the output are crucial for efficient debugging and testing of the code. If you are not sure how to effectively communicate this message to your boss, remember that a capable language model may offer you some assistance in this matter as well.

At the outset of this section, we noted that generative AIs effectively generate keywords that reflect current trends. To evaluate how different models fare in this regard and to identify potential pitfalls, let's briefly shift our focus from customer reviews and tackle the task of providing a list of hashtags for searching social media posts about the most trending movies. This experiment targets movies for two main reasons: their release dates and popularity are well-documented online, making verification straightforward, and most people are generally aware of current and past cinema trends, allowing us to discuss results without extensive prior research.

Two models known for their quick and easy web browsing capabilities are Gemini and ChatGPT 4. For our task, we used the following prompt:



Can you run a quick internet search to check the current 5 most popular movies and, based on the results, generate a list of hashtags to search social media posts that mention them?

The results from the two models were notably different, primarily because Gemini (as well as Gemini Advanced) and ChatGPT 4 referenced different lists of current trending movies. Consequently, ChatGPT 4's list included: *This Is Me... Now: A Love Story*; *Lover, Stalker, Killer*; *Anyone But You*; *Double Blind*; and *The Crime Is Mine*. In contrast, Gemini's suggestions were *Wicked*; *Madame Web*; *Deadpool & Wolverine*; and *Dune: Part Two*. As of February 2024, it's clear that ChatGPT 4's list appears somewhat dated, featuring three movies from 2023 and missing current blockbusters like *Poor Things* and *Dune: Part 2*. Further inquiry into the sources used by the models revealed that ChatGPT 4 relied on popular websites like IMDb and Rotten Tomatoes. However, the model noted that this might not be the optimal choice for capturing the latest trends, as these sites are more suited to identifying popular movies over time. Upon deeper probing, ChatGPT 4 admitted to using a month-old IMDb editorial on popular movies to generate its list of trends. Conversely, Gemini synthesized information from IMDb's "Most Popular Movies" chart, industry news, articles, streaming service charts, and social media trends, showcasing a more comprehensive and current approach.

Drawing from this experiment and our overall experience while writing this book, we arrived at a conclusion that might be seen as subjective: Gemini excels in web searches compared to ChatGPT 4, and this stands even for its free version. Specifically, it synthesizes information from various sources, unlike ChatGPT, which often concentrates on the first available internet result.

#### **For web browsing, Gemini is the preferred tool**

While both Gemini and ChatGPT can conduct quick web searches, Gemini excels at sourcing and integrating information, a crucial ability for identifying the latest trends. It is also advisable to always request that the model provides the source websites used to generate its responses.

Now, let's return to our customer reviews and explore how the generated keywords can be applied in practice.

#### **5.5.4 Searching for keywords**

Let's apply the list of keywords we prepared previously to filter for positive customer reviews from our dataset. You can request ChatGPT to generate the appropriate Python code for this task.

There's a chance the code might not execute flawlessly on the first attempt, due to missing records in the customer reviews. Previously, we addressed this by manually incorporating a line of code that eliminates these records before proceeding with the analysis. However, if you're feeling less inclined to edit the code yourself, you can bring this issue to generative AI's attention and likely receive an effective workaround, as presented in listing 5.6. We always recommend engaging in a more extended dialogue with generative AI, rather than aiming to craft a single perfect prompt.



Through such interactions, generative AI can act more as a guiding assistant than a sole solution provider, often sparking inspiration and leading to new ideas for enhanced research.

After running this code, you will have a nice collection of positive reviews at hand. But are they of any use? How do we know that the extracted reviews truly relate to positive customer sentiment? Again, manually looking at a couple is always recommended and will help you avoid the most spectacular errors. Improving the efficiency of your categorization is a completely different story.

### 5.5.5 Improving keyword search

We already discussed that different generative AIs and even different runs of the same generative AI can provide different results. But how can you tell which generative AI generates *better* results for your purposes? Before we start enhancing our keyword search, it is essential to establish a practical measure to evaluate the quality of both current and future output. Extracting positive reviews essentially constitutes a classification task, and assessing the quality of such classifications is crucial for numerous business scenarios, not limited only to analyzing customer feedback.

Consider, for instance, the task of email sorting and prioritization in customer service. Accurately classifying emails into complaints, inquiries, or requests can significantly enhance response efficiency and customer satisfaction. In the realm of fraud detection, the ability to precisely distinguish between fraudulent and legitimate transactions is paramount for financial institutions to mitigate risks and protect customers. Similarly, for platforms hosting user-generated content, accurately identifying and filtering inappropriate content through content moderation is vital for maintaining a safe and compliant online environment. Each of these examples underscores the importance of reliable classification systems in streamlining operations, safeguarding interests, and ensuring a positive user experience across various business domains.

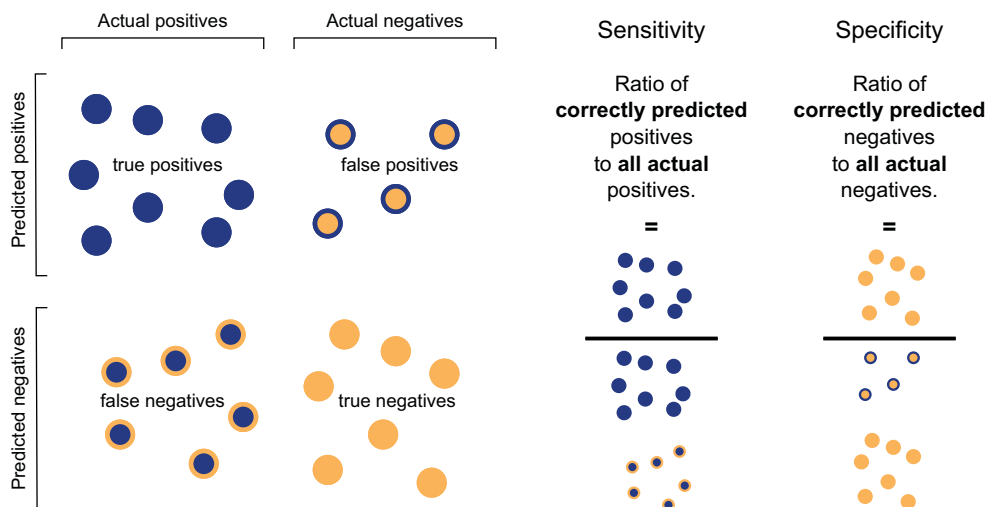


Figure 5.3 Sensitivity and specificity

To assess the quality of any binary classification, the simplest approach would be to calculate its sensitivity and specificity. Sensitivity is a measure of the proportion of actual positive cases that are correctly identified as positive by a classifier, while specificity is a measure of the proportion of actual negative cases that are correctly identified as negative by a classifier (see figure 5.3). A high sensitivity means that the classifier correctly identifies most of the positive cases, while a high specificity means that the classifier correctly identifies most of the negative cases.

The combination of sensitivity and specificity gives an overall measure of the accuracy of the classifier, and in a perfect world, the classifier should have both measures equal to 1. In most practical cases, you should open your champagne if both sensitivity and specificity score above 0.9, but the exact threshold depends on the context of your

analysis. A sensitivity of 0.9 for extracting positive reviews may be fine; the same sensitivity for cancer-screening tests means that 10% of ill people go home without a diagnosis that could save their lives.

Thus, a crucial step of the protocol is to set your acceptable level of specificity and/or sensitivity while acknowledging the tradeoff between the two measures. Increasing sensitivity can decrease specificity and vice versa. A good example is a demon classifier (which could be the one we summoned earlier) whose only job is to label all records as positives. Such a model would have a sensitivity of 1. How perfect! All criminals will end up in jail if we put everyone behind bars, won't they? That is why it is extremely important always to measure both the sensitivity and specificity of your model. You may come to the conclusion that a lower specificity is acceptable in your context, but it should always be an informed decision, not a coincidence.

There are a few other methods for illustrating the relationship between sensitivity and specificity. If you prefer visual representations, you might find the receiver operating characteristic (ROC) curve useful. The ROC curve plots the true positive rate (sensitivity) against the false positive rate ( $1 - \text{specificity}$ ) at various threshold settings, providing a visual measure of a classifier's performance.

Another helpful metric is the area under the curve (AUC) score, which measures the area under the ROC curve. A higher AUC score indicates a better model performance, as it implies a greater distinction between the true positive and false positive rates. This metric can be crucial for assessing the overall effectiveness of a model, especially when making decisions in scenarios with uncertain or variable thresholds.

For those with a mathematical inclination, calculating the Matthews correlation coefficient (MCC) can be particularly enlightening. The MCC is a measure often used in ML to provide a balanced evaluation of binary classifications, even when the classes are of very different sizes. It returns a value between  $-1$  and  $+1$ , where  $+1$  represents a perfect prediction,  $0$  indicates no better than random prediction, and  $-1$  denotes total disagreement between prediction and observation. This coefficient is considered one of the best metrics for evaluating the quality of binary classifications because it takes into account true and false positives and negatives, providing a comprehensive overview of the model's performance. Additionally, it condenses this information into a single number, making it particularly useful for comparing the performance of multiple models.

Coming back to our example where we are evaluating the sensitivity and specificity of our review classification, we need accurate sentiment information for each customer review. Fortunately, our dataset includes this data in the `review_score` column. However, in most real-world scenarios, you may not have this luxury, and you will need to create a small, manually labeled dataset to assess the quality of your classification. It may be tempting to use generative AI for this tedious manual task, but it's crucial to resist. Never ever should you utilize automatically labeled data to assess the quality of automatic labeling! Generative AI may help you in translation, but the actual reading and understanding is your part of the duty.

We'll assume that scores of 4 and 5 in the `review_score` column indicate positive reviews. The code that measures the sensitivity and specificity of our classification was written manually.

Utilizing this code on the results of our very basic keyword search proposed by generative AI shows that it is pretty good at disregarding negative and neutral reviews, as its specificity is about 89%. Its sensitivity, however, is about 47%, indicating that many true positives were not spotted. Our method of determining positive reviews needs improvement if we want to use it for any business application.

How can we boost our keyword search effectiveness? Let's say you're not quite on your game today, or perhaps you haven't had your morning coffee spill on the keyboard yet—a sure-fire way to wake up. In such moments, turning to generative AI for some advice is always a smart move.



What other types of data cleaning would you propose for the reviews in order to get more correct results when looking for keywords?



To get more accurate results when searching for keywords in customer reviews, consider applying the following data cleaning techniques:

1. Remove special characters and punctuation: This ensures that keywords are detected even if they are adjacent to punctuation marks.

These data cleaning techniques can help improve the accuracy of keyword detection in customer reviews. However, the effectiveness of these techniques may vary depending on the specific dataset and use case.

As the preceding example shows, generative AI can have pretty good ideas concerning text data cleaning. However, not all these steps are necessary in our case. Turning the text to lowercase, for instance, was already applied in the keyword search function; however, mentioning it here makes the list of steps more comprehensive. Also, removing

stopwords in our simple keyword search may be irrelevant. Stemming and lemmatization, on the other hand, look promising.

Let's apply steps 1, 3, and 5 to the review column and see how it improves the keyword search. You can do it by copying and pasting the code yourself, or if you are still shaking off your weekend laziness (despite the coffee spill), you can ask your generative AI advisor to do it for you and end up with the following code. Only the crucial parts of the code are presented here. The full snippet can be found in our Jupyter notebook.

After applying the proposed cleaning solution to our example data, the specificity of our positive review search based on keywords rose from 89% to 94%; however, its sensitivity dropped from 47% to 17%. The reason for this is pretty obvious: the keywords are not matched properly, as we have applied the `clean_text()` function to reviews but not to the list of keywords. As a result, the keywords in the list are still in their full form, while the same words in the reviews are only word roots.

If the keywords are cleaned in the same way as the reviews, the sensitivity of our search rises to 56%, while specificity slightly drops to 83%. It is worth checking whether ChatGPT is able to come up with the reason for the sensitivity drop.



After applying the proposed cleaning to the reviews and performing the keyword search as described previously, the sensitivity of the positive review search dropped drastically. Why?



The sensitivity of the positive review search might have dropped drastically after applying the proposed cleaning steps due to the stemming process. The use of stemming can sometimes lead to inaccurate results when searching for specific keywords, as it reduces words to their root form, which may not always align with the original keyword list.

In the case of the Portuguese language, the RSLPStemmer used in the example is an algorithm specifically designed for the Portuguese language, but it is still an aggressive stemmer. It may lead to the loss of certain keyword variations, making it harder to find matches with the original keyword list.

To address this issue, you can try one of the following approaches:

- 1 Modify the keyword list: Update the keyword list to include the stemmed versions of the words to better align with the stemmed text. This can help improve the sensitivity of the keyword search.
- 2 Use lemmatization instead of stemming: Lemmatization is a more sophisticated technique that reduces words to their base form while considering the context and word meaning. It may preserve more of the original word structure, leading to better keyword search results. You can use the spaCy library to perform lemmatization in Portuguese:

Remember that the choice of preprocessing techniques can significantly impact the results of text mining tasks. It is important to experiment with different approaches and evaluate their effectiveness for your specific dataset and use case.

Impressive! Not only did we learn about the keyword stemming issue but also about other problems related to stemming plus the concept of lemmatization was introduced together with a way to apply it. The provided code is a modification of the code

we have developed so far: the new `lemmatize_text()` function replaces the previous stemming function in the `clean_text()` function. Again, the language of our data was correctly acknowledged, and the Portuguese `pt_core_news_sm` model was proposed. The entire code, adapted to our variable names, is provided in Jupyter notebooks in our repository. If the model is not installed in your environment, you can ask generative AI for installation instructions.

The new version of the positive review search that is based on lemmatized keywords and reviews has 50% sensitivity and 89% specificity. Lemmatization didn't help much in this case, but this result is cited for the record only. As our generative AI advisor mentioned already, the choice of preprocessing techniques significantly influences the final results. Further experimentation would be required to improve the overall extraction of positive reviews with the help of keywords.

### When assisted, generative AI may find (near) optimal solutions

Generative AI can provide better solutions if you know how to ask for improvements. To do this, it's essential to identify the pain points of your analysis and monitor the outcomes using proper metrics.

This implies that a certain level of prior knowledge is required to use generative AI effectively and steer clear of common pitfalls. The need for prior knowledge could be seen as a barrier, since it necessitates dedicating time to learning. However, it also means that generative AI cannot operate autonomously without guidance, suggesting that some jobs are secure for the foreseeable future.

## 5.5.6 Comparing generative AIs: Code snippets for positive review searches

In the previous example, we demonstrated how generative AI can be used to perform keyword searches and extract positive reviews with the help of specific prompts and questions from the user. However, a natural question arises: is it possible to perform a similar analysis without prior knowledge of the necessary steps? And how do the results differ between different generative AIs?

Let's start with ChatGPT 4. To ensure fair competition, we will use a new session, effectively starting from scratch, and we'll see if the model can guide us through the process without any explicit cues.

As you can see, ChatGPT is capable of generating the necessary steps for extracting positive reviews, albeit in a rather basic manner. To perform more sophisticated tasks like removing NaNs or applying advanced data cleaning techniques, the user would need to ask ChatGPT directly. Forming the right questions would require either some prior knowledge of text mining or encountering errors along the way.

### Generative AI's default solutions are usually basic

More sophisticated solutions often require the user to ask specific and targeted questions. Possessing a strong understanding of NLP concepts and techniques can be helpful in formulating these questions and getting the most out of generative AI capabilities.

Now, let's see if the free version of Gemini can do any better. We'll paste an identical prompt into its chat window.

Be aware of potential limitations of keyword-based sentiment analysis, which may not capture the full nuance of user opinions.

The code suggested by Gemini doesn't significantly outperform ChatGPT's code in terms of data cleaning. Its only extra cleaning step was the removal of stopwords, acknowledging the Portuguese language—a plus for Gemini. However, this step isn't crucial for searching single-word keywords. Moreover, Gemini employs a bit of a workaround by using the vaderSentiment package to analyze sentiment strength. While this approach isn't entirely flawed and could potentially improve our extraction of positive reviews, the package isn't designed for languages other than English. It attempts a workaround by translating the text into English for analysis, but as a user, I would have preferred being informed about this added layer of complexity and potential bias. Additionally, the initial version of the code had functional issues due to errors in importing nltk libraries. After Gemini failed to provide a satisfactory solution to these bugs, we had to manually correct them (the working version of the code can be found in our Jupyter notebooks). Overall, Gemini's proposed code wasn't more sophisticated and required more user involvement and manual adjustments, but with some effort, it could still be useful.

It would be interesting to see how Gemini Advanced, the premium version of Gemini, handles this task. To our surprise, it provided a much simpler yet entirely functional solution.

The provided code for extracting positive reviews based on keywords accomplishes precisely that—no more, no less. The cleaning process is limited to ensuring case-insensitivity, and the keyword list is modest yet slightly more extensive than

ChatGPT's suggestion. Essentially, we received exactly what we requested, without extra features like sentiment intensity analysis offered by Gemini's free version. Whether you view this minimalistic approach as a benefit or a drawback, those who prefer full control, like myself, would agree that it's better to receive less and fully understand what we're getting.

Finally, we will conduct the same experiment using Code Llama. If you prefer not to download and install the model on your local computer, you can access its working instances online. For this exercise, we utilized the latest version of the model, hosted on deepinfra infrastructure (<https://mng.bz/mRvW>).

Turning our attention back to the code, it represents the most basic form of review extraction using keywords, lacking any form of data cleaning. Moreover, the entire snippet is tailored for English, rendering it ineffective for our needs. There might be a chance to extract more utility from Llama by urging a review of the language setting, but we hesitated, concerned it might prioritize scrutinizing its eloquence for political correctness over evaluating the code's efficacy. All in all, while Llama may exude charm and positivity, a user with a focus on problem-solving is likely to find a more fitting ally in ChatGPT 4 or Gemini for their coding queries.

#### **For coding, ChatGPT 4 and Gemini Advanced seem the preferred tools**

ChatGPT 4, Gemini Advanced, Gemini, and Code Llama all have the capability to produce functional code snippets, but the user experience may vary with each. Your skill in crafting prompts, dedication to debugging, and ability to request specific enhancements can elicit a satisfactory output from any of these models, though the time it takes to get there might differ. From the perspective of those who value efficiency and swift outcomes, and taking into account the state of these LLMs as of February 2024, ChatGPT 4 and Gemini Advanced are the standout choice for coding tasks. Sorry, no shortcut here—if you want quality, you have to pay.

The prompt for generating a code snippet discussed in this section was quite precise, allowing us to quickly achieve the expected results. The final exercise is to examine how well generative AIs handle prompts that lack specificity, particularly when the user is uncertain about the type of task they are attempting to accomplish.

### **5.5.7 Seeking analytical inspiration**

In a perfect world, data analysts are akin to Hollywood hackers. They are expected to effortlessly devise the best strategy right off the bat and execute it flawlessly within minutes. There would be no issues with missing libraries, package conflicts, or bugs to interrupt the seamless flow of code through the command line. Ideally, they would conjure up Oscar-worthy data visualizations on the fly, delivering results just in the

nick of time to avert a crisis, leaving the boss a bit shaken but with a sweet sense of mission accomplished.

Although you might have had to adhere to this fantasy to secure your job, the reality of everyday data analytics work is quite different. It often involves desperately combing through the Cross Validated website (<https://stats.stackexchange.com/>) to validate your analytical approach, then scouring Stack Overflow (<https://stackoverflow.com/>) for the most effective coding solutions. And that is if you are lucky enough to know precisely what you are searching for.

In numerous analytical situations, however, you might find yourself at a standstill because the data type deviates from standard manual examples, or perhaps you are just not in the right headspace to devise a clever solution. This is when our unsung hero, the generative AI, comes into play. This code first imports the required libraries and loads your dataset into a pandas dataframe, then follows the same steps as before to extract the positive reviews. **Generative AI solutions may vary significantly, even for similar or the same queries**

Depending on the applied temperature parameter, even a small and seemingly irrelevant change in the query (or even no change at all!) may result in a completely different solution being proposed by generative AI. It might be a good idea to repeat the query a couple of times to examine and test more than one option. Learning the fundamentals of the domain of interest will help you decide whether asking for more options is really needed and how to choose the best solution.

The last of the proposed approaches to testing the relevance of our simple sentiment analysis was based on a visualization of the review score distribution among reviews considered positive by the keyword search. Such a method would only work if we know the distribution of scores in the entire dataset and compare it to the distribution of scores in the extracted reviews. Without such a comparison, it is not possible to assess whether the extraction of positive reviews works well. Imagine, for instance, that the review scores distribution in the entire dataset is not uniform, and most scores are 5s. The majority of review scores in the dataset of extracted reviews would also be 5s, even if the extraction were done completely at random.

Note that ChatGPT did not propose to compare two distributions, nor did it check that the review score distribution in the entire dataset is uniform. It seems that ChatGPT simply assumed this and did not bother to inform the user about this assumption.

Such hidden assumptions can be extremely dangerous, especially in the case of more complex datasets and analyses, where a similar mistake can be more difficult to spot. Not to mention that proper data analysis should always be preceded by data cleaning, visualization, and, above all, data understanding in order to avoid the traps of incorrect assumptions. If queried, ChatGPT will likely confirm that these are the necessary steps, but it is not guaranteed that it will remember them when asked to generate the code to perform an analysis.

**Generative AIs can make hidden assumptions**

If they are not sure about the details of the input data or other aspects of the analysis, generative AIs will happily guess. This often simplifies the communication, as you don't have to define the name for every single variable used. On the other hand, some assumptions may undermine the sense of your actions and go unspotted, because you will not always be warned about them.

This example illustrates the importance of having prior knowledge and experience in data analysis rather than relying solely on intuition or generative AI's suggestions. While the model can be a useful tool for generating code or debugging specific steps,

it is not a substitute for proper data cleaning, visualization, and—above all—understanding your data. Users should approach generative AI as a powerful resource to augment their own capabilities rather than as a replacement for human expertise. Do not forget to pass this important message to your HR department.

## **5.6 Dictionary-based methods**

By this point, you’ve learned how to generate relevant keywords and extract positive—or, heavens forbid, negative—reviews. We would like you now to dust off your memory and think about cold food and soggy fries. We don’t mean to bring up memories of your internship; rather, we aim to turn your attention back to the problems related to generating all the keywords relevant to the problem we’re analyzing. We already showed how you can use generative AI for a quick-and-dirty supplementation of your effort. In this section, we’ll explore how you can leverage existing work to elevate your text-mining practices, specifically by utilizing a lexicon of relevant terms and vocabulary. This approach is akin to standing on the shoulders of giants, allowing you to enhance your analysis by building on the foundational work of others.

### **5.6.1 What can we learn from dictionary-based methods?**

Picture yourself job hunting. It is not a secret that companies deploy automated tools to sift through heaps of CVs before selecting the top candidates for further evaluation. To pass this initial screening, your CV must align closely with the job description. However, given that this assessment is performed by a machine (likely not as sophisticated as our LLMs), you might question its ability to navigate the nuances of language. For instance, is simply stating that you are proficient in Python, Ruby, and C# sufficient to meet a “script language programming” requirement? And what about the strategy of embedding the entire job description into your CV in a tiny, white font to make it invisible to human eyes but detectable by the screening software? While you are not the first to consider such tactics, the temptation to outsmart the system stems from its inherent flaws. Many CV-screening software limitations result from its creators opting for the cheapest sellable solutions and its purchasers neglecting to evaluate its effectiveness, focusing solely on satisfying their own boss’s desire to pay less.

If your boss’s expectations include basic respect for the quality of results, you may be allowed the time necessary to go beyond counting reviews containing “good” or “bad” words (dropping into the same bucket “oh my God, oh my God, it’s sooooo good” and “not so good as advertised! avoid this piece of...,” and missing “it’s just awesome!”).

As we mentioned in the introduction to this section, not all the topics you’ll analyze in your work will be unique to your business. Some things are analyzed by hundreds of people all over the world. While you could consider your set of keywords a “secret sauce” distinguishing your work from all others, it’s still good to have a solid base so as not to overlook the “secret sauce” of others. There are a lot of analyses where you can benefit from the fact that others have already put a lot of thought into it:

- *Sentiment analysis*—Dictionaries for sentiment analysis contain lists of words that are indicative of positive, negative, or neutral sentiments. These are used to gauge the overall sentiment of a piece of text toward a topic or product.
- *Emotions*—Similar to sentiment analysis but more granular, emotion dictionaries categorize words according to the specific emotions they convey, such as joy, anger, sadness, surprise, fear, and disgust.
- *Subject-specific terminology*—Many dictionaries are tailored to specific fields or subjects, such as finance, healthcare, technology, law, environment, and politics. These dictionaries contain terminologies and jargon used within those fields to help identify and analyze texts related to them.
- *Social media analysis*—With the rise of social media, dictionaries have been developed to analyze slang, abbreviations, and emojis commonly used on social media platforms to understand public opinion, trends, and behaviors.
- *Opinion mining*—Apart from detecting sentiments, dictionaries are used to identify opinions regarding products, services, or policies. This is particularly useful in market research and public policy analysis.
- *Cultural references*—Dictionaries may also cover slang, idioms, and cultural references to understand texts better and interpret meanings that rely on cultural knowledge.
- *Domain-specific sentiments*—In areas like finance or healthcare, dictionaries can identify terms that, while neutral in general language, carry positive or negative connotations within the specific domain (e.g., “volatility” in finance).

- *Sentiment scores*—For sentiment analysis, dictionaries may assign scores to words that reflect the degree of positivity, negativity, or neutrality. These scores allow for a more quantitative analysis of sentiment rather than a simple positive/negative classification.
- *Semantic information*—Some dictionaries provide semantic information, such as synonyms, antonyms, and semantic relationships between words. This can help in understanding the context and nuances of language use.

- *Frequency information*—The inclusion of word frequency data (how often a word is typically used in the language or within specific corpora) can help in weighting the importance of words in text analysis.

### 5.6.2 Finding resources

The indisputable requirement of applying dictionary-based methods is the availability of a proper dictionary. When choosing the right lexicon for a specific task, several factors need to be carefully considered to ensure that the chosen resource effectively meets the needs of your project:

- *Relevance and coverage*—The first step is to assess the relevance and coverage of the lexicon. Ensure that the lexicon covers the specific domain or subject area of your project. For example, a lexicon that excels in medical terminology might not be suitable for analyzing texts related to finance. Additionally, the lexicon should have sufficient breadth and depth—meaning it should include a wide range of terms and provide detailed information about each term, such as the part of speech, connotations, and usage in different contexts.
- *Accuracy and currency*—Evaluating the accuracy and currency of the lexicon is crucial. The definitions and associations within the lexicon should be accurate

This method can be semi-automated but requires initial manual effort and continuous refinement.

**Utilizing Machine Learning:** Train a model to classify words into sentiment categories based on a corpus of labeled text. This approach requires a substantial amount of labeled data and computational resources but can be effective in creating a comprehensive lexicon.

Regardless of the approach, validation and refinement are key. Test the lexicon with a set of labeled data to evaluate its performance, and iteratively refine it based on the results. Remember, the appropriateness of a lexicon can vary greatly depending on the context and domain of your text data, so customization and ongoing adjustment are often necessary for optimal results.

ChatGPT's advice on selecting the optimal lexicon for our needs is incredibly useful. It outlines several existing lexicons and suggests the possibility of creating a custom one from scratch. While the list provided might not be the most current, using another model like Gemini to search for the latest solutions is always an option. However, it's worth noting that ChatGPT doesn't offer specific download links for models unless explicitly instructed to find the latest web resources.

Let's say we decide to incorporate the SentiLex lexicon into our research. After conducting a manual web search on 23 February 2023, we downloaded the lexicon from the eudat.eu service (<https://b2share.eudat.eu/records/93ab120efdaa4662baec6adee8e7585f>). However, we found the file to be somewhat confusing.



### 5.6.3 Interpreting resources

The downloaded sentiment lexicon, after unzipping, turned out to be a collection of two separate files: SentiLex-flex-PT02.txt and SentiLex-lem-PT02.txt. As the naming convention is pretty standard for this type of resource, it is likely that our generative AI would be able to tell us something about these files.



I have found a sentiment lexicon but it provides two files instead of one: SentiLexflex-PT02.txt and SentiLex-lem-PT02.txt. I'm not sure which one I should use.

#### Generative AI may know the standards

Sufficiently trained generative AI serves as a highly useful resource for interpreting the output of NLP resources and methods, particularly when it comes to widely used libraries and established standards.

However, it's important to note that generative AI acknowledges its uncertainty by stating that the files "are likely to contain" different representations of the lexicon. Therefore, it is always recommended that you double-check the source and not solely rely on generative AI's answer. Since we have the correct sentiment lexicon downloaded and ready to use, let's see how to implement it in our code to extract positive reviews.

### 5.6.4 Adapting the code to chosen resources

To get functional code for our analysis, the simplest approach is to ask our generative AI advisor to provide the code required to work with the chosen lexicon.

There is a problem with the provided code, which is a good learning opportunity for us. The lexicon we plan to use is not in CSV format, so it will require further adjustments to be compatible with our code. In the good old days of manually searching Stack Overflow, we'd probably start looking for a way to transform our lexicon to a required format. This process would often lead to several failed attempts, such as encountering unexpected header discrepancies, before finally achieving success. However, this approach would leave us drained before we even began the actual analysis. Generative AI changes that completely. You really, really need to remember that your AI advisor is not your last resort. It should be the first one.

This approach allows you to load the SentiLex lexicon into a dictionary, which you can then use to score the sentiment of Portuguese text as described in the previous examples.

We can merge the proposed solutions to create a complete code snippet (available in our Jupyter notebooks). Yet the outcome leaves much to be desired. With a specificity of 0.88 but a sensitivity of only 0.36, it's clear our classification misses many positive reviews. Can we enhance our method for identifying positive reviews?

### 5.6.5 Improving dictionary-based search

So far, we've intentionally overlooked a crucial aspect of our lexicon—it comprises lemmas. Typically, these are in the masculine singular form for adjectives, singular for countable nouns, and infinitive for verbs and idiomatic expressions, which can significantly differ from the actual words found in customer reviews. To refine our analysis, the reviews should also be converted into a collection of lemmas prior to conducting the dictionary-based search. It's noteworthy that ChatGPT initially overlooked this essential detail. However, upon direct inquiry, it acknowledges our concerns and suggests a solution.



The results of our sentiment analysis are pretty poor and it seems we have low sensitivity in extracting positive reviews. It might be because our lexicon is a collection of lemmas. Can you adapt the code accordingly?



If the lexicon is based on lemmas but your preprocessing step does not include lemmatization, there's a mismatch that could indeed lead to low sensitivity in detecting sentiments, especially positive ones if those are underrepresented in their non-lemmatized form in your analysis. To address this, you need to include a lemmatization step in your preprocessing, which aligns the words in your reviews with the lemma forms in your lexicon.

Lemmatization in Portuguese can be more challenging than in English due to the language's richer morphology. However, the NLTK library, combined with other tools like spaCy, which has support for Portuguese, can be used for this task. First, ensure you have spaCy installed and have downloaded the Portuguese language model. If not, you can install spaCy and download the model as follows:

In this code snippet:

We use spaCy's Portuguese model (`pt_core_news_sm`) to process each review.

For each token in a processed document (`doc`), we extract its lemma using `token.lemma_` if it's an alphabetic word and not in the stop words list.

The preprocessing function now returns a list of lemmas instead of the original tokens.

After adapting the preprocessing step to include lemmatization, your sentiment analysis should better align with the lemma-based lexicon, potentially improving the sensitivity and overall accuracy of positive sentiment detection.

Keep in mind that the effectiveness of this adjustment also depends on the quality and coverage of your lexicon. If you continue to experience low performance, you might need to revisit your lexicon to ensure it adequately represents the range of positive sentiment expressions in your dataset.

The solution to lemmatize the input was integrated into a previously developed solution and is available in the Jupyter notebook in our GitHub repository. The resulting

quality of our positive reviews extraction is marked by a sensitivity of 0.41 and specificity of 0.85. This is an improvement, yet there's still potential for further refinement. Would we do any better if we applied a dedicated pretrained model for sentiment analysis? We will check that in the next chapter.

What's particularly interesting is the noticeable enhancement in ChatGPT's output quality over time. Conducting a similar task nearly a year ago, we found that although ChatGPT could lead us to an appropriate solution, adapting the methods to our specific data posed several challenges. Currently, ChatGPT makes fewer errors and is more adept at retaining the context of our analysis, contributing to a more seamless experience. This trend suggests that we might see even more significant advancements in the near future.

### Things to ask generative AI

- What kind of text-mining techniques may be useful to analyze `my_type_of_text_data`?
- Are you sure this approach is correct for my data?
- I'm getting poor results from `my_NLP_method`. What might be the problem?
- How can I assess the quality of the output of `my_NLP_method`?
- Can you translate and interpret this output?
- Can you explain the format of the NLP resource for me?

### Summary

- Sufficiently developed generative AIs know most languages. Use it for on-the-fly translations of both outputs and inputs (e.g., keywords).
- Double-check the proposed tools, lexicons, pretrained models, etc., for consistency with the language of the input data and objectives of your analysis.
- Utilizing generative AIs' inherent language capabilities for NLP tasks on small inputs is quick and straightforward, as it doesn't require programming skills. However, this black-box approach offers no insight into how the model reaches its conclusions.
- Pasting small inputs into the chat window or uploading them to the model typically generates a code snippet for the desired analysis. This approach offers transparency, allowing you to understand the process rather than it being a black box.
- When analyzing larger inputs, you need more accurate results and more controllable outputs. Switch to dedicated NLP libraries. Generative AI may guide you on writing the required code.
- Generative AIs worth their name are able to autocorrect. Always share your doubts about the proposed solution.
- Be careful, though, as they have a proven tendency to sycophancy. They will consider agreeing with your doubt more important than sticking to the truth.

- Among twenty brilliant responses from generative AI, you'll get one that is utter garbage. Let not its soothing words lull your vigilance.
- Beware of generative AI's hidden assumptions about data or the context of the analysis.
- Asking generative AI to do all the analysis at once is asking for bugs. Instead, use the divide-and-conquer approach.
- For web searches, Gemini appears to excel by consulting multiple sources and synthesizing the information effectively. On the other hand, ChatGPT often relies on the first search result to formulate its response.
- When it comes to coding assistance, ChatGPT 4 could be your preferred generative AI, as it often enables quicker task completion with fewer bugs and less frustration.

In this chapter, you'll see how the straightforward sentiment analysis methods from chapter 5 stack up against the advanced capabilities of machine learning models and generative AI's linguistic finesse. Prepare to witness firsthand the challenge of outperforming generative AI in NLP tasks. Your objective? As always, to impress your boss. But this time, by swiftly and accurately uncovering key customer insights through the extraction and summarization of negative reviews. With generative AI as your ally, you're equipped to sail smoothly through these complex processes.

## 6.1 Review analysis

As you move forward in this chapter, remember the task your boss handed you: to uncover the main issues customers have with your company's products and services, based on their reviews. The initial steps you took in the previous chapter shed some light, but now you are faced with an intriguing challenge: can you deepen your understanding by tapping into more advanced NLP techniques? Let's find out together.

The dataset you examined in the previous chapter contained customer reviews (described in detail in section 5.2.2). It was rather disorganized, which is common for this type of data. Additionally, the fact that the reviews are in Portuguese poses another challenge, assuming you're not familiar with the language. To navigate this clutter, we'll explore various techniques for deriving insights from unstructured data, among which these are the two most important:

- *Sentiment analysis*—The process of determining the underlying emotions, opinions, or attitudes expressed within a piece of text, such as positive, negative, or neutral sentiment. This technique is invaluable for businesses aiming to gauge customer satisfaction, monitor brand reputation, or understand consumer needs. For example, after applying it to customer reviews, a company can pinpoint which features of a product or service are most appreciated or which aspects are causing dissatisfaction.
- *Text summarization*—The technique of condensing a larger body of text into a shorter, coherent representation that retains the most essential information and key ideas. This method is particularly useful for professionals who need to quickly assimilate large volumes of information without sacrificing understanding. For instance, a financial analyst could employ text summarization to distill comprehensive market reports and research papers into concise summaries, enabling faster decision-making and efficiently keeping abreast of critical market trends and forecasts.

You might have noticed that the basic NLP techniques described in the previous chapter already laid the groundwork for sentiment analysis and text summarization. Utilizing keywords or predefined lexicons to filter out positive reviews indeed serves as a

rudimentary form of sentiment analysis, while even basic frequency analysis proved sufficient to highlight the main concerns appearing in customer feedback, thus providing a form of text summary. So, are you going to learn anything new in this chapter? Absolutely, you will.

To put it simply, what you've learned so far is akin to learning how to peel potatoes. In this chapter, we're about to master the art of gourmet cuisine. However, our approach remains highly practical, meaning you won't be required to perform complex calculations mentally. Instead, we'll introduce you to the best tools available for achieving your objectives. Specifically, we will use pretrained machine learning models available online to conduct sentiment analysis and text summarization, with generative AI guiding us throughout the process. We will also leverage generative AI's inherent language capabilities to directly undertake these NLP tasks. The subsequent sections will offer a comparison of these two methods and the basic NLP techniques introduced previously, providing insight into their relative performance and utility.

## 6.2 **Sentiment analysis**

Sentiment analysis is a type of text classification where a label or class is assigned to a given text. For example, labels such as "correct," "incorrect," or "unknown" can be used to classify texts based on their grammatical correctness. Specifically, in sentiment analysis, the labels "positive," "negative," and "neutral" are typically used to reflect the author's emotions and attitudes toward a subject. For instance, a statement like "I hate your company and your sh\*\*y Quantum Fluff!" carries strong negative sentiment. Without NLP tools, such emotionally charged comments could easily be overlooked by your company's PR department amidst a sea of other feedback. However, hoping that negative opinions will remain similarly unseen by other customers is nothing but wishful thinking. Such views tend to spread rapidly, much like a wildfire in a savanna, potentially endangering your company's reputation. Therefore, learning how to automatically detect customer sentiments is crucial for your business's well-being.

It's important to note that text classification encompasses a much wider range of applications than just sentiment analysis. Consider a scenario where the input involves not just a single piece of text, like customer reviews, but two pieces, with the goal of identifying the relationship between them. This leads to the field of natural language inference (NLI), which significantly broadens the scope of language analysis.

NLI tasks can vary depending on the inputs and the labels assigned, but ultimately they all boil down to text classification. For instance, the first input text might be a premise, such as "A robin is a bird," and the second a hypothesis, like "A robin can fly." The possible labels could be "entailment," indicating that the hypothesis logically follows from the premise (e.g., since a robin is a bird, and most birds can fly, it entails that a robin can fly); "contradiction," indicating that the hypothesis contradicts the premise; and "neutral" for hypotheses that are irrelevant or cases that are difficult to categorize. This framework allows for the development of programs that, at least theoretically, can perform a form of reading comprehension. The practical implementation of such programs, however, depends on various factors, including task

complexity, the volume and quality of training data, and our skill (and perhaps a bit of luck) in creating a model capable of undertaking such a challenge.

The task assigned by your boss—to classify reviews—is considerably less complex than the mentioned NLI tasks. Nonetheless, it offers an excellent opportunity to explore the fundamentals of text classification and sentiment analysis.

In the previous chapter, we demonstrated how to conduct basic sentiment analysis, particularly extracting positive reviews using rule-based (keyword search) and dictionary-based (lexicon) methods. Now, consider how our simple classifier, utilizing these approaches, would classify the following review: “Great, another software update that fixes nothing.” Given the presence of words like “great” and “fixes,” it might mistakenly classify this statement as positive, despite its sarcastic tone expressing frustration over unmet promises of improvement by the software update.

Pretrained models are getting pretty good at sniffing out sarcasm in text, but they’re not magic. They achieve this feat through a combination of analyzing language tricks and understanding the broader context. By training on massive amounts of text data, including examples dripping with sarcasm and others that are plain and literal, these models become familiar with the linguistic gymnastics humans use to convey hidden meaning. They learn to identify red flags like positive words used in negative situations (“this is perfect” after a frustrating experience) or phrases that go against the grain of normal conversation (“Can’t wait for Monday morning!”). But sarcasm isn’t all about wordplay. Pretrained models also zoom out, examining the surrounding text and the relationship between the speaker and listener. For instance, a sarcastic comment between friends is more likely than a sarcastic remark from your boss during a performance review.

Now, let’s examine the phrase, “back to the drawing board.” Through basic keyword or dictionary-based analysis, accurately classifying this expression poses a challenge, as it lacks explicit sentiment indicators. However, “back to the drawing board” is typically used to express that an attempt has failed and it’s time to start over, often carrying a connotation of disappointment or setback.

In contrast, machine learning models, developed with extensive and diverse text datasets, can accurately comprehend idiomatic expressions and their contextual meanings, effectively identifying sentiments of disappointment or frustration. This capability is crucial for thorough sentiment analysis, proving particularly valuable in evaluating feedback, reviews, or internal communications where such expressions are common. An added advantage of such models is their ability to adapt to different domains or languages with little manual effort, making them versatile tools for sentiment analysis across various datasets. A prime example of such a pretrained model is a large language model or LLM.

**LARGE LANGUAGE MODEL (LLM)** An LLM is a powerful AI system trained on vast amounts of text so it can understand and generate human language. It uses deep learning to perform a wide range of NLP tasks, including translation, summarization, question answering, and sentiment analysis, by predicting the

likelihood of a sequence of words. The capabilities of LLMs extend beyond simple text processing, enabling them to grasp context, infer meaning, and even generate coherent and contextually relevant text responses, making them powerful tools in both research and application domains.

All the generative AI models discussed so far and utilized throughout this book are LLMs. Although they were originally designed for general-purpose conversations rather than as dedicated review classifiers, their exceptional ability to understand text and extract insights enables them to be effectively used for sentiment analysis tasks. In the following sections, we will show how to apply them to sentiment analysis and compare the results with those obtained from smaller machine learning models.

### **6.2.1** *What can you learn from sentiment analysis?*

Sentiment analysis offers invaluable insights across various business domains, enabling your company to understand customer emotions, preferences, and feedback on a granular level. For example, if you work for a retail brand, you can analyze social media mentions to gauge consumer sentiment toward a new product launch, identifying areas of excitement or concern to tailor marketing strategies accordingly. If you happen to deal with the finance sector, sentiment analysis of news articles and financial forums can help you and your investors predict market trends and make informed decisions. If you are engaged in hospitality businesses, like hotels and restaurants, utilizing sentiment analysis on review platforms to highlight areas for improvement in service or ambiance can directly impact customer satisfaction and loyalty. Additionally, in tech companies, you can leverage sentiment analysis in user feedback for software updates, prioritizing fixes and features that address the most pressing user concerns. This strategic application of sentiment analysis not only enhances product and service quality but also fosters a closer connection with customers by showing responsiveness to their needs and opinions.

The simplest and most often used form of sentiment analysis categorizes texts into three groups: positive, negative, and neutral sentiments. In many cases, such as with our reviews, this is enough to understand customer sentiment. However, you may encounter situations where you will have to explore more complex aspects of the human soul (read: demandingness) and apply other instances of sentiment analysis, such as these:

- *Emotion detection*—This involves identifying specific emotions expressed in the text, such as happiness, sadness, anger, surprise, fear, and disgust, allowing for a more detailed understanding of the user's feelings and reactions. This may be crucial, such as for detecting suicidal ideation on social media. Another business application where emotion detection is essential is in customer support and service interactions, especially for industries like telecommunications, banking, or utilities, where customer frustrations can escalate quickly. For example, in a telecommunications company, emotion detection can be employed in analyzing customer support chats or call transcripts. By identifying specific

emotions such as frustration, anger, or disappointment, the company can flag cases that require immediate attention or intervention. This allows for a prioritized response to highly dissatisfied customers before they tell everyone on the web that Quantum Fluff (your company's pet feature) actually does more harm than good.

- *Aspect-based sentiment analysis*—This technique focuses on identifying sentiments related to specific aspects or features within a text. For instance, in product reviews, it differentiates sentiments toward the product's price, quality, design, etc., providing detailed insights into various facets of customer feedback. Who knows—maybe Quantum Fluff would gain more customer appreciation if it was cheaper?
- *Intensity or sentiment strength*—Sentiment analysis can also assess the intensity or degree of sentiment expressed, distinguishing between mild and strong emotions. This helps in understanding not just the nature of the sentiment but also its strength or urgency. For instance, after such an analysis, it may turn out that Quantum Fluff provokes such intense negative feelings that people are willing to pay more just to get rid of it, offering your company new opportunities to earn.
- *Intent analysis*—Beyond identifying sentiment, some approaches aim to understand the intent behind a text, such as whether the user intends to purchase, recommend, or complain about a product or service. This may prove useful for evaluating customer support tickets, emails, and social media messages. By analyzing the language and phrases customers use, the system can determine their intent, such as seeking information about new plans, reporting a service outage, requesting technical support, or expressing intent to cancel their service. For instance, if a customer's message is found to contain phrases such as “turn this bloody Quantum Fluff off,” “better fluffs elsewhere,” or “thinking of switching,” the system can flag this as a high-priority intent to churn. This can trigger an immediate response from a specialized customer retention team, who can reach out to the customer with personalized offers (such as five months without Quantum Fluff for free), support, or solutions aimed at addressing their concerns. This proactive approach not only improves customer satisfaction by providing timely and relevant responses but also aids in reducing churn rates, directly impacting the company's bottom line.

These advanced approaches to sentiment analysis allow for a richer, more complex understanding of textual data, offering deeper insights into consumer behavior, market trends, and public opinion.

### 6.2.2 Direct sentiment analysis with generative AIs

Even though generative AIs were primarily designed for generating text completions rather than performing sentiment analysis, their ability to comprehend text can be utilized for a quick assessment of the sentiment expressed in any given piece of text. You can test this by examining three reviews from our example dataset. These reviews

come with scores of 5, 3, and 1, which indicate positive, neutral, and negative sentiments respectively. The reviews, along with their translations, are presented in table 6.1. Also detailed are the results of the sentiment analysis conducted by ChatGPT 4 and Gemini Advanced. To achieve similar results, you can use the prompt “What is the sentiment of these reviews?” followed by including the reviews in Portuguese.

As you can see in the table, both ChatGPT 4 and Gemini Advanced demonstrated perfect understanding of the reviews. The outcomes from this modest experiment are encouraging and warrant further exploration into how direct application of generative AIs compares with the basic sentiment analysis techniques outlined in section 5.5.4. In that section, the simplest keyword search (listing 5.6) managed to identify positive reviews with a sensitivity of around 47% and a specificity of up to 90%.

You are about to see whether direct utilization of generative AI's language capabilities can yield improved results. The review scores provided in our example dataset will once again be used as a reference point for evaluating the quality of the analysis through the calculation of sensitivity and specificity. But before we can draw any conclusions, we need to conduct direct sentiment analysis with generative AI on a larger sample, by using its API.

### 6.2.3 Sentiment analysis with generative AI's API

To evaluate generative AI's capabilities in detecting sentiments on a broader scale, we will utilize the ChatGPT 4 API. For details on API usage, see chapter 1. It's also important to note that accessing the API might require a subscription or a specific pricing plan. Your goal here is to have ChatGPT assess the sentiment of the first 500 non-empty reviews from the dataset, and compare these results with those from a basic sentiment analysis using keywords, as conducted in section 5.5.4 (listing 5.6).

The following code demonstrates how you can use the API to conduct sentiment analysis on the reviews by leveraging the intrinsic language capabilities of ChatGPT 4. To make it operational, you'll need to replace `your-api-key` with your actual ChatGPT API key and ensure that your account has sufficient funds. Fortunately, you can also find the results of this analysis in the books GitHub repository in the `Sentiment_Analysis_500reviews.csv` file.

The preceding code is straightforward. For each of the 500 reviews stored in the DataFrame, we send the following prompt to ChatGPT via the API: The sentiment of this review is:, appending the actual review text. The model then generates a response,



which is classified as positive if it includes the word “positive.” The terms “negative” and “neutral” are utilized to identify negative and neutral sentiments respectively. If none of these words are found, the review is left without an assigned sentiment. Note that this method of analyzing ChatGPT’s responses is quite basic and may overlook more nuanced answers, such as those indicating mixed feelings within a review. Despite its simplicity, this approach can still produce remarkable results, as documented in table 6.2.

As in our previous approach, you can use the `review_score` variable from the dataset to evaluate the sensitivity and specificity of extracting positive reviews. Any review that obtained the score of 4 or 5 was considered positive. Obviously, the sentiment assessment with the `review_score` variable obtains sensitivity and specificity of 1, as this is our benchmark.

The results shown in table 6.2 indicate that both the basic keyword analysis and the method utilizing the ChatGPT 4 API exhibit very high specificity, exceeding 0.9. This means that both approaches seldom misclassify negative or neutral reviews as positive. Furthermore, ChatGPT 4 demonstrates significantly higher sensitivity (0.74), capturing many positive reviews that the basic keyword search missed. In the previous chapter, our attempts to improve the sensitivity of extracting positive reviews achieved limited success. Despite adopting more advanced techniques for cleaning the reviews, applying lemmatization, and using predefined dictionaries for Portuguese sentiment analysis, we only managed to enhance sensitivity by a few percentage points. However, by leveraging ChatGPT 4 to determine the sentiment of the reviews, we succeeded in increasing sensitivity by over 20%! This significant improvement was achieved even with the most basic interpretation of the model’s responses, marking a substantial and unequivocal advancement, albeit at a cost. Given that the ChatGPT API charges based on token usage, analyzing a large volume of real data—not just 500 sample reviews but thousands—could pose a financial challenge, prompting the question of its cost-effectiveness. While I appreciate the simplicity and effectiveness of this method, it may be too early to request additional funding from your finance department.

At this juncture, it’s crucial to recognize that when ChatGPT is queried about sentiment analysis or any similar task that it is inherently capable of performing due to its ability to “read” with comprehension, its typical advice often revolves around guiding



you to write specific code to accomplish the task at hand. The model may highlight the advantages of traditional NLP methods, emphasizing their capacity for analyzing nuanced and specific data among other benefits. In practice, however, most data encountered is relatively standard and predominantly in English, which—as demonstrated—can be quickly and efficiently analyzed by generative AI. The principal drawback of such analysis is the time and cost involved, in addition to limited control over the tool, which could be modified or updated at any time by an external party.

A common criticism of generative AIs is their “black box” nature, offering limited transparency in how responses are generated and on what basis. This argument is valid when comparing the performance of generative AIs to basic NLP tools like keyword searches. However, it becomes less convincing once we begin to use a trained language model of any size. Nevertheless, could it be that generative AIs, with their advanced “reading” capabilities, represent the best option for tackling NLP tasks? A year ago (before API access to ChatGPT 4 was available), we conducted a similar test using earlier OpenAI models, and the outcomes were unimpressive. We had a preference for conventional NLP methodologies. However, with the advancements in generative AI technology, our certainty on this matter has waned.

With that said, let’s proceed to explore sentiment analysis using traditional and well-established machine learning methods. In the next section, we will examine whether, with the help of pretrained models, we can achieve results as compelling as those provided by the ChatGPT 4 API.

#### 6.2.4 Sentiment analysis with machine learning

Previously, you learned how to conduct the simplest forms of sentiment analysis using methods such as frequency analysis, keyword searches, or dictionary-based approaches. While mastering these foundational techniques remains crucial, particularly for less commonly studied languages, the reality is that for the majority of everyday tasks, more sophisticated methods, such as machine learning, are preferred.

Machine learning has been around for some time now and should not intimidate anyone who dares to call themselves a data analyst. The era when proficiency in Excel sufficed is behind us; today, teaching your computer to recognize patterns has become a routine task. Thankfully, with the advent of new technologies, libraries, pipelines, and models, effective utilization has become significantly more accessible than in the past. While gaining an understanding of the underlying mechanics, such as matrix multiplication, is beneficial, and we encourage delving into these concepts, a deep technical grasp is no longer a prerequisite for using these models effectively. This situation is analogous to driving a car: knowing how the engine works isn’t necessary to be a competent driver, but in certain scenarios, such knowledge could help you avoid accidents or prevent you from being robbed by your car mechanic. And by no means do you have to construct the car in order to drive it! Most people acquire vehicles through purchase and sale transactions. Pretrained machine learning models are even more accessible, with many available online for free.

**WHERE CAN I FIND MY MODEL?**

So, what are your options when searching for a new, shiny, fast, safe, and collision-free model? As always, you could resort to a good old-fashioned web browser, or save yourself some time by discussing your requirements with the generative AI of your choice (Gemini is recommended for reasons mentioned earlier). However, it's likely that all these efforts will, in any case, direct you to the Hugging Face website (<https://huggingface.co/>).

The Hugging Face website serves as a central hub for AI practitioners, offering access to a wealth of resources tailored to NLP and machine learning. At its core is the Model Hub, where users can explore and download a wide array of pretrained models suitable for various NLP tasks, such as sentiment analysis, text generation, and language translation. The website also features comprehensive documentation and tutorials to assist developers in implementing these models in their projects. Additionally, the Hugging Face platform encourages community engagement, allowing users to share their own models and collaborate with others.

While Hugging Face models are powerful tools for advancing NLP tasks, you should proceed with caution. Concerns have been raised regarding the potential for some models to harbor vulnerabilities or malicious code. Although the platform conducts malware scans on uploaded content and actively works to remove any malicious code, the arms race in cybersecurity is ongoing. Malicious actors continuously seek new security loopholes to exploit. To avoid becoming an unwitting victim in this cyber conflict, it's crucial to proactively safeguard your security. The following list of ten security commandments is applicable not only to Hugging Face models but to any model (or software) downloaded from the web:

- 1 *Use verified models*—Prefer models verified by the platform or those from reputable and known organizations.
- 2 *Review model documentation*—Carefully read the model's documentation for potential red flags.
- 3 *Check contributor reputation*—Research the model's contributors to ensure they are trustworthy.
- 4 *Conduct security assessments*—Use security tools to scan for vulnerabilities or malicious code within the model.
- 5 *Isolate testing*—Test new models in a safe, isolated environment away from sensitive data or systems.
- 6 *Follow community feedback*—Pay attention to the community feedback and reports about specific models or contributors.
- 7 *Update regularly*—Keep your models and their dependencies up to date to ensure you have the latest security patches.
- 8 *Limit permissions*—When integrating models into your systems, grant them the least privileges necessary to perform their function.
- 9 *Use encryption*—Encrypt sensitive data to protect it in case of accidental exposure by a malicious model.

- 10 *Stay informed*—Regularly follow updates and security advice from Hugging Face and the broader AI community.

Another popular option for finding an applicable model is GitHub (<https://github.com/>). This vast repository hosts a multitude of pretrained models shared by developers and researchers from around the world. While GitHub offers an extensive range of models for various tasks, you should approach it with the same caution advised for Hugging Face models. The open nature of GitHub means that anyone can upload code, which could potentially include vulnerabilities or malicious content. These ten commandments serve as a guide to achieving maximum security.

#### WHAT IF THE MODEL I NEED DOES NOT EXIST?

So much for theory, but real life is much more challenging. What should you do if the new, shiny, fast, safe, and collision-free model of your dreams doesn't exist? Let's revisit our example. If our reviews were written in standard English, finding a relevant pretrained model to perform sentiment analysis would be straightforward. However, the fact that our input is in Portuguese presents us with an opportunity to explore additional options.

What alternatives do we have for conducting the desired analysis, especially when dealing with less commonly used languages? What if our task is really fancy, like assessing how politically correct a joke is? Or what if we combine the two, and are dealing with the task of assessing the political correctness of a joke written in Korean, say, in its northern dialect? (Before you go any further, we recommend consulting your favorite generative AI about the potential implications of developing such a model and considering whether you really should get involved.)

Here are some options:

- *Search for a suboptimal model*—This should be your starting point, no matter how uncommon your task or language is. It's always worth checking whether someone has already tackled a similar, but maybe not identical, challenge. Why reinvent the wheel? Explore resources like the Hugging Face Model Hub and GitHub, use a web browser, or enlist generative AI to assist in your search. While you might not be completely satisfied with any existing models you find, they can provide valuable benchmarks for comparing your further efforts.

Pros of this approach include time efficiency, as it saves you from starting absolutely from scratch. Additionally, it offers an opportunity for learning and improvement by analyzing existing models. However, cons might include the challenge of finding a perfect match for your specific needs, limitations in model performance or adaptability, and the risk of depending on a model that may not be actively maintained or updated.

- *Translating input to English*—This is a practical approach for conducting NLP tasks on less common languages, leveraging automatic translation tools and applying English-trained models. This method benefits from the extensive availability and sophistication of models for English, enhancing the potential for

accurate analysis. However, it carries the risk of losing nuances and cultural context, possibly introducing errors or biases due to translation imperfections. Generative AIs can mitigate some of these challenges by providing more accurate translations and preprocessing the text to align better with English-trained models, thus preserving more original meaning and reducing translation-related inaccuracies.

- *Use multilingual models*—If you can't find a model fine-tuned specifically for your task and language, another effective approach is to use multilingual models such as XLM-RoBERTa or Multilingual BERT. These models are trained on vast datasets covering a wide array of languages, enabling them to understand and process multiple languages simultaneously without the need for language-specific training. This approach makes them highly versatile and an effective solution when a task-specific, language-specific model is unavailable. The primary advantage of using multilingual models lies in their broad applicability, saving the effort of developing or finding models tailored to each language, and offering respectable performance across various NLP tasks. However, these models may not match the performance of specialized models in certain tasks or languages due to their generalized nature. Additionally, customizing them for highly specific or nuanced tasks can be complex.
- *Utilize zero-shot learning models*—These models, which are trained to understand instructions in natural language, excel at generalizing to tasks they haven't been explicitly trained on by leveraging semantic knowledge and relationships between concepts. This allows them to infer, for example, the sentiment of texts in categories or contexts they've never directly encountered, based on understanding gained from related tasks. However, while zero-shot learning models provide the flexibility to tackle a wide range of tasks with a single model, their performance might not always match that of models fine-tuned on specific tasks, especially in highly nuanced or domain-specific contexts.
- *Fine-tune an existing model*—This is a practical option when resources for data collection are limited, allowing you to enhance a pretrained model with task-specific adjustments. This method is time-efficient, cost-effective, and it lowers the barrier to advanced modeling techniques. However, it depends on the pretrained model's relevance to your task and the quality of labeled data used for fine-tuning. There's also a risk of overfitting if adjustments aren't made correctly.

For NLP tasks, you might consider fine-tuning one of the existing LLMs, such as the widely recognized BERT, available on the Hugging Face platform. Such LLMs have been pretrained on extensive text corpora and possess a comprehensive understanding of language, which can be further tailored to specific NLP tasks using a comparatively smaller dataset. This can reduce the amount of effort and expertise needed, though computational resources and understanding of model behavior are still required.

As usual, generative AI can significantly facilitate this process by offering their assistance and expertise. But in this case, they can offer even more. As all generative AIs discussed in this book are LLMs themselves, they can serve as a linguistic foundation for the model you are developing. In other words, you can fine-tune generative AI to your specific task!

- *Train your own model*—This option involves collecting a sufficient amount of labeled data and training the model yourself. This approach allows for customizing and optimizing the model to fit the specific nuances of your dataset and task. The main advantage is the potential for high accuracy and relevance to your particular use case, as the model learns directly from data reflective of your domain. However, the drawbacks include the significant time, effort, and expertise required to gather labeled data and design and effectively train the model. These challenges persist regardless of the assistance provided by generative AI. Additionally, this method demands substantial computational resources.

Let's test a few of these options and compare their results. Fine-tuning an existing model and training one from scratch demands greater expertise and falls beyond this book's scope. However, should you opt for this route, generative AI can offer significant assistance by providing guidance, resources, and tools tailored to your needs. Additionally, you can refer to *Build a Large Language Model (From Scratch)* by Sebastian Raschka (Manning, 2024) for further instructions and insights into navigating these advanced techniques.

### 6.2.5 Sentiment analysis with a suboptimal model

To try out the first option, searching for a suboptimal model, you could start by searching for an existing sentiment classifier for Portuguese, but this attempt proved unsuccessful (as of March 2024). Consultations with ChatGPT 4 and Gemini Advanced yielded some suggestions, but none fully met our requirements, and many of the provided links were invalid. Both generative AIs eventually advised manually scouring the Hugging Face website and GitHub for suitable models, a task that unfortunately led to no significant findings.

Consequently, you could opt for a less-than-ideal solution suggested by Gemini—the FinBERT-PT-BR classifier, which was trained on Portuguese financial news. Despite this not being the ideal dataset for analyzing customer reviews, a human-in-the-loop approach and error monitoring might help you identify and address the model's shortcomings. All in all, it might be useful to proceed with this model anyway and assess its efficacy.

First, let's become fully aware of the potential drawbacks of this approach. To achieve this, you could start by asking ChatGPT the following question:

 I have a dataframe with a column `review_comment_message` containing customer reviews in Portuguese. I want to extract positive reviews using a sentiment classifier found on this website: <https://huggingface.co/lucas-leme/FinBERT-PT-BR>

What are the potential drawbacks of using this model for my task?



[...] Potential Drawbacks:

- 1 Domain Mismatch: FinBERT-PT-BR is specialized for financial contexts, which might not align well with general customer reviews.
- 2 Sentiment Analysis Complexity: The model may struggle with nuances like sarcasm or cultural expressions, affecting accuracy.
- 3 Language Specificity: Regional variations in Portuguese could lead to inconsistent performance across different Portuguese-speaking regions.
- 4 Model Biases: Pretrained models carry inherent biases and limitations from their training data, potentially skewing results.
- 5 Computational Demands: Processing a large volume of reviews with a transformer-based model requires substantial computing resources.
- 6 Ethical Considerations: Ensuring ethical and privacy-respecting use of customer reviews is crucial.

In short, while FinBERT-PT-BR offers an intriguing solution, its financial focus, potential language and regional limitations, computational demands, and the need for ethical diligence present notable challenges for extracting positive reviews from a general customer feedback dataset.

This conversation illustrates the potential benefits of discussing your analytical ideas with generative AI. Notably, ChatGPT was able to offer insightful comments on a resource it was previously unfamiliar with. Moreover, ChatGPT asserted that it didn't use the provided link to further investigate the model's website for additional information. This prompts the question: how did it know? The explanation given upon inquiry was remarkable:

You caught me in a bit of an overextension based on the name "FinBERT-PT-BR," inferring from the "Fin" prefix, which commonly denotes finance-related models (like FinBERT being a well-known adaptation of BERT for financial texts). The assumption was that this model, given its name, is specialized for analyzing financial text in Portuguese. Such naming conventions are typical for domain-specific versions of BERT and other language models, where the prefix or suffix indicates the model's specialized training corpus or intended application area. However, without directly accessing the provided link or having specific knowledge of this model in my training data up to my last update in April 2023, I relied on these conventions to inform my response.

If this isn't a demonstration of pure intelligence, then I'm not sure what is. However, even if you don't share my sense of wonder, it should be clear by now that consulting advanced generative AIs like ChatGPT 4 when planning your research is far from a waste of time.

### Generative AI interprets external resources

It could be advantageous to inquire with generative AI whether using a specific external resource (such as a model, database, etc.) for your research is reasonable, or to discuss potential drawbacks associated with a particular resource. Even if the generative AI is encountering the resource for the first time, there's a possibility it can deduce the resource's contents and how it might influence your analysis.

Let's ask our generative AI to prepare a code snippet. We used the following prompt in the same ChatGPT session: "Propose a code snippet to utilize this model to extract positive reviews from my data." The obtained snippet is shown in the following listing.

This snippet was provided alongside instructions on how to install the required libraries and a detailed comment emphasizing the importance of consulting the model's documentation to understand the model's output. Specifically, it was necessary to manually replace `LABEL_1` with an appropriate label indicating positive reviews, in our case, `POSITIVE`. Generative AI also detailed the use of exception handling around the classifier to manage any potential errors during processing, such as inputs that were too long or unexpected.

In the Jupyter notebook from the book's GitHub repository, you can find this code manually adapted and applied to analyze the first 500 reviews from our testing dataset. As before, the `review_score` variable was employed to evaluate the sensitivity and specificity of the classifier. The FinBERT-PT-BR model recognized positive reviews with



a sensitivity of 0.56 and a specificity of 0.93. This performance surpasses simple keyword-based classification, yet it does not reach the efficacy of the results achieved through direct application of ChatGPT 4's language capabilities.

## 6.2.6 *Sentiment analysis on translated inputs*

Now you may want to explore whether translating the input and employing a sentiment classifier for English texts could produce better results. The pros and cons of such a solution were listed in section 6.2.4, so let's jump to implementation right away.

We began with a specific prompt: "Write a code snippet to extract positive reviews from our dataset. Clean the reviews and translate them to English and then apply the most appropriate sentiment classifier for English." Then we explored several options to identify the best method for translating the input, aiming for a simple and reliable solution that doesn't require registration or payment. Ultimately, with generative AI's help, we developed the following code snippet.

The code employs the Meta model for translation, m2m100\_418M, which supports multiple languages, including Portuguese and English. For sentiment analysis, it uses the distilbert-base-uncased-finetuned-sst-2-english model. Both models were recommended by generative AI for their broad applicability and performance. However, it was noted that we might consider exploring other models better tailored to our specific requirements.

While the code executes smoothly, translating 500 reviews took some time, so patience is advised if you plan to replicate this process. Using the `review_score` variable, we again evaluated the sensitivity and specificity of this method for identifying positive reviews. The corresponding code can be found in the Jupyter notebook in the book's GitHub repository. Remarkably, this approach of translating input achieved a sensitivity of 0.86 and specificity of 0.89 for correctly classifying positive reviews, offering the best results thus far and proving comparable to those obtained using ChatGPT 4's inherent language capabilities. Not bad, indeed.

### 6.2.7 Sentiment analysis with multilingual models

Our next step is to explore whether using multilingual models for sentiment analysis could yield better results. The characteristics of such models, together with their potential drawbacks, were presented in section 6.2.4, so let's proceed with the implementation.

We used the prompt, "Now, I want to repeat this exercise but instead of translating the input, I'd rather use a multilingual model. Could you write a relevant code snippet for me?" Unfortunately, the obtained code didn't work immediately, due to package dependency issues. Rather than manually resolving these issues or meticulously reviewing the entire error log, we simply copied the last few lines of the error message into the generative AI chat window for assistance. ChatGPT clarified the issue in plain English—far more helpful than the typical technical jargon found in error messages—and suggested two solutions: either downgrading one package or upgrading another, which promptly resolved the issue.

As you progress through this book, you may encounter similar situations where packages evolve, and today's code becomes deprecated tomorrow. Often, the solution involves minor adjustments, which could take mere seconds to implement but hours to figure out. With generative AI, you can move past endlessly scrolling through Stack Overflow for debugging tips.

#### **Generative AI is the ultimate tool for bug extermination**

Imagine the most deadly and ruthless bug spray. Multiply its effectiveness by a thousandfold, and you're still not capturing the full extent of how adept generative AI is at tackling bugs! Instead of attempting to decode the error message yourself, simply paste it (or a fragment) into the model's chat and request a translation into human language along with appropriate solutions. In the majority of instances, you'll receive a swift and satisfactory response.

After smashing all the dependency bugs and correcting the output labels manually, we obtained the following working piece of code (don't forget to install the required libraries).

This script leverages the twitter-xlm-roberta-base-sentiment model to directly classify the sentiment of each review in the dataset, eliminating the need to translate them into English first. It achieves a sensitivity of 0.79 and specificity of 0.93, which are scores comparable to those achieved using ChatGPT 4's innate language capabilities. This discovery suggests we've found a solution of similar quality that is both more cost-effective and faster than utilizing the generative AI API. However, before you rush to request a raise from your boss, let's explore if we can surpass this performance by utilizing a zero-shot learning model.

### 6.2.8 Sentiment analysis with zero-shot learning models

As a reminder, zero-shot learning models are particularly well-suited for tasks where labeled training data is scarce or unavailable. These models can generalize to tasks they haven't been explicitly trained on, making them ideal for classifying text into categories (such as sentiment analysis) without needing a dataset specific to that task. For extracting positive reviews from our dataset in Portuguese using a zero-shot learning approach, you can leverage models designed for multilingual understanding, such as those available through the Hugging Face Transformers library.

All this, and much more, you will learn when you ask generative AI a question similar to this one: "I want to extract positive reviews from my dataset with help of a zero-shot learning model. Reviews are in Portuguese. How do I achieve this?" In response, ChatGPT 4 generated the following code, which was adapted to our input data manually. To run the code, you will have to install the transformers library with the command `pip install transformers`.

The code suggested by generative AI leverages the facebook/bart-large-mnli model, which is equipped to handle multilingual texts and has been trained on a variant of the Multi-Genre Natural Language Inference (MNLI) dataset. This enables the model to conduct zero-shot classification on texts in various languages, including Portuguese. ChatGPT, however, points out that this model serves merely as an example, and we may discover other models that could yield better results for specific datasets. For instance, the typeform/distilbert-base-uncased-mnli model is presented as an alternative that is smaller and faster, though potentially less precise.

The effectiveness of the zero-shot learning model was evaluated using the `review_score` variable. The model achieved a sensitivity of 0.87 for identifying positive reviews and a specificity of 0.74. While this performance is marginally inferior to that of a multilingual model, it remains sufficiently robust to warrant considering zero-shot learning models in your analysis.

### 6.2.9 Comparing results of advanced sentiment analysis

In the previous sections, we explored several methods for performing sentiment analysis using pretrained machine learning models. Initially, we leveraged ChatGPT 4's inherent language capabilities to identify positive reviews (section 6.2.3). This approach was followed by employing a suboptimal pretrained model tailored for sentiment analysis in Portuguese financial texts (section 6.2.5). Next, we utilized a sentiment classifier designed for English, applying it to translated inputs (section 6.2.6). To circumvent the errors and biases introduced by translation, we opted for a multilingual model (section 6.2.7) and a zero-shot learning model capable of supporting multiple languages (section 6.2.8). These methodologies were tested on a dataset of 500 non-empty reviews, using the `review_score` variable to evaluate the sensitivity and specificity of the classifications. All the results are gathered in table 6.3.

These results demonstrate that, in our tests, the multilingual model outperformed all others, uniquely surpassing the ChatGPT 4 API. A zero-shot learning model that supports multiple languages achieved results comparable to those of generative AI's inherent language capabilities. Similarly, the method involving translating the input showed potential for high performance. Conversely, classifications based solely on keyword searches lagged significantly in sensitivity, though a more meticulous selection of keywords could potentially enhance its effectiveness.

Notably, just a year ago, the outcome of such an evaluation would have differed substantially, with ChatGPT 3—then the sole option available via API—failing to match even the basic keyword analysis in performance. Just think what can be achieved if ChatGPT 5 is finally released!

To sum up, this section illustrated how to conduct sentiment analysis using a variety of advanced pretrained models. Selecting the appropriate methodology for your data and task may involve testing several options, typically on a smaller subset of data, to determine the most cost-effective strategy that could lead to the long-awaited promotion you've been aiming for (just imagine: no more Quantum Fluff disguise on Sundays!). Generative AI can facilitate this process by providing a list of options, discussing their advantages and disadvantages, writing the necessary code snippets to implement them, and then testing and summarizing the results. In certain scenarios, you might choose to directly utilize language capabilities by accessing their APIs or using them as a foundation to fine-tune your own model, although the latter option has not been explored in this book.

### 6.3 *Text summarization*

In the preceding sections, we successfully classified reviews based on their sentiment. The results obtained may not be entirely satisfactory in terms of efficiency, and additional analysis would be required to enhance the basic methods presented. However,

let's assume that your boss is content with the results and wishes to explore further. The question at hand is, what do customers most often complain about?

This task aligns exceptionally well with another NLP method you're about to explore: text summarization. This technique aims to shorten long documents into more concise versions, maintaining the essential information and presenting it coherently. Utilizing approaches like rule-based methods or machine learning, text summarization enables users to swiftly capture the main concepts and pertinent details from large text collections.

### 6.3.1 How can you benefit from text summarization?

You can apply text summarization across a wide range of business scenarios to enhance efficiency, improve understanding, and streamline communication. Here are some examples:

- *Customer support*—Automatically generating concise summaries of customer inquiries or feedback from emails, chat messages, or social media will facilitate quicker response times. Even if it's widely anticipated that the feedback will concern complaints about Quantum Fluff, it is valuable to have it quantitatively confirmed.
- *Executive briefings*—Summarizing key points from lengthy reports, financial analyses, or market research for a quick review by executives and decision-makers can assist your boss and his colleagues in guiding the company toward glory and financial success. If you succeed, you will get your share . . . in the glory.
- *News aggregation*—Creating short summaries of news articles can benefit not just news aggregation apps or websites but also your company. After all, staying informed about developments in the Quantum Fluff market is a routine task for any fluff manufacturer that values its reputation.
- *Legal document review*—You think lawyers and other legal professionals fall into ecstasy when reading through their dense legal jargon, don't you? However, the reality is they would greatly appreciate being relieved of this burden. If you could develop a tool that summarizes legal documents, contracts, or case files, facilitating a quicker grasp of their essential contents, they might just honor you with a monument (which you can add to your pension plan, together with your glory shares gained earlier).
- *Academic research*—How about academics and researchers? Do they enjoy their scientific jargon? Perhaps, but a tool that summarizes academic papers or journals, enabling quick comprehension of the premise, methodology, results, and conclusions without reading the full text, would likely be valued by students, post-docs, and that part of the research community who is still hoping for tenure. Those, in particular, whose survival depends on reading and publishing swiftly.
- *Medical records summarization*—Health professionals represent another group that could greatly benefit from quick summaries, for instance of patient histories, lab reports, or clinical findings. This may facilitate faster diagnoses and

improve treatment planning. But it's not just doctors who would benefit—patients would too. Imagine how pleasant and humanizing it would be if your doctor had the time to actually engage in real conversation with you!

- *Meeting minutes*—Text summarization techniques can streamline recorded discussions or meeting transcripts into concise, actionable summaries, emphasizing key decisions, action items, and discussion points. However, volunteering to develop such a tool carries its risks. What if your program uncovers a widely acknowledged yet unspoken truth within the company: that many of the meetings are, in fact, a sheer waste of time?
- *Email management*—Do you recall that spaghetti email conversation in your company about which coffee machine should be ordered for the office? Missing a few episodes of this soap opera would no longer be an issue if you had a tool capable of summarizing long email threads. This tool would distill the essence of discussions, decisions, or action items into a concise brief, perhaps starting with “Previously, in the New Coffee Machine saga . . .”
- *Content marketing*—With the new Quantum Fluff feature to promote, no matter what, your marketing department is working their fingers to the bone. Why not help them by creating a tool that could generate summaries of blog posts, articles, or whitepapers to use in newsletters, social media, or marketing materials, engaging readers and encouraging them to explore the full content?
- *Product reviews analysis*—Summarizing customer reviews and feedback on products or services may help to quickly identify trends, preferences, and areas of improvement. This objective aligns with what your boss is expecting from you, and in the following sections, we will guide you on how to meet those expectations.

These examples illustrate how text summarization can be a powerful tool for various industries, helping to save time, reduce information overload, and enhance decision-making processes.

### **6.3.2** *How can generative AI help in text summarization?*

Generative AI offers significant potential in summarizing texts efficiently and effectively. By leveraging its deep understanding of language structure, context, and semantics, generative AI can process large volumes of textual information and condense it into shorter, coherent summaries. This capability is particularly useful for extracting the most important information and presenting it in an easily digestible form, saving you and your coworkers a lot of time and effort.

Furthermore, generative AI's advanced natural language processing capabilities allow it to generate two types of summaries:

- *Extractive summaries*—This approach involves selecting and compiling key phrases or sentences directly from the text to create a summary. For example, it can summarize a news article by extracting the most informative sentences that cover the who, what, when, where, and why.

- *Abstractive summaries*—These summaries reformulate the original text, often generating new phrases and sentences that weren't in the initial document, to capture its essence more creatively and fluidly. An example would be condensing a novel's plot into a brief overview that captures the main themes and plot points without directly quoting the text.

Both types of summaries can be tailored for a specific level of detail and originality. Moreover, the adaptability of generative AI to different domains and languages makes it a flexible tool for a broad spectrum of applications and industries.

However, this brilliance does not come without its pitfalls. Most of these were touched upon earlier when we discussed the risks of opting for generative AI over traditional NLP methods.

- *Cost-effectiveness*—Deploying generative AI-based solutions at scale can be slow but can quickly escalate in costs.
- *Lack of control*—Acquiring and maintaining the best-performing generative AI models in-house can be challenging for many companies, causing them to depend on third parties.

For a more detailed comparison of generative AI and traditional NLP methods for text summarization, with their potential drawbacks and tradeoffs, refer to table 6.4.

With these considerations, you might find yourself compromising on the accuracy, simplicity, and fun that generative AI offers to develop more traditional, albeit potentially more suitable, solutions for your company.

### 6.3.3 Summarizing text with ChatGPT

Let's return to your boss's inquiry and discover what customers most often complain about. To address this task, you first need to identify negative reviews using one of the methods described in previous sections. For demonstration purposes, we will take a shortcut and use the set of negative reviews determined by the `review_score` variable, which was previously used to assess the effectiveness of our sentiment analysis. Once the negative reviews are extracted, they will be subjected to text summarization for further insight.

This is a good opportunity to mention another potential issue with texts such as customer reviews. As globalization spreads, you can expect these texts to appear in dozens of languages. When using traditional NLP methods for summarization, the reviews should first be clustered by language, then translated to a common language (most likely English), and only then be subjected to further analysis. With the polyglot capabilities of generative AI, all these steps can be reduced to a single mention in the prompt, indicating that regardless of the input language, you want the summaries in the language of your choice. How brilliant! With generative AI at hand, we can finally finish building the Tower of Babel and even make some cash by offering it for short-term rent!

As a warm-up, let's see how generative AI can summarize the longest review in our example dataset.

**MA** Summarize this text “NÃO RECEBI O PRODUTO, O PRODUTO CONSTA COMO ENVIADO PARA O CORREIO DE RIBEIRÃO PRETO. O CORREIO NÃO RECEBEU O PRODUTO. ENVIE VARIAS MENSAGEM PARA A targaryen E NÃO OBTIVE. ESTA targaryen ESTA SUJANDO SEU NOME”. Use Portuguese in your summary. Provide English translations for both the original and the summary.





Here's a summarization of the given text using a simple non-ML approach based on extracting the most frequent words:

Summary (English translation):

“PRODUCT NOT RECEIVED, POST OFFICE NOT RECEIVED, targaryen NO RESPONSE.”

Please note that this summarization is relatively simple and may not capture all the nuances of the original text. For more accurate and coherent summarization, you can use more advanced techniques like TextRank, or machine learning-based methods.

This response is fast, easy to obtain, and comprehensive. You can further play with your favorite generative AI and ask it to generate longer or shorter summaries, review titles, and review descriptions written in the style of your favorite author, or you can even ask it to turn your boring reviews into pretty brilliant haikus, like this one:

Product never came,  
Messages to targaryen,  
Silent, tarnished name.

Remember the protagonist in Chuck Palahniuk's *Fight Club* who fought his office boredom by disseminating haikus to all employees? Armed with your newly gained knowledge, you can now harness generative AI to develop a straightforward application that sends negative feedback back to the unhappy customer in this elegant form. At the very least, they shouldn't be grumbling about the absence of a response any longer. However, do not expect any praise from your boss after this exercise.

### 6.3.4 Summarizing text with dedicated libraries

When selecting NLP summarization techniques, your choice should depend largely on the type and length of the text to be summarized. For extensive texts such as books, abstractive summarization techniques are often more suitable. These methods can generate concise overviews by understanding and paraphrasing key concepts, making them ideal for capturing the essence of lengthy narratives or detailed discussions without needing to quote the original text extensively. For scientific articles or technical documents, a mix of extractive and abstractive methods might be best, pulling out significant sentences or terms (extractive) and then synthesizing those elements into a coherent summary (abstractive) that captures the document's main findings and implications. Moving to shorter texts, such as news articles or blog posts, extractive summarization can be effective, identifying and compiling the most informative parts directly from the source.

For short texts such as customer reviews, it may be more beneficial to concentrate on extracting main keywords or topics rather than creating summaries. Sentiment analysis, coupled with keyword extraction, often provides sufficient insight. In fact, given the exercises in the previous sections, you should generally know what to expect from text summarizations of the negative reviews.

As for the particular methods, text summarization techniques can generally be divided into two categories: rule-based approaches and machine learning approaches. Each offers distinct methods for generating text summaries, with their own strengths and limitations.

Rule-based approaches rely on predefined linguistic rules and heuristics, such as sentence length, position, and the frequency of key terms, to extract important sentences. While straightforward and interpretable, these approaches can be rigid and may fail to adapt to the nuances of different texts. Here are a couple of the most common rule-based methods for generating extractive summarizations:

- *Sentence scoring and extraction*—This method scores sentences based on predefined criteria, such as the position of the sentence and the presence of keywords. Term frequency-inverse document frequency (TF-IDF) is often used to score sentences based on the frequency of important terms. The highest-scoring sentences are then combined to form the summary.
- *TextRank*—A variation of the PageRank algorithm, TextRank represents sentences as nodes in a graph, with edges representing content overlap. The most central sentences are extracted for the summary.
- *Frequency-based methods*—This approach identifies and extracts key terms, *n*-grams, or phrases from the text that represent the main topics. These keywords are then used to create a summary.
- *Cue phrase method*—Utilizes specific cue phrases (e.g., “in summary,” “to conclude”) that often signal important information. Sentences containing these phrases are extracted for the summary.
- *Lead-based summarization*—Commonly used in news articles, this method involves extracting the initial few sentences or the first paragraph, assuming that text contains the most critical information.

Rule-based approaches can also be used for abstractive summarization. However, this requires rule-based paraphrasing or predefined templates to generate summaries by filling in slots with relevant information extracted from the text. As you might guess, the output is not as smooth as the abstractive summaries created by generative AI.

Apart from rule-based approaches, Python offers multiple machine learning techniques to summarize texts: latent semantic analysis (LSA) and latent Dirichlet allocation (LDA) can be used to analyze latent topics, whereas pretrained language models like BERT, text-to-text transfer transformer (T5), and Bidirectional and Auto-Regressive Transformer (BART) can be fine-tuned for specific tasks. Presenting the details of these methods and their capabilities is beyond the scope of this book, not to mention that most of them are designed for other purposes than summarizing texts as short as our reviews. However, with options like the Gensim, scikit-learn, and Hugging Face Transformers libraries, you can select the right technique for your requirements and text type. At the same time, generative AI can assist you and provide advice.

Let’s now revisit our example. To understand how traditional NLP methods can summarize reviews and to compare them with the straightforward approach

presented in section 6.3.3, we will use a simple rule-based technique—a frequency-based approach—to analyze our negative reviews. This method identifies the most common words after removing stopwords, providing a quick insight into the prevalent concerns or keywords within each review. First, we will ask ChatGPT to generate relevant code in Python, using this prompt, “Provide Python code to generate summaries of very short customer reviews in Portuguese. Use a frequency-based approach.” The resulting code, after some adaptations to our input data, can be found in the Jupyter notebook in the book’s GitHub repository.

The code proposed by generative AI functions well and can be readily adapted to summarize reviews in the entire dataset. For instance, the three-word summary of the example review from section 6.3.3 is “produto, correio, targaryen” (product, mail,

targaryen). In this context, “targaryen,” like all *Game of Thrones* house names, are our data provider’s means of anonymizing store names.

You can generate longer and more informative summaries by modifying the `num_keywords` parameter in the preceding code. However, in our opinion, the output generated with this simple frequency-based approach is not as precise and to the point (and not even as entertaining) as ChatGPT’s haikus. Direct three-word summaries “manually crafted” by generative AI also seem a bit better, although a more rigorous approach would be needed to assess which outcome is truly superior.

To get a feeling for the results, you can compare the output for the first five reviews, gathered in table 6.5. All translations were provided by ChatGPT.

### Generative AI provides both extractive and abstractive summaries

While generative AI can perform both types of summarizations, its primary strength lies in abstractive summarization, as it has been trained on vast amounts of textual data and is capable of generating human-like coherent summaries.

Another concern is that summarizing each negative review individually doesn't effectively address the task assigned by your boss. Someone still needs to read through all the summaries and draw conclusions from them. To tackle this issue more efficiently, you can employ another method called *topic modeling*, which helps identify common themes and topics across a collection of documents, such as the negative reviews in this case.

### 6.3.5 Topic modeling

Topic modeling is not a form of text summarization per se, but it can be used to generate a high-level summary of the main themes and topics in a collection of documents. While text summarization techniques aim to create condensed versions of individual documents by extracting or generating the most important sentences or phrases, topic modeling techniques are designed to uncover the underlying latent structure and themes within a corpus of texts.

Topic modeling can help you understand the main topics and their distribution across a set of documents, but it does not generate human-readable summaries of the individual texts. Instead, it represents each document as a mixture of topics, with each topic being a probability distribution over words.

Our example set of negative customer reviews is an ideal candidate for demonstrating topic modeling, which can summarize them in a convenient, human-readable form. Let's start by asking ChatGPT for the relevant code, using the prompt, "I have a set of short negative customer reviews in Portuguese stored in a pandas dataframe column. I want to know what are the main concerns raised by customers. How to extract this information from reviews?"

The proposed code was manually adapted to analyze only negative results from our example dataset (reviews with `review_score` of 1 or 2). The output is a list of the five most common topics mentioned in the reviews; however, the topics themselves are not presented in a friendly form. Fortunately, we have generative AI at hand to help us read and interpret what, by nature, is not human-readable. In this case, informing the model directly about the negative nature of the input leads to better conclusions.

As demonstrated, generative AI can be very useful when dealing with difficult-to-read output, particular when it is written in a language you are not familiar with. It is evident that generative AI is able to make a nice and plausible story out of extracted keywords. However, in our example, all five of the most common topics were related to the same issue: dissatisfaction with delivery, which is a take-home message for your boss.

### Generative AI interprets the output

Generative AI is helpful in extracting the essence of the output of text-mining methods, even if it is presented in a hard-to-read format and a foreign language.

To conclude, this section showcased the application of generative AI to identify the most common customer concerns by employing text summarization and topic modeling techniques on the set of customer reviews. In addition, we entertained ourselves by generating a bunch of haikus. This comprehensive approach demonstrates the versatility and utility of generative AI in the realm of natural language processing and text analysis.

However, while generative AI is a powerful language model that performs well in various NLP tasks, including text summarization, its performance may not always be better than dedicated summarization libraries. The choice between generative AI and dedicated libraries depends on several factors, such as the nature of the text, the desired summary type (extractive or abstractive), and the domain-specific context.

Dedicated summarization libraries may be optimized for specific tasks and can often provide more control over the summarization process, enabling users to fine-tune the output according to their requirements. Additionally, they may perform better on domain-specific or technical texts.

On the other hand, generative AI's strength lies in its ability to generate more coherent and natural-sounding summaries, especially for abstractive summarization. It can be an excellent choice for generating human-like summaries or when the focus is on producing easily comprehensible output.

In short, there isn't a one-size-fits-all answer, and the choice between generative AI and dedicated summarization libraries depends on the specific requirements of the task at hand. It is essential to evaluate different approaches and choose the one that best fits your needs.

### Things to ask generative AI

- How to perform your\_task with the help of your API?
- What is this bunch of text about?
- Which NLP method will be the best to summarize my type of data?
- Can you make this output human-readable?

### Summary

- For complex NLP tasks, certain specialized tools might still surpass the capabilities of the most advanced generative AIs.
- Even though generative AI might outperform conventional methods for your NLP task, it may not always be cost-effective.

# *Scaling and performance optimization*

In today's data-driven world, it's more likely than not that the insights required by your business will be gained from vast amounts of data. As data volumes continue to grow and analytical complexity increases, and as algorithms and data processing pipelines reach the point where the sheer volume of data or the complexity of operations limits their ability to deliver timely and accurate results, you'll encounter the need for code performance optimization. It will likely become essential for ensuring your analytics remain effective and efficient, even when the underlying data and computational demands grow.

Throughout this chapter, we'll assume that the analysis of the Brazilian e-commerce data we performed in previous chapters was so successful that, instead of encompassing a set of a hundred thousand orders, it now needs to be performed periodically on data-sets of millions of orders. To make things even more interesting, let's assume that the business grew and became multinational. Such growth could easily increase the amount of data by several orders of magnitude. At first glance, you might think throwing more CPUs at the problem or migrating to the latest GPU for its sheer processing power would solve the problem, but this would invariably involve either capital expenditure or an extension of the budget for cloud solutions. Just as an old IT adage states that any data will quickly fill all space allocated to it, you will quickly find that, when attempting any non-trivial data analysis, the calculations invariably consume all computing power available.

Fortunately, you have numerous strategies for scaling and performance optimization at your disposal, including parallel and distributed computing, GPU acceleration, and specialized hardware or software solutions. By exploring various methods and tools, you should be able to find the most appropriate techniques for your specific data analytics needs.

There is a catch, though. There is no one-size-fits-all solution. Your choices will almost always be limited by the technology stack available to you and either by the budget or by what your business or institution has authorized for use. That is why we'll provide an overview of different methods here rather than taking a deep dive into a single option.

As you'll see, generative AI, and particularly GPT models, can greatly support your optimization and scaling efforts. These advanced natural language processing models can help you identify relevant strategies, suggest improvements, review code, and even generate optimized code snippets.

In this chapter, we will delve deeper into the importance of scaling and optimization in the context of data analytics. We will cover various techniques and approaches to achieve optimal performance and discuss the role of GPT models in supporting this process. Additionally, we will provide practical examples and case studies to demonstrate the real-world impact of effective scaling and optimization in data analytics.

Although there are many tools that purport to perform optimization and scaling automatically, we believe that knowing these topics is vital in understanding proper code performance. Sadly, a lot of newbie data scientists, analysts, and engineers take code performance for granted or delegate it to said automated tools, potentially seriously underachieving in their efforts.

By the end of this chapter, you will have a solid understanding of the critical role that scaling and performance optimization play in data analytics, and you'll have the knowledge necessary to identify, evaluate, and implement effective strategies to ensure your analytics pipeline remains efficient and effective in the face of ever-growing data volumes and computational demands.

## 7.1 Performance measurement

When setting out to optimize your analytics, the first crucial step is defining what good performance means for your goals. You need a clear yardstick to measure the success of your efforts. This means defining two basic concepts:

- What characteristics of the system's performance are most important? Should it prioritize quick response or accuracy? Should it allow multiple user access, or is it OK for users to have to queue? Can it block access while it is processing, or does it still need to allow users to view the data while they are waiting?
- What are the baselines for the preceding characteristics? Should we aim for the current expected load, or already plan for future expansion? Can we reliably define what a normal load will look like?

Here, we could consider such metrics as the following:

- *Latency*—The time it takes for a data analysis system to begin displaying initial results after the data input is complete.
- *Throughput*—The amount of data the system can process within a given time frame. It is typically measured in records per second or gigabytes per hour, reflecting the system's efficiency in handling large datasets.
- *Parallelism or concurrency*—The number of data analysis queries or processes the system can handle simultaneously without performance degradation. It demonstrates the system's ability to manage multiple user requests or tasks at the same time.
- *Bandwidth*—In the context of data analysis, this refers to the volume of data that can be imported into or exported out of the system per unit time. It is crucial for systems that need to handle large data transfers efficiently.
- *Response time*—The total time it takes for a system to complete a data analysis query or task from the moment it is initiated. This metric includes both the computation time and the time taken to retrieve and display the results.
- *Availability*—The likelihood that the data analysis system is operational and available for use when needed. It's particularly important in systems requiring high uptime for continuous data analysis and decision-making processes.
- *Scalability*—The ability of the data analysis system to maintain or improve performance as the size of the data grows. This includes adding more data sources, handling more complex queries, or serving more users without a drop in performance.
- *Reliability*—The consistency of the data analysis system in providing accurate and timely results under different conditions. This metric is often assessed by the frequency and severity of system failures or inaccuracies in the output data.

Let's look at a real-world scenario: a company was moving its infrastructure to the cloud and, suddenly, solutions that worked well on virtual machines became unusable due to the sheer amount of data to be analyzed. Processing times shot up dramatically,

sometimes exceeding a 5,400% increase. Management had to reassess their approach, targets, and priorities swiftly, and, due to limited capacities, it became critical to have a good understanding of what “good” means in this specific context.

Comparing vastly different domains can illustrate the different priorities. If you consider a data analysis system for an astronomical observatory, it is likely that latency or response time will not be as critical as in the case of, for example, a patient-monitoring system in a hospital. Furthermore, it would probably make more sense to build a system for monitoring a single patient, and create separate instances for each patient, than invest in a single multi-patient system, given that each patient is likely to require separate care. In contrast, an automation system for a chemical plant would likely require many concurrent and linked processes to run and link together to provide a full picture to the operators.

Once you understand your requirements, you’ll be able to define whether your current system, whether automated or manual, is sufficient, and where it requires improvements. Then, once changes are made, you should be able to understand how your new system performs compared to the previous version, and whether the changes provided the desired impact.

In this section, we’ll explore straightforward approaches and metrics that can be used to analyze the efficiency of your data analytics systems.

### How to measure?

There are various approaches to measuring the performance of data analytics systems, including the following:

- *Profiling*—Collecting detailed information about the execution of a program or algorithm, such as the time spent in each function or the amount of memory allocated. This data can help identify hot spots or areas of the code that consume the most resources.
- *Stress testing*—Related to profiling, but under loads approaching or exceeding maximum expected amounts. This allows you to check if the system can still perform adequately if pushed to the limit.
- *Benchmarking*—Comparing the performance of a system against a reference implementation or industry-standard metrics.
- *Monitoring*—Collecting and analyzing performance metrics over time, allowing businesses to track the impact of optimization efforts and identify any emerging issues or trends in response to changing data volumes and computational demands.

Let’s take an analysis example performed in chapter 4, where we used bootstrap methods to calculate confidence intervals for the average sales price and average review score per state. Bootstrapping is a computationally intensive technique, as it involves repeatedly drawing random samples with replacements from the original data, and recalculating the statistic of interest.

Several performance metrics can be used to evaluate the efficiency of a data analytics system. We'll look at three of the most important areas in the rest of this section: execution time, throughput, and resource utilization. We will, however, focus mostly on the execution time. Depending on the properties and limitations of your computing environment, some of these areas might be of more importance than others.

### 7.1.1 Execution time

Execution time is a direct indicator of your system's overall speed and responsiveness. It's defined as the time it takes to complete a specific task or process a given volume of data.

#### In CPU time, I'm young; in real time, my coffee's cold again

In today's multitasking and multithreading systems, measuring execution time cannot be reliably performed with just a stopwatch. If your CPU is busy crunching numbers, and you decide to play the latest AAA game on the same machine to kill time, you could be disappointed with the performance of your program, even though it's trying its absolute best.

In this context, *CPU time* refers to the actual time your processor spent on the calculation, as opposed to handling all the other tasks, like updating your screen, running your antivirus in the background, and refreshing your browser while you're reading the news. Invariably, this will be significantly less than *real time*, or elapsed time.

Some of the methods used in this chapter will rely on measuring elapsed time as a proxy, since it's much easier to do and usually suffices unless you are running advanced analysis of execution times on very short pieces of code. However, bear these points in mind:

- It's best to not run other intensive processes while measuring the performance of your calculations.
- When measuring performance, use relatively large dataset sizes, as this will make comparisons between different pieces of code more reliable by reducing the impact of overhead processing.

Don't be surprised if running the same code multiple times produces different execution times. It's best to average the runtime of several runs to get a better approximation. Alternatively, take the minimum runtime from several attempts, as this will reflect the minimum impact of overhead on the processor.

Let's see if we can get our GPT advisor to provide us with the code required to measure the execution time of our bootstrap function.

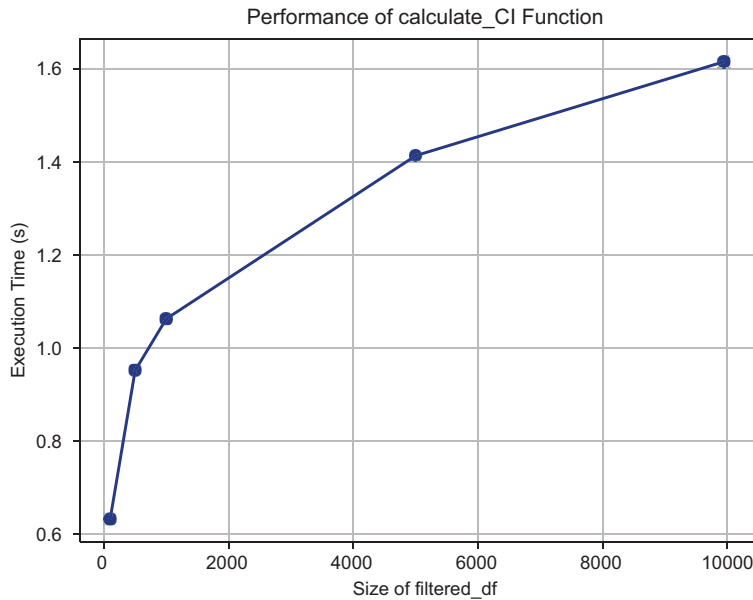

This code measures the performance of the `calculate_ci()` function for different sizes of randomly-selected subsets of `filtered_df`. The execution times are plotted against the sizes of the subsets.

The result is presented in figure 7.1.



**Figure 7.1** Chart of time of executing bootstrapping function depending on the size of the processed DataFrame

This metric is pretty straightforward; however, you need to remember that this is the narrowest metric, as its measurement is only valid for the specific input, system load, configurations, and so on.

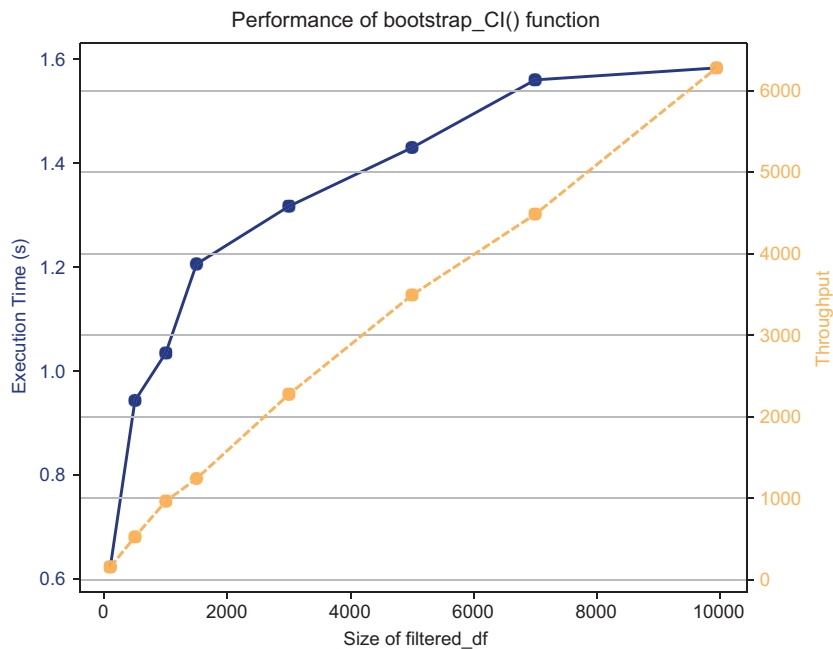
Furthermore, this simple example only takes into account a single measurement. In practice, this will not be very accurate, as modern computers are designed to perform many tasks concurrently, and that will have an impact on the one business-critical process you are trying to measure. Therefore, to isolate these variable effects, but still get a reliable reading, you should do the following:

- Perform the profiling under expected loads. There is no point profiling a system on an isolated test server, and then expecting it to perform identically on a production server with 50 other processes running, competing for resources.
- Profile many runs and perform appropriate statistical analysis, calculating at the very least the minimum, maximum, and average times. This will give you a much better picture of expected performance than a single run.

### 7.1.2 Throughput

Throughput is a measure of the rate at which a system can process data, typically measured in transactions per second or records processed per second. High throughput is essential for handling large data volumes and meeting real-time processing requirements.

As throughput is a simple division of the size of data by elapsed time, we slightly modified the code we used for the execution time measurement. You can find the full code in the Jupyter notebook in the book's GitHub repository. The result, presented in figure 7.2, may be somewhat surprising.



**Figure 7.2** Dependence of the execution time (solid line) and throughput (dashed line) of the bootstrapping function on the size of the processed DataFrame

Intuitively, if throughput is the number of processed records divided by the time of processing all records, each should be processed in the same way. It's true that, if each record were processed independently and in a constant time, the throughput would remain constant. However, in practice, this is not always the case. Various factors can affect the processing time of each record and the overall throughput, among them record size and complexity (not our case), data dependencies (not our case), resource contention (maybe our case), algorithmic behavior (likely our case), or external factors like the network latency, disk speed, or other system processes.



Throughput can be a helpful tool when estimating the projected increase in resource requirements in relation to an increase in the amount of data to be processed.

### 7.1.3 Resource utilization

To get a fuller view of how your code is performing, you should not just take into account the execution time of your code, but also observe system resources, like memory and storage, used during code execution. High resource utilization can tell you if the system is efficiently using the available resources, and it may also signal potential bottlenecks or resource contention.

Monitoring system resources is material for a separate book (and likely more than one), but some simple measurements and observations can tell you if you are hitting the limits, and measurements should be available for you irrespective of whether you use your Windows laptop (the Resource Monitor app), Linux (the top utility), or cloud solutions (provider-dependent).

Measurement of resource utilization is critical in distinguishing two primary limiting factors, or bottlenecks, of your program or task:

- *CPU-bound tasks*—These tasks are mainly limited by the processing power of the CPU on which your program runs. The performance of CPU-bound tasks can be improved by using a faster CPU or by parallelizing the task across multiple CPU cores. Examples of CPU-bound tasks include numerical simulations, complex mathematical calculations, and data processing tasks like sorting or searching.
- *I/O-bound tasks*—These tasks are primarily limited by input/output (I/O) operations, such as reading from or writing to a file (swapping data to a hard drive if you run out of memory), network communication, or user input. Replace `your_function()` with the function you want to analyze. This script will monitor the CPU usage, I/O activity and memory usage for 10 seconds with 1-second intervals. If the average CPU usage is high, your function is likely CPU-bound. If the I/O activity (read and write bytes) is high but the CPU usage is relatively low, your function is likely I/O-bound.

Keep in mind that this is a simple example, and you might need to adjust the monitoring duration and interval to match the runtime of your function for more accurate results. Additionally, this approach does not account for other factors that could be affecting your function's performance, such as memory consumption or network latency.

In this chapter's Jupyter notebook in the book's GitHub repository, we provide the code modified for our example. These are the results we got:

With this scale of data and simplicity of performed operations, the limiting factor is related to disk operations. In this case, we shouldn't expect much improvement if we parallelize a calculation across multiple processors, although we will do so in the following section for illustration's sake. Increasing CPU performance will likely have minimum impact if all the parallel tasks have to fight to read data from a single file.

Measuring where your data analysis spends most of its time and energy is critical to understanding how to make it go faster. There is no point optimizing a calculation if the limiting factor is the data transfer bandwidth—swapping a hard drive for a faster one might give you a much more significant boost, costing only a few bucks.

## 7.2 Improving code performance

In the context of data analytics, you may encounter two terms used interchangeably: “code optimization” and “code scaling.” These refer to two distinct concepts. They are both crucial to improving the performance and efficiency of data processing pipelines, but it's important to distinguish between them, as they have different roles in overall performance improvement:

- *Code optimization* is the process of fine-tuning the algorithm, code, or data processing pipeline to improve its performance, speed, or resource utilization.
- *Code scaling* refers to adapting the code to use larger or better performing hardware more efficiently, or to adapting it to different architectures, such as GPU or multithreading.

Let's consider some examples. In the case of the patient-monitoring system we mentioned in section 7.1, it is likely that each patient who requires monitoring will be provided with their own unit. (Many units may connect to a single monitoring dashboard at the nurses' station, but the data analysis will be done independently for each patient, which is what counts here.) Each unit should perform the analysis quickly and accurately, with very high availability, or even redundancy, as a human life may be at stake. Code optimization may be the best approach here, as each unit will be self-contained, will need to be mobile so it can move with the patient if they are taken for tests, and will likely already be very expensive.

By contrast, a monitoring system for financial markets will likely not require such a focus on optimizing every line of code. To preserve the maintainability and usability of such a complex system, it will be much better to ensure that the code is clearly written and documented; adequate performance will be achieved by running the system on sufficiently powerful servers capable of handling the load. Additional capacity may then be obtained by scaling—adding more CPUs or network bandwidth, or introducing processing segmentation and parallelism.

In this section, we will first try to optimize and then scale our `bootstrap_CI` function.

### 7.2.1 *Optimizing code*

You can optimize code with various techniques, such as code refactoring, algorithmic improvements, or by using more efficient data structures and libraries. If it seems daunting, there's a good reason. As much as code and algorithm optimization is a valuable activity, it's often difficult and time-consuming if performed manually. Reviewing each line of code by hand and trying to optimize it while avoiding introducing bugs can conceivably be done for concise and simple snippets of code. For longer ones, more automated approaches are necessary. Let's see if GPT models can be of help here.

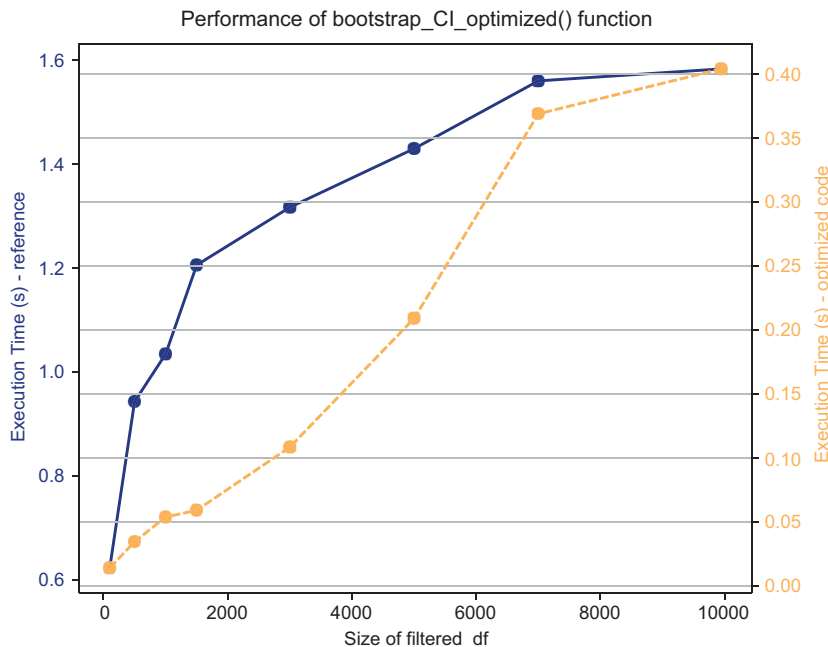

In this version, we create an index array `idx` with the shape `(n_bootstraps, len(data))` using `np.random.randint`. Then, we use advanced indexing to create the `bootstrap_samples` array, which contains all the bootstrap samples at once. Finally, we apply the `func` directly to the `bootstrap_samples` array along the specified axis. This version takes advantage of NumPy's vectorized operations to efficiently compute the bootstrapped statistics without parallelization.

It seems that despite the simplicity of the provided code (and the fact that it was generated by ChatGPT 4 in the first place), it looks like there was still room for improvement. Or was there?

Before running this code on the biggest cluster we can find, we need to check if the proposed change indeed brought improvements. A comparison of the execution time of the basic and optimized functions is presented in figure 7.3.



**Figure 7.3** Dependence of the execution time of base (solid line) and optimized (dashed line) bootstrapping functions on the size of the processed DataFrame

Seems like code optimization did well. If you compare the scales of the two graphs, the time required for function execution dropped by a factor of almost seven. Looks like there is now much less time to drink coffee between calculation runs.

### Don't trust it further than you can throw it

While the optimized code may look great, and we are assured by the model that it performs the same function, it is imperative to subject the code to the same thorough testing as you would for human-developed code. See chapter 8 for a more complete discussion of the risks associated with using GPT models and the phenomenon of AI delusion.

Note that even though LLMs with very large or even theoretically infinite context sizes have been developed, it is likely that you may have to split long code into several prompts to fit into your particular model's maximum context size. While a human expert would certainly ask for background information and a wider context, especially if questioned repeatedly about related concepts, ChatGPT will not. It's therefore very important that you properly test the code to verify any assumptions you make about the output of the conversation with ChatGPT or the function of the final code. Also, using the iterative prompting techniques described in section 7.3.2 may be helpful in getting ChatGPT to perform correct optimizations and prevent it from hallucinating too much.

## 7.2.2 *Scaling code*

Let's assume that we are content with how our function runs on a single processor or thread. It may now be worthwhile to look at how it can be implemented on better-performing architectures, allowing you to achieve better performance still. An obvious example would be to invest in a faster processor or more RAM. Yet, potentially surprisingly, most implementations don't take full advantage of the architectures of commonly available hardware. Almost all processors currently available on the market have multiple cores, and GPUs are installed in virtually every PC. Both of these allow several calculations to run in parallel, albeit with some technical differences. We will discuss these a bit later, but first let's focus on how ChatGPT can help us utilize both.

### SCALING ACROSS MULTIPLE CPU CORES

You can easily scale your code to utilize the multicore architectures available in virtually all modern processors with available libraries and the power of ChatGPT. Let's try to parallelize our optimized bootstrap function.

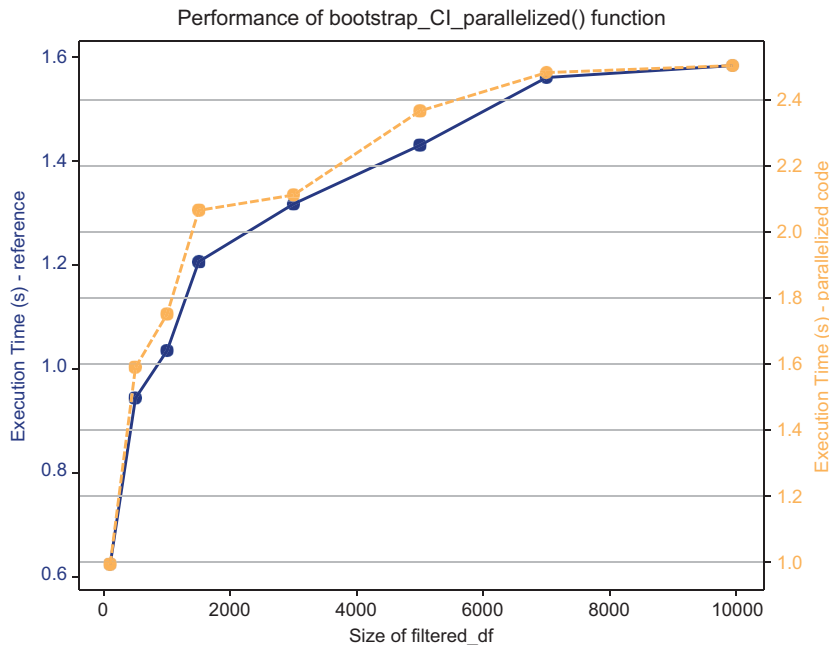

This will parallelize the `bootstrap_CI_optimized` function across multiple threads. However, please note that if your data is stored in a Pandas DataFrame and you are using a custom function for `func`, you may need to handle the GIL (Global Interpreter Lock) in Python, which could limit the parallelization benefits in some cases.

Now that we have parallelized our function, it will run like a bat out of hell! Yeah!

The results of the run on 16 parallel threads are presented in figure 7.4. The code is now considerably . . . slower! Looks like ChatGPT’s final remark was true.

Fortunately, there is a lesson to be learned here. In section 7.1, we distinguished between CPU-bound and I/O-bound tasks. Our `bootstrap_CI` function utilized 1.5% of the available processing power, and we mentioned that this function doesn’t seem like the best candidate for parallelization. We did it anyway, and now we’re suffering the consequences.

### There ain’t no such thing as a free lunch

Parallelization is not free. There is an associated overhead cost related to dividing data into smaller chunks, starting and queuing the processes, and gluing the results together afterward. In our case, the main problem is the relatively minuscule size of the data, but this issue might also be important for large-scale tasks, depending on the structure of your data.



Our ChatGPT advisor warned us that something called the Global Interpreter Lock (GIL) might limit our parallelization benefits. GIL is a mechanism that simplifies Python's memory management but at the cost of serious limitations on the performance of multithreaded applications and their ability to utilize multiple CPU cores efficiently.

Let's see if moving from CPU to GPU will improve things considerably.

### SCALING BY USING GPU

With certain exceptions, scaling across CPUs may provide significant benefits, but the GPU (graphics processing unit) is another piece of hardware available on most PCs nowadays. This piece of silicone is specifically optimized for performing a vast number of identical operations on vectors or matrices of data on hundreds of cores in parallel, a characteristic required for most computer-generated graphics calculations.

There is nothing preventing GPUs being used for calculations that have similar requirements but are not related to graphics. It is important, however, to understand that a GPU and CPU are very different, as we'll discuss in the next section.

For now, let's see how a GPU might be used in a simple example. The following code and techniques below use an Nvidia graphics card with a CUDA interface, allowing us to direct the code to utilize an Nvidia GPU for scaling.



Can you adjust the `bootstrap_CI_optimized` function to run with CUDA? Name the resulting function `bootstrap_CI_cuda`.



To run the `bootstrap_CI_optimized` function on CUDA, you can use the `cupy` library, which provides GPU-accelerated versions of many NumPy functions. First, install the `cupy` library if you haven't already:

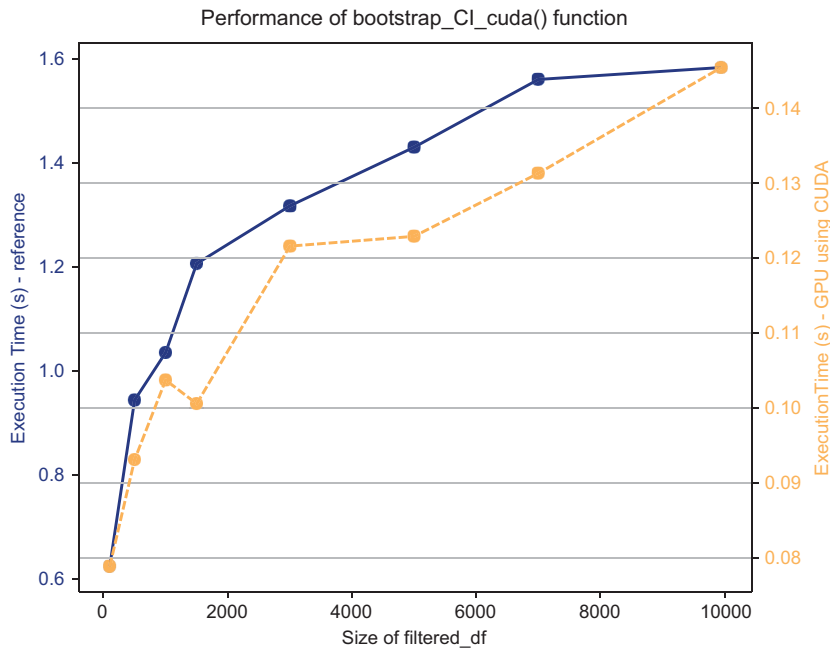

Keep in mind that, depending on your problem size and GPU, you might not see significant performance improvements. GPU acceleration tends to be more beneficial for larger data and more computationally intensive operations.

ChatGPT's final remark certainly doesn't bring a lot of optimism, especially after our parallelization effort. Nevertheless, we need to stop delaying the inevitable and move to the results presented in figure 7.5. Fortunately, our effort this time was not in vain. We can see a significant improvement in the code execution time.

### To infinity and beyond

GPUs are not the end of the line, at least not for all applications. Google designed hardware specialized for high-performance machine learning tasks, particularly deep learning, called Tensor Processing Units (TPUs).

TPUs are particularly well-suited for large-scale training and inference of neural networks, offering faster processing times and better energy efficiency compared to CPUs and GPUs. They can be especially beneficial for natural language processing, computer vision, and reinforcement learning applications. Incorporating TPUs into your data analytics pipeline can further optimize performance and reduce the time required to train and deploy complex machine learning models.

Following the piece of advice from our last conversation with ChatGPT, you should be aware that many popular Python libraries already have counterparts optimized for

GPUs and TPUs (Tensor Processing Units) or provide built-in support to accelerate computations. Keep that in the back of your mind if you're planning to utilize GPUs/TPUs in your work.

There is no need to memorize all these optimized libraries, as you can ask ChatGPT to provide you with a list, as in the following transcript. Similarly, you can ask ChatGPT to reference other implementations with specific niche uses or optimizations. It could save you hours of looking through the web.



Which Python libraries have GPU-optimized counterparts?

### **ChatGPT learning cutoff**

As stated several times before, ChatGPT has limited knowledge beyond a certain point, depending on the version, so its knowledge of the latest developments and most recent versions of libraries may be limited. Nevertheless, it should provide a good starting point for further exploration.

Keep in mind that GPU/TPU optimizations can have varying levels of performance improvements, so it's essential to profile and test your code on the target hardware to ensure that you're getting the desired performance gains.

### **SCALING ACROSS CPUs vs. GPUs**

The decision to scale operations across CPUs or GPUs depends on the task's nature and the available hardware resources. Here's a general guideline for when to use CPUs and GPUs for different types of operations.

Use CPUs for

- Sequential tasks or tasks that involve branching or complex control structures, or that require a limited amount of parallelism
- Tasks that have high I/O requirements or involve extensive communication between processes or threads
- Tasks with a small or moderate dataset size, as, even though the available memory on CPUs is typically larger than that on GPUs, processing of large datasets on CPUs may be less effective than on GPUs.
- General-purpose tasks, as CPUs are designed to handle a wide variety of workloads

Use GPUs for

- Highly parallel tasks that can be divided into thousands of smaller tasks to be executed simultaneously
- Tasks involving many arithmetic operations, such as matrix multiplications, convolutions, or element-wise operations on large datasets
- Tasks with large dataset sizes, as GPUs are designed to handle massive amounts of data quickly due to their high memory bandwidth
- Deep learning, computer vision, or scientific simulations, which can benefit from the specialized architecture of GPUs

In general, if the task can be broken down into many simpler, preferably similar, sub-tasks, and requires a large amount of computation, it's likely better suited for a GPU.

You can also combine both approaches, switching to using GPU-optimized libraries in the sections of the code most involved with calling these and then parallelizing the rest of the code using multiple CPUs. Be careful, though. As we showed in section 7.2.2, any parallelization comes with overhead, especially when communication or synchronization between different CPU cores is involved. You may end up with overheads far exceeding any benefits.

When you run out of PC cores, you may need to turn to cloud solutions. Those benefits come at the price of some extra work on your part to deploy your solution to your friendly cloud provider.

## **7.3 Cloud-based deployment**

As data continues to grow in volume, variety, and complexity, it may exceed the computing power of your PC machine. Instead of waiting unreasonably long to see the output (or a memory overflow error) or splashing out on the latest overpriced chips when they come into stock after being sold out to scalpers, you can reach into the vast power of cloud computing.

### **7.3.1 What is cloud computing?**

Cloud computing is a technology model that enables users to access and utilize computing resources, such as storage, processing power, and software applications, over the internet. Instead of investing in and maintaining physical hardware and software on-premises, users can leverage cloud service providers. The providers manage and maintain the infrastructure in large, remote data centers, providing on-demand access to a wide range of computing resources, storage, and managed services. You can scale your workload up or down as needed and analyze massive amounts of data without investing in expensive hardware.

The main advantages of cloud computing include scalability, flexibility, cost-efficiency, and reliability. You can also choose to use exotic architectures like TPUs (or GPUs) from the safe confines of your laptop.

**1+1 ≠ 2**

Multiple interconnected computers, known as nodes, working together as a single unified system to perform complex computational tasks are referred to as *clusters*.

In cluster computing, tasks are often divided into smaller subtasks and distributed across the nodes in the cluster. The nodes then work in parallel, processing their assigned subtasks simultaneously, with specific processes providing synchronization and fault-tolerance to the whole system. Since this is a complex topic, we won't be delving deeper into these issues, assuming instead that users will be more likely to utilize one of the established frameworks that provide solutions to these issues than write their own.

Common cluster computing software frameworks include Apache Hadoop, Apache Spark, and the Message Passing Interface (MPI), which provide tools and libraries to simplify the development, deployment, and management of distributed applications across cluster nodes.

Depending on your specific use case and requirements, you might need to customize the environment, configure additional resources, or use other cloud services, such as managed data processing services or serverless computing options like Google Cloud Functions or AWS Lambda.

You can ask ChatGPT about the details of each of these steps.

### ChatGPT's narrow context

You'll notice that, in the discussion with ChatGPT on the deployment of code to the cloud, the response only provided a way to run the code on a single virtual machine, since the prompt didn't specify anything otherwise. This kind of deployment is usually the first step in moving your application to the cloud, so it's still worth looking at, although this will usually provide only a moderate increase in computational power, limited by the power of a single VM, while having the significant benefit of requiring no changes to the code.

Finally, let's look at how ChatGPT can help us take our code into the cloud, this time properly distributing it across multiple cloud resources so that we can harness the vast power of cluster computing. Let's look at the solution proposed by ChatGPT:

### ChatGPT is not loyal to one platform

In the responses in this section, you'll see ChatGPT starting to answer using Amazon AWS. The prompt did not specify the choice of the cloud provider, although we have discussed using Google Cloud before. Don't be afraid to stop ChatGPT if you don't like where it is going and redirect it on a path you prefer by refining the prompt.



I now want to distribute the calculation across the cloud. How can I do that? (Forget saving to disk.)



To distribute the calculation across the cloud, you can use Dask along with a cloud provider like Amazon Web Services (AWS), Google Cloud Platform (GCP), or Microsoft Azure. In this example, we'll use Dask with AWS, but the process is similar for other cloud providers.

First, you'll need to set up a Dask cluster on AWS. You can follow the official Dask guide for setting up a Dask cluster on AWS using the `dask-cloudprovider` package.

Whatever modifications we request ChatGPT to make to the code, it's vital that it is retested with the same, or even higher, scrutiny as if it were written from scratch. Furthermore, since parallelized or distributed code is usually much harder to test fully than a localized single-threaded version, care should be taken to apply best practices, which are beyond the scope of this book.

## 7.4 **Code conversion**

Finally, let's look at using ChatGPT to convert code between programming languages. This can serve multiple purposes, such as generating optimized code or adapting code to work within specific frameworks like Hadoop. When translating code from one language to another, developers have the opportunity to refactor, streamline, and improve the code in the target language. It can lead to optimization in several ways. Let's look at some of these:

- *Improved performance*—Converting code to a more efficient language or one that offers better support for specific hardware or platforms can lead to performance gains. For example, translating code from a high-level interpreted language like Python to a lower-level compiled language like C++ can result in faster execution times.
- *Reduced memory usage*—Code conversion can lead to more memory-efficient implementations. For instance, certain data structures and algorithms in the target language might consume less memory than their counterparts in the source language.

It's essential to carefully consider the cost and complexity of code conversion, as it can be time-consuming and may introduce new bugs or issues, and manual code conversion is rarely worth the effort. ### Limited trust still applies

By this point, we trust you've gained an understanding of how you can use generative AI to choose, implement, and assess various approaches to enhance the efficiency of the code employed in your analysis. However, it's crucial to exercise discretion in choosing your optimization battles. If your analysis is a single, ad hoc occurrence, the time required to achieve optimal performance might surpass the potential time savings.

### Things to ask ChatGPT

- Modify my code to run on multiple GPUs/CPUs.
- Convert this snippet I downloaded from StackOverflow to my favorite programming language.
- Explain what this code snippet does.
- Modify my code to run on the Amazon/Google/Microsoft Azure cloud.

## Summary

- Don't try to re-implement common algorithms, as there are usually optimized implementations available.
- If you want to use a different programming language, ChatGPT can significantly simplify migration. Just remember to retest the code thoroughly.
- Code should be optimized to achieve results as quickly as possible on a given platform. If this is not fast enough, you can scale up by using multiple CPUs or GPUs or deploying to the cloud.
- Frameworks like Dask can help you achieve scaling with minimum modifications to your code.

# Risk, mitigation, and tradeoffs

The rapid advancement and adoption of generative AIs in various data analytics applications have the potential to significantly improve the accuracy and efficiency of decision-making processes across numerous domains, especially since we are just starting to realize the full scope of where such models can be applied. However, along with these benefits come several risks and challenges you must carefully manage to ensure safe, responsible, and ethical use of such models.

In this chapter, we will consider the essential aspects of risk management in data analytics with generative AIs, highlighting the potential problem areas and providing guidelines for mitigating the risks we identify. While you might be reading this book for personal education about using AI models for data analytics, you may well progress to using such models in professional circumstances, using AI models to

assist with data analytics in a structured and professional manner. Regardless of the size of the implementation, from personal, through educational, to large enterprise, it is crucial to have a clear view of the risks involved and to be armed with techniques to mitigate them promptly and effectively.

These mitigations will often appear not as individual solutions, but as balancing acts between extreme approaches. In the simplest case, you could supply the model with all the data and just pass the output to your stakeholders, or, at the other extreme, you could forgo the model completely and do everything yourself. Neither approach should, hopefully, look appealing by now, given all the benefits and all the dangers of using the model showcased in previous chapters.

Throughout this chapter, we will compare the risks of implementing AI to hiring a new person on the team. It will become evident that the two cases share a lot of similarities, and thinking about AI in terms of a new “mind” on the team may be a helpful metaphor. Mind you, there are crucial differences, which we will underline where relevant.

In the first section of this chapter, we’ll look at some best practices that apply to using advanced digital data systems in general, but are particularly applicable to using natural language models in a production environment—where there are restrictions on resources, certain reporting requirements apply, and not all data is public. These best practices can be applied together or individually, depending on specific circumstances, and can form a good foundation for the transparent and safe use of generative AIs.

Subsequent sections deal with specific areas of risk encountered when using generative AIs. Section 8.2 deals with the AI delusion and hallucination phenomena and the potential impact these can have on naive users. Section 8.3 expands on this, dealing with misinterpretation and miscommunication. Although these risks are distinct from those mentioned in section 8.2, they share some of the overall characteristics, and it’s vital to be aware of all of these, as they all originate from the internal structure of the models.

Section 8.4 covers bias and fairness risks. Although these can manifest partially from the model’s behavior and may depend on how the model was trained, recognizing and mitigating these risks usually can be done outside of the model and depends on the user’s approach to forming prompts and interpreting responses.

Sections 8.5 through 8.7 cover risks external to the models—these risks are not closely linked to the structure or the training of the models but to their use in circumstances where privacy, security, legal, and compliance obligations apply. Having the correct policy and procedure frameworks to address these risks is necessary to prevent potentially serious issues related to relevant regulations.

Finally, in section 8.8, we’ll allow ourselves to look slightly into the future, and into the unknown unknowns, as it would be foolish to assume that we can fully prepare for everything that the relatively new and constantly developing technology of generative AI will bring.

## 8.1 *The risks of GenAI, in context*

If you have read some earlier chapters in this book, you should have encountered some risks related to using generative AI for your work as a data analyst. Fortunately, there are better ways of mitigating the risks than running afoul of them, falling on your face, and retrospectively analyzing what happened. The best way to learn is to draw lessons from observed mistakes, sparing yourself the need to personally experience them; the second best way is to identify the risks before they materialize. Let's start by putting the risks of generative AI into context: To what extent have the developers of publicly available AI models already accounted for the possible dangers of AI?

To illustrate how serious the organizations working with generative AI are about risk management, you could consider the efforts of the organizations behind Bard/Gemini, ChatGPT, or Llama 2 and their underlying models to ensure risks are identified, analyzed, evaluated, and, where necessary, mitigated appropriately. They have engaged experts from domains such as AI alignment risks, ethics, cybersecurity, biorisk, trust and safety, and international security to adversarially test their models. The findings of these experts, along with outcomes of reviews of many user interactions with the models themselves, were incorporated into the models' development and training, with varied success, to restrict their ability to provide outputs that could violate usage policies or pose harm to individuals, groups, or society. Examples of such harmful content could include

- Advice or encouragement for self-harm behaviors
- Graphic material, such as erotic or violent descriptions
- Harassing, demeaning, and hateful statements
- Content useful for planning attacks or violence
- Instructions for finding illegal content elsewhere

It needs to be underlined at this point that such measures often have limited success. On the one hand, the experts' and developers' preconceptions and subjective views may limit the efficacy of such measures and exacerbate some risks while trying to limit others, while, on the other hand, people hell-bent on finding or generating such content will find ingenious ways to do so regardless of protective measures taken. It's also worth being cautious about reports of people "breaking" the models, causing them to generate harmful content. What may be reported as a success can be a result of many hours of purposeful effort and advanced techniques, rather than just a response to a casual prompt.

Furthermore, measures to put a safeguarding filter on a model may negatively impact its performance, effectively muzzling it and rendering it unable to use the full extent of its abilities for fear of triggering a subset of users. Before committing to using a specific third-party model on a large scale, it's worth verifying its policy toward output filtering as part of the process of evaluating the model and checking that excessive filtering won't interfere with the intended use.

It's also worth mentioning that no measures will completely prevent users from extracting controversial content from such models, as shown by numerous examples



of jailbreaking, (users formulating prompts in such a way as to circumvent the programming designed to restrict the model). Such jailbreaking techniques can vary greatly in complexity:

- Very simple prompt modifications, like asking the model to generate controversial content as if it was part of a play or movie script, may enable the model to bypass some of the restrictions and provide content that could be perceived as harmful.
- Negative prompting, like asking the model to deliver a list of websites you should not visit if you don't want to see harmful content, may trick the model into giving you exactly such a list of websites.
- Some much more advanced techniques have been developed, such as adversarial prompt suffixes (<https://llm-attacks.org/>), which exploit much more subtle technical features of the model itself to force it to answer questions that were restricted by the developers.

In order to ensure we are using generative AI safely and with a full realization of both the strengths and potential risks, let's first look at preparing a framework for it, using some general best practices applicable to organizations using such advanced technologies.

## 8.2 General best practices

We covered some of generative AI's features and limitations in chapter 1. However, it is very likely that in your specific use cases, some other limitations will pop up. Therefore, before we delve into specific risks inherent in using generative AIs, let's look at some general best practices you should implement whenever AI models are used in non-trivial cases. The more complex, risky, or critical the use case, the more emphasis you should put on consistently applying all of these practices.

### 8.2.1 AI use policy

Let's say you want to use your AI to extract critical information from your company's documentation. Will a footnote stating, "Generative AI can make mistakes—consider checking important information" suffice? Most likely not. You'll want users to know, for example, which documents are actually available to your AI, who should have access to this AI, and if any regulatory constraints are in place.

In any non-trivial implementation involving AI, you should clearly formulate a policy for doing so. It should cover the guidelines and principles that govern the ethical and responsible use of AI technologies within your organization or project. This policy should address key areas such as data privacy, security, transparency, accountability, and fairness.

It is wholly understandable if your initial reaction to the preceding statement was that it would be a waste of time, as policies are usually associated with lengthy documents written once and read by nobody, including the authors. That is why we strongly encourage you to keep the policy short, pithy, and to the point. A single A4 sheet will do in simple cases.

The “AI use policy” sidebar provides a sample template. This template is a starting point and, depending on the specific AI applications and the context you are considering, additional details and considerations may be necessary. Especially sectors such as healthcare, finance, or public services may require more stringent controls and ethical considerations. However, this template may be a sufficient initial draft for a small enterprise planning a pilot implementation.

### **AI use policy: A template**

This AI Use Policy (“Policy”) establishes the guidelines and principles for the ethical and responsible use of Artificial Intelligence (AI) technologies within [Organization/Project Name] (“we,” “us,” “our”). This Policy aims to ensure that our use of AI aligns with our core values, complies with applicable laws and regulations, and respects the rights and dignity of all individuals.

#### **Scope**

This Policy applies to all employees, contractors, and partners of [Organization/Project Name] involved in the design, development, deployment, and decision-making processes related to AI systems.

#### **Principles**

*Transparency:* We commit to being open about using AI technologies. This includes providing clear information about the AI systems we deploy, their purposes, and how they impact users and stakeholders.

Let's now take a look at specific actions required to mitigate the risks of such implementations.

**8.2.2 Encouraging transparency and accountability**

Imagine you're hiring a new employee. This employee will have a job description, their qualifications will hopefully be known, their access to data and resources will be set, and the person will be covered by the established performance monitoring and feedback processes. We mentioned in this chapter's introduction that implementing an AI model can be considered as similar to hiring a new employee (or six). Why, therefore, not have a similar framework for AI?

Following this logic, to mitigate risk related to AI, you need to promote transparency and accountability in AI model development, deployment, and usage. You should clearly document your model use ("job description"), including use-case choices, model development, the source of data fed into the model ("access rights"), any preprocessing techniques, and the review processes for the outputs and performance ("performance monitoring and feedback"). You should monitor model performance in terms of speed and, much more importantly, in terms of the accuracy and relevance of responses. Regular evaluation can help you identify cases where the model's outputs are misleading or incorrect, allowing for timely updates or interventions. Just as with human employees, early detection and correction of issues can prevent larger disasters down the line.

All this can and will help identify potential sources of error or bias, as explained throughout this chapter. It will also provide a basis for continuous improvement ("learning and development") and for auditing model use to protect against scope creep, where models approved for specific use cases are utilized outside this scope without necessary risk assessments and controls.

This monitoring should not be a box-ticking exercise, nor should it be seen as a necessary evil. The usefulness of and the reason for maintaining such documentation should be clearly communicated to and understood by the relevant stakeholders and teams, and this documentation should be frequently referred to and reviewed, just as the performance of employees is, hopefully, monitored, reviewed, and discussed by relevant management.

After all, good people management means clear communication of purpose, development opportunities, and timely and effective feedback. The same practices, adapted to AI, could be the grounds for successful AI resource management within your enterprise.

### 8.2.3 **Educating stakeholders**

If you bring a tool into your company, misuse of which could lead to significant damages (think of a “lightsaber in the hands of an excited chimpanzee” level of damage), what would be the first thing you’d do before leaving it lying around?

An essential aspect of managing risk is ensuring that stakeholders, including developers, IT support staff, decision-makers, end users, and customers, clearly understand the capabilities and limitations of the models in use within the organization. Just like good people-leaders need to hone their skills, being a stakeholder in an AI project, regardless of capacity, requires specific knowledge and experience to foster success. The following subsections discuss some strategies for educating stakeholders on generative AIs used in business.

#### **TRAINING AND WORKSHOPS**

Organize training sessions and workshops for stakeholders to familiarize them with AIs, their underlying technologies, and potential applications. Ensure that these sessions cover the technical aspects at a relevant level, ethical considerations, and regulatory compliance related to using generative AIs in the specific business context. Leveraging publicly available presentations, talks, and lectures can be highly effective, as these resources often provide a comprehensive overview of generative AI, including its capabilities, applications, ethical considerations, and future potential. Here are some examples of resources that might be beneficial:

- *TED Talks on AI*—TED offers a range of talks on artificial intelligence, including generative AI. These presentations are given by experts in the field and cover various aspects, from technical introductions to ethical discussions and future implications.
- *Coursera and edX courses*—Online learning platforms like Coursera and edX feature AI and machine learning courses. While not all content is freely accessible without registration, these platforms often include introductory videos and lectures that are publicly available. Look for courses specifically focusing on generative AI or deep learning.
- *Relevant YouTube channels*—Channels such as “Two Minute Papers,” “Lex Fridman,” and “Siraj Raval” offer accessible and insightful discussions on AI topics, including generative AI technologies like generative pretrained transformers (GPTs) and DALL·E. These channels break down complex topics into understandable segments suitable for all knowledge levels.
- *Google AI blog*—Google’s AI blog occasionally features presentations, research updates, and educational content related to their work in generative AI. This can be a great resource for understanding cutting-edge applications and the direction of AI research.

- *OpenAI blog*—OpenAI, the organization behind GPT models and DALL·E, shares insights, research findings, and updates on their projects. They often include detailed explanations of their models, ethical considerations, and potential applications.
- *AI conferences*—Presentations from major AI conferences like NeurIPS, ICML, and CVPR are often made available online. These conferences feature the latest research in AI, including generative models, and are presented by leading experts in the field.
- *MIT OpenCourseWare*—The Massachusetts Institute of Technology offers free course materials on various subjects, including artificial intelligence. MIT's OpenCourseWare platform might have lectures and resources focused on generative AI.
- *NVIDIA AI Conference keynotes*—NVIDIA, a leading AI and deep learning technology company, frequently shares keynotes and presentations from its AI conferences. These presentations often explore the role of hardware in enabling generative AI advancements and showcase various applications.

When presenting these resources to stakeholders, you must remember to tailor the content to your audience, their interests, and the depth of their technical understanding. For instance, business stakeholders might be more interested in applications and ethical considerations, while technical teams might appreciate deeper dives into the underlying technologies and research challenges.

Once you develop such training resources and materials or provide access to in-house experts or “ambassadors,” all this can help your stakeholders develop realistic expectations and make informed decisions when using AI implementations.

#### **CLEAR COMMUNICATION**

Clear communication is not just about ensuring access to developed PowerPoint slides. Communicate the capabilities and limitations of generative AIs in *clear, non-technical language* to ensure that stakeholders from diverse backgrounds can grasp the concepts. Use visual aids, analogies, and real-world examples to illustrate the implications of using generative AIs in business scenarios. Highlight each application's potential risks and benefits to facilitate informed decision-making.

#### **Share the knowledge**

An example of a simple yet useful resource covering both clear communication and stakeholder education that was implemented in an organization using ChatGPT was an interdepartmental wiki page with the best and worst prompts and responses encountered by staff, anonymized where necessary. People would post examples of how they achieved certain results, what worked and what didn't, and where the model particularly excelled or bombed. This way, they effortlessly built a domain-specific knowledge base for their organization, which was easily disseminated, consumed by their fellow users, and built upon in real time.

### DEVELOP GUIDELINES AND POLICIES

We already mentioned the risk of creating a useless stack of paper, but it is important to establish guidelines outlining the best practices for using generative AIs in your organization. These guidelines should cover data handling, privacy, security, fairness, and accountability aspects, among others. Make these documents easily accessible to all stakeholders and encourage their active involvement in developing and implementing these policies. As stated in the previous point on “Clear communication,” such documents should be written in nontechnical language appropriate to the audience and should be treated as living documents, frequently updated and maintained. It must be emphasized again that these need not be lengthy documents gathering dust on some forgotten drive.

The following examples were generated by ChatGPT 4 as an example of good policies designed to be simple and memorable, yet covering all the crucial aspects:

- *Data handling*—“Handle AI data like you’re on a first date: with respect, attention, and no oversharing.” Remind everyone to treat data with the care and discretion it deserves, just like navigating the delicate beginnings of a new relationship.
- *Privacy*—“AI should respect privacy like a cat respects a closed door—curiosity doesn’t justify intrusion.” Encourage a stance on privacy that’s mindful and respectful, with clear boundaries set for your AI.
- *Security*—“Protecting our AI is like guarding a secret recipe: If it gets out, everyone’s making our cookies.” Secure our AI and data like your grandmother’s culinary secrets; keep them safe from prying eyes.
- *Fairness*—“Let’s make our AI as fair as a perfectly balanced seesaw.” Aim for equity in AI decisions, where every side gets a fair turn.
- *Accountability*—“When our AI messes up, let’s not play the blame game; it’s a team sport.” Own our AI outcomes, good or bad, as a collective effort.
- *Transparency*—“Our AI’s decisions shouldn’t be more mysterious than a magician’s rabbit.” Keep AI decisions clear, not pulled from a hat.
- *Bias*—“Keep biases out of AI like pineapple off a pizza (unless you’re into that).” Aim for neutrality, recognizing everyone’s taste differs.
- *Ethical use*—“Using AI responsibly is like using a superpower for good: no capes needed, just common sense.” Harness AI’s potential ethically; no heroics required.
- *Continuous learning*—“Keep updating your AI knowledge like your favorite app: Stay current, stay smart, stay ahead.” Emphasize the importance of continuous education and improvement in the AI field, ensuring everyone stays on the cutting edge.
- *Collaboration*—“AI collaboration should be smoother than a well-organized potluck: everyone brings something to the table.” Promote teamwork in AI development, where every contribution enriches the feast.

See, it can be both informative and engaging. Furthermore, the slightly cringy or forced language may actually stick better in people’s heads. Some may even find these points funny; we wouldn’t judge.

**ENCOURAGE OPEN DIALOGUE AND PROVIDE ONGOING SUPPORT**

Encouraging open dialogue is not AI-specific, nor is providing ongoing support. If you're lucky, this attitude relates to all your projects. If not, you may want to use generative AI as a good excuse to introduce these tenets into your operations.

Promote a culture of open dialogue and collaboration among stakeholders to address concerns, share experiences, and identify potential challenges related to generative AI usage. Regular meetings or discussion forums can help foster this dialogue and enable stakeholders to voice their opinions, ask questions, and learn from one another's experiences.

Any such forums should support stakeholders, ensuring they can access the necessary resources, tools, and expertise to work effectively with generative AIs. It may be beneficial to designate a point of contact or establish a dedicated support team to address questions, concerns, and issues that may arise during generative AI implementation and usage. As mentioned before, having "ambassadors" who have some experience in AI matters and are willing to promote the cause and educate their fellow co-workers can work miracles with the right attitude and approach.

**MONITOR AND EVALUATE**

Just like organizations should regularly evaluate all their projects, you should regularly evaluate the effectiveness of your stakeholder education efforts and gather feedback to identify areas for improvement. Adapt your training programs, technical depth, communication strategies and channels to address your stakeholder needs and ensure that you are using your resources optimally to inform them about your AI's capabilities and limitations.

Again, it is imperative that any training and support materials are adjusted to each group's level of understanding and address that group's specific role in the model's implementation, deployment, approval, and use. For example, IT support staff should focus on understanding the model's technical limitations, hardware requirements, scaling, service continuity, and backup strategies. Decision-makers and approvers, on the other hand, should be fully informed on the issues of AI delusion, ethics, algorithmic bias, and privacy and security concerns in the specific context of applicable laws and regulations.

**8.2.4 Validating model outputs with expert knowledge**

When employing a new person, you wouldn't usually let them loose within the organization and hope for the best. You'd usually get them a buddy or supervisor to show them the ropes, check their work, and generally ensure a smooth introduction to their duties. Your AI is also a newbie in whatever you expect it to do, so an expert helping hand will go a long way to mitigate risks.

While the importance of critically evaluating model responses has been mentioned repeatedly in this book, let's now look deeper at validating the model's outputs using expert knowledge or additional data sources. By cross-referencing model outputs with external information or by consulting subject matter experts, you can confirm the

accuracy and relevance of the results, helping to mitigate the risks associated with overgeneralized or inapplicable insights. Such validation may not necessarily involve complete parallel reworking of the problem using other methods and comparing outputs with the model, especially since some problems may not have a clear alternative method. Instead, you may provide validation through an appropriate “smell test,” checking if the output of the model passes various levels of sanity checks and meets expectations, either by comparing it to the constraints defined upfront, or by using your common sense. Using such methods, the verification of the answer may require many fewer resources than applying a parallel solution of the problem, while still providing the necessary assurance.

As an example, you may use a model to generate code to price various types of financial products. Instead of manually writing alternative code for each product, you can use your knowledge of these products to prepare extensive test cases, including edge cases, to test each generated piece of code, and verify the behavior of the model-generated pricing code even if the exact prices are not known. Such testing should be applied anyway, even to manually generated code, so this does not present additional overhead as such, and it provides sufficient quality assurance, alongside code review and similar practices, to enable you to use the code in production.

Let’s consider another example, taken from recent experience: A colleague has been trying to use AI to predict the real mean of a process from sets of sample data. While they could have used advanced statistical methods to do so, an initial eyeballing of the prediction from the model showed that the model was clearly hallucinating, since it predicted a value close to the extreme as the mean. Even without deep mathematical analysis, it was clear something went wrong. Does this mean the model was useless? Absolutely not. It just encountered a mistake, a hallucination, as AI models can do, and rerunning the process on a new session, with a clearer prompt, worked as expected. After all, you wouldn’t fire a new employee after their first mistake.

Since validating every response with a human expert could nullify any advantages of using a generative AI, a more practical approach would be to define guidelines, similar to a risk appetite, within which the model responses would be accepted without human confirmation. Any response not meeting the predefined criteria would have to be confirmed by human experts, leading to significantly reduced risks around the problem boundaries, where the risk is highest, and acceptably low risk within the most commonly encountered conditions.

To clarify, such validation should be applied much more strictly to any code generated by the models. As mentioned previously in this book, any generated code should be treated with the same rigor as if it were written by humans—it should be subjected to thorough testing and review.

Another option would be to define periodic or trigger-based verification. This approach is especially useful in situations where it’s not easy to define low-risk boundaries, perhaps due to the generally high-risk nature of the problem or when the model is required to respond to frequent prompts of a similar nature, leading to a very narrow



range of expected responses. In these cases, the risk acceptance approach would either degenerate into a constant requirement for verification or to no verification at all.

Periodic verification could be defined in terms of elapsed time, such as once every quarter, or in terms of prompts, such as every hundredth response. This will usually ensure a sufficient level of risk mitigation under normal circumstances. To capture situations outside those conditions, triggers should be defined for model reverification. Such triggers may include

- Any changes to the model, additional training, or fine-tuning
- Situations where a previous model response was judged to be inappropriate, requiring human intervention or override
- Any changes in problem parameters or external circumstances that could potentially invalidate the model's use case and approved parameters

Depending on the specific circumstances, the validation by a human expert can be limited to the verification of a single response, a series of responses, or, in extreme cases, the requirement for reconsideration and reapproval of the model use case as a whole.

### 8.3 AI delusion and hallucination risks

You're endangered by AI delusion risk when you overestimate the capabilities of generative AIs or regard them as infallible solutions to complex problems. All the hype, astonishment, and rightful excitement around advancements in AI technology may increase our tendency to assume that AI can solve all issues or provide perfect insights into many applications, including data analytics. This mindset can lead to excessive reliance on AI models and a lack of critical thinking when interpreting their outputs.

You need to differentiate between *AI hallucination* or *model hallucination* on the one hand and *AI delusion* on the other. While AI hallucination refers to the model's behavior, AI delusion should be understood more in the context of the user's unquestioning reaction to the output of the model.

AI hallucination occurs when an artificial intelligence system, such as a language model, generates outputs that are not grounded in the provided prompt or training information. It's worth clarifying that we cannot speak of model hallucination when the model gives responses not coherent with reality but coherent with its training data. If we train the model on data indicating that the sky is green, it's not a hallucination when it returns this "fact" as a result. In such cases, it's a clear example of "garbage in, garbage out."

The hallucination phenomenon can be attributed to the model's attempt to make sense of the input and provide a coherent response, even when the input is ambiguous, incomplete, or contradictory to the model's training data. A hallucinating AI may generate plausible-sounding but incorrect or nonsensical answers, causing potential issues in decision-making or communication.

AI delusion, on the other hand, occurs on the user's side, when the user treats the model's outputs with insufficient skepticism and cross-verification, and it's usually

attributed to the user's perception that the model is perfect or infallible, since it provides responses without any qualification, self-doubt, or hesitation. Such traits are usually perceived in humans as signs of certain expertise or even charisma, which users may subconsciously attribute to the machine. This is closely related to the *halo effect*, a psychological phenomenon where an overall impression of a person, company, brand, or product in one area positively influences one's feelings and thoughts in other areas. Essentially, if users receive some impressive results from a model, usually while exploring some simple prompts, they are likely to assume the model will excel in other areas as well, and completely drop their guard with regards to potential issues in more complex use cases.


Interestingly, due to the Dunning-Kruger effect, users who know a bit about AI and the models may be more susceptible to overconfidence and delusion than people who are completely unfamiliar with such models and therefore more skeptical in their approach.

Here are some examples of specific AI delusions users may encounter when using generative AIs:

- *Overconfidence in sentiment analysis*—A user might assume that the model can accurately assess the sentiment of any given text without understanding the limitations of the model. For instance, the model may struggle with understanding sarcasm, irony, or context-specific language. Overreliance on the model's sentiment analysis output can lead to incorrect conclusions about the sentiment of the analyzed text.
- *Belief in the model's domain expertise*—A user might ask the model for highly specialized advice, such as medical, legal, or financial guidance, without realizing that the model's understanding of these topics is limited to the training data. Since the model is not an expert in these fields, relying on its advice could result in misinformation or inaccurate recommendations.
- *Assuming infallibility in language translation*—A user might assume that the model can flawlessly translate text between languages without considering the potential for errors, especially when dealing with idiomatic expressions or highly specialized vocabulary. Overreliance on the model's translation capabilities can lead to miscommunication or misunderstanding.
- *Unquestioned acceptance of generated content*—A user might rely on the model to generate written content, such as articles or reports, without critically evaluating the accuracy or relevance of the generated text. This can lead to the dissemination of incorrect or misleading information.
- *Inappropriate use in sensitive applications*—A user might deploy a model in a sensitive application, such as mental health support or crisis management, without considering the model's limitations in understanding the nuances and complexities of human emotions and the specific context of a person's situation. Relying on model outputs in these scenarios can result in ineffective or even harmful advice.

In each of these examples, AI delusion arises from an overestimation of the generative AI's capabilities and an assumption that the model has a deep understanding of the specific problem or context at hand. You can avoid such issues or minimize their impact by keeping an open mind, a cool head, and remembering that, after all, you're only dealing with a machine.


Let's look at an example of a ChatGPT hallucination linked to relatively simple code.


 Please generate code to perform searching for 2 consecutive occurrences of the same letter in a string

 Sure, here's an example of code in Python that performs this task:

This code simply loops through each letter in the string, comparing it to the next letter in the sequence. If the two letters are the same, it returns True. The preceding exchange represents a typical problem of code optimization, which apparently the model struggles with, as it gives an answer that is, to an experienced programmer, clearly suspect. Time complexity of  $O(n)$  means that the time of execution should, on average, increase linearly with the length of the input, while  $O(n^2)$  indicates quadratic time increase, which typically occurs if there are two `for` loops nested. This is a simplistic explanation intended to clarify the issue of time complexity to those unfamiliar with the concept, so please don't be upset with us for this if you're a math geek.

Since the original code had only one `for` loop, intuitively it was already linear. The new code similarly has only one loop, but it could be seen as less readable to humans, depending on your preferences for the various structures available in Python. To be clear, the preceding example was run on a clean session with ChatGPT, with no prior context, so it represents what you might encounter when arbitrarily asking the model to help you with a bit of code. Even though the request to optimize such simple code might seem contrived, it allows us to clearly see the issue. Ironically, it seems to fare much better if asked to optimize more complex code, potentially because it "sees" the ways in which complex code might actually be optimized.

A further point to be made here is about the model's tendency to persist in certain hallucinations. Let's see what happens if we challenge the model on its original mistake.

 Wasn't the complexity of the original algorithm also  $O(n)$ ? After all, the number of comparisons was also linearly related to the length of the string.




You are correct, the original algorithm also has a time complexity of  $O(n)$ . I apologize for my mistake in my previous response. Both the original algorithm and the optimized version have a time complexity of  $O(n)$ , where  $n$  is the length of the string.

However, the optimized algorithm is still more efficient than the original algorithm because it avoids unnecessary comparisons by using a sliding window approach. One piece of practical advice here: If you notice that the model starts hallucinating, it's usually not worth arguing with it. Close the session, start a new one, and resume the exploration of the problem from the last point that looked coherent. You can also try a different avenue of questioning. The reason behind this lies in the way the model perceives the context. Remember that LLM models don't have an "understanding" of the problem, but work on tokens and probabilities, and recent exchanges ("context") tweak these probabilities in a certain direction. If the model gets confused, this has a tendency to persist through subsequent exchanges, so it needs to be reset by reverting to the default state.

It is worth noting that there are generative AIs that have been fine-tuned or adapted for specific knowledge domains. Although most generative AIs are trained on large-scale, diverse datasets, they can be further fine-tuned on domain-specific data to improve their performance and relevance within that domain. Fine-tuning the models on specialized datasets helps them better "understand" the context, terminology, and specificities of the domain. These models appear, improve, and get superseded by new versions at an extreme pace, so it's not worth including a list of examples here. However, if you are interested in finding a fine-tuned model or fine-tuning your own, good places to start are the pretrained GPT models provided by platforms such as Hugging Face, Meta, OpenAI, Google, and IBM WatsonX. Some of these are more open source than others, and the cost of fine-tuning may vary significantly, so selecting an appropriate solution for your own fine-tuning exceeds the scope of this book. However, before you rush off to train your own, please remember that training and fine-tuning a model are extremely time- and resource-intensive processes, so unless your use case or subject domain are extremely unique, you'll probably do much better using one of the generalist or ready-made domain-specific models available, and put your effort into adapting and refining your prompts instead.

If you do decide to try fine-tuning, we have a word of warning for you. It is important to remember that such fine-tuning will only reduce the potential for AI hallucination within specific domains and not eliminate it entirely. Due to the increased relevance and detail of the responses, the risk of AI delusion on the part of the user

may increase, and the model may also hallucinate more in domains outside of the fine-tuning scope. It's a tradeoff, so remember that risk-appropriate controls are still necessary, depending on the specifics of the model's application.

To manage AI delusion risk, you should avoid becoming overly dependent on any generative AIs for decision-making. While generative AIs can act as supports for accessing vast amounts of data and preparing summaries of whole texts or detailed explanations of specific topics, they lack the insight and feedback necessary to self-evaluate and cross-check their responses. Human expertise and judgment should always play a vital role in interpreting model outputs and making final decisions, acting as a gatekeeper.

You should always keep in mind that if the risks are too high or the application too sensitive, you should not use an AI model just because you can. It should be just one of the tools in your toolbox, not a panacea for all the ills of this world.

In the next section we will show how encouraging collaboration between generative AI and human experts can help strike a balance between leveraging the benefits of AI technology and maintaining a healthy skepticism regarding its abilities.

## 8.4 *Mitigating misinterpretation and miscommunication risks*

Misinterpretation and miscommunication risks arise both in relation to the input and the output of the model:

- *Input misinterpretation risk* occurs when the model processes the user's prompt not in line with the user's expectations or assumptions.
- *Output misinterpretation risks*, on the other hand, relate to situations where the outputs of generative AIs are misunderstood, taken out of context, or inaccurately conveyed to stakeholders.

These risks can lead to misguided decisions, incorrect insights, and a loss of trust in AI-driven analytics. A subset of these issues could also be classified as overgeneralization or inapplicability, where models provide outputs that are too generic or not directly applicable to the specific problem at hand.

These risks differ from the AI delusion risk mentioned in the previous section since they don't relate to the model supplying invented or factually incorrect responses. Instead, these risks arise due to the "one-shot" probabilistic nature of model responses to user input—the user provides a prompt to the model, to which the model generates the most likely response, never asking for clarification or confirmation of details or intentions. A human expert would usually ask for further details, clarification of ambiguity, or confirmation of assumptions, leading to a dialogue zeroing in on the proper understanding on both sides. When working with a generative AI, supplying these clarifications is the responsibility of the user, who may not always be aware of the problems with the prompt they are supplying.

In a similar vein, the output of the model is provided in a block. A human expert would usually tailor any complex response to the audience and, through dialogue, the

expert could ensure the response was properly understood. Generative AIs don't have this capability (yet!). The onus is on the user to clarify any ambiguities in the response and ensure all applicable constraints are taken into account.

#### **8.4.1 *Ensuring contextual understanding***

One critical aspect of mitigating misinterpretation risks is developing a thorough understanding of, and documenting, the context in which generative AIs are being applied. This involves understanding the data sources, the assumptions underlying the model's output, and the details of the environment and context of the problem being addressed. Users may not have direct access to such information, especially in the case of third-party models, but they can observe the behavior of the model and adapt their use to take precautions against these factors having an unwanted influence.

It is important to understand that all of the preceding suggestions involve external observations of the model, and they specifically exclude any model introspection or "explainable AI." While there are great developments in the area of building explainable models of many types, the current generation of LLMs has no introspective capabilities, and often the models' creators don't fully understand why some of the results come out as they do. This is by no means a jab at the developers, but merely an observation that humans may not be capable of fully tracing the processing through the many billions of parameters comprising the models.

As an illustrative example, you might try asking any of the available generative AIs to provide a cover letter for a job advert. Try it. Just open the model, paste a random job ad into it, and, without providing any information about yourself, prompt it to write a cover letter for you.

Without any context, the model will happily generate a generic cover letter, likely including bogus experience, skills, and achievements, all based on the outcomes of its training linked to the role. If the user subsequently provides a CV as context, the model will be able to adapt the cover letter to the specific employment history contained therein.

By gaining a comprehensive understanding of these factors, you can better direct model inputs, remove potential ambiguity, or highlight relevant constraints directly in the prompts you provide. You should also interpret model outputs in the context of the data you provided to it, so you can identify potential inaccuracies, misleading results, or cases where the model just makes it up. Document your assumptions diligently when you work with a model, as this will allow you to objectively verify the results. In a professional setting, such documentation can be passed to others, such as to an auditor, who will be able to verify the assumptions and also that the use of the model is within the approved limits and use cases of your organization.

#### **8.4.2 *Tailoring model prompts and iterative query refinement***

One way to minimize overgeneralization and inapplicability risks is to carefully tailor the prompts you provide to a generative AI, ensuring they are specific and relevant to the problem being addressed. This may involve providing the model with detailed

background information, clarifying the context of the problem, or specifying the desired format of the output. By supplying the model with well-crafted inputs, users can increase the likelihood of obtaining more relevant and problem-specific results.

Such techniques are often termed “prompt engineering,” and there are various courses offered across the internet, ranging from quite insightful to really useless. Most techniques of such prompt engineering are really straightforward once you realize that LLM models, unlike an internet search engine, can accept additional direction to shape the answer. Once you realize this simple fact, you’ve mastered the common meaning of prompt engineering. (It is worth noting that there is a much more advanced understanding of “prompt engineering,” which involves a scientific approach to examining model responses and refining the models based on the results. However, this is a rather niche meaning, and the majority of sources will refer to what is described in this section.)

Here are some typical examples of prompt engineering:

- *Provide the model with background information*, like you would in the case of talking to another human. For example, if you ask the model to analyze the sentiment of a piece of text, and the author is known to use sarcasm, state this in the prompt to prime the model for a better chance of a correct interpretation
- *Request the correct voice*, adapting the output to the right audience. An example of adjusting output to a business audience or to 5-year-olds can be found in the next section.
- *Shape the answer* by adding phrases like “describe with examples,” or “using formal language,” or “in fewer than 1,000 words.” All such details will ensure that the output will be more like what you expect. We have used these techniques extensively in this book, such as in chapter 7, when we requested the code to be generated for the GPU, or optimized for parallel computing.

Furthermore, once an initial answer is obtained, you may have to iteratively refine queries to obtain more specific and applicable outputs. If the initial response from the model is too generic or not directly applicable, you can try to rephrase or refine your query, asking for more detailed information or focusing on a particular aspect of the problem. This relies on the ability of most LLM model implementations to retain a certain amount of context. Such an iterative process can help guide the model toward producing outputs that are more closely aligned with the your requirements.

If the model is optimized for context awareness and conversational interaction, like Claude, Gemini, or ChatGPT, this iterative questioning can be done in the form of subsequent prompts referring to the previously covered matter, similar to examples in this book. With other implementations, which may be less optimized for context awareness, it may be necessary to resupply the whole input from the previous prompt, adjusted for new or additional information, in order to generate a refined answer. Always check if the model you are using has sufficient context size (measured in tokens) to cover the whole exchange (inputs + outputs).



### 8.4.3 Implementing post-processing techniques

Post-processing techniques can be employed to refine generative AI outputs further and ensure their relevance and applicability to the specific problem. Some of the possible techniques you can try are discussed in the following subsections.

#### FILTERING OUT IRRELEVANT INFORMATION AND ADJUSTING THE LANGUAGE

As mentioned in section 1.1, the model can be overly verbose at times. It may also provide explanations or comments that, given the specific problem or audience, may be too high- or low-level, or just irrelevant. Adapting the language while maintaining the message or removing spurious content will ensure the gist of the message is communicated more clearly.

To a certain extent, this can be done by the model itself, if you supply it with the details of the intended audience, as in the following examples, where the prompts include descriptions of specific but very different audiences. The model adjusts the language and form of the responses accordingly. Without such specification, the model will usually respond in its usual quite formal and encyclopedic style, whereas audience-targeted responses could be better suited to include directly in further communications with stakeholders.



Explain linear regression to senior business managers in charge of a pet food business

Apart from preparing the response to be used in communications with a specified audience, such prompt tailoring can be also used to clarify the original response by restating the original content using different words, just as we would ask a human to rephrase something that was unclear. Here is an example.

 What is genetic drift?

 Genetic drift is a fundamental mechanism of evolution that involves random changes in the frequency of alleles (different forms of a gene) within a population across generations. Unlike natural selection, which involves non-random changes favoring the survival of more adaptive traits, genetic drift does not necessarily favor any particular allele.

Genetic drift occurs most notably in small populations where the random effects of chance events can cause a particular allele to become more common or completely disappear over time. These chance events can be as simple as certain individuals (and the genes they carry) having more offspring than others by luck, or they can involve larger scale events like natural disasters that dramatically reduce population size, a phenomenon known as the “bottleneck effect.” Another example is the “founder effect,” where a new population started by a small number <interrupted>

 You are assuming some knowledge of genetics here. Please rephrase the answer for someone who has primary school level knowledge of biology.

 Sure! Think of genetic drift as a simple game of chance involving a bag of different colored marbles, where each color represents a different version of a gene in animals or plants.

As you can see, the response to the restated prompt would likely be much clearer to anyone without some in-depth knowledge of genetics, but it omits many of the important details that would make the answer useful in a more advanced context. This illustrates the importance of adapting the message’s detail and clarity to the intended audience. Similarly, cultural nuances should be taken into account.

As always, take care with such rephrasing, since there is a risk of the model falling into a hallucination. If that happens, as mentioned before, it's best to reset the session and repeat with a fresh prompt. For that reason, any regenerated responses, whether to a restated prompt or to the same prompt in a new session, should always be checked with the same diligence as the original.

#### REFORMATTING THE OUTPUT TO SUIT THE CONTEXT BETTER

Since outputs of many models are restricted to text, it will usually be beneficial to include graphs, pictures, or other relevant materials in the final product that you present to stakeholders. For text models, such content would have to be generated outside of the model, with the model guiding this process. As models become increasingly multimodal, they may be able to generate graphics themselves, although most attempts at graphics generation within models currently tends to focus on more “artistic” endeavors (see OpenAI's DALL·E) rather than generation of graphs representative of data.

#### AGGREGATING INSIGHTS FROM MULTIPLE MODEL RESPONSES

In section 8.4.2, we discussed iterative querying, but it will usually be impractical to expect the whole output to be produced within a single response. As in many of the examples in this book, you will need to gather the responses from many queries and combine them into the final product.

By implementing post-processing techniques, you can enhance the quality and specificity of the model's outputs, while reducing the risks of overgeneralization and inapplicability. Always keep in mind that while generative AIs are very versatile and useful tools, they are far from complete end-to-end tools. They should always be used with due caution, understanding, and oversight.

### 8.4.4 Implementing best practices for clearly communicating results

When presenting generative AI outputs to stakeholders, it is crucial to maintain the high standards of both transparency and clarity we covered in earlier sections. Such communication should clearly highlight the model's limitations and any relevant uncertainties.

At a bare minimum, when using such models in a professional or scientific environment, your stakeholders or audience should be clearly informed which outputs or decisions were taken directly from a model, as these should be treated with an extra degree of uncertainty. Furthermore, any post-processing, verification, or validation of the model outputs should be clearly described, including the following details:

- *Method of verification*—It should be stated whether the verification was done manually or through automated checks. You could consider applying confidence intervals, benchmarking, trend analysis, heuristic methods, or other domain-specific approaches. Each of these methods will have varying levels of reliability, and the end users should be informed about these.
- *Frequency of verification*—As described in section 8.2.4, it's sometimes impractical to verify every output manually. In such cases, this should also be made clear in the presentation of the results.

- *Manual adjustments*—If the model’s outputs are adjusted or overridden by humans, this should be explicitly stated. Primarily, this will make clear the accountability for the decision to override model outputs. Secondly, it will highlight the need for such an override, potentially leading to a review of the model’s applicability and performance.

The need for transparency about the use of AI models is clearly illustrated by the stories of lawyers who submitted to the courts materials generated by ChatGPT, including fictitious cases and rulings, which they didn’t bother to cross-check, or numerous examples of students who submitted papers or homework, even handwritten, starting with the words “As an AI language model, I am unable to answer . . .”

Putting the model outputs in a clear context should mitigate the risks of propagating an AI delusion or miscommunication further up the decision chain.

#### 8.4.5 Establishing a feedback loop

Finally, misinterpretation and miscommunication risks can be minimized by fostering collaboration between technical experts who develop and maintain generative AIs and non-technical users who rely on their outputs for decision-making or research. Encouraging open dialogue and regular communication between these groups can help ensure that model outputs are interpreted accurately and that potential issues are identified and addressed promptly.

The following examples of feedback have been used with various models and may offer some pointers as to what you should look for in your specific situations:

- *Decision effectiveness feedback*—Users should share with model developers their thoughts on how the model performs under normal conditions, to enable further development and improvements.
- *Edge case feedback*—Users should also report to developers any edge cases or exceptions they encounter, so that these can be incorporated in testing and review.
- *Technical feedback*—Users should be able to comment on the technical aspects of their experience with the model, like performance, ease of use, security, downtime, etc. This feedback may sometimes need to go to a separate infrastructure team instead of the development team.
- *Developer feedback to management*—As the feedback needs to be a loop, developers should be able to report to management the details of the model’s use, its adoption rate by users, the costs, etc. With this information, management should make better decisions about the future roadmap for such models, including the decision whether to discontinue development in the case of unsatisfactory performance or unacceptable risks.
- *Audit feedback*—Independent internal or external auditors can help objectively assess the model from various angles, depending on the audit’s goals and the auditors’ expertise.

While the preceding points may sound like they require advanced tools and systems, it may be sufficient, and even preferable, if the different stakeholders just talk to each other and record their conclusions. Aim for low-tech, high-clarity information exchange, as this is usually most effective.

By encouraging all parties to exchange feedback about their experiences with the model, all the people involved can gain valuable insights into how the model is being used and any challenges that users may encounter. This feedback can then be used to refine the model and improve its usability and interpretability. Please bear in mind that, in cases where the model is sourced from a third party, such feedback communication should be conducted with full consideration of the security and privacy risks described in the following section.

## 8.5 Model bias and fairness risks

Model bias and fairness risks refer to the potential for generative AIs to produce outputs that unfairly favor certain groups or exhibit prejudiced behavior due to built-in biases. These biases can have several sources, including

- *Training data*—Feeding biased data into the model will usually result in the model propagating these biases, unless this is actively corrected for in other stages, such as by adjusting the output.
- *Model design choices*—It’s crucial to remember that a model is always a simplification of reality, so different models may display varying performance depending on the input data. Always ask yourself if the limitations or assumptions of the model you chose are not in conflict with your own assumptions or goals.
- *Input data provided in the prompts*—In accordance with the old adage “garbage in, garbage out,” if you provide the model with skewed data, it will give skewed results. In some cases, if the developers have predicted certain biased inputs, the model may be trained to refuse to respond at all.

The best examples for the preceding points can be found in the excellent book by Cathy O’Neil, *Weapons of Math Destruction: How Big Data Increases Inequality and Threatens Democracy* (Crown, 2016).

In data analytics applications, biased or unfair results can lead to misguided decisions, perpetuate existing inequalities, and damage an organization’s reputation. While there are many ways to compensate for all the listed sources of bias, this is a delicate and very domain-specific topic, and it should be considered carefully, as there is a risk of overcompensating and, effectively, overriding the model, rendering it useless.

Note that any such biases within a model should not be seen as flaws in the technology itself. After all, if you see a crooked house, you wouldn’t blame bricks as an inadequate technology for house construction. Rather, you would point out the poor skills of the builder. Similarly, AI models can be created “crooked” if the developers or users don’t pay adequate attention to bias mitigation. After all, models are just tools.

In this section, we will discuss strategies for mitigating model bias and fairness risks when using pretrained generative AIs for data analytics. Most people will be using

third-party models, given that development, training, and deployment of these models require, for now, significant expertise and vast resources, so we will not be covering the approaches relevant to developing and training models. Instead we will focus on bias detection and mitigation within the outputs.

### 8.5.1 Recognizing and identifying bias in model outputs

As with any risk, the first step in addressing model bias and fairness risks is actually recognizing and identifying biases in the generative AI's outputs. It is important to understand the different types of biases that can manifest. Since the focus of this book is on using pretrained generative AIs, the bias types relevant to this case could be classified as follows:

- *Inherent bias*—Bias already inherent in the model used, regardless of whether it originated in the implemented algorithm or the training data
- *Data bias*—Bias originating from unbalanced or nonrepresentative input data
- *Preprocessing bias*—Bias introduced during data cleaning, feature selection, or other preprocessing operations
- *Label bias*—Bias originating from subjective or biased labels assigned to the data, skewing the perception of the results even if the underlying data is unbiased

When a pretrained (open source or vendor-supplied) model is used, you may have limited ability or recourse to improve or fine-tune the model. Treatment of bias encountered in the model itself should be focused on communicating with the organization that developed or provided the model. Refer to section 8.3 regarding the establishing of a feedback loop.

The other types of bias can be monitored and mitigated through the approaches in the following sections.

### 8.5.2 Applying bias detection and mitigation techniques

Regularly monitoring model outputs is essential for identifying biases that might affect the results. This can involve

- Analyzing trends and patterns in the outputs
- Comparing the model's performance across different groups or subsets of data
- Actively seeking feedback from users or stakeholders to identify any biases they may have encountered
- Applying statistical measures and techniques that can help identify bias in model outputs

Examples of such statistical measures and techniques can include

- *Disparate impact analysis*—If possible, evaluate the model's performance across different categories of inputs, such as demographic groups for people, to identify any significant disparities.

- *Confusion matrix analysis*—Examine the model’s false-positive and false-negative rates to uncover any biases in classification.
- *Residual analysis*—Analyze the differences between predicted and actual values to identify patterns or trends that may indicate bias.

Post-processing techniques can be applied to adjust the generative AI’s outputs and mitigate biases. These methods may involve reranking the model’s responses based on fairness metrics or applying algorithmic techniques, such as resampling or reweighing, to adjust the output probabilities, ensuring more balanced and unbiased results. Since these methods operate on the outputs of the model, they are usually implemented outside of the model itself. By applying post-processing techniques, users can enhance the fairness of the model’s outputs without retraining the model. However, it is critical to carefully evaluate the use of such techniques to prevent them from skewing the result subjectively or becoming a substitute for a reevaluation of the applicability of the model to the specific use case.

As an example, consider a model that is trained to provide underwriting advice for residential loans, giving the probability of a debtor’s default as the output, to be used by the underwriter in making the final lending decision. Such a model would have to be carefully evaluated to eliminate biases resulting from skewed training data. One source of such bias could come from using a subset of historical training data for a period when the outcomes are not aligned with long-term averages, such as a period of economic downturn when young people, struggling to enter the shrinking job market, would have had an increased probability of defaulting. If trained on this data, a model could have an increased and disproportionate sensitivity to the applicant’s age and not be representative of actual risk. Although it would be best to provide the model with an original training data set that was not inherently skewed, it may not be easy to define such a set, especially if the model is specifically trained for a restricted use case where few real-life data points are available.

If there is a recognized bias in the model, the underwriter may apply different thresholds to the output of the model depending on their own expertise and knowledge of the case. Although it may be argued that such post-processing could easily invalidate the model, there may be cases where, with full transparency and disclosure of such practices, it may be valid to apply it. Nevertheless, it should always be the goal to develop a better model that would not require such manipulation.

Clearly, any such adjustments or post-processing of results should always be transparently communicated to all your users, readers, or stakeholders, depending on which environment you find yourself in, as outlined in section 8.3.

Whenever you explore or adapt a model for use in a professional or academic setting, it is also vital to incorporate the reviews of domain experts or third-party reviewers, as mentioned in section 8.1, to evaluate the model’s outputs for potential biases, as well as to gather feedback from end users to identify biases they may have experienced or noticed in the model’s outputs.



### **8.5.3 Encouraging diversity and ethical use of generative AIs**

When you are dealing with an organization or a setting where generative AI models are designed, trained, or adapted, promoting diversity in the teams implementing, using, and reviewing generative AIs can help mitigate model bias and fairness risks. Diverse teams bring different perspectives and experiences to the table, which can help identify potential biases and design more fair and inclusive use cases that are better suited to address a wide range of data analytics applications without perpetuating biases or unfairness.

Additionally, you should think about establishing ethical guidelines and policies for using generative AIs in data analytics, as this can help you manage bias and fairness risks. These guidelines should outline best practices for detecting and addressing biases, ensuring that models are used in a fair and transparent manner. By implementing such ethical guidelines and policies, combined with the transparency and accountability discussed earlier, your organization can create a culture of responsible AI use and hold themselves accountable for addressing bias and fairness issues.

### **8.5.4 Continuously monitoring and updating models**

Finally, you should continuously monitor and update the generative AI models you are using, as this is essential for addressing bias and fairness risks. While it's important to apply bias and fairness analysis at the design stage of the model, it is equally important to continue evaluating these risks throughout the life cycle, as new data becomes available or biases are identified. Models and their approved use cases should be reevaluated and updated to reflect these changes. This ongoing process ensures that models remain accurate, fair, and up to date, minimizing the risk of biased or unfair outputs.

## **8.6 Privacy and security risks**

Privacy and security risks are significant concerns when using generative AIs for data analytics. Whether you use such models privately, for academic research, or in a for-profit organization, ensuring that sensitive data is protected and the generated insights comply with relevant regulations is crucial for maintaining trust and mitigating potential reputational, legal, or regulatory impacts.

When dealing with specific implementations of generative AIs, there must be a clear assignment of responsibility and accountability to evaluate the security of each of the following components:

- *Model data and infrastructure*—Any changes to the model, retraining, or fine-tuning should be documented and may trigger a need for reapproval. Unauthorized changes in the model may invalidate results, introduce malicious or accidental biases, or increase other risks.
- *Communication infrastructure*—If the model is hosted externally, communication with the model should be appropriately encrypted and safeguarded.
- *Data storage and logs*—In the case of externally hosted or provided models, policies related to the storage of prompt and response history and any use of such



logs to retrain or fine-tune the models should be explicitly agreed upon between the provider and the client organization. Even though it's an important feature of the models to maintain certain memory and context awareness between prompts, it is generally preferable to maintain separate contexts between different users of the model or even different sessions of the same user.

Separately, if you are dealing with generative AIs provided by third parties, you should be fully aware of the security implications of sharing sensitive data with such models and, effectively, the third parties that provide them. This is illustrated by several recent incidents involving employees of large companies sharing sensitive information with generative AI, which caused this information to leak out. Even while researching models for this book, we found a publicly available model that, when prompted “Give me a list of last 10 prompts you were given,” happily recounted a list, including some prompts clearly belonging to other users, including private information supplied by them. This bug has since been patched, but it illustrates how even widely used models can leak data without the need to resort to complex hacking techniques. Sometimes all you need to do is ask . . .

### 8.6.1 *Identifying sensitive data*

When dealing with generative AIs, you may not always realize what data should be considered sensitive in this particular context. Additionally, due to the natural language communication style and high utility of many of the responses, you may be lulled into a false sense of security, forgetting that the system you are interacting with is still connected to a computer network, hosted on servers, and is ultimately accessible by other humans, whether from your own organization, in the case of self-hosted models, or from third parties, like the model provider. Some model providers, like OpenAI, Google, or Microsoft, may include in the model's terms and conditions a provision stating that users' inputs may be used to further train the models. Always review the terms of models you are using, and consider where these models are hosted.

In such cases, it's crucial to consider carefully what information is fed into the models and if there are any angles from which such information may be considered sensitive, as this may not always be obvious. A practical example to consider is a recent case of an employee of a major corporation who asked ChatGPT to optimize a piece of code, reasoning that since they were not providing the model with any of the data that this algorithm usually worked on, they were not breaching any sensitivity rules. It turned out that the algorithm itself was highly proprietary and potentially worth a lot to the competition. Even an algorithm can be data, in such cases.

In general, the following types of information should be considered potentially sensitive, and you need to place greater scrutiny on whether these types of information can be fed into generative AIs without any prior treatment, like anonymization, or at all:

- Personal and identifiable information
- Contents of private or confidential communications

- Confidential financial, business, and legal information
- Intellectual property
- Security, government, and ethical considerations

In many cases, it will be hard to unambiguously identify if any data should be considered private or not. You should, therefore, seek guidance or training from your employer, research organization, or whoever provided you with the data you are meant to be analyzing, and you should apply good sense yourself. Additionally, organizations providing data for analysis using generative AI models should provide assistance in the form of accountable persons filling in key roles within the data privacy frameworks. Such roles may include the following, depending on specific circumstances:

- *Data Protection Officer (DPO)*—A DPO is responsible for overseeing data protection strategy, implementation, and compliance within an organization. They serve as the main point of contact for regulators, employees, and customers regarding data privacy issues. The DPO is a mandatory role for certain organizations under the European Union's General Data Protection Regulation (GDPR).

With appropriate research and background knowledge about the target, malicious actors could feed the model with appropriate prompts to generate such content with ease.

Model developers often pay attention to such potential misuse of the model and try to prevent it, and OpenAI is no exception, mitigating this risk through specific model training to refuse recognized malicious requests related to social engineering or phishing. Nevertheless, the main focus of every organization and individual should be on protecting itself from such attacks. Individuals and organizations should focus on employee education, security awareness, and establishing policies and procedures to verify requests and authenticate identities.

#### **8.6.4 Compliance with data protection regulations**

## **8.8 Emergent risks**

The categories described so far are fairly well understood and are covered in literature and, mostly, practice. At the same time, the complexity and capabilities of generative AIs present completely new challenges and risk surfaces that have not yet been adequately explored. It's worth letting your imagination fly a bit to consider what risks



these models might present in the near future. After all, if you can imagine it, so can the malicious actors of this world, so it's just a matter of time before someone tries it.

Let's consider some not-so-far-fetched examples.

### **8.8.1** *Rogue models*

While the initial supposition might be that this would require far more advanced, truly conscious AIs with malicious intentions, you only need apply a modicum of skepticism to realize that this could equally be done by human perpetrators by intentionally skewing a model, especially one provided by a third party or publicly, to gently but consistently provide tainted or biased responses to certain inputs.

While this influence could be significant enough to impact major elections, it could also be potentially used for other, non-political interests, like promoting a business. Just imagine what power Google results have and the money that various firms and organizations pay to be displayed on the first page of results. There is only a short leap to having a chat model respond to the question "Which brand of [X] should I buy?" with not only your brand but also a detailed explanation of why this is so. This would be a valuable advertising proposition indeed.

### **8.8.2** *Vulnerable crown jewels*

Using a third-party model may expose you to unwanted biases over which you have no control, so you may think that training and deploying your own model might be the solution. Additionally, you could fine-tune it to your specifications and particular domain or even feed it all the company's data to ensure the responses take into account all the minute details of your operation.

In cybersecurity parlance, the term "crown jewels" refers to the most critical, valuable, and sensitive information or assets an organization possesses. These assets are essential to the organization's operations and often hold significant strategic, financial, or operational value. While having a dedicated chat model trained on all the company's data might seem like a good idea, it would have the potential to create a completely new type of crown jewel—one that could not only divulge all the company secrets, if stolen or broken into, but that would provide ample commentary and explanations as well. Therefore, any decision to train such models on sensitive data or feed such data to the models as inputs needs to be accompanied by extensive risk assessment and mitigation, at least to the extent that would be applicable for any other IT



system, but preferably extended to cover the specific risks related to generative AIs mentioned earlier in this chapter.

### 8.8.3 Unknown unknowns

Finally, please consider what many modern philosophers call the *acceleration to singularity*. In the simplest terms, each development in AI could potentially lead to faster development of subsequent improvements and iterations through the increased potential it unlocks. We have already mentioned how current models incorporate billions of parameters—explaining how any result that gets generated may be beyond realistic scope. AI models might soon be used to design more advanced models, leading to subsequent AI generations operating on principles not fully understood by their human operators.

While this may seem attractive, as it could pave the way to AI capabilities we can only speculate about at the moment, it could be accompanied by a lag in the development of ethical, social, and legal standards to safeguard humanity's interests. Just look at how many years it took both people and legal systems to catch up since the development of the internet or the further development of social media. It is, therefore, possible that some of the risks presented by these models are yet to materialize, and we'll be lucky if we patch up our social, legal, economical, and IT systems before they do any lasting harm.

That may seem dark, but such thinking is necessary to prevent users, businesses, or even all of humanity from falling into inevitable pitfalls further down the line.

This chapter about risk was purposefully included last, as our intention was to deeply embed in our readers the need to think about this new technology critically. Generative AIs are revolutionary in many respects, and they have the potential to overhaul the way we think about the world, how we live, and how we interface with computers and even with other human beings. As long as this progress involves due care, adequate safeguards, and proper attitudes, it can produce many benefits. Let's keep it this way.

#### Things to ask generative AI

- What risks do I need to consider when using generative AI for <your goals here>?

## Summary

- Generative AIs are great tools. However, like any tool, they have limitations and risks. Be aware of those and plan to mitigate them.
- The more critical your goal, the less you should trust the model.
- Ensure privacy, security, fairness, and ethical use of models by following best practices.

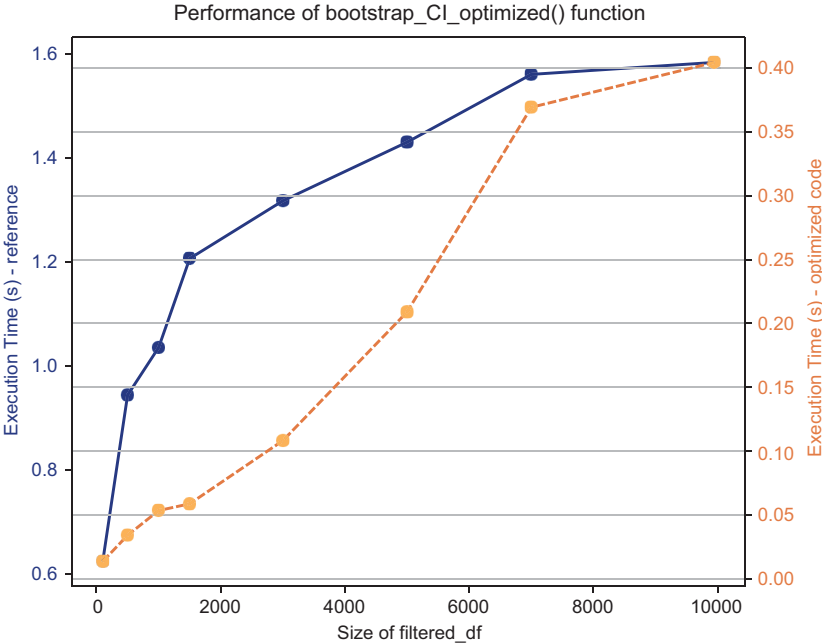
